Le teacht an Acht Ealaíon sa bhlian 2003 bhí sé de riachtanas ag údarás áitiúil Plean Ealaíon a scríobh agus a chur i ngníomh dá gceantair údarás féin. Nuair a thosaíomar ag pleanál dár bPlean Ealaíon Fine Gall, bhí dhá rogha oscailte dúinn, fógraigh agus déan comisiniú ar chomhlacht shainchomhairleoirí ealaíon lenár bPlean a scríobh, nó é a scríobh muid féin. Indiadh dúinn tamall gairid a chaitheamh ag plé le sainchomhleoírí ealaíon, bheartaíomar ar an tasc a dhéanamh muid féin.

Ón dtosach, bhí sé soiléir domsa agus do mo chomhleacaí Sarah O'Neill go raibh Plean réadúil agus cothromaithe uainn agus, níos tábhactaí fós go mbeadh teacht ag na healaíontóirí a bhíonn muid ag plé leo ar bhonn laethúil go héasca air. Bhí sé mar aidhm againn chomh maith Plean Ealaíon a sholáthar a mhúsclódh spéis i ndaoine bheith páirteach sna healaíona laistigh dá bpobail féin. Cuid bunúsach de forbairt an Phlean againn ab ea dul i gcomhairle le saoránaigh Fine Gall. Bhí orainn pobal na ealaíon a roinnt i sé fo-ranna éagsúla. Na grúpaí seo ná Ealaíontóirí (Profaisiúnta agus Neamh Phrofaisiúnta), Grúpaí Ealaíon, Lucht Féachana, Bunscoileanna, Meánscoileanna, Eagraíochtaí Ealaíon, Ginireálta/Poiblí. Scríobhadh ceistneoirí sonrachados na sé grúpaí, agus seoladh níos mó na míle díobh amach.

Cuireadh ár bhfonn aighneachtaí scríofa a fháil in iúl i gcúig nuachtán áitiúla agus sa phreas náisiúnta. Chomh maith leis sin, cuireadh sraith chruinnithe poiblí ar siúl le teacht ar thuairimí agus moltaí an phobail. Fuaireamar níos mó ná céad aighneacht. Bhí an próiseas chomhairle poiblí seo an-chabhrattheach chun riachtanais an phobail ealaíon, idir phrofaisiúnta agus amaitéireach, a fháil amach chomh maith leis an bpobail i gcoitine. Tá sé i gceist againn leanúint leis an scéim chomhairle seo le healaíontóirí, oibritheoirí agus eagraíochtaí ealaíne, agus an pobal go ginireálta, mar pháirt de phróiseas leanúnach bhailiúcháin eolais do phorbairt pholasaithe sa todhchaí.

Mar pháirt den phróiseas dearaidh, bheartaíomar ar ealaíontóir atá ag teacht chun cinn a fhostú leis an tréith fhótografaíoch den Phlean a léiriú. Chuaigh muid i gcomhairle le roinnt ealaíontóirí mar gheall air agus d'iarramar orthu samplaí dá saothair a sholáthar dúinn. Roghnaigh an painéal Dianne Whyte, fótagrafaí óg atá ina cónaí i mBaile Átha Cliath. Chruthaigh Dianne carn oibre a dhear pictiúr de ghníomaíocht na nealaíon i bhFine Gall; tá bailiúchán den obair seo léirithe sa Phlean agus beidh sé seo mar bhunús do thaispeántas ealaíon I nDraíocht I 2007.

Chuaigh an doiciméad rétihe ós comhair an Chomhairle agus glacadh leis ar an 13ú Feabhra 2006 d'aon toil. Is mar thoradh díreach ar riachtanais an phobail na nealaíon I bhFine Gall gur cuireadh I gcrích agus gur glacadh lein an bPlean Ealaíon.

Cinnteoidimde, foireann ealaíon Chomhairle Contae Fine Gall, go gcoimeádtar na healaíona chun tosaigh ar chlár gnó an Chomhairle. Leanfaimid orainn ag obair chun a chinntíú go mbeidh teacht ag gach éinne, cuma pé áit gurb as dóibh, pé creideamh atá acu nó pé suíomh eacnamúil ina bhfuilid, ar ghníomaíochtaí Ealaíon.

## Introduction

Rory O'Byrne, County Arts Officer

With the 2003 Arts Act it became mandatory that local authorities were required to write and implement an Arts Plan for their administrative areas. When we began to plan for our Fingal Arts Plan, there were two options open to us, advertise and commission arts consultants to write our Plan, or write it ourselves. After a brief foray into the arts consultants market, we decided to take the task on in house.

From the beginning, both my colleague Sarah O'Neill and I were clear that we wanted a Plan that was realistic, balanced and most importantly easily accessible to all those arts practitioners with whom we deal on a daily basis. We also wanted to produce a Plan that would inspire people to get involved in the arts within their own communities.

Fundamental to the development of our Plan was how we consult with the citizens of Fingal. It became necessary to subdivide the arts community into six distinct groups. These groups were Artists, Arts Groups, Audience, Primary Schools, Second-Level Schools, Arts Organisations, General/Public. Detailed questionnaires were written for each of the six groups, and over one thousand were sent out.

Written submissions were also invited through advertisements placed in five local newspapers and the national press. In addition, a series of public meetings were organised to invite public opinion and suggestions. We received over one hundred submissions. This process of public consultation proved most useful in ascertaining the needs of the arts community, both amateur and professional, as well as the wider community. We intend to continue this dialogue with artists, arts practitioners, organisations and the community in general, as part of an ongoing process of information gathering for future policy development.

As part of the design process, we commissioned an emerging artist to produce the photographic element of the Plan. A selection of artists were approached and asked to submit samples of work. The selection panel chose Dianne Whyte, a photographer based in Dublin. Dianne created a body of work documenting arts activity in Fingal; a selection of this work is illustrated in the Plan and this will form the basis of an exhibition at Draíocht in 2007.

The finished document went before Council and was unanimously adopted on 13th February 2006. The completion and adoption of our Arts Plan is a direct response to the needs of the arts community in Fingal.

We, the arts staff of Fingal County Council, will work to ensure that the arts remain high on the agenda of the Council. We will continue to work towards ensuring that all citizens, regardless of location, creed or economic circumstance have access to Arts activities.

## Réasúnaíocht an Phleain Ealaón

Tá sé mar riachtanas Plean Ealaón a bheith ann faoi Alt 6 d'Acht Ealaón 2003. Deir an tAlt: *Faoi Alt 67 d'Acht Ealaón 2001, ullmmhóidh agus comhlíonfaidh údarás áitúil pleannanna forbartha ealaíne laistigh dá limistéar feidhmiúil féin agus dá réir sin beidh sé freagrach as polasaithe an Rialtais i leith na n-ealaón a chur i bhfeidhm.*

Is freagrait straitéiseach é Pleain Ealaón a ullmhú chun aghaidh a thabhairt ar ghanntanas forbairt ealaón i bhFine Gall. Tugann sé deis do dhaoine a gcuid spéisie sna healíona a spreagadh agus a athnuachan, agus bheith páirteach iontu, agus cruthaíonn sé atmaisféir ina mbíonn daoine sásta dúshlán a bheth orthu agus sásta so saibhrítear a saolta de bharr na n-ealaón.

Déanann Údarás Áitiúla socruithe gach lá a théann i bhfeidhm ar chaighdeán maireachtála daoine. Is páirt lárnach den phróiséis seo Pleánáil Chultúrtha. Tá tionchar díreach ag cultúr ar phobail, más trí chabhair dhíreach ó dheontais chuiig grúpa drámaíochta áitiúil, scéimeanna d'éalaíontóirí cónaithe i scoileanna áitiúla, foráil ar shaothair ealíona poiblí nó aíseanna cultúrtha sainiúila a chruthú cosúil le Lárionaid Ealaón atá i gceist.

Le deich mbliana anuas in Éirinn, tá tábhacht níos mó tagtha ar ról an chultúir agus na nealaón i bpleanáil na rialtas áitiúil. Is slí éifeachtach iad na healaíona cabhrú le rialtais áitiúla spriocanna sóisialta agus eacnamúla a shroichint. Sa réimse seo tá tionscnaimh fhorbartha sóisialta i gcomhthéacs cathrach agus tuaithe maidir le athnuachan eacnamaíoch, pleánáil cathrach, cuimsíú grúpaí imeallaithe sa sochaí agus cruthú timpeallacht fisiciúil ar ard chaighdeán

Tá sé mar phroinsabal lárnach ag Comhairle Contae Fhine Gall go mbeadh soláthar seirbhís ealaón inbhuanaithe go hard ar an gclár gnó, agus déanfaidh siad dian iarracht a chinntí go mbeadh deis chothrom ag gach saoránach, cuma cá as dóibh, a seasamh sóisialta, nó a suiomh eacnamúil, freastal ar, agus páirt a ghlagadh ins na gníomhaíochtaí cultúrtha i bhFine Gall.

## Rationale for the Arts Plan

The provision of an Arts Plan for the county is a requirement under Section 6 of the 2003 Arts Act. The Section states that: *A local authority shall, for the purposes of section 67 of the Act of 2001, prepare and implement plans for the development of the arts within its functional area and shall, in so doing, take account of policies of the Government in relation to the arts.*

The preparation of an Arts Plan is a strategic response to address the needs of arts development in Fingal. It offers an opportunity for people to become engaged with, to invigorate and renew their interest in the arts, and to help create an environment where people are willing to be challenged and have their lives enriched through participation in the arts.

Local Authorities make decisions every day which impact on the quality of people's lives. Cultural planning is an integral part of this process. Culture has a direct impact on communities, whether it is through direct grant aid to a local drama group, artist- in-residence schemes in the local schools, the provision of public art works or the creation of specific cultural facilities such as Arts Centres.

Over the last decade in Ireland, the role of culture and the arts has assumed greater importance in local government planning. The arts can be an effective means of assisting local government to achieve social and economic objectives. These range from community development initiatives in urban and rural contexts to economic regeneration, urban planning, the embracing of marginalised groups and the creation of a high quality physical environment.

As a core principle, Fingal County Council will ensure that the delivery of a sustainable arts service remains high on its agenda, and will strive to ensure that all citizens, regardless of location, social standing or economic circumstance, have equal opportunity to access and participate in arts and cultural activities in Fingal.

Agus muid ag forbairt inár seirbhís dos na pobail seanbhunaithe agus na pobail nua mearfhorbarthacha, tuigeann Comhairle Contae Fhine Gall tábhacht na n-ealaíon i gcás forbairt féiniúlacht chultúrtha de, agus i gcás saibhriú saolta daoine. Cuireann na healáiona leis an eacnamaíocht áitiúil, le comhtháthú laistigh de phobail, le cur in aghaidh mothúcháin an uaignis agus le daoine a chumhachtú a d'fhéadfadh a bheith éagumhachtach nó ar imeall an phríomhsrutha.

Aithníonn Comhairle Contae Fhine Gall an gá atá ann dearcadh comhtháite a bheith againn i gcás forbairt na nealaíon amach anseo. Lena leithéid déanta, aithníonn sé go bhfuil saol cultúrtha saibhir agus éagsúil i bhFhine Gall. Is ó bheogacht agus éagsúlacht ár gcultúr a thagann a chuid láidreachta agus a chabhraíonn linn ár dtraigisiún a cheiliúradh agus a fhorbairt trí mheán na nealaíon.

Ta Fine Gall ar an Údarás Áitiúil is mó tógáil sa ír. Léiríonn Daonáireamh 2006 gur 239,813 daonra Fhine Gallanois, is méadú 22% é sin laistigh de thréimhse ceithre bliana ó Dhaonáireamh 2002. Cuireann sé seo béim ar an ngá dearcadh pleánalta a bheith againn maidir le soláthar cultúrtha ón gComhairle Chontae.

Tá Oifig Ealaíon Chomhairle Contae Fhine Gall suite laistigh de Rannóga Phobail, Cúltúr agus Spóirt de Roimh an Áineasa & Conláistí Pobail. Bunaíodh an Oifig Ealaíon sa bhlian 1994 nuair a cuireadh tú le post Oifigeach Ealaíon an Chontae.



Fingal County Council is currently overseeing the building of more housing than any other local Authority in the state. The 2006 Census shows the population of Fingal to be 239,813, an increase of 22% in the four year period since the 2002 census. This highlights the need for a planned approach to cultural provision by the Council.

The Arts Office of Fingal County Council is located within the Community, Culture and Sports Division of the Community Recreation and Amenities Department. The Arts Office was founded in 1994 with the establishment of the post of County Arts Officer.

- Cláiranna Ealaíontóirí sa scoil, áit is féidir le healaíontóirí profaisiúnta a gcuid scileanna a chur ar fáil sa seomra ranga agus fóram den mbriathar cruthaitheach a chur ar fáil.
- Is féidir le heagraíochtaí agus grúpaí ealaíona cúnamh airgeadais a lorg faoi Alt 6 den Acht Ealaíon 2003.
- Scéim sparánachta d'earnáil profaisiúnta na nealaíon, a thugann deis d'ealaíontóirí le stíleanna éagsúla a gcuid oibre a chleachtadh i Láirionad Thír Eoghain Guthrie ag Cúil Darach Contae Mhuineacháin.
- Seirbhís eolais ealaíona curtha ar fáil ag Comhairle Contae Fhine Gall, sheol an Oifig Ealaíon a gComhadlann Ealaíon Chontae [www.fingalarts.ie](http://www.fingalarts.ie). Cuireann an tseirbhís seo bunachar ar fáil de ealaíontóirí, daoine atá ag plé le ealaíon, grúpaí ealaíona, eagraíochtaí, ionaid, meáin agus acmhainní dos na healaíona i bhFhine Gall. Sa láithreán gréasáin seo tá íomhánná físeach, téacs, agus mioneolas ag baint le gach gné de phobal ealaíon Fhine Gall. Baineadh úsáid as an scéim Per Cent For Art chun bailliúchán de shaothair a fhorbairt in áiteanna poiblí.

Luachanna Lárnacha de Sheirbhís Ealaíon Chomhairle Contae Fhine Gall:

- Chun luach na nEalaíon a chur chun cinn mar pháirt riachtanach de fás phobail chuimsíthigh chothrom agus go mbeadh mothúcháin dena bhféiniúlacht faoi leith acu.
- Chun cuimsitheacht a spreagadh agus rochtain níos leithne a chur ar fáil do gach éinne gur spéis leo bheith páirteach san hEalaíona.
- Chun seirbhís ealaíon a chur ar fáil i slí chóir, oscailte agus tréadhearach.
- Chun polasaithe inbhuanaithe a sholáthar i gcomhairle leis na Rannóga áirithe de Chomhairle Contae Fhine Gall, eagraíochtaí caoi nó grúpaí pobail.
- Chun Polasaithe agus Nósanna Ealaíona áitiúla, náisiúnta agus idirnáisiúnta a thógáil san áireamh.
- Chun na healaíona a chur ar fáil do dhaoine míchumasaithe.

In providing the citizens of Fingal with opportunities for access and participation in a range of cultural activities, the Arts Office has devised a series of policies and programmes in partnership with various agencies and community groups.

These include:

- Artists-in-Schools programmes, wherein professional artists bring their skills to bear in the classroom and provide a forum for creative expression.
- Arts organisations and arts groups can apply for financial assistance under Section 6 of the 2003 Arts Act.
- A bursary scheme for the professional arts sector, which provides opportunities for artists from a variety of disciplines to develop their work at the Tyrone Guthrie Centre at Newbliss County Monaghan.
- An arts information service offered by Fingal County Council. The Arts Office maintains an on-line County Arts Directory [www.fingalarts.ie](http://www.fingalarts.ie). This service provides a database of artists, arts practitioners, arts groups, organisations, venues, media and resources for the arts in Fingal. The multi-media arts website features visual images, text and detailed information embracing the entire Fingal arts community. The Per Cent for Art Scheme has also been utilised to develop a collection of arts works in public spaces.

The core values of Fingal County Council's Arts Service:

- To promote the value of the Arts as an essential component in building balanced inclusive communities with a sense of their own identity.
- To promote inclusiveness and wider access for all citizens who wish to be involved in the Arts.
- To develop and deliver an arts service in a fair, open and transparent manner.
- To develop sustainable policies in consultation with the various Departments of Fingal County Council, relevant organisations and community groups.
- To take account of local, national and international Arts Policies and trends.
- To make the arts accessible to people with disabilities.



**Stairiúil**

Is ceantar é Fine Gall, nó 'Contae Thuaidh Bhaile Átha Cliath' a tugtar air uaireanta, a bhfuil stair agus traidisiún saibhir ag baint leis agus is féidir rian de a fheiceáil chomh fada siar le cetihere mhíle bliain. Tagann an t-ainm *Fingall* (an leagan is luaithe den ainm *Fingal*) ón nGaeilge *fine* a chiallaíonn críoch nó náisiún agus *gall* a chiallaíonn strainséir nó coimhthíoch. Tá an dóchúlacht ann go bhfuil an cur síos seo ag tagairt do na Lochlannaigh a lonnaigh go síochánta i bhFine Gall, áit is féidir a sinsir agus a dtionchar a fheiceáil in ainmneacha na ndaoine agus na logainmneacha

**Geografach**

Bunaíodh Fine Gall mar a ghlaodhanois air, mar thoradh ar an Acht Rialtais Áitiúil 1993, a lánscoir Comhairle Contae Bhaile Átha Cliath agus a chruthaigh trí údarás áitiúla eile. Clúdaíonn Fine Gall achar de 450 cileaméadar cearnaithe, ón leithinis ag Binn Éadair go Baile Brígin theas ó thuaidh, soir go teorann na Mí le Baile Gháire agus ó theas go dtí an Life.

**Déimeagrafach**

An daonra a bhí ag Fine Gall ná 239,413 i nDaonáireamh 2006. Ba mhéadú 22% ar na ceithre bliana roimhe. Meastar sna réamh mheastacháin go leanfaidh an daonra ag fás ar an luas céanna is gur léirigh na figiúrí sa todhchaí luath. Tá an líon is mó daoine óga in Éirinn i bhFine Gall le 58% de daonra faoi aois a 35. Meán-aosi an cheantair ná 28.5, in áit 34 atá mar mheán-aosi an náisiúin.

**Eacnamaíoch**

Tá traidisiún láidir sa ghairneoireacht agus i ngníomháiochtaí tírdhreacha i bhFine Gall. Ba 'chiseán aráin' Bhaile Átha Cliath é go stairiúil de bharr a suíomh geografach. Tá Aerfort Bhaile Átha Cliath ar an ngeata idirnáisiúnta is mó agus is tábhachtaí in Éirinn, ní amháin sin ach is sóchmhainn eacnamaíoch shuntasach é d'Fhine Gall leis an méid is mó fosaithe sa tir in aon áit amháin ann freisin. Léiríonn na háirimh ó 2001 gur thacaigh an tAerfort le 14,500 postanna lán aimseartha agus gur ghn sé €295m in ioncam bliantúil go háitiúil sa Chontae. Tacaíonn Aerfort Bhaile Átha Cliath go hindíreach le 26,000 post a ghineann €900m in ioncam bliantúil i mórcheantar Bhaile Átha Cliath.

**Historical**

Fingal, sometimes referred to, as 'North County Dublin', is an area rich in history and tradition which can be traced back four thousand years. The name 'Fingall' (the earliest version of the name Fingal) derives from the Irish *fine* meaning territory or nation and *gall* meaning stranger or foreigner. This description is probably referred to the Vikings who settled peacefully and integrated into Fingal and where their descendants and influence can be traced today in family and place names.

**Geographic**

Fingal, as we now refer to it, was established as a result of the Local Government Act 1993, which dissolved Dublin County Council and created three new local authorities. Fingal covers an area of approximately 450 square kilometres, stretching from the peninsula of Howth in the south to Balbriggan in the north, east along the Meath border to Garristown and south to the Liffey.

**Demographic**

The population of Fingal was 239,813 according to the 2006 Census. This figure represented a rise in population of 22% in the previous four years. Projections estimate that the population of the county will continue to increase in proportionate scales to the foreseeable future. Fingal has the youngest profile population in Ireland with 58% aged fewer than 35. The average age of residents of Fingal is 28.5, while the national average is 34.

**Economic**

Fingal has a strong tradition in horticulture and landscape activities. Given its geographic location, it was historically the 'breadbasket' of Dublin City. While Dublin Airport is Ireland's largest and most important international gateway, it is also a major economic asset for Fingal and is the single largest employer in the county. Calculations for 2001 indicate that the Airport directly supported 14,500 full-time jobs and generated €295m in annual income locally in the county. Dublin Airport also indirectly supports 26,000 jobs and generates an estimated €900m in annual income in the greater Dublin Area.

## Sóisialta

Dar le daonáireamh 2003, tá breis is 11,000 duine ag maireachtáil i bhFine Gall gurb as tíortha nach Éireann nó an Ríocht Aontaithe dóibh, 6% de dhaonra an chontae ina ionlán. Léiríonn meastachán an POSE go rachaidh an nós seo i méid. Deir meastachán Forfás go mbeidh 35,000 imirceach de dhíth gach blian ar feadh 10 mbliana chun na folántais poist a líonadh a tharla de bharr fás eacnamaíoch in Éirinn. Ag féachaint dúinn ar mheastachán Forfás, déanfaidh Comhairle Contae Fhine Gall tréan iarracht na himeachtaí agus na tionscnaimh a dhéanann iniúchadh ar éagsúlacht agus cosúlacht idir cultúir an domhain a aithint.

## Cultúrtha

Ó bunaíodh Comhairle Contae Fhine Gall tá an-chuid athruithe feicthe sa Chontae maidir lena phróifil chultúrtha agus lena sheirbhís soláthar ealaíon. Deich mbliana ó shin, d'fhéadfaí a rá go raibh próifil Fhine Gall míchothrom agus neamh-fhorbartha. É sin ráite, tá gluaiseacht Ceoldrámaíochta agus Drámaíochta amaitéireach láidir i gcónai ann. Tá borradh fós sa ghluaiseacht seo, le an-chuid Cumann tréan-bhunaithe ann. I dtéarmaí na nealaíon traidisiúnta, maíonn Fine gall go bhfuil oidhreacht shaibhir sna healáiona traidisiúnta acu, ón gceol, amhránaíocht agus damhsa go cleamaireacht agus ceirdeanna traidisiúnta.

Tá dhá cheann des na gealaraithe ealaíne fiseach is fearr sa tír san lonad Ealaíon Draíochta i mBaile Bhlainséir. Tá sainspás stiúideo curtha ar fáil ag Comhairle Contae Fhine Gall d'ealaíontóirí profaisiúnta i nDraíochta agus i Sord. Tá Draíocht feistithe le closlúp ionduchtaithe do dhaoine a bhfuil alláire orthu. Chomh maith leis sin, tá an Comhairle tar éis úsáid a bhaint as an scéim Per Cent for Art agus tá deich saothar ealaíona comisinithe go dtí seo againn. Trí sholáthar airgid, a ceadaítear faoin Acht Ealaíon 2003, tairgíonn an Comhairle cúnaimh airgeadais, sparánachaí agus tacaíocht aontaithe do ghrúpaí agus ealaíontóirí profaisiúnta agus amaitéireacha. Ag tógáil déimeagrafach an óige san áireamh, cuireann an Comhairle cláranna oideachais agus for-rochtain suntasach ar fáil do dhaoine ar Bhunscoileanna agus iar-Bhunscoileanna.

## Social

A feature of the population of Fingal is the relatively high percentage of residents who were born outside the State. The C.S.O. predicts that this trend will continue to increase further. Forfás, estimates that 35,000 new immigrants will be needed each year, over the next ten years, in order to fill positions and job vacancies created by economic growth in Ireland. Taking cognisance of the Forfás estimates, Fingal County Council endeavours to identify multi-cultural events and projects exploring the diversity and similarities between cultures.

## Cultural

Since the establishment of Fingal County Council, the County has seen many positive changes in terms of its cultural profile and arts service delivery. A decade ago, the cultural profile of Fingal could have been characterised as uneven and underdeveloped. However, the county has always had a strong amateur musical and dramatic movement. This tradition continues to thrive with numerous well-established Societies. In terms of the traditional arts, Fingal can boast a rich legacy in the traditional arts from music, singing and dancing to mumming and traditional crafts.

Draíocht Arts Centre, in Blanchardstown, now provides two of the best visual art galleries in the country. Fingal County Council has also provided specialised studio space for professional artists at Draíocht and in Swords. Draíocht is also equipped with an audio-induction loop for the hard of hearing. In addition, the Council has utilised the *Per Cent for Art Scheme* and has commissioned ten artworks to date. Through provision of monies, as permitted under the 2003 Arts Act, the Council offers financial assistance, bursaries and allied support to professional and amateur artists and groups. Given the youth demographic of Fingal's population, the Council continues to fund and operate extensive outreach and education programmes in Primary and post-Primary schools.



**Ionaid Ealaíne**

D'eisigh Comhairle Contae Fhine Gall Doiciméid Plé Ealaíon agus Cultúr sa bhlian 1994. I roinn faoin dteideal Na hEalaíona a Chóiriú, chuir sé béim ar an ngá atá le bonneagar ealaíon a chruthú trí áiseanna cultúrtha a thógáil, go bhféadfadh na healaíona fás iontu.

Le blianta beaga anuas, tá na húdaráis áitiúla ar thus cadhnaíochtra ó thaobh fhorbairt, mhaoiniú agus chaomnnú láthair ealaíon agus cultúrtha de laistigh dá limistéar riacháin. I bhFine Gall, tacáodh leis an bpróiseas seo le cabhair deontais chaipitiúil faoin Scéim Dreasachta Forbartha Chultúrtha (S.C.F.D.) 1994. Rinneadh páirt-mhaoiniú do Draíocht agus Ionad Chultúrtha Séamus Ennis faoin scéim S.C.D.F.

Mar pháirt dá thiomantas d'fhorbairt na healaíona i bhFine Gall agus, níos beachta fós, i gceantar Bhaile Átha Cliath 15 ina bhfuil daonra ard, chomisiúnaigh an Comhairle tuairisc darbh ainm Fuaiméanna na mBruachbhailte le Comhairleoir Ealaíon Declan Gorman. Cúis an dhoiciméid ná dearcadh an Chomhairle i leith pleánail chultúrtha a chur in iúl agus na deactrachtaí atá ann na healaíona a sholáthar sa socháí seo atá faoi chois ag na meáin-leictreacha – go háirithe sna bruachbhailte.

Caomhníonn Fine Gall an saol cultúrtha i gcónaí agus tá na healaíona curtha ar fáil aige don phobail leis an dá ionad ealaíon atá forbartha ann. Is ionad ilfhóinteach é Draíocht do lucht na mbruachbhailte a chuireann drámaíocht, damhsa, ealaíona fiseach comhaimseartha agus oideachas is for-rochtain pobail ar fáil. Is páirt ríthábhachtach anois é Draíocht den saol cultúrtha éagsúil agus fairsing ag Baile Átha Cliath 15. Is ionad ceoil traidisiúnta ionad Cultúrtha Séamus Ennis a bhfuil mar aidhm aige traidisiún tuaithe a chaomhnú sa cheantar ilathraitheach tuaithe seo de Fine Gall. Tugann an dá ioand deis do mhuintir Fhine Gall gníomhaíochtaí ealaíne éagsúla ó Éire agus ó thar lear a fheiceáil. Maoiníonn Comhairle Contae Fhine Gall Draíocht agus Ionad Cultúrtha Séamus Ennis, le maoiniú sa bhreis ag teacht ó Chomhairle Ealaíon Éireann.

**Art Centres**

In 1994 Fingal County Council published an *Arts and Culture Discussion Document*. In a section headed *Housing the Arts*, it stressed the need to begin the process of building an arts infrastructure within Fingal through the development of key cultural facilities, within which the arts could flourish.

In more recent years, local authorities throughout Ireland have been in the forefront of developing, funding and sustaining arts and cultural venues within their own administrative areas. In Fingal this process was assisted through capital grants awarded under the Cultural Development Incentive Scheme (C.D.I.S.) 1994. Both Draíocht and The Séamus Ennis Cultural Centre benefited from part funding under the C.D.I.S. scheme.

As part of its commitment to the development of the arts in Fingal and, more particularly, in the densely populated Dublin 15 area, the Council commissioned a report entitled *Sounds of the Suburbs* by Arts Consultant Declan Gorman. The purpose of the document was to inform the Council's overall view of cultural planning and an examination of the challenge posed by the demands of the arts in contemporary electronic media-dominated society – particularly in the suburbs.

Fingal County Council continues to preserve cultural life and provide public access to the arts in Fingal through its development of two arts centres. Draíocht is a multi-purpose arts venue for the suburbs offering theatre, dance, contemporary visual arts and community education and outreach. Draíocht is now a vital part of the expanding and diverse cultural life of Dublin 15. The Séamus Ennis Cultural Centre is a traditional music venue which aims to develop and maintain rural traditions in the rapidly changing environment of rural Fingal. Both venues offer the people of Fingal the opportunity to experience a broad variety of arts activities from home and abroad. Fingal County Council funds both Draíocht and The Séamus Ennis Cultural Centre, with additional funding support from the Arts Council of Ireland.



## Ealaín Phoiblí

Le fiche bliain anuas, tá béim níos mó curtha ag Rialtais Áitiúil ar shaothair ealaíne a lonnú in áiteanna poiblí. Ar fud Fhine Gall, tá an iliomad samplaí de ealaín phoiblí, agus cuireann gach saothar díobh le féiniúlacht pobail áitiúil agus le cultúr saibhir is éagsúil Fhine Gall.

Séard is ciall le 'Ealaín Phoiblí' ná saothair ealaíne atá suite i spás poiblí nó i bhfoigneamh go bhfuil teacht ag an bpobal air. Le déanaí tá sé de nós ag an ealaín bheith neamh-flíorach, gan a bheith ag feidhmiú mar chomóradh ar dhuine nó eachtra stairiúil, ach chun cur leis an dtimpeallacht, bíodh sé den nádúr nó lámh-thóghtha, ina bhfuil sé suite. Múscláíonn ealaín phoiblí idirghníomháíocht sa phobal, san ealaín chomhaimseartha agus sa timpeallacht, a chuireann chun cinn an ealaín i saol laethúil na ndaoine.

## An Scéim Per Cent for Art

Sa bhliain 2003 d'eisigh Comhairle Contae Fhine Gall doiciméad darbh ainm *Coimisiún Idirghníomhaigh agus Comhtháigh*, a rinne tagairt don phróiseas choimisiú saothair ealaíne poiblí do Halla Chontae nua an Chomhairle. Ba mheabhrúchán don Chomhairle é dá fhreagracht maidir le saothair nua a chomisniú i bhFhine Gall, agus ba chomhartha é chomh maith don phróiseas éachtach de choimisiú a tharla le tréimhse trí bliana. Scoir an dearcadh seo ós na gnáis agus bhunaigh sé meoin nua i measc na núdarás áitiúil i leith chomisniú saothair ealaíne poiblí.

## Bailiúcháin Ealaíne Chathrach Chomhairle Contae Fhine Gall

Sa bhliain 2000 thosaigh Comhairle Contae Fhine Gall ag ceannach oibreacha ealaíne ó ealaíontóirí gairmiúla. An cuspoir a bhí rompu ná bailiúcháin ealaíne comhaimsire a chothú agus a chur ar taispeáint sna foirgintí poiblí ag an gComhairle agus tacáiocht phraicticiúil a chur ar fáil d'ealaíontóirí gairmiúla Éireannacha. Tugann na bailiúcháin seans freisin do shaoránaigh Fhine Gall radharc a fháil ar ealaón comhaimseartha ina gcomhlúadar áitiúil.

## Cartlann Thraigisiúnta Fhine Gall

Tá oidhreacht shaibhir ag Fine Gall sna healaíona traidisiúnta, sa cheol, san amhránaíocht, sa damhsa maraon le cleamaireacht agus na ceirdeanna traidisiúnta. Cuirfidh Comhairle Contae Fhine Gall roimhe trí bhíthin na Cartlainne thraigisiúnta, eolas um ealaón thraigisiúnta sa Chontae a bhailiú agus cuntas buan a chruthú le taifead fuáime is físe ealaíontóirí is aisteoirí.

## Public Art

The commissioning and placement of works of art in public spaces has become an important function of Local Government over the last two decades. Throughout Fingal, there are many examples of public art, each helping to create a sense of identity in the local communities and to build on Fingal's rich and unique culture.

The term 'Public Art' refers to artworks located in a public space or placed within a publicly accessible building. In recent times, contemporary public artworks tend to be non-figurative, the function of which is not to commemorate an individual or historic event but to complement the environment, either built or natural, in which it stands. Public art imaginatively stimulates interaction between the community, contemporary art and the environment, making art a more integral part of people's everyday lives.

## Per Cent for Art Scheme

In 2003 Fingal County Council published a document entitled *Commission Interact Integrate*, which made comment on the process of commissioning public artworks for the Council's new County Hall. It was a reminder to the Council of its responsibility to commission new artworks in Fingal, and a witness to the remarkable process of commissioning which took place over a three-year period. This new approach broke with accepted norms and established a fresh approach to how local authorities commission public artworks.

## Fingal County Council's Municipal Arts Collection

In 2000 Fingal County Council began to purchase works of art from professional artists. The purpose was to build a collection of contemporary artworks, which would go on display in the Council's public buildings, and to offer practical support to Irish professional artists. The collection also provides the citizens of Fingal with the opportunity to view the very best of contemporary art in their local communities.

## Fingal Traditional Archive

Fingal can boast a rich legacy in the traditional arts, from music, singing and dancing as well as mumming and the traditional crafts. Through the Traditional Archive, Fingal County Council will endeavour to collect information relating to the traditional arts in the county and create a permanent record through audio and video recordings of traditional artists and performers.



## **Scéimeanna Maoiniú**

Tugann Oifig Ealaón Chomhairle Contae Fhine Gall spreagadh agus tacaíocht do ghníomhaíochtaí cultúrtha i bhFine Gall trí bhíthin tacaíochta airgeadais do ghrupaí ealaíne agus do ghrupaí pobail faoi Alt 6 dAcht Ealaón 2003. Sa bhliain 2005, bhronn an Comhairle deontaisí níos mó ná €55,000 ar cheol, ar dhrámaíocht, ar na h-ealaíona físe agus ar na gníomhaíochtaí traidisiúnta ealaíne sa Chontae. Sa tréimse céanna bronnadh deontaisí €60,000 ar mhór-fhéiltí pobail agus ar fhéiltí ceoil traidisiúnta.

Cruthaíodh na deontaisí d'aon ghnó don ghníomhaíocht agus don aisteoir go bhfuil éileamh fairsing air sa tír agus a chuirfidh go mór le saol cultúrtha Fhine Gall. Tá an tacaíocht airgeadais céanna ar fáil dóibh siúd a eagríonn féiltí ealaíne nó gníomhaíochtaí eile ealaíne ar bhonn bliantúil sa chontae.

## **Earnáil Ealaíne Gairmiúil**

Tá sraith gníomhaíochtaí eagraithe ag Comhairle Contae Fhine Gall d'fhonn tacú leis an earnáil ealaíne gairmiúil a chuireann ar chumas ealaíontóirí a saothair a chur ar taispeáint i bhFine Gall. Tá fostú maoinithe ag an gComhairle do ealaíontóirí ag scéimeanna Ealaíontóirí Cónaithe. Tá seirbhís chuimsitheach eolais againn ar [www.fingalarts.ie](http://www.fingalarts.ie) a léiríonn deiseanna Scoláireachtaí Bliantúla agus comisiúnú ealaíne.

## **Sparánachtaí Ealaíontóirí**

Ón mbliain 2001 chuir Comhairle Contae Fhine Gall deis ar fáil d'ealaíontóirí gairmiúla de bharr scéim Sparánachta Ealaíontóra coicís a chaitheamh ag Ionad Guthrie Thír Eoghain in Eannach Margaidh Chontae Mhuineacháin. Cuireann ionad Guthrie Thír Eoghain timpeallacht shuaimhneach chíúin ar fáil d'ealaíontóirí d'fhonn tionscnaimh ealaíne a forbairt. Cuireann sé deis ar fáil freisin d'ealaíontóirí imoibriú le h-ealaíontóirí gníomhacha eile.

Is gradam bliantúilanois é sparánacht Ionad Guthrie Thír Eoghain a chuireann Oifig Ealaíne Chomhairle Contae Fhine Gall ar fáil. Ní bhíonn an stíl ealaíne céanna i gceist ó bhliain go bliain d'aon ghnó chun seans agus tacaíocht a thabhairt do gach gné ildánach den ealaín i bhFine Gall.

## **Funding Schemes**

Fingal County Council's Arts Office encourages and supports cultural activity within Fingal by offering financial support to organised arts and community groups under Section 6 of the 2003 Arts Act. In 2005, the Council awarded over €55,000 in grants to music, drama, visual arts and traditional arts activity in the County. During the same period, €60,000 in grants was awarded to a number of large-scale community arts festivals and traditional music festivals.

These grants are specifically designed for events and performances which have a broad countywide appeal and which add positively to the cultural life of Fingal. Financial support is also available to those organising arts festivals or other cultural events on an annual basis in the county.

## **Professional Arts Sector**

In order to support the professional arts sector, Fingal County Council has organised a series of events which enable artists to showcase their work in Fingal. The Council provides paid employment opportunities to Artists through the Artist-in-Residence Schemes. We also provide a comprehensive arts information service through [www.fingalarts.ie](http://www.fingalarts.ie) which details opportunities such as the annual Bursary Scheme and the commissioning of public art.

## **Artists Bursaries**

Since 2001, Fingal County Council has offered professional artists the opportunity, through its Artist Bursary Scheme, to spend two weeks at the Tyrone Guthrie Centre at Annaghmakerrig, Co. Monaghan. The Tyrone Guthrie Centre offers a peaceful and secluded environment for artists to develop artistic projects. It also affords the opportunity for artists to interact with other practitioners.

The Tyrone Guthrie Centre Bursary is now an annual award offered by Fingal County Council's Arts Office. The favoured art forms change from year to year, in order to ensure the support and diversity of arts disciplines in Fingal.



### Oideachas agus For-rochtain

Teastaíonn ó Chomhairle Contae Fhine Gall trí bhíthin a chlár oideachais agus for-rochtain in rochtaineacht gníomhach ealaíne a chur ar fáil agus rannpháirtíocht a spreagadh i measc gach earnáil sa phobal i bhFine Gall. Ba mhaith linn cumarsáid agus tuiscint a chothú, comhthuiscint cultúrtha a mhalartú agus féin íomhá dearfach maraon le h-íomhá dearfach pobail a chruthú.

Tá clár cultúrtha á sholáthar ag an gComhairle dos na hAosaigh agus don Óige le bearta eagraithe agus maoinithe. Tacaíonn Comhairle Contae Fhine Gall le Bealtaine, féile bliantúl náisiúnta go bhfuil sé mar aidhm aige cruthaitheacht an Aosaigh a cheiliúradh.

### An Óige

Tá an Oifig Ealaíon i gcomhpháirtíocht le scoileanna, grúpaí pobail agus údarás reachtúla áirithe chun ceardlanna a bhfuil deacháillíocht acu agus cláir Ealaíontóirí Cónaithe a bhunú. Tugann scéim an Ealaíontóra Cónaithe deis cleachtadh ealaíne profaisiúnta a thabhairt go suiomh poiblí. A leithéidí Ceoil, Ealaíona Físe, Filíochta agus scríobhnoireacht cruthaitheach a bheadh i gceist. Tá na cónaiteachtaí seo thírithe ar thras ghearradh den phobal, le béim faoi leith ar riachtanais an Óige agus daoine le míchumais intinne nó coirp orthu. Tá sé i gceist ag na cláir seo tacú leis an obair a déantar lasmuigh des na curaclaim scoile agus chun deiseanna a thabhairt do dhaoine óga nach mbeadh acu de ghnáth.

### Ré Foghlama ar Feadh an tSaoil

Cuireann an tseirbhís, trí bhíthin a clár ealaíne, go mór le saol cultúrtha Fhine Gall. Tacaíonn ócайдí ealaíon i Leabharlanna poiblí go mór le bunú agus cothú grúpaí scríbhneoirí áitiúil. Is áit iad freisin inar féidir taipeántais agus drámaí a chur ar siúl ina mbrainsi faoi leith. Eagraíonn an Oifig Ealaíon agus Earnáil na Leabharlanna roinnt des na h-ócайдí seo lena chéile agus táid thírithe ar foghlaim ar feadh an tsaoil. Tá caidreamh láidir fásta idir an Oifig Ealaíon agus na Leabharlanna ó bunaíodh an Comhairle agus rinneadar comh-fhorbairt ar an-chuid imeachaí cultúrtha ar nós an clár litríochta *Finscéal*.

### Féiltí Bliantúla

Tacaíonn Comhairle Contae Fhine Gall le seacht bhféile ealaíne bliantúil go háitiúil. Bíonn na hócайдí seo, a mbíonn saorálaithe i gceannas orthu, ar siúl ar fud an chontae ó Bhealtaine go Deireadh Fómhair gach bliain. Leanann siad ar aghaidh go tipiciúil ar feadh deireadh seachtaine nó ar feadh seachtaine agus bíonn idir imeachaí ceoil agus litríochta go sain ‘Scoileanna’ traidisiúta iontu.

### Education and Outreach

Through its Education and Outreach programme, Fingal County Council seeks to provide access to arts activity and encourage participation by all sectors of the community within Fingal. We aim to foster communication and tolerance and to promote cultural exchange and also to create a positive image of self and community.

The Council makes cultural provision for its senior citizens and young people through organised events and funded programmes. Fingal County Council supports Bealtaine, an annual nation-wide festival, which aims to celebrate creativity in older people.

### Youth

The Arts Office has formed partnerships with schools, community groups and relevant statutory bodies to provide quality workshops and Artist-in-Residence programmes. The Artist-in-Residence scheme allows for professional arts practice to be brought directly into a community setting. These cover Music, Visual Arts, Poetry and creative writing residencies. The residencies are targeted at a cross section of the community, with particular emphasis on the needs of the young and people with physical and intellectual difficulties. The programmes seek to complement work outside the normal school curricula and to give young people access to cultural opportunities that they would not otherwise have.

### Life Long Learning

The Library service, through its arts programming, significantly adds to the cultural life of Fingal. Arts events in Public Libraries offer support in establishing and sustaining local writers groups. They also provide for exhibitions and live theatre in the various branch libraries. Some of these events are jointly organised between the Arts Office and the Libraries Division and are aimed at encouraging life long learning. The Arts Office and the Libraries have enjoyed a close relationship since the inception of the Council and have co-developed many new cultural initiatives such as the annual literature programme *Finscéal*.

### Annual Festivals

Fingal County Council supports seven annual locally-based arts festivals. These events, organised by volunteers, take place throughout the county from May to October each year. They typically last from a weekend to a week, range from music and literature events to specialised traditional Scoileanna.



## **Imeachtaí**

Tá clárú bliantúil ar siúl ag an Oifig Ealaíon de thaibhléirithe agus imeachtaí i bhFine Gall. Is ócáid dé-bhliantúil an Féile Fótagrafaíochta Idirnáisiúnta Phine Gall agus tá sé ar siúl le deich mbliana anuas. Sa bhliain 2006 bhí sé mar ardán d'oibreacha fhótagrafadóirí ó fiche thír éagsúil san Eoraip. Ócáid bhliantúil scríobhnóra is ea *Finscéal* agus tá sé ar siúl ó Aibreán go Samhain. Is Féile bliantúil Idirnáisiúnta Pháistí é *Spréacha* agus eagraítear é i gcomhoibriú le Draíocht, mar atá *Amharc Phine Gall*, taipeántas bliantúil d'ealaíontóirí atá ag maireachtáil is ag obair sa chontae.

## **Comhpháirtithe**

I Meitheamh 2005, d'éisigh an Oifig Ealaíon Comhpháirtí dos na hEalaíona creat-dhoiciméad a mhíníonn a dhearcadh nua maidir le comhpháirtíocht le húdarás áitiúil mar seo a leanas: *scrúdaigh an chomhpháirtíocht atá againn le húdarás áitiúil i láthair na huaire agus cruthaigh caidreamh níos oiriúnaí agus straitéisí chun a bheith in oiriúnt don timpeallacht nua.*

Cuireann Comhairle Contae Phine Gall fáilte roimh dearcadh nua comhpháirtíocha a léiríonn tuiscint ar ghnó a chéile

## **Maoiniú**

Tuigeann Comhairle Contae Phine Gall go bhfuil gá le maoiniú ceart a bheith ann ionas gur féidir Plean Ealaíon a sholáthar. Aithníonn an Comhairle an ról atá ag na h-ealaíona i bhforbairt agus i gcothú pobal. De bharr a gcuid tuiscine maidir le tábhacht fhorbartha, tá acmhainní sa bhréis tugtha ag Comhairle Contae Phine Gall don Oifig Ealaíon le cúpla bliain anuas don tseirbhís seo. Tá leibhéal foirnithe an Oifig Ealaíon méadaithe ó duine amháin go ceathrar laistigh de thréimhe cuíosach gairid ama. Chomh maith leis sin tá buiséad an Chomhairle don Oifig Ealaíon ardaithe ó €619,000 sa bhliain 2001 go dtí €1,516,000 sa bhliain 2006, ardú de 144% laistigh de tréimhse sé bliana. Táthar ag súil go ligfidh na cùinsí don bhuiséad fanacht ag an leibhéal seo, de réir bhoilscithe, le cinntíú go néireoidh le feidhmiúcháin an Phleain Ealaíon.

## **Events**

The Arts Office continues to programme on an annual basis for performances and events in Fingal. The Fingal International Festival of Photography is a bi-annual event and is now in its tenth year. In 2006 it served as a forum for the work of photographers from twenty different European countries. *Finscéal* is an annual writers' event and extends from April to November. *Spréacha* is an annual International Children's Festival and is organised in co-operation with Draíocht, as is *Amharc Phine Gall*, an annual exhibition for professional artists living and working in the county.

## **Partnerships**

In June 2005, the Arts Council published *Partnership for the Arts* a framework document, which outlines its new approach to partnership with local authorities as: *review our current partnership with local authorities and devise a more appropriate, strategic relationship that reflects the changed environment.*

Fingal County Council welcomes a new partnership approach that is reflective of a closer understanding of each other's roles.

## **Funding**

Fingal County Council acknowledges that, in order to deliver the Arts Plan, adequate funding must be in place. The Council recognises the role that the arts have to play in building and sustaining communities. In its acknowledgement of the importance of cultural development, Fingal County Council's budget for the Arts Office has committed increased resources over the past number of years to this service. The staffing level of the Arts Office has increased from one person to a current complement of four over a relatively short period of time. In addition, from a financial perspective, the Council's budget for the Arts Office has risen from €619,000 in 2001 to €1,516,000 in 2006, an increase of 144% over the six-year period. It is hoped that circumstances will allow the budget to maintain its current level, in line with inflation, in order to ensure the successful implementation of the Arts Plan.



**Breithnithe**

Mar thus le léiriú an Phleain thosaigh an Oifig Ealaíon ar dhian próiseas cruinniú eolais ó gach earnáil i bhFine Gall chun scrúdú a dhéanamh ar ról na n-ealaíon i saol mhuintir Fhine Gall. Bhí sé tábhachtach riachtanais an phobail a chinntí agus timpeallacht a chruthú áit a bhféadfadh tionscnamh cultúrtha bláthú. Aithníodh sé earnáil faoi seach sa phobail ealaíne agus pleánáileadh saincheistneoirí dóibh agus seoladh chucu iad:

- Grupaí Ealaíne
- Eagraíochtaí
- Ealaíontóirí Profaisiúnta
- Lucht Éisteachta
- an Pobal Coitianta
- Scoileanna agus Coláistí

Cuireadh fáilte roimh fhógraí scríofa i gcúig nuachtán áitiúla. Chomh maith leis seo reachtáladh sraith cruinnithe poiblí ag fáiltiú roimh barúil agus moltaí ón bpobel. Chuidigh próiseas breithnithe an phobail go mór le deimhniú ar riachtanais an phobail i gcoitinne. Tá sé beartaithe ag an Oifig Ealaíon leanúint leis an gcomhrá le h-ealaíontóirí, le lucht ealaíne gníomhacha, le heagraíochtaí agus leis an bpobel i gcoitinne, mar chuid den próiseas leanúnach cruinnithe eolais d'fhoinn forbairt polasaithe sa todhchaí.

**Consultation**

As a starting point for the production of the Plan, the Arts Office began an intensive process of information gathering from all sectors of the community in Fingal in order to examine the role that the arts play in the lives of Fingallians. It was important to ascertain the needs of the community and to create an environment where multiple cultural projects can flourish. Six individual sectors of the arts community were identified, for which specific questionnaires were planned and dispatched:

- Arts Groups
- Organisations
- Professional Artists
- Audiences
- the General Public
- Schools and Colleges

Written submissions were also invited through advertisements placed in five local newspapers. In addition, a series of public meetings were organised to invite public opinion and suggestions. This process of public consultation proved most useful in ascertaining the needs of the arts community, both amateur and professional, as well as the wider community. The Arts Office intends to continue this dialogue with artists, arts practitioners, organisations and the community in general, as part of an on-going process of information gathering for future policy development.

Maraon leis na Gníomhairescaí Stáit, déanfar aidhmeanna an Phleain a chomhlíonadh i gcomhar agus i gcomhphártí le grupaí pobail, scoileanna agus pobal na nealaíon ach go háirithe.

Goals and Actions listed as follows form the core of this Plan. The comprehensive public consultation process has been central in informing these goals. Feedback from the consultation process and further research indicates that the major areas of interest and concern are: Arts Centres, Information, Funding, Partnerships, Education, Infrastructure and Policies, Professional Arts and Access to the Arts. Each theme identified has relevant actions to facilitate the implementation.

In endeavouring to achieve the individual goals set, it will be essential that the Council work in collaboration with the following; the Arts Council, the Department of Arts, Sport and Tourism, the Department of Education and Science, the Department of Environment, Heritage and Local Government and also the Co. Dublin VEC. Aside from the formal State Agencies, the delivery of the actions in the Plan will be done in conjunction and partnership with local community groups, schools and the arts community in particular.

- 4 Explore opportunities in partnership with public/private arts organisations, to publicise arts activity in Fingal.

## Goal 2 Access and Information

**To provide Fingal residents with opportunities to interact and engage with the best of contemporary and traditional arts practice within their local communities.**

### Actions

- 1 Continue to enhance the Council's Municipal Arts Collection.
- 2 Develop an archive of the existing and future collections.
- 3 Provide technical training to enable staff of the Arts Office to develop an archive for the traditional arts.
- 4 Record, edit and produce DVD-standard recording of all significant traditional arts figures in Fingal.
- 5 Work in partnership to identify emerging multi-cultural events and projects, exploring the diversity and similarities between cultures through the medium of arts practice.
- 6 Provide assistance and support to those programming quality traditional events.
- 7 Access funds through *Deis*, the Arts Council's funding scheme for the traditional arts.
- 8 Identify all opportunities for additional funding in support of the traditional arts.
- 9 Develop a Public Sculpture Trail in Fingal.

- 7 Develop a model of support between Youth and Community Centres.
- 8 Develop further international links.

### Goal 4 Education

To extend and develop the range of outreach and education projects to schools and the local community and to develop new innovative pilot projects.

Actions

- 1 Advocate the use of professional artists in schools, in order to enhance, broaden and complement school curricula.
- 2 Create and develop models of good practice that provide quality arts experience for people of all ages and encourage life long learning.
- 3 Enhance and develop the scope, range and quality of Artist-in-School programmes.
- 4 Design and implement new and innovative, long-term education pilot programmes, in partnership with schools, professional artists and relevant State Agencies.
- 5 Monitor and evaluate all educational programmes.
- 6 Develop an amateur art training programme.

- 1 Develop new models for multi-functional venues in Fingal, which provide adequately for arts activities and cultural needs.
- 2 Establish a Public Art Selection and Acquisition Panel.
- 3 Establish a professional artist's panel for Public Arts commissions.
- 4 Establish a policy toward commissioning, through the *Per Cent for Art Scheme*, in line with the National Guidelines.
- 5 Develop a Youth Arts Policy.
- 6 Undertake a feasibility study for an annual countywide Arts Festival.

## Goal 6 Arts Centres

**Actively encourage access and participation in the arts through the direct funding and continued development of Draíocht and the Séamus Ennis Cultural Centre.**

### Actions

- 1 Maximise all opportunities to develop and enhance the infrastructure of the two Centres.
- 2 Provide a safe and positive environment for young people to learn and participate in cultural activity.
- 3 Ensure that both venues are recognised as centres of excellence for the Arts, and offer a 'quality experience' to audiences and participants.
- 4 Cultivate a child-friendly ethos at Draíocht.
- 5 Develop an international element/profile to the work of the Séamus Ennis Cultural Centre and Draíocht.
- 6 Generate new audiences for the arts through outreach and education programmes.
- 7 Identify new sources of funding for both Arts Centres and develop a multi-annual funding relationship with the Arts Council.

- 1 Continue to offer funding under Section 6 of the 2003 Arts Act.
- 2 Develop events to enable professional artists to showcase their work.
- 3 Purchase works of art from artists to develop the Municipal Arts Collection.
- 4 Endeavour to make provision for professional artist studio space in Fingal.
- 5 Investigate sustainable artists housing through public private partnership.
- 6 Establish, on an annual basis, professional development training workshops, in order to address the professional practice needs of artists working in the sector.
- 7 Develop sustainable partnerships between Fingal County Council and the Arts Council of Ireland and others, to strengthen the professional arts community in Fingal.

## Goal 8 Support and Funding

**Stimulate and support local arts activity through provision of practical support and funding.**

Actions

- 1 Produce a statement of guidelines, criteria and clear application procedures for funding.
- 2 Disseminate information on the new criteria for funding.
- 3 Continue to offer funding and support to Arts events, under Section 6 of the 2003 Arts Act.
- 4 Raise awareness of events funded by Fingal County Council through increased branding and focused communications.
- 5 Re-evaluate Fingal County Council's funding relationship with each festival committee, and explore the idea of three-year funding for festivals, to allow for medium and long term planning.
- 6 Support developmental costs and audience research.
- 7 Develop a framework to promote the active participation in the arts and arts events funding, in partnership with business interests.

Aireofar sa chlár bliantúil na bearta a bheidh i gceist don phobal don Chultúr agus don chlár spóirt.

Déanfar measúnú ar Phlean Ealaón Fhine Gall mar seo a leanas:

- Cuirfear tuairisc bhliantúil faoi bhráid Stiúrthóir Roinn Seirbhísí Caiteamh Aimsire agus conláistí Pobail, Léiríodh an tuairisc forbairt na bliana agus nithe práinneacha a bheidh le déanamh. Molfaidh an tuairisc leasaithe agus agusíní is gá sa Phlean.
- Beidh an Oifig Ealaón ag cothú dlúth-nascanna le healaíontóirí agus le heagraíochtaí i bhFhine Gall a chuirfidh le fíorú an Phlein.
- Beartóidh moltaí an Phlein sa pleán oibre bliantúil Pobail, Cultúr agus Spóirt.
- Beidh luach ar airgead i gceist sa Phlein.
- Rachfar i gcomhairle le Coiste Cuimsitheach monatóireachta Sóisialta agus an Plean á chur i ngníomh chun deimhin a dhéanamh de go n-áireofar fíor riachtanais an dreama uaigneach imeallach sa phobal.

**Cur i gcrích**

Scrúdófar an pleán ag coiste S.I.M.S. Fhine Gall agus díreofar ar mholtaí um leasaithe. Beidh Cumarsáid Idir-riarach riachtanach chun an Plean a chur i ngníomh d'fhonn malartú eolais agus d'fhonn monatóireacht a dhéanamh ar thorbairt agus ar dhul chun cinn.

**Monitoring, Evaluation and Review**

It is essential that the Fingal Arts Plan 2006–2010 be monitored and reviewed on a regular basis. Ideally, it should be open to constructive criticism and amendment in order to ensure that it continues to accord with the values of Fingal County Council. The Plan should also aspire to meet with the wishes of the people of Fingal, whether they have a strong or passive involvement and interest in the arts. The Plan retains a degree of flexibility in order to respond to changing circumstances, new initiatives and ongoing feedback from interested parties engaged in arts participation.

The detail of the delivery on the Goals contained in the Plan and the Actions set will be embodied in the Community, Culture and Sports Division's annual Work Programme.

The Fingal Arts Plan will be evaluated in the following ways:

- A report will be submitted to the Director of Services of the Community Recreation and Amenities Department on an annual basis. The report will outline progress during the year and set priorities. The report will also recommend amendments and additions to the Plan.
- The Arts Office will continue to develop strong links with individuals and arts organisations in Fingal, whose input into the implementation of the Plan will be sought.
- The recommendations of the Plan will determine the annual Work Plan for the Community, Culture and Sports Division.
- The principles of 'value for money' will be applied to the implementation of the Plan.
- The Social Inclusion Monitoring Committee (SIMS) will be consulted during the implementation of this Plan in order to ensure that particular regard is paid to the needs of the more excluded and marginalised members of the community.

**Implementation**

The plan will be scrutinised by the Fingal S.I.M.S. Committee and any recommendations for amendments will be taken into account. Inter-Departmental contacts will be vital to ensure the implementation of the Plan and a mechanism to ensure regular exchanges of information and monitoring of progress will be developed.
