NOTICE OF PROPOSED DEVELOPMENT. PLANNING & DEVELOPMENT ACT 2000 (AS AMENDED) PART 8 OF THE PLANNING AND DEVELOPMENT REGULATIONS 2001 (AS AMENDED)

Proposed development of 11 apartments including associated site works at Rathbeale Road, Swords, Co Dublin.

In accordance with Part XI of the Planning and Development Act 2000 (as amended) and Part 8 of the Planning and Development Regulations 2001 (as amended), Fingal County Council hereby gives notice of the **proposed works** to be carried out at the above site:

- · Removal of existing depot buildings and site enclosure.
- Construction of building comprising 11 apartments.
- Provision of parking for 14 vehicles and storage for 20 bicycles.
- All associated site development works including access road, footways, site boundaries, external amenity space, communal bin storage, drainage, external lighting, utilities and services.

The mix of dwellings includes:

- · 4 no. one bedroom two person apartments
- 2 no. two bedroom three person apartments
- 2 no. two bedroom four person apartments
- 3 no. three bedroom five person apartments.

Submissions or observations must be made on, or before **5pm on Wednesday 27th November 2019**.

In accordance with Articles 81 and 120 of the Planning & Development Regulations 2001 (as amended), Fingal County Council has concluded from a preliminary examination that no significant effects on the environment are likely as a result of the proposed development and that an Environmental Impact Assessment is not required.

Any person may, within 4 weeks from the date of this notice, apply in accordance with the provisions of article 120 of the Planning and Development Regulations 2001 (as amended) to An Bord Pleanála for a screening determination as to whether the development would be likely to have significant effects on the environment.

Issues raised in submissions and observations to the Council in regard to this development, including the response of the Chief Executive thereto, will form part of the statutory report to be presented to the monthly meeting of Fingal County Council.

The statutory report will also list the persons or bodies who made submissions or observations with respect to the proposed development in accordance with regulations made under Part XI of the Planning and Development Act as amended.

The minutes of that meeting including the statutory report will appear on the Council's Website.
