RE: ANCA_F19A/0449_RF01 (Planning Register No. F19A/0449) APPLICATION FOR PLANNING PERMISSION FOR A CHANGE OF USE TO PROVIDE FOR AN INCREASED COMBINED PASSENGER CAPACITY FOR ALL PASSENGER BUILDINGS FROM 32 MILLION PASSENGERS PER ANNUM (MPPA) TO 35 MPPA (OF WHICH 3 MPPA WILL BE CONNECTING PASSENGERS) IN THE TOWNLANDS OF CORBALLIS AND COLLINSTOWN, AT DUBLIN AIRPORT, CO. DUBLIN.

Tom Phillips + Associates ('TPA'; Planning Consultants), has been retained by daa plc as part of an Arup led team, (Arup; Consulting Engineers); to apply to Fingal County Council ('FCC') for planning permission for a proposed change of use to provide for an increased combined passenger capacity for all passenger buildings from 32 million passengers per annum (mppa) to 35 mppa (of which 3 mppa will be connecting passengers). These proposed capacities would apply to all passenger buildings and not just Terminal 1 and Terminal 2 as is currently the case. There are no works proposed as part of this application.

Further to your letter dated 19th December 2019 (addressed to daa and copied to TPA), we note the contents of your letter and the stated request for information under Section 9 (10) of the 2019 Act, which provides that ANCA, may for the purposes of an assessment of the noise situation at the airport, direct the applicant to provide ANCA with such information as ANCA may reasonably require.

Having regard to the extensive nature of the assessments and determinations requested, it is not possible to prepare the information required by the date you have requested. We therefore request that additional time be granted by ANCA in order to prepare and collate the information requested.
