

As Mayor of Fingal County Council, I am delighted to introduce our new Fingal Arts Plan 2019 – 2025. This seven-year programme builds on all that we have achieved since the county – and the Arts Office – were established in 1994. It also responds with ambition and an invigorating sense of purpose to the challenges and opportunities of our county as the fastest growing and one of the youngest and most diverse in Ireland.

With the Fingal population expected to rise to 330,000 by 2021,<sup>1</sup> it is more important than ever that we cultivate the arts and ensure their place in the lives of all our citizens. By doing so, we can create a strong, vibrant, confident community and a county that people want to live and work in, or to visit. That's why, over the course of this plan, we will invest €30 million in the development of the Swords Cultural Quarter. As an elected official and citizen, I am proud of the arts service we deliver for our citizens and I am excited about the future as set out in this plan. I look forward to working with my colleagues in the Council to make it happen and to ensure the arts for everyone in our great county.

I mo cháil mar Mhéara Chomhairle Contae Fhine Gall, tá ríméad orm ár bPlean Ealaíona Fhine Gall 2019 – 2025 a chur i láthair. Cuireann an clár seacht mbliana seo le gach atá bainte amach agaínn ó bunaíodh an contae – agus Oifig na nEalaíon – in 1994. Freagraíonn sé freisin le huaillmhian agus feidhm spreagúil ar dhúshláin agus deiseanna ár gcontae mar cheann de na contaetha is mó a bhfuil borradh fúithi agus ceann de na contaetha is óige agus is éagsúla in Éirinn.

Táthar ag súil go dtiocfaidh méadú ar dhaonra Fhine Gall go 330,000 faoi 2021, agus mar sin, tá sé níos tábhachtú anois ná riagh go ndéanfaimid na healaíona a chothú agus a n-áit a chinntí i saol ár saoránach uile. Ar an gcaoi sin, is féidir linn pobal láidir, bríomhar, muiníneach a chruthú, chomh maith le contae ina dteastaíonn ó dhaoine bheith ag maireachtáil agus ag obair, nó teacht ar chuairt chuige. Is ar an gcúis sin, le linn thréimhse an phlean seo, go ndéanfaimid €30 milliún a infheistiú chun Ceathrú Cultúrtha Shoard a fhorbairt. Mar chuid den tionscnamh bunathraitheach seo, cuirfear leabharlann úrscothach ann, chomh maith le hionad ealaíon ina bhfuil amharclann, spásanna cleachtaidh agus spásanna ilúsáide, agus déanfar an timpeallacht sheachtrach a bheochan freisin.

Mar oifigeach tofa agus saoránach, táim bródúil as an tseirbhís ealaíon a chuirimid ar fáil d'ár saoránaigh agus táim ar bús faoin todhchaí mar atá sé leagtha amach sa phlean seo. Táim ag súil le bheith ag obair le mo chomhghleacaithe sa Chomhairle chun an plean a chur i ngníomh agus chun na healaíon a chinntí do chách inár gcontae iontach.

There are number of features that define Fingal as a county. For some, it is our size, as the third most populous local authority area in the country, or our youthfulness, with 30% of our citizens under 18. For others, it is the diversity of that population, which is fast-growing and continuing to change. Our location and landscape, bordered by land and sea, at once coastal, rural, urban and suburban, is notable. This situation gives us the distinction of being home to key elements of national and regional infrastructure, including Dublin Airport, which drives much of our economic advantage. Obviously, we are defined by the communities we serve, with areas of Swords, Donabate, Skerries, Balbriggan, Blanchardstown, Howth and Malahide being established centres that can trace their roots back hundreds of years, and emerging locales such as Castleland and Tyrellstown, which are rooting themselves for the future. As a county, we may also be defined by our culture: the complex whole of beliefs, values and norms which have created a county that is confident, ambitious, progressive and community-focused.

As we are on the cusp of celebrating 25 years of an arts service in Fingal, I can say with certainty that the arts have played a critical role in shaping the culture of our county and, moreover, have become another of our defining features. Fingal is recognised for its commitment to the arts and close support of artists, professional and amateur alike, and for the quality and imagination of its art and arts provision, reaching across people, place and practice.

Of course, our work is not yet done. This plan builds on all that we in Fingal County Council have achieved to date and encompasses new ambitions and opportunities such as the landmark development of the Swords Cultural Quarter and the Balbriggan Socio Economic Strategy. This investment is evidence, if any is needed, of our commitment to the arts and of our understanding of the powerful and empowering role that the arts can play in a community. →

Is ann do roinnt gnéithe ar leith a shainmhíníonn Fine Gall mar chontae. Ceapann roinnt daoine gurb é méid Fhine Gall an rud is suntasaí faoi ós rud é gurb é an tríú údarás áitiúil is mó sa tír; agus tá daoine eile den tuairim gurb é aois a shaoránach an rud is suntasaí agus 30% dá shaoránaigh faoi bhun 18 mbliána d'aois. Ceapann daoine eile gurb é éagsúlacht a dhaonra an ghné is suntasaí a bhaineann leis agus an daonra sin ag fás go mear agus ag síorathrú. Is díol suntais é an áit a bhuilimid lonnaithe agus ár dtírdhreach, muir agus thír araon taobh linn, agus Fine Gall ina cheantar cois cósta, ceantar tuithe, ceantar uirbeach agus ceantar fo-uirbeach go léir ag an am céanna. Leis sin, tá roinnt príomhgħnēithe den bhonneagar náisiúnta agus réigiúnach lonnaithe i bhFine Gall, lena n-áirítar Aerfort Bhaile Átha Cliath a spreagann an chuid is mó dár mbuntáiste eacnamaóch.

Gan aon dabht, is rud ar leith ar fad iad pobail Fhine Gall, cuid díobh amhail Sórd, Domhnach Bat, na Sceirí, Baile Brigín, Baile Blainséir, Binn Éadair agus Mullach Íde ina n-ionaid sheanbhunaithe a mbaineann stair fhada leo; agus pobail eile amhail Fearann an Chaisleáin agus Baile an Tírialáigh atá á mbunú féin anois le haghaidh na mblianta fada atá romhainn amach. Mar chontae, seans gur rud ar leith freisin ár gcultúr: na creidimh, na luachanna agus na noirm chasta atá tar éis contae muiníneach, uaillmhanach, forásach atá dírithe ar an bpobal a chruthú.

Agus muid anois ar tí 25 bliain de sheirbhís ealaón i bhFine Gall a cheiliúradh, is féidir liom a rá gan aon dabht go raibh ról ríthábhachtach ag na healaíona maidir le cultúr ár gcontae a mhúnlú agus, ar a bharr sin, is saintréith eile d'Fhine Gall iad na healaíona. Aithnítear Fine Gall as a thiomantas do na healaíona agus as an dlúth-thacaócht a thugann sé d'ealaontóirí, idir ealaontóirí gairmiúla agus ealaontóirí amaitéaracha araon, agus as cáilfócht agus samhláocht a chuid ealaíne agus soláthair ealaíne, agus an bealach a nascann an tiomantas sin daóine, áit agus cleachtadh.

Ach níl ár gcuid déanta fós againn dar ndóigh! Cuireann an pleán seo le gach atá bainte amach againn go dtí seo i bhFine Gall agus cuimsítear ann uaillmhianta agus deiseanna nua amhail an fhorbairt shuntasach ar Cheathrú Cultúrtha Shoird agus Straitéis Shoch-eacnamaóch Bhaile Brigín. Is fianaise é an infheistiú seo, más gá fianaise a léiriú, ar ár dtiomantas do na healaíona agus ar ár dtuiscint den ról cumhachtach spreagúil atá ag na healaíona i bpobal ar bith. →

### Rory O'Byrne, Oifigeach Ealaón an Chontae

The Arts Office of Fingal County Council operates within the Community, Culture & Sports Department; its primary function is the promotion and development of the arts in Fingal. It does this through a series of initiatives and incentives, including providing financial and educational supports to artists, arts organisations and audiences, and through the work of its two arts centres, Draíocht and the Séamus Ennis Arts Centre. As the primary advocate of the arts within the Council, the Arts Office also provides advice to the Chief Executive and elected members of Fingal County Council on cultural matters, cultural planning, and strategy.

The arts service dates back to before the establishment of Fingal County Council on 1 January 1994, as a result of the division of the administrative county of Dublin under the Local Government (Dublin) Act, 1993. Previously, there had been a light-touch arts service through the distribution of arts grants under the 1973 Arts Act by the Council's predecessor, Dublin County Council.

The creation of the role of County Arts Officer in 1994 signalled a new era for arts development at local government level, going from a situation of six local authority Arts Officers in 1994, to the current situation, where there are Arts Officers and staff in 31 local authorities in the State.

Fingal County Councils' arts service has evolved over the last 25 years and has always sought to respond to the needs of one of the most rapidly changing counties in Ireland. In 2005, the Council created three key posts – Deputy Arts Officer, Youth & Education Officer, and Public Art Officer. In hindsight, the establishment of these three posts can be seen as game-changers. These appointments provided the Arts Office with direction informed by priority policy areas.

Fingal's inaugural Arts Plan 2006–2010 was written in-house and presented a framework for the development of a countywide arts service. In 2012, we entered a phase of research and consultation for the development of the second Fingal Arts Plan 2013–2017. Informed by this, Fingal Arts Office committed to expanding its programmes to include several new and compelling initiatives in the area of Artists Supports, Youth & Education, and Public Art. →

Feidhmíonn Oifig Ealaón Chomhairle Contae Fhine Gall laistigh den Rannóg Pobail, Cultúir & Spórt agus é mar phríomhfeidhm aici na healaóna a fhorbairt agus a chur chun cinn i bhFine Gall. Déantar é sin trí shraith tionscnamh agus dreasachtaí, lena n-áirítear tacálocht airgeadais agus oideachais a sholáthar d'ealaontóirí, d'eagraíochtaí agus do phobail ealaón, agus tríd an obair a dhéantar sna dá ionad ealaóna, Draíocht agus Ionad Ealaón Séamus Ennis. Agus í ina príomhthanantóir sa Chomhairle ó thaobh na n-ealaón, soláthraíonn Oifig na nEalaón comhairle do Phríomhfeidhmeannach agus chomhaltaí tofa Chomhairle Contae Fhine Gall maidir le cúrsaí cultúir, pleánáil cultúir, agus straitéis.

Cuireadh túis leis an tseirbhís ealaón roimh bhunú Chomhairle Contae Fhine Gall ar an 1 Eanáir 1994 mar thoradh ar chontae riarcháin Bhaile Átha Cliath a roinnt faoin Acht um Rialtas Áitiúil (Baile Átha Cliath) 1993. Roimhe sin, bhíodh seirbhís éadrom ealaón ann faoi na deontais a thug réamhtheachtaí na Comhairle, Comhairle Cathrach Bhaile Átha Cliath, amach faoin Acht Ealaón 1973.

Le cruthú ról an Oifigigh Ealaón Contae in 1994, cuireadh túis le ré nua ó thaobh na n-ealaón a fhorbairt ag leibhéal an rialtais áitiúil, agus chuamar ó 6 Oifigeach Ealaón de chuid an údarás áitiúil in 1994 go dtí an cás mar atá sé anois agus Oifigigh Ealaón agus foirne i 31 údarás áitiúil ar fud an Stáit.

Tá athrú mór tagtha ar sheirbhís ealaón Chomhairle Contae Fhine Gall le 25 bliain anuas agus d'fhéach an tseirbhís sin i gcónaí le freastal ar riachtanais ceann de na contaetha is mó in Éirinn atá ag athrú go tapa. In 2005, chruthaigh an Chomhairle 3 phost thábhachtacha - Leas-Oifigeach Ealaón, Oifigeach Óige & Oideachais, agus Oifigeach Ealaíne Poiblí. Ar bhearrthnú siar, ba chor cinniúna é bunú na bpost sin. Thug na poist sin treoir d'Oifig na nEalaón maidir le réimsí thírbhachtacha beartais.

Scríobhadh an chéad Phlean Ealaón 2006–2010 de chuid Fhine Gall go hinmheánach agus tugadh creat ann maidir le seirbhís ealaón a fhorbairt ar fud na tíre. In 2012, chuamar isteach i gcéim taighde agus comhairliúcháin maidir leis an dara Plean Ealaón de chuid Fhine Gall, 2013–2017 a fhorbairt. Agus é sin mar bhonn eolas aici, thug Oifig Ealaón Fhine Gall faoi a cláir a leathnú chun roinnt tionscnamh nua agus fíorláidir a áireamh sna réimsí seo a leanas: Tacálochtaí d'Ealaontóirí, Óige & Oideachas, agus Ealaín Phoiblí. →

As we publish this third arts development plan, we reflect on what went before and seek to build on our successes. The two previous plans were artist centred, and engaged with our communities in developing work that was significant locally, nationally and internationally, and which supported artists at all stages of their careers by developing permanent infrastructure and supports through the provision of arts centres, studios, and a variety of spaces for making art.

This eight-year Arts Plan sets out a clear vision and ambition that allows us to strategically plan and look positively to the future. Our primary wish is to grow Fingal’s cultural capacity by retaining and attracting creative practitioners to live and work in Fingal. This will ensure that culture will continue to play a central role in people’s lives and to contribute in a positive way to building an inclusive and vibrant Fingal.

This plan also takes account of recent developments within the context of the arts nationally. The Arts Council’s 10-year strategy, Making Great Art Work, was published in 2016 and the Creative Ireland Programme was established in 2017. The Fingal plan responds to the opportunities within each and we look forward to playing an active role in Creative Ireland Fingal. It also affirms our new partnership arrangement with the Arts Council in the Framework Agreement 2019 – 2025, while sitting in recognition of the Department of Culture Heritage and the Gaeltacht – Culture 2025 & Project 2040.

Closer to home, as a service of Fingal County Council, we were keen to assert how the arts are aligned with, and can contribute to, the goals of the county’s development plan. Most significantly, of course, it allows for the development of the new Swords Cultural Quarter.

The process of developing this plan in many ways embodied our values of curiosity, bravery and integrity. We undertook a robust review of our previous plan, our work and our impact with an external consultant. We created opportunities for all our stakeholders, including school children, to share their considerations of our work to date and to advise on priority areas for the future. The findings from this consultation were discussed at the highest level within the Council and significantly informed our thinking and decision-making in relation to this plan. We would like to thank all who engaged with us in this hugely valuable process.

Over the next seven years, we will focus our efforts by making space for art, connecting people and ideas, enabling excellence, and developing our capacity to deliver this plan optimally. We look forward to it.

Agus an tríú phlean forbartha seo á fhoilsíú againn, déanaimid machnamh ar an méid atá déanta roimhe sin agus féachaimid le cur leis an rath sin. Bhí an dá phlean roimhe seo dírithe ar ealafontóirí agus chuaigh siad i dteaghmáil lenár bpobail ó thaobh obair shuntasach a fhorbairt go háitiúil, go náisiúnta agus go idirnáisiúnta, agus thug siad tacaíocht d’ealaíontóirí ag gach céim dá ngairm trú bhonneagar agus tacaíochtaí buan a fhorbairt le hionaid ealaón, stiúideonna agus réimse spásanna éagsúla inar féidir ealaín a dhéanamh.

Sa Phlean Ealaón 8 mblíana seo, leagtar amach fíos agus uaillmhian soiléir a ligeann dúinn pleanáil straitiseach a dhéanamh agus féachaint ar aghaidh go dearfach chuig an todhchaí. An rud is mó is mian linn ná cumas cultúrtha Fine Gall a fhorbairt trí chleachtóirí cruthaitheacha a choinneáil i bhFine Gall, agus a mhealladh chuig Fine Gall, chun maireachtáil agus obair ann. Leis sin, cinnteofar go bhfanfaidh an cultúr i gcroí lár shaol na ndaoine agus go gcabhraíonn sé ar bhealach dearfach chun Fine Gall ionchuimsitheach agus bríomhar a chothú.

Cuirtear san áireamh sa phlean seo freisin forbártí a tharla le déanaí i gcomhthéacs na n-ealaón go náisiúnta. In 2016, foilsíodh straitéis 10 mblíana de chuid na Comhairle, Making Great Art Work, agus bunaíodh an Clár ‘Éire Chruthaitheach’ in 2017. Freagraíonn pleán Fine Gall ar na deiseanna a luaitear sa dá rud sin agus táimid ag súil le ról gníomhach a bheith againn in Éire Chruthaitheach: Fine Gall. Dearbhátear leis freisin ár gcomhshocrú compháirtfocalta leis an gComhairle Ealaón sa Chreat-Chomhaontú, 2019 – 2025, agus Cultúr 2025 & Tionscadal 2040 de chuid na Roinne Cultúir, Oidhreachta agus Gaeltachta á n-aithint ag an am céanna.

Go háitiúil, mar sheirbhís de chuid Chomhairle Contae Fine Gall, theastaigh uainn béim a chur ar an mbealach atá na healaóna i gcomhréir le spriocanna phlean forbartha an chontae agus conas is féidir leo cur leis na spriocanna sin. Gan dabht, ligeann sé go háirithe do Cheathrú Cultúrtha Shoird a fhorbairt.

Is léiriú é an próiseas trínar forbraíodh an pleán seo ar na luachanna seo againne: fiosracht, muinín agus ionracas. Thugamar faoi athbhreithniú láidir a dhéanamh, i gcomhar le comhairleoir seachtrach, ar ár bpleannanna roimhe seo, ar ár gcuid oibre agus ar ár dtionchar. Chruthaíomar deiseanna d’ár bpáirtithe leasmhara, lena n-áirítear leanaí scoile, chun a dtuairimí a roinnt maidir lenár gcuid oibre go dtí seo agus chun comhairle a thabhairt maidir le réimsí tosaíochta amach anseo. Pléadh tortaí an chomhairliúcháin seo ag an leibhéal is airde laistigh den Chomhairle agus chuir na tortaí sin bonn eolais luachmhar lenár machnamh agus cinnteoireacht maidir leis an bplean seo. Ba mhaith linn buíochas a ghabháil leo siúd go léir a ghlaic páirt sa phróiseas fíorluachmhar seo.

Dá réir sin, sna seacht mblíana atá amach romhainn, díreoirímid ár n-iarrachtaí tri spás a dhéanamh le haghaidh na healaíne, trí dhaoine agus smaoíntí a nascadh, trí shármhaitheas a chumasú agus trínár gcumas a fhorbairt chun an pleán seo a chur i gngíomh ar an mbealach is fearr. Táimid ag súil go mór leis sin go léir.

# Fingal County Council and the Arts: A Bird's Eye View – Martin Drury Comhairle Contae Fhine Gall agus na hEalaíona: An Radharc ón Spéir – Martin Drury

A bird flies over Fingal. A bird like that in the graphic identity of the County Council. It flies over beach and field, lane and motorway, pier and airport, village and town centre. The bird sees that all the blue and green and grey it flies over is connected by a tissue of roads and larger arteries that merge and separate, circle and disperse, moving people and goods through the county: a county of 448 square kilometres and 296,000 people; a county that is very ancient and yet, administratively, established just 25 years ago.

Browsing the website of Fingal County Council is like gliding over the county as that bird. Swooping virtually, hovering occasionally, getting a bird's eye view of the myriad roles and responsibilities of the county's local authority: 'Planning and Buildings', 'Business and Economy', 'Community and Leisure', 'Water and Drainage', 'Roads and Travel', 'Environment' and 'Housing'.

Picture that bird landing for a while and tapping its beak against 'Community and Leisure'. A few clicks in, it would unearth this cluster of statements:

Our greatest resource is our people. Fingal has the third biggest, fastest growing and youngest population in Ireland. The vibrancy and diversity of our culture is one of our greatest assets.<sup>2</sup>

This might seem like a high-flown declaration, not grounded in reality. But the evidence is otherwise.

Fingal County Council was established in 1994 and in the same year it employed an Arts Officer. It was an early signal of intent. Twenty-five years later, the Arts Office – a small, steadfast unit of dedicated, skilled professionals within the Community, Culture & Sports Department – has developed and published what is its third Arts Plan, covering the period 2019 – 2025. The plan's governing purpose is simply and eloquently expressed as 'to bring art to life in Fingal and Fingal to life through art'. →

Eitlíonn éan os cionn Fhine Gall. Éan mar sin in aitheantas grafach na Comhairle Contae. Eitlíonn sé os cionn trá agus goirt, lána agus mótarbhealaigh, cé agus aerfoirt, sráidbhaile agus lár baile mhóir. Feiceann an t-éan go bhfuil an gorm, an glas agus an liath go léir atá thíos faoi naschta ag fiochán bóithre agus artairí móra a thagann le chéile agus a dheighleann óna chéile arís, a chiorcláonn agus a scaipeann, bóithre a bhogann daoine agus earraí ar fud an chontae; contae atá 448 ciliméadar cearnach agus 296,000 duine; contae fíor-ársa ach fós, ó thaobh riarrachán de, nár bunaíodh ach 25 bliana ó shin é.

Agus brabhsáil á dhéanamh ar shuíomh gréasáin Chomhairle Contae Fhine Gall, is amhlaidh go bhfuil faoileitilt á dhéanamh os cionn an chontae ar nós an éin sin. Agus ruathair fíorúla á ndéanamh, ag faoileáil anois is arís, is féidir radharc ón spéir a fháil ar an iliomad ról agus freagrachtaí atá ag údarás áitiúil an chontae: 'Pleanáil agus Foirgnimh', 'Gní agus Eacnamaíocht', 'Pobal agus Fóillíocht', 'Uisce agus Draenáil', 'Bóithre agus Taistéal', 'Comhshaol' agus 'Tithíocht'.

Samhlaigh an t-éan sin ag teacht anuas ar feadh tamaillín agus a ghob a chnagadh i gcoinne 'Pobal agus Fóillíocht'. I ndiaidh cúpla cnag, thiocfadh sé ar an gcuasach ráiteas seo:

Is iad na daoine an acmhainn is mó atá ag Fine Gall – Tá an daonra is tapúla fás agus is óige agus an tríú daonra is mó in Éirinn aige. Tá beogacht agus ilchineálachas ár gcultúir ar cheann dár sócmhainní is tábhacthaí.<sup>2</sup>

Fiche cúig bliain ina dhiaidh sin, tá Oifig na nEalaón – aonad beag, daingean de ghairmithe tiomanta oillte laistigh den Rannóg Pobail, Cultúir agus Spórt – tar éis an-fhorbairt a dhéanamh agus a tríú Phlean Ealaíona foilsithe aici, maidir leis an tréimhse 2019 – 2025. Cuirtear feidhm rialála an phlean in iúl go simplí agus go deisbhéalach – 'beocht a chur san ealaín i bhFine Gall agus beocht a chur i bhFine Gall tríd an ealaín'. →

Ón mór 'Olár Fhine Gall Ildánach' ar shuíomh gréasáin Chomhairle Contae Fhine Gall.

That phrase, too, might be dismissed as a rhetorical flourish, were it not for the demonstrable achievements since 1994: the physical infrastructure of public arts venues and of studios for artists; the highly-regarded and innovative public art programme;<sup>3</sup> the range of supports and services for artists and arts organisations in the county; the endorsement and resourcing of amateur and community arts practice; the sustained commitment to children and young people; the programme of festivals and events that provide public access to high-quality arts and cultural experiences.

It is no accident that the words ‘public’, ‘people’, ‘community’ recur so often in this list of achievements. The focus on people derives from a set of public service values that have remained consistent since the inception of the arts service. But the democratic imperative derives also from the remarkable fact that in that same quarter-century the population of Fingal has increased by about 80% to its present level of just under 300,000 people. The emblematic bird flying over Fingal has seen extraordinary change in the county since 1994.

As important as the growth in its size are the exceptional cultural diversity and the very young age profile, which are key features of the county’s population. When such demographic transformation is allied to changes in technology (affecting production, presentation and public engagement in the arts), cultural planning needs to be flexible and responsive. It is good therefore to note the commitment of Fingal Arts Office in Goal Four of this plan to develop its own ‘ability, agility and resilience’.

Throughout the plan can be found another conviction critical to its successful realisation. This is referenced variously as ‘brokering partnerships, collaborations and connections’ (in the Mission Statement) and as ‘connecting people and ideas’ (in the Strategic Goals) and – as an envisaged outcome of the plan – ‘the Arts Office will be recognised and utilised as an integral service of the Council’. Therein lies an exacting challenge: how, by its intra-organisational behaviours and actions, can Fingal County Council progress its own plan ‘to bring art to life in Fingal and Fingal to life through art?’ The question mark confirms that the question is not rhetorical; the answer needs to be embedded in the work programme deriving from this plan, and ideally not just the work programme of the Arts Office.

Is éasca freisin beag is fiú a dhéanamh den ráiteas sin mar cheist reitriúil go dtí go leagtar amach na héacaití móra ón mbliaín 1994 go dtí an lá atá inniu ann: bonneagar fisiciúil na n-ionad ealaíne poiblí agus stiúideonna le haghaidh ealaíontóirí; an clár ealaíne poiblí nuálach a bhfuil meas mór air;<sup>3</sup> an réimse tacaíochtaí agus seirbhísí le haghaidh ealaíontóirí agus eagraíochtaí ealaíne sa chontae; an faomhadh agus na hacmhainní a tugadh do chleachtais ealaíon amaiteáracha agus pobail; an tiomantas leanúnach do leanaí agus daoine óga; na féilte agus imeachtaí uile a thugann deis rochtana don phobal ar eispéiris ealaíon agus cultúrtha atá ar ardchaighdeán.

Ní haon dearmad é go luaitear na focail ‘pobal’ agus ‘daoine’ chomh minic sin sa liosta éachtaí thuasluaithe. Tagann an fócas ar dhaoine ó shraith luachanna seirbhise poiblí nár athraigh ó thíos na seirbhise ealaíon. Ach baineann an riachtanas daonlathach sin freisin leis an méadú mór thart ar 80% a tháinig ar dhaonra Fhine Gall sa 25 bliain sin go dtí an leibhéal reatha, nach mór 300,000 duine. Is mór an t-athrú ó 1994 atá feicthe ag an éan léiritheach sin ag eitilt os cionn Fhine Gall.

Díreach chomh tábhachtach leis an méadú ó thaobh daonra de, tá an éagsúlacht chultúrtha shuntasach agus aoisphróifíl an-óg na ndaoine ina phríomhghné eile de dhaonra an chontae. Nuair a baineann cloachlú déimeagrafach mar sin le hathruithe teicneolaíochta (rud a imríonn tionchar ar líríú, cur i láthair agus rannpháirtíocht an phobail sna healaíona), is gá go mbíonn an phleanáil chultúrtha solúbtha agus sofrehagrúil. Is díol suntais freisin tiomantas Oifig Ealaíon Fhine Gall do Sprioc 4 den phlean seo chun a ‘cumas, eifeachtúlacht agus athléimneacht’ féin a fhorbairt.

Tá prionsabal eile sa phlean atá ríthábhachtach dá bhaint amach. Tugtar ‘compháirtíochtáí, comhoibriú agus naisc a chothú’ (sa Ráiteas Misean) agus ‘daóine agus smaointí a nascadh’ (sna Cuspóirí Straitéisearcha) agus – mar thoradh beartaíthe – ‘aithneofar Oifig na nEalaíón i gcónai agus úsáidfear í mar sheirbhís lárnach de chuid na Comhairle’. Is ansin atá an dúshlán mór: conas, trí a iompair agus gníomhaíochtaí laistigh den eagraíocht, is féidir le Comhairle Contae Fhine Gall a phlean féin a chur ar aghaidh chun ‘beocht a chur san ealaín i bhFhine Gall agus beocht a chur i bhFhine Gall tríd an ealaín?’ Dearbháitear leis an gcomhartha ceiste nach ceist reitriúil í; is gá an freagra a dhaingniú sa chlár oibre a thagann ón bplean seo, agus ní hamháin ó chlár oibre oifig na n-ealaíon go hidéalach.

Foilsítear Plean Ealaíon Fhine Gall ag túis tréimhse a bhfuil gealladh faoi i ndáil le healaíona agus cultúr na hÉireann a fhorbairt. Tá fianaise ann ar lucht déanta beartais ag díriú isteach ar rannpháirtíocht an phobail; ar acmhainní breise á dtabhairt do chleachtais ealaíon agus gníomhaíochtaí cultúrtha atá níos leithne ná na cinn seánbhunaithe; agus go ndéantar an cultúr a chomhtháthú i gcláir oibre ranna rialtais go náisiúnta agus i stíúrthóireachtaí, ranna agus seirbhísí údarásí áitiúla.

The Fingal Arts Plan is published at the start of a period of promise for the development of arts and culture in Ireland. There is evidence of policymakers paying greater attention to public engagement; of increased resources being allocated to arts practices and cultural actions that are wider than the well-established modes; and evidence too of greater integration of culture within the agendas of government departments nationally and within the directorates, departments and services of local authorities.

The long-standing partnership between Fingal County Council and the Arts Council now sits within the wider frame of the 10-year agreement made between the Arts Council, as the national development agency for the arts, and the County and City Management Association (CCMA). Published in 2016 as A Framework for Collaboration,<sup>4</sup> this provides the context for advancing shared agendas, for supporting organisations and programmes of mutual interest, and for identifying and pursuing particular actions where there is benefit in harnessing the particular knowledge and expertise of each partner.

The advent of the ‘all-of-Government’ project Creative Ireland<sup>5</sup> presents Fingal Arts Office and its counterparts nationwide with a significant challenge and set of opportunities. Under Pillar Two of the Creative Ireland Programme, focused on communities, Fingal County Council has published a Culture and Creativity Strategy 2018 – 2022. Its scope is wider than the arts as generally understood. Indeed, it seeks to harness the links between the arts, heritage and libraries and beyond those areas, to explore connections with aspects of enterprise, tourism and technology. A challenge for the Arts Office will be to advocate and provide for the arts as discrete disciplines. Links with other departments of the Council and with other partner agencies will need to be developed in ways that enrich strategic planning, maximise opportunities, and augment resources for the arts as distinct and valued practices. It is important to encourage stakeholders and practitioners out of their silos and into shared fields of action, but that should not be at the cost of securing the harvest of traditions, materials and skills that are held and renewed in those grain stores of contemporary practice in the different art forms. →

Leagtar amach in Making Great Art Work – Arts Council Strategy (2016 – 2025) gur ceann de na cúig phríomhréimse sa straitéis é ‘Pleanáil Spásúil agus Déimeagrafach’, agus deirtear go dtugtar faisnéis thábhachtach sna réimsí sin ‘maidir le gníomhaíochta chomhoibritheach agus infheistíocht chomhroinnt arna déanamh ag páirtithe leasmhara áitiúil a agus náisiúnta’ (lch 34).

Tá an chomhpháirtíocht sheanbhunaithe idir Comhairle Contae Fhine Gall agus an Chomhairle Ealaón suite anois i bhfráma níos leithne an chomhaontaithe 10 mbliana idir an Chomhairle Ealaón ina cáil mar ghrafainnpháirtíocht forbartha náisiúnta na n-ealaón agus an Cumann Bainistíochta Contae agus Cathrach. Foilsithe in 2016 mar Chreat don Chomhpháirtíocht,<sup>4</sup> tugann sé seo an comhthéacs chun clár oibre chomhroinnta a chur chun cinn, chun tacú le heagraíochtaí agus clár leasa choitinn, agus chun gníomhaíochtaí sonracha a shainainn agus a leanúint i gcás go mbaineann buntáiste le heolas agus saineolas sonrach gach comhpháirtíocht a úsáid.

Le teacht an tionscadail chruthaithigh ‘ule-Rialtais’ Éire Chruthaitheach<sup>5</sup>, tugtar dúshlán suntasach agus sráith deiseanna d’Oifig Ealaón Fhine Gall agus a contrapháirtíonna ar fud na tíre. Faoi Cholún 2 den Chlár ‘Éire Chruthaitheach’, atá diríthe ar phobail, tá Comhairle Contae Fhine Gall tar éis Straitéis Chultúir agus Cruthaitheachta 2018 – 2022 a fhoilsíú. Tá scóip níos leithne ag an straitéis sin ná na healaóna mar a thuigtear go ginearálta iad. Gan dabht, féachann sí leis na naisc idir na healaóna, an oidhreacht agus leabharlanna agus go leor eile a úsáid, chun na ceangail le gnéithe den fhionraíocht, den turasóireacht agus den teicneolaíocht a iniúchadh. Beidh sé ina dhúshlán d’ Oifig na nEalaón tathant agus soláthar a dhéanamh do na healaóna mar dhisciplíní scoite. Is gá naisc le ranna eile de chuid na Comhairle agus le gníomhaíochtaí eile comhpháirtithe a fhorbairt ar bhealaí a chuireann go mór le pleannáil straitéiseach, a dhéanann deiseanna a uasmhéadú, agus a mhéadaíonn acmhainní le haghaidh na n-ealaón mar chleachtais luachmhara ar leith. Is tábhachtach páirtithe leasmhara agus cleachtóirí a mhealladh as a stórais aonraithe agus isteach i ngoirt gníomhaíochta chomhroinnta, ach níor cheart go gcuirtear i mbaol tríd sin a dhéanamh na traidisiún, na hábhair agus na scileanna a choinnítear agus a athnuaitear sna stórais aonraithe de chleachtais chomhaimseartha sna foirmeacha ealaíne éagsúla.

Bunaíodh Éire Chruthaitheach in 2017 i ndiaidh rath na gcuimhneachán céad bliain ar Éirí Amach 1916 ach i ndairíre, admhaíodh i mí na Samhna 2016 go raibh teipthe ag Éire oifigiúil ar na healaóna agus ba as sin a thíainig an smaoineamh.<sup>6</sup> Trí iarraidh ar na hearnálacha ealaóna agus ar sheirbhísí cultúrtha údaráis áitiúla gnéithe suntasacha den chlár Éire Chruthaitheach a sholáthar, is tábhachtach a ithint go bhfuil gá le bonneagar eagraíochtaí na n-ealaón – agus é aitheanta nár tugadh go leor acmhainní do na hearnálacha sin, go mór mór le linn an chúlaithe eacnamaíocha – a neartú ionas gur féidir leo gníomhaíochtaí cultúrtha tábhachtacha agus inbhuanaithe a fhorbairt agus níos mó a chur ar fáil ná roghchlár de gníomhaíochtaí cultúrtha. →

Creative Ireland was born in 2017 out of the success of the centenary commemorations of the 1916 Rising but it was conceived out of the earlier recognition, articulated in November 2016, that in many ways official Ireland had failed the arts.<sup>6</sup> In asking the arts sector and local authority cultural services to deliver significant dimensions of the Creative Ireland Programme, it is important to recognise that the organisational infrastructure of the arts – acknowledged as under-resourced and further diminished during the decade of recession – now needs to be strengthened, so that it can develop meaningful and sustainable cultural actions and not merely provide a menu of cultural activities.

Local government has been largely responsible for infusing cultural policymaking in Ireland with an understanding of the importance of spatial and demographic planning. The presence of that agenda within the current 10-year strategy of the Arts Council is testament to this.<sup>7</sup> Fingal is already a case study in the alignment of spatial and cultural planning and the period of this plan will see this enacted as Swords Cultural Quarter, as advanced per the County Development Plan.<sup>8</sup> This project will pose a challenge in terms of achieving a set of balances between the requirements of Swords and those of the wider county; the focus on the Cultural Centre and the wider lens of the Cultural Quarter; and the resource needs of physical infrastructure and those of developmental programmes involving the public and creative practitioners.<sup>9</sup>

This Arts Plan, like its predecessors, will sit within the County Development Plan referenced above, which itself sits within wider national strategies such as Project Ireland 2040: The National Planning Framework.<sup>10</sup> The connections and relationships are at once exciting and demanding: Arts within Culture; Culture within Creativity; Creativity within Community; Community within County; County within Ireland. Taking a perspective on these, and knowing how to navigate them to the benefit of those who live and work in Fingal, or who visit it, requires the Arts Office to take a bird's eye view: sometimes flying high for oversight and sometimes landing for well-grounded insight.■MD

Tá rialtas áitiúil freagrach ar an iomlán as tuiscint ar an bpleanál spásúil agus déimeagrafach a fhí isteach sa cheapadh beartais cultúrtha in Éirinn. Is fianaise air sin gur cuimsiodh an clár oibre sin i straitéis 10 mbliana reatha na Comhairle Ealaón.<sup>7</sup> Is cás-staidéar cheana féin é Fine Gall maidir le hailíniú na pleanála spásúil agus na pleanála cultúrtha agus i rith shaolré an phlean seo, cuirfear é sin i gníomh le forbairt Cheathrú Cultúrtha Shoird, de réir mar a cuireadh chun cinn é i bPlean Forbartha an Chontae.<sup>8</sup> Bainfidh dúshlán leis an tionscadal seo ó thaobh cothromáiocht a bhaint amach idir riachtanais Shoird agus riachtanais an chontae go ginéarálta; an fócas ar an Ionad Cultúr agus an fócas níos leithne ar an gCeathrú Cultúrtha; agus riachtanais acmhainní an bhonneagair fhisiciúil agus riachtanais acmhainní clár forbartha ina bhfuil an pobal agus cleachtóirí cruthaitheacha rannpháirteach.<sup>9</sup>

Suíonn an Plean Ealaón seo, mar a shuigh na pleananna roimhe sin, laistigh de Phlean Forbartha an Chontae thusluaité, pleán a shuíonn é féin laistigh de straitéisí náisiúnta níos leithne, amhail Tionscadal Éire 2040: An Creat Náisiúnta Pleanála<sup>10</sup>. Is naisc agus caidrimh iontach, agus éilitheach freisin iad, ag an am céanna: na hEalaóna laistigh de Chultúr; an Cultúr laistigh den Chruthaitheacht; an Chruthaitheacht laistigh den Phobal; an Pobal laistigh den Chontae; agus an Contae laistigh d'Éirinn. Chun a bheith in ann tuairim á glacadh maidir leo sin agus a bheith ar an eolas maidir le conas gabháil timpeall orthu chun leasa na ndaoine atá ag maireachtáil agus ag obair i bhFine Gall, nó daoine a thagann ar cuairt chuige, is gá go bhfaigheann Oifig na nEalaón radharc ón spéir; ag eiltíl go hard os cionn na háite uaireanta chun forléargas a fháil agus ag teacht chun talún uaireanta eile chun léargas dea-fhódaithe a fháil.



Tá cáil ar Fine Gall as ealaíontóirí agus ealaín den scoth.

**Ár gCumas a Phorbairt**  
Tá an t-eolas, na scileanna agus na hacmhainní ag Comhairle Contae Fine Gall agus ag Oifig na hEalaón chun an pleán seo a chur i ngníomh.

**Tá dhá phrionsabail dhaingean** mar bhonn agus mar thaca ag na spriocanna straitéiseacha a ritheann trí gach gné dár gcuid oibre: **tiomantas don tseirbhís phoiblí agus an socrú ar dhaoine, áit agus cleachtas ealaíne a nascadh**. Dá réir sin, féachaimid le muintir uile Fine Gall, is cuma cé hiad nó cá bhfuil siad, a chumasú chun réimse leathan eispéiris ealaíne agus cultúrtha a rochtain. Féachaimid freisin chun éagsúlacht a spreagadh i ndáil le héagsúlacht cleachtais ealaíne agus chun tacú le healaíontóirí ó chúlraí éagsúla.

**Goal 1****Making Space for Art**

**Through investment in infrastructure and in the creation of opportunity, we ensure a place for the arts in people's lives.**

It is our aim to infuse everyday life with arts and culture. Therefore, we want to expand the arts infrastructure that we have in Fingal and progress the arts opportunities that we offer to the public and artists. We want to create new physical spaces dedicated to the arts, to support the ambition of our existing cultural spaces, and to ensure that all who live and work in, or visit, Fingal have the opportunity to access and engage with the arts.

**Objectives**

- To support the development of the Swords Cultural Quarter and the Balbriggan Socio Economic Strategy and build on their visibility and value for the Fingal community.
- To continue to develop and support the ambition of existing cultural spaces in Fingal.
- To identify and enable the development of new creative spaces for people to make or experience art.
- To enable participatory opportunities that help to build, transform or celebrate communities.
- To extend and deepen our programme of work, enabling children and young people to access artistic and cultural experiences.
- To expand and enhance our public art programme and to advance engagement with it.

**Outcomes**

- The Council will have developed the Swords Cultural Quarter, fulfilling an objective of Your Swords: An Emerging City: Strategic Vision 2035. People from the local area and far beyond will be engaged in arts experiences that excite and have meaning for them.
- The county's existing cultural spaces will have advanced in how they reach and engage with the communities they serve.
- There will be new creative spaces, both temporary and permanent, across the county, where artists and the public will be making or participating in art. In achieving this, Fingal will be recognised for enabling new models of creative enterprise, including the development of sustainable creative spaces in underutilised or vacant buildings.

We will have ensured that public art is integral to the Council's Public Realm Strategies and will have inspired enthusiastic engagement with the arts in this context.
- Through our work in the Arts Office, we will have made a significant contribution to the vitality and viability of urban and rural areas and to the aims of social cohesion and individual wellbeing, as outlined in the County Development Plan.

## Goal 2

### Connecting People and Ideas

**People are confidently and imaginatively coming together in and through the arts.**

We believe that when people come together through the arts, great things can happen—knowledge is shared, connections are made, collaborations are formed, and ideas take shape. We want Fingal to be a place where such inspiration happens. We want our county to be a place in which people and ideas meet, confident in our support for innovation and enterprise.

### Objectives

- To review and strengthen the existing partnerships we value and to foster new partnerships at local, national and international level that strengthen our programme, augment our resources, advance our thinking, reach new artists, or engage new audiences.
- To bring together and create connections between those who, whether individuals or organisations, amateurs or professionals, are interested in progressing the arts in Fingal.
- To facilitate information – and knowledge – sharing at a local, national and international level.
- To encourage and explore new ways of engaging with the arts and of creating space for the unexpected.

- We will have discovered new ways for our communities to engage meaningfully with the arts and for artists to engage with our communities.
- We will have contributed to the county's economic success and its appeal as a place in which to live and work, through attracting and retaining creative talent.

We fulfill many roles in the Arts Office as partners, advocates, experts, curators, advisors and brokers, but our main role must be that of enablers, as we create the conditions and the opportunities that allow the arts in Fingal to thrive. We want to encourage individuals and organisations to excel in their thinking and practice, supported by a culture of innovation and risk-taking. We want art and artists of the county to be celebrated here and to be widely known and in demand far beyond.

## Objectives

- To support artists and organisations across the county to develop and produce high-quality work, understanding the diverse ways in which artists work.
- To foster experimentation and risk-taking.
- To support artists and organisations to lead in innovation, collaboration and the development of original work.
- To invest in research to deepen our understanding, improve the quality, and support advocacy of the arts.

Teastaíonn uainn daoine aonair agus eagraíochtaí a spreagadh chun sármhaiteas a bhaint amach ó thaobh smaointeoireachta agus cleachtas de, agus cultúr nuálaíochta agus fiontraíochta mar thacaíocht acu. Teastaíonn uainn go ndéanfar ceiliúradh anseo ar ealaín agus ealaíontóirí an chontae agus go mbeidh clú, cál agus éileamh orthu i bhfad i gcéin.

The ambition of this strategy needs to be supported by a Council and an Arts Office that has ability, agility and resilience, that is equipped to make informed decisions, that leads on best practice, and that is resourced appropriately.

- The Arts Office will have an appropriate complement of officers and administrative support staff with relevant competencies, expertise and experience.
- The Arts Office will schedule a review and adjust activity in support of the delivery of this plan and ensure its continued alignment with the Council’s plans.
- The Arts Office will have the systems and processes in place that best support, track and measure the delivery of this plan.
- There will be greater awareness, understanding and interest in the work of the Arts Office and of its contribution and impact locally and nationally.
- The Arts Office will continue to be recognised and used as an integral service of the Council.
- Understanding the cultural, social, economic and environmental impacts of the work of the Arts Office will have leveraged additional support for its programmes.
- The activities of the Arts Office will have benefitted from, or contributed to, key local and national strategies. It will have been a key delivery partner for Creative Ireland locally.
- The Arts Office will have embedded research, evaluation and reflection into its working practice and also facilitated others to do so.

- A chinntí go ndéantar an pleán seo a fhorbairt mar fhreagairt ar phríomhstraitéisí áitiúla agus náisiúnta, amhail Plean Forbartha na Comhairle, an Creat Náisiúnta Pleanála agus Éire Chruthaitheach.

## Torthaí

- Beidh foireann iomchuí oifigeach agus pearsanta tacaíochta riarracháin ag ofig na nEalaón agus na hinníulachtaí, saineolas agus taithí ábhartha acu go léir.
- Déanfaidh Oifig na nEalaón athbhreithniú a sceidealú agus a gníomhaíochtaí a choigeartú de réir mar is cùí chun an pleán seo a chur chun feidhme agus déanfar a chinntí freisin go bhfanfaidh sé i gcomhréir le pleannanna na Comhairle.
- Beidh na córais agus próisis iomchuí i bhfeidhm ag Oifig na nEalaón chun cur chun feidhme an phlean seo a thacú, a rianú agus a thomhas ar an mbealach is éifeachtaí agus is féidir.
- Beidh tulleadh feasachta, tuisceana agus suime ann in obair Oifig na nEalaón agus san ionchur agus tionchar a bhíonn aici go háitiúil agus go náisiúnta.
- Aithneofar Oifig na nEalaón i gcónaí agus úsáidfear í mar sheirbhís lárnach de chuid na Comhairle.
- Beidh tacaíocht bhireise ann do chláir Oifig na nEalaón de bharr na tuisceana atá ann ar thionchair cultúrtha, sóisialta, eacnamaíocha agus comhshaoil obair na hOifige sin.
- Beidh príomhstraitéisí áitiúla agus náisiúnta tar éis dul chun leasa gníomhaíochtaí Oifig na nEalaón. Beidh Oifig na nEalaón tar éis a bheith ina príomhpháirtneir maidir leis an gclár ‘Éire Chruthaitheach’ a chur chun feidhme.
- Beidh Oifig na nEalaón tar éis taighde, measúnú agus athmhachnamh a dhaingniú ina gcuid cleachtais oibre agus comhpháirtithe eile a éascú chun an rud céanna a dhéanamh.

# Consultation Process

## an Próiseas Comhairliúcháin

The development of the Fingal Arts Plan 2019 – 2025 was informed by a process of public consultation that took place over six weeks from May to June 2018.

As a starting point for the development of the plan, the Arts Office began an intensive process of information-gathering from all sectors of the community in Fingal. In order to examine the role that the arts play in the lives of the residents of Fingal, and to inform the development of the plan with insight from relevant stakeholders, we devised two stages of consultation.

We wanted to encourage engagement and meaningful dialogue between the Arts Office and key stakeholders and it was hoped that in doing so, we would provide greater understanding and recognition of the work of the Council's Arts Office. In turn, we would also create an enhanced sense of community, confidence and optimism among stakeholders with a shared commitment to the arts in Fingal.

The first stage of public consultation took the form of an online survey. The second stage of the consultation employed the 'World Café' methodology, whereby the Arts Office hosted two half-day workshops with invited stakeholders: one in Dublin 15 and another in the north of the county.

Bringing the stakeholders together allowed networking opportunities, the cross-fertilisation of ideas, the identification of shared priorities, and a better understanding of the scope and depth of artistic activity within the county. It also offered scope for a broad discussion, as well as more in-depth cohort-specific reflection.

In addition, the Arts Office consulted with young people to ensure that their voices were heard and considered in the planning and delivery of arts and cultural services in Fingal. This consultation took the form of an online survey which was circulated to Comhairle Na Óg, all primary and post primary schools in Fingal, and the National Arts in Education portal.

We facilitated two informal, interactive workshops at Fingal Community College and Holywell Community Centre. Two focus groups for the participants of ROOM 13 were also facilitated. Finally, we hosted a workshop with the Public Participation Network (PPN).

Mar bhonn eolais ag Plean Ealaíona Phine Gall 2019 – 2025, tá próiseas comhairliúcháin phoibl a réachtáladh thar tréimhse 6 seachtaíne ó mhí na Bealtaine go mí an Mheithimh 2018.

Mar thúsphointe d'fhorbairt an phlean, chuir Oifig na nEalaón tú le dianphróiseas bailithe eolais ó gach earnáil den phobal i bhFine Gall. Chun iniúchadh a dhéanamh ar ról na n-ealaón i saol na ndaoine a bhfuil cónaí orthu i bhFine Gall, agus chun bonn eolais a chur le forbairt an phlean le léargas ó pháirtithe leasmhara ábhartha, leagamar amach comhairliúchán ina raibh dhá chéim.

Theastaigh uainn rannpháirtíocht agus comhrá tábhachtach a spreagadh idir Oifig na nEalaón agus na príomhpháirtithe leasmhara agus ba é an aidhm a bhí leis ná tuiscint agus aitheantas níos fearr a chothú maidir le hobaír Oifig na nEalaón. Dá réir sin, dhéanaimis mothú feabhsaithe pobail, muiníne agus soirbhíochas a chothú i measc páirtithe leasmhara a bhfuil comhthiomantas acu do na healaíona i bhFine Gall.

Ba é a bhí i gceist leis an gcéad chéim den phróiseas comhairliúcháin ná suirbhé ar líne. D'úsáid an dara céim den chomhairliúchán modheolaíocht an 'Caifé Domhanda', inar reáchtáil Oifig na nEalaón dhá cheardlann leath lae le páirtithe leasmhara ar tugadh cuireadh dóibh; ceann amháin in mBaile Átha Cliath 15 agus ceann eile i dtuaisceart an chontae.

Trí na páirtithe leasmhara a thabhairt le chéile, ceadaíodh deiseanna líonraithe, crostoirchiú smaointí, sainaithint tosaíochtaí comhroinntí; agus tuiscint níos fearr ar raon agus ar dhoimhneacht na gníomhaóchta ealaíonta laistigh den chontae. Tugtar scóip leis le haghaidh plé leatha, chomh maith le machnamh doimhin a bhaineann le cohórt sonrach.

Anuas air sin, chuaigh Oifig na nEalaón i gcomhairle le daoine óga chun a chinntí gur chualathas a nguth agus go ndearnadh breithníú air le linn seirbhísí ealaíne agus cultúrtha i bhFine Gall a phleanáil agus a sholáthar. Ba é a bhí i gceist leis an gcomhairliúchán sin ná suirbhé ar líne a scaipeadh ar Chomhairle na NÓG, ar na bunscoileanna agus iarbhuinscoileanna uile i bhFine Gall agus ar thairseach Náisiúnta na hEalaíona an Oideachais.

Rinneamar dhá cheardlann neamhfhoirmiúil idirghníomhach a éascú: ceann amháin i gColáiste Pobail Phine Gall agus ceann eile in ionad Pobail an Tobair Naofa. Rinneadh dhá fhócasgrúpa a éascú freisin le haghaidh rannpháirtithe SHEOMRA 13. Ar deireadh, reáchtála mar ceardlann leis an Lónra Rannpháirtíocha Pobail.

The overall consensus from this consultation demonstrated a high level of satisfaction with the existing arts programmes and access to the arts. However, a number of consistent themes emerged about what needs to be improved, strengthened or put in place over the course of the next strategy. In most instances, this was about **more** or **better** rather than **new**. It is within this context that the Fingal Arts Plan 2019 – 2025 outlines a realistic approach to addressing the current and future challenges for the delivery of a countywide arts service. This will be achieved by setting attainable goals for future development, which will ensure that the arts are valued in people's everyday lives.

## Funding

The Arts Office is funded from the Council's Revenue Budget and from the Arts Council of Ireland. Appropriate funding is required over the lifetime of the plan, in order to implement the goals and objectives. Additional staffing resources with appropriate competencies, expertise and experiences may be sought to support the delivery of the plan.

## Evaluation Monitoring, Evaluation and Review

It is essential that the Fingal Arts Plan 2019 – 2025 be monitored and reviewed on a regular basis. Ideally, it should be open to constructive criticism and amendment, in order to ensure that it continues to accord with the values of Fingal County Council. The plan should also aspire to meet with the wishes of the people of Fingal, whether they have a strong or a passive involvement and interest in the arts. The plan retains a degree of flexibility, in order to respond to changing circumstances, new initiatives and ongoing feedback from interested parties engaged in arts participation.

The detail of the delivery on the key principles contained in the plan will be embodied in the Community, Culture and Sports Department's Annual Operational Plan. The Council's Annual Report will include an account of the achievements of this plan, and a midterm review will be undertaken and presented to the Strategic Policy Committee in 2022.

### The Fingal Arts Plan will be evaluated in the following ways:

- A report will be submitted to the Director of Services of the Community and Housing Department on an annual basis. The report will outline progress during the year and set priorities. It will also recommend amendments and additions to the existing plan.
- The Arts Office will continue to develop strong links with individuals and arts organisations in Fingal, whose input into the implementation of the plan will be sought.
- The recommendations of the plan will determine the annual work plan for the Arts Office.

Ba léir ón gcomhairliúchán sin go raibh ardleibhéil sásaimh i measc daoine i ndáil leis na cláir ealaíona reatha agus rochtain ar na healaíona. Tháinig roinnt téama chun cinn áfach maidir leis na gnéithe is gá a fheabhsú, a neartú nó a bhunú thar tréimhse na chéad straitéise eile. Sa chuid is mó de cásanna, ba iad na focail **tuilleadh** nó **nós fearr** a luadh ní ba mhinice ná **nua**. Is laistigh den chomhthéacs sin a leagfaidh Plean Ealaón 2019 – 2025 cur chuige réalafoch amach maidir le dul i ngleic le dúshláin reatha agus thodhchaí i ndáil le seirbhís ealaíon a sholáthar ar fud na tíre. Bainfear é sin amach trí chuspóirí insroichte a leagan sos i ndáil le forbairt amach anseo, rud a chinnteoidh go bhfuil léiritear meas ar na healaíona i ngnáthshaol laethúil daoine.

## Maoiniú

Is le maoiniú ó Bhuiséad Cánach na Comhairle agus ón gComhairle Ealaón a dhéantar Oifig na nEalaíon a mhaoiniú. Is gá leis an maoiniú iomchú le linn shaolré an phlean, ionas gur féidir na spriocanna agus na cuspóirí a bhaint amach. Is féidir acmhainní foirne breise a bhfuil na hinniúlachtaí, saineolas agus taithí iomchú acu a lorg chun tacú le cur chun feidhme an phlean.

## Measúnú

Monatóireacht, Measúnú agus Athbhreithniú

Is riachtanach go ndéanfar monatóireacht agus athbhreithniú ar Phlean Ealaóna Phine Gall 2019 – 2025 ar bhonn rialta. Go hidéalach, ba cheart go mbeadh an plein oscailte do Iéirmheatóstireacht chuiditheach agus leasú, ionas a chinntí go gcloíonn sé le luachanna Chomhairle Phine Gall. Ba cheart go mbeadh sé mar aidhm ag an bplean fonn mhuintir Phine Gall a chomhlíonadh, má tá suim acu sna healaíona agus iad an pháirteach iontu nó a mhalaírt. Coinníonn an plein solúbthacht éigin chun freagairt do chúinsí athraitheacha, tionscnaimh nua agus aiseolas leanúnach ó pháirtithe a bhfuil suim acu i ranpháirtíocht sna healaíona.

Cuimseofar i bPlean Oibríochta Blantúil na Rannóige Pobail, Cultúir agus Spóirt na sonraí maidir le príomhphrionsabail an phlean a chur chun feidhme. Cuirfear cuntas ar ghnólachtaí an phlean seo san áireamh i dTuarascáil Bhliantúil na Comhairle, agus déanfar athbhreithniú lárthearma agus cuirfear i láthair an Choiste um Beartas Straitéiseach in 2022.

Déanfar Plean Ealaóna Phine Gall a mheasúnú mar seo a leanas:

- Cuirfear tuarascáil faoi bhráid Stiúrthóir Seirbhísí sa Rannóige Pobail agus Tithíochta ar bhonn rialta. Leagfar amach dul chun cinn le linn na bliana sa tuarascáil agus leagfar tosaochtaí síos intí freisin. Déanfar leasuithe agus breisithe ar an bplean reatha a mholadh sa tuarascáil freisin.
- Leanfaidh Oifig na nEalaíon de naísc láidre a chothú le daoine aonair agus le heagraíochtaí ealaíon i bhFine Gall, agus déanfar ionchur na daoine/grúpaí sin a lorg maidir le cur chun feidhme an phlean.
- Beidh plein oibre blantúil na hOifige Ealaón bunaithe ar mholtáí an phlean.

- Evidence from the Arts Office’s research will be used to inform its annual work plan.
- The principles of ‘value for money’ will be applied to the implementation of the plan.

## Implementation

The Arts Office recognises that the actions set out in this plan are dependent on funding and available resources. The plan will be continuously reviewed and flexible enough to respond to changing circumstances. Accountability and transparency are essential elements of local authority service provision. The Arts Office will implement the key principles in this plan over a seven-year period, through annual operational plans. It will monitor and evaluate each programme on an ongoing basis and submit a progress report to the SPC midway through the term of the plan, to ensure of its ongoing relevance.

- Úsáidfear fianaise ó thaighde na hOifige Ealaón chun bonn eolais a chur lena plean oibre bliantúil.
- Cuirfear prionsabail ‘luach ar airgead’ i bhfeidhm agus an plean á chur chun feidhme.

## Feidhmiú

Aithníonn Oifig na nEalaón go mbraitheann na gníomhaíochtaí a leagtar amach sa phlean seo ar mhaoiniú agus ar na hacmhainní atá ar fáil. Déanfar athbhreithniú leanúnach ar an bplean agus beidh sé solúbtha go leor chun freagairt do chuínsí athraitheacha. Tá cuntasacht agus tréadhearcacht ina ngnéithe ríthábhachtacha de sholáthar seirbhíse in údaráis áitiúla. Cuirfidh Oifig na nEalaón príomhphrionsabail an phlean seo i bhfeidhm thar tréimse 7 mbliana trí pleananna oibríochtaí bliantúla. Déanfaidh Oifig na nEalaón monatóireacht agus measúnú ar gach clár ar bhonn leanúnach agus cuirfidh sí tuarascáil ar dhul chun cinn faoi bhráid an Choiste um Beartas Straitéiseach leathslí trátháarma an phlean, chun a ábharthacht leanúnach a chinntiú.
