

# ROADS ACT 1993 TO 2015 - SECTION 75 **TEMPORARY CLOSURE OF ASHGROVE** ROAD, GARRISTOWN, CO DUBLIN

An application h as been received from KN Group, for permission to temporarily close L1040, Garristown, Co. Dublin, to facilitate installation of new duct route. It is proposed the road will be closed from **9.00am to 6.00pm on Monday 27th July 2020 until** Wednesday 2nd September 2020.

#### 27th July 20 for 6 days

#### Alternative routes available for vehicular traffic are as follows:

#### Blanchardstown Bound Traffic:

All vehicular traffic travelling from Naul to Blanchardstown

At the Green Lane junction Ashgrove Road - turn right on to Green Lane. Follow the Green Lane until junction R130. Take a Right at R130 and head southbound

#### Naul Bound Traffic:

All vehicular traffic travelling from Blanchardstown to Naul

• At Ashgrove Road continue along R130 for 1.3km - turn right on to Green Lane. Follow the Green Lane until junction Ashgrove Road. Take a Left at junction Green Lane Ashgrove Road and head Northbound

#### 3rd August 20 for 18 days

## Alternative routes available for vehicular traffic are as follows:

# Blanchardstown Bound Traffic:

- All vehicular traffic travelling from Naul to Blanchardstown
- At the Nutstown Lane junction Ashgrove Road turn right on to Nutstown Lane. Follow Nutstown Lane until junction Nutstown - Lonsy Bush L1045-0. Follow road and take next right. Take next left along Wyestown Lane and at junction of R130 take a left and continue southbound on R130. Local Traffic can take next left along Green lane if destination is return to Ashgrove Road

#### Naul Bound Traffic:

All vehicular traffic travelling from Blanchardstown to Naul

At take a left at Green Lane towards R130. At junction Green Lane and R130 take a right and head northbound towards junction R130 and Wyestown Lane. Follow Wyestown Lane until junction Nutstown - Lonsy Bush L1045-0 follow road until Nutstown Lane and take right to continue onto Ashgrove Road

#### 24th August 20 for 10 days

## Alternative routes available for vehicular traffic are as follows:

Blanchardstown Bound Traffic:

All vehicular traffic travelling from Naul to Blanchardstown

At the junctioan R122 Ashgrove Road – follow R122 for 1.5km until Junction R122 and Cottrelstown-Brown's Cross. Take Right at this junction and continue towards Ashgrove Road. At jui nction take a left and follow Ashgrove Road Southbound.

## Naul Bound Traffic:

All vehicular traffic travelling from Blanchardstown th Naul

 At Ashgrove Road junction Cottrelstown-Brown's Cross – turn right on to Cottrelstown-Brown's Cross. Follow the road until junction R122. Take a Left at junction Green Lane Ashgrove , Road and head Northbound
