Chief Executive's Foreword

We are now in the early stages of the Recovery phase of the pandemic and we have the Government's plan for the easing of restrictions throughout the month of May and into June. The emphasis on outdoor activity will continue for the next number of weeks and months with the theme for Summer 2021 being 'Think safe, think outdoors'.

We are focusing on outdoor activities from both a social and economic perspective. Active travel will be promoted and to assist with this the bleeper bike scheme will be extended and additional bike racks will be put in place. In anticipation of increasing numbers of people using our parks, beaches and public realm spaces additional litter bins have been and will continue to be provided in tandem with an increased presence from the litter wardens. Litter cleansing crews are operating each morning and evening and we are engaging with local businesses regarding their responsibilities in relation to litter and waste. Additional staff have also been deployed for litter picking in the villages and beaches. Existing public conveniences are open and an interim measure of portable toilets will be put in place in high demand locations. New public conveniences will also be in place in a number of locations in the coming weeks.

We are working hard to support local businesses reopening and applications for outdoor dining are currently being considered along with applications for parklets and street furniture licences and we encourage businesses to avail of the suite of supports available to them. The draft casual trading byelaws are currently on display and submissions are invited from the public. A number of non statutory public consultations will take place regarding Summer 2021 plans.

Libraries will re-open to the public from the 10th of May which is positive news as they are a much valued and utilized resource across the county. Supporting communities at this time is a key focus and our teams are engaging with groups across the county to provide assistance and funding for a wide range of initiatives spanning every age profile.

There will be a continued focus on recruitment with a significant number of competitions underway or due

to commence. It is an exciting time to join Fingal County Council with opportunities to work on a wide range of ambitious projects with experienced and dedicated staff who are always seeking ways to innovate and deliver to an exceptional standard. Liam Burke is the Acting Director in the Housing and Community Development department following Margaret Geraghty's departure and there will be a permanent appointment in due course.

I am delighted that we are well advanced with our plans for Summer 2021 and we will continue to engage with our wide range of stakeholders to ensure that it is an enjoyable and prosperous summer for all.

Thank you for your continued support and stay safe.

Major Emergency Management



The Major Emergency Management structures in place within the Council continue to provide the framework within which the Council's Departments adapt and update business continuity plans. Following on from the Government announcement last week outlining the phased easing of public health restrictions throughout May and into June the Council continues to update Business Continuity plans to reflect changes as they come into effect.

The MEM Eastern Region Steering Group, chaired by the Chief Executive, with representatives from the HSE, Gardaí, local authorities, fire services and Defence Forces continues to co-ordinate a strategic, interagency response to the public health emergency, to co-ordinate services regionally and to support the HSE while ensuring that activities are in line with the national measures. The Group will continue to meet as required.

Locally, Fingal County Council's Management Team continues to meet regularly to ensure continuity of services and put measures in place to align with the Governments plan to ease restrictions throughout May and June.

HUMAN RESOURCES

CRM Information Technology Communications




The Human Resource Department continues to plan for and respond to the challenges brought by Covid19. In line with the Government's **COVID-19 Resilience and Recovery 2021 - The Path Ahead,** under current level 5 restrictions staff who can work from home are encouraged to do so. Staff continue to be kept up to date on relevant Government directives and are provided with useful information through text alerts and a dedicated staff information webpage.

Training and development of our staff, including statutory Health & Safety training, continues throughout the pandemic ensuring that critical services are not adversely affected. Many of the Council's structured training programmes are now online and are continuing remotely. As part of the Local Authority Climate Action Training Programme, Council staff are currently undertaking "Climate Action - Raising Awareness" training, delivered through the Climate Ireland Learning Platform. The HR Department in April also began delivering Diversity & Interculturalism Training which will assist the Council in meeting its obligations under the Public Sector Equality & Human Rights Duty.

The HR Department is engaging in large scale recruitment campaigns for a range of roles and there are currently 18 active competitions.

Health & Safety Unit (HSU)

The HSU continues with its remote working VDU assessment program, reaching out on MS Teams to staff working remotely. To date 568 remote working assessments have been completed. Accident investigation, Covid-19 compliance checks, fielding staff queries and risk assessment / SOP review continues in tandem with the assessments. A communications package for staff and customers was prepared for Workers Memorial Day.


For the month of April, the Council's Customer Care Agents dealt with a total of



The table below shows the number of Councillor's representations assigned to each Department for the year to date.



Public Wi-Fi

The rollout of a total of 48 Public Wi-Fi hotspots is underway across 17 locations throughout Fingal by Magnet Networks.

The initiative is supported by the WIFI4EU voucher scheme which aims to provide high-quality internet access across the EU to citizens and visitors via free of charge Wi-Fi hotspots in public spaces such as town and village centres, parks and civic spaces.

As Wi-Fi Access Points are installed, they become available for use by the public. When all the access points in a funding area are operational and tested, the Council will launch the scheme with corresponding publicity of the service to inform the public of availability.

The Balbriggan 3D Model is a visual tool which will help citizens visualise the planned transformations of the town outlined in the Our Balbriggan 2019-2025 Town Rejuvenation plan. The Smart Balbriggan team officially launched the Balbriggan 3D Interactive Model on 12th April 2021. The model can be described as a '3D Map' or 'Digital Twin' of Balbriggan as it was created using aerial survey photography and ground level photo surveys. It provides easy access to a visual representation of the reimagined Harbour and Quay Street area.

The model will be used to enhance community engagement, enabling the people and businesses of Balbriggan to view the future transformation of their town. An interactive web viewer has been created for the public to view and immerse themselves in Balbriggan's reimagined spaces. Using this web viewer, you can walk down Quay Street and toggle to a festival view, where people are enjoying outdoor craft fair, food and music. This 3D environment showcases the potential of the Our Balbriggan 2019-2025 Town Rejuvenation plan.

The Fingal Coastal Way is envisaged to be a flagship scheme for tourism in the county with the potential to promote and enhance the local tourist economy.

On Twitter, we now have 19,592 followers including 90 new followers. Our 214 posts received 837,000 impressions, with a 1.2% engagement rate.


Our Top Tweet related to the launch of the public consultation on the Fingal Coastal Way route option selection, receiving 33,100 impressions and 1,849 engagements.

Our Instagram account continues to grow and now has 3,611 followers. Our most popular post also related to the launch of the Fingal Coastal Way route option public consultation.

We now have 4,160 followers on Linkedin which is an increase of 10.79% since the start of the year.

Irish Language

The Council's Irish Language scheme has been reviewed following a public consultation and the draft 4th Irish Language Scheme 2021 – 2024 will be presented to the Councillors at the May meeting before being sent to the Department of the Gaeltacht for approval.

A list of useful phrases/frásaí úsáideacha in Irish was circulated to all Councillors to assist them with using small amounts of Irish at meetings if they wish.



Engagement

The Communications Unit is working with various departments on communications and engagement strategies for a number of projects including the Fingal Coastal Way and the Development Plan.

We have also worked with the Environment Department on campaign entitled Stop Dumping On Us Campaign which has included the creation of new social media graphics, videos featuring staff talking about the impact of littering and illegal dumping, as well as a podcast.



Press Releases

A total of 13 press releases and media invitations were issued by the Communications Unit during April.

Fingal News

Edition 18 of Fingal News was published during April. The English edition has had 2,307 impressions and 2,165 reads, a conversion rate of 93.84%. The Irish edition has 39 impressions and 17 reads, a conversion rate of 43.5%.

EVENTS AND FESTIVAL FUNDING SCHEME



The Events Unit continues to facilitate those groups who have been awarded funding under the Council's Events and Festivals Funding Scheme. All successful applicants have been funded to assist them in delivering a blended or hybrid virtual model event.

The Events Unit will monitor the guidance on Covid-19 restrictions and liaise with event organisers.

TOURISM

Food Tourism

Planning is continuing for upcoming events and projects with Fáilte Ireland Dublin Team and food consultant Marie Brouder on Food Tourism.

Dublin Coastal Development Plan

Workshops and networking events continue with the industry stakeholders around the coastal plan. Some very interesting collaborations and possible developments of new coastal experiences have evolved from this process. The next steps will involve working with the stakeholders to deliver these new experiences across the coastal villages. Cross promotion will be a big outcome of this process.

Tourism Development Groups

The groups continue to work on preparing for the reopening of the industry, focusing on consistent messaging in marketing and social media around safety, unique outdoor dining experiences and open spaces. As consumer sentiment research conducted by Fáilte Ireland shows people are missing fun, spontaneity and human interaction, this will feature strongly in messaging going forward. The groups are also looking at possible outdoor events throughout the summer months that would allow them to extend their own offering while meeting the demands of consumers. The Dublin 15 group has developed the Liffey Valley Trail which has gone to print and will be available in the coming weeks.

HERITAGE PROPERTIES

UPDATE ON HERITAGE PROPERTY REOPENINGS



Under the Government's Covid-19 Resilience & Recovery 2021 Plan, and following the recent Government announcement, the following changes have been implemented:

- The grounds within Swords Castle re-opened to the public on Monday 26th April.
- Malahide Walled Gardens and West Lawn and Newbridge Farm re-opened on Thursday the 29th April.
- Cafés across the properties remain open for takeaway only.

All heritage properties remain closed pending further clarification from Government on the re-opening of indoor spaces.

HERITAGE PROPERTIES CAPITAL WORKS UPDATE:

SWORDS CASTLE PERIMETER WORKS

The public realm works at Swords Castle are ready to proceed, with pre-cast units, lighting cages, parking bay sleepers all on standby for delivery. Based on Government's current guidance on the anticipated reopening of wider construction activity, it is anticipated that the completion of the perimeter works will commence in May with a duration of 4 weeks.

MALAHIDE CASTLE GREAT HALL RENOVATIONS

The Council has recently appointed a conservation design team to address building fabric issues, services upgrade and decoration of the Great Hall. Works completed to date have focused on historic research, investigations and surveys to inform the tender documents. The intended investment will provide a secure and environmentally stable environment appropriate for a stately room furnished with antiques and artworks.

Work is expected to be tendered in May to commence in summer with completion of works in 2021.

ARDGILLAN CASTLE PAINTING OF MAIN TOUR ROOMS

It is expected that the contractor can commence the painting works throughout the main public rooms at Ardgillan Castle in May once restrictions for nonessential construction are lifted.

CREATIVE FINGAL PROGRAMME 2021



Cruinniú Na nÓg, a day of free creative activity for children and young adults, will take place Saturday 12th June, 2021. Minister Catherine Martin, TD, at the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media will officially launch the day nationally on Monday 4th May, 2021. Fingal County Council's programme of events offers Fingal's citizens a wide variety of activities across Arts, Libraries, Sports and Music to choose from on and participate in on the day. All of Fingal County Council's events will be available to view on <u>https://www.fingal.ie/cruinniuna-nog-2021</u>.

The Creative Ireland programme is progressing. All 15 community groups offered grant funding have accepted the offer and are proceeding with the development stage of their proposed projects. Each project has a plan B – Covid plan to adjust and adhere to whatever Covid guidance may be in place at the time.

The commemoration programme is also progressing well as we move through the most sensitive phase of the Decade of Centenaries (2020-2023). The recent awarding of contract to a Research Historian will assist the Council in continuing to plan centenary commemorations with an inclusive, respectful, authentic, measured and consultative approach in line with National commemorations.

SMALL BUSINESS ASSISTANCE SCHEME FOR COVID


The Small Business Assistance Scheme for Covid closed to new applications on Wednesday 21^{st} April, 2021. Fingal County Council received 223 completed applications from Fingal businesses. The grant of \notin 4,000, which is available as a contribution towards fixed costs to assist a business to keep operational for an eventual re-opening, is only available to applicants operating from a rateable property.

The Economic, Enterprise, Tourism & Cultural Development Department are currently validating and processing all completed applications and it is expected that approximately €800k will be paid out through this scheme to the successful applicants in the coming weeks.

This amount represents the first payment due to eligible businesses under the SBASC scheme. An additional payment of €4,000 will be made to applicants continuing to meet the scheme eligibility criteria from Quarter 3.


Infrastructure Public Art Programme Launch – Assemble – A Film Trilogy Anthony Haughey & The Global Migration Collective online.


Music Generation Fingal

Exploring & Thinking; Early Childhood Arts Partnership






Fingal County Council Arts Office has partnered with Dublin City Council, South Dublin County Council and Dún Laoghaire-Rathdown County Council to select eleven artists for the 2021 Exploring & Thinking Bursary Award, which supports individual professional artists developing their artistic practice working with and/or producing work for early childhood arts.

The Award will assist its recipients - Clare Breen, David Beattie, Mark Joyce, Cliodhna Noonan, Diane Crotty, Helen Barry, Helen Keenan, Angelica Santander, Mary O'Donnell, Liam McCarthy and Mark Ball – to develop their practice in a wide range of different arts practices and creative experiences with or for children aged 0-5 years in different contexts.

'Exploring and Thinking' is a collaborative framework for early childhood arts in the Dublin region, originating in 2016 when the four Dublin Local Authorities partnered for the first time to collectively consider early childhood arts provision in Dublin.

The programme aims to reach children in underserved communities and to support the development of artistic collaborations, professional development and the research and creation of new work.

D.15 Youth Theatre and FeliSpeaks





Fingal Arts Office invited poet, performer and playwright FeliSpeaks, aka Felicia Olusanya, to work with Dublin 15 Youth Theatre and to develop new poetry for presentation at Cruinniu na nOg 2021. Created by the members while working with FeliSpeaks and actor/facilitator Emily Matthews, these works reflect the lives of these young people living in Dublin 15 today. FeliSpeaks guided the group through thought provoking discussions, meditation practices and word association games before introducing some of her own work and the work of others such as poetry duo Sarah Kay & Philp Kay to give inspiration. After composing eight individual poems the group decided to create two collectives with four members in each. A symbiotic relationship evolved where both collectives thrived with the support of each other and guidance from Felicia and wrote two unique poems. The group is now working with Arcade Film to realise the physical presentation and translation of these works to an audience.

Libraries - Tumble Books and Tumble Math

Tumble Math is a comprehensive collection of maths picture books. All are in the amazing Tumble Book format, complete with animation and narration, so the collection is a very effective way to teach maths concepts. Tumble Math also has thousands of fun quizzes, making leaning maths fun! Books are always available, with no wait list, and can be accessed by any number of users, so they are ideal for teachers and classes.

Carnation Theatre will present 'Midwives of the Nation' on the 27th and 28th May - a performance which follows the women of 1916. On 12th May, Dr. Maebh O' Regan will give an illustrated lecture on the creative achievements of the Yeats family from early childhood through to adulthood. Booking for these events is on Eventbrite. Book Gifting Scheme

The Book Gifting Scheme from Fingal Libraries came about as a result of funding received in late 2020 from the Dormant Accounts Fund. A School's Wellness programme was devised that included rolling out events to schools in Fingal such as Yoga for children and Comic Book Workshops. In addition, it was decided that Wellness Packs including books, were to be distributed to schools in the Fingal area. These packs would supplement the school libraries or classroom resources of the schools and provide an opportunity for relaxation and increased engagement in reading together for pleasure for the children. 600 packs so far have been dispatched by Mobile Libraries to schools in Dublin 15, Malahide, Swords, Skerries, Balbriggan, Portmarnock, Sutton, Baldoyle, St Margaret's, Lusk and Donabate. There has been some wonderful feedback on this initiative:

Fingal Libraries Poetry Competition 2021

Suitable for beginners and for people with a more advanced knowledge of gardening, the workshops can be booked on Eventbrite from 1st May.

ECONOMIC DEVELOPMENT

FINGAL IN IT TOGETHER



The Council continues its efforts under the Fingal In It Together Charter to support businesses and in April introduced three economic stimulus measures to assist businesses as they reopen.

Outdoor Dining Scheme



With funding from Fáilte Ireland, the Council has launched the Outdoor Dining Scheme to assist the hospitality and tourism sector to increase their outdoor dining capacity. The Council has issued a call for applications for grants of up to €4,000 to help businesses to upgrade and enhance venues and public space and implement weather-proofing solutions to facilitate outdoor dining all year round. The Scheme provides funding for outdoor tables, chairs, umbrellas, electric heaters, screens and windbreaks etc. Expenditure must be incurred between 1st April 2020 and 30th September 2021. Further information is available on the Council's website and applications can be made at www.fingal.ie/outdoordining

Parklet Partners



Following on from the success of the 2019 pilot initiative, which aimed to support local businesses by transforming the existing streetscape into a welcoming and attractive community space, the Council has launched another call for applications under "Parklet Partners" initiative. The parklet, which accommodates dining space and additional seating, is aimed at encouraging people back into the centre of towns and villages while complying with public health guidance. Fingal Main Street Shopfronts & Residences Improvement Grant

The Council has launched a call for applications under the Shopfront and Main Street Residences Scheme 2021, where main street property owners can apply for grant funding of up to 50% of eligible costs and a maximum of \leq 1,500 to replace and renovate shop fronts and main street residences in Fingal town and village centres. Sustainable Fingal



The Council's **Sustainable Fingal** initiative continues with an aim of engaging with the business community on the implementation of sustainable business measures. The Council's brochure "Sustainable Ideas for SMEs" contains simple actions for businesses' to improve their sustainability and is available at www.fingal.ie/sustainablebusiness

To encourage business engagement in Sustainable Fingal the Council is running a competition for businesses to win a Sustainability Assessment and Action Plan from Balbriggan based Patel Tonra Ltd. Environmental Solutions and a video case study to feature on the Sustainable Fingal webpages. The closing date for business entries is Friday 28th May 2021.

Business Supports for Summer 2021

The Council is considering potential initiatives to support business and the community across the county for Summer 2021 which, in addition to the economic stimulus measures already advertised, may include full/partial pedestrianisation of designated streets, provision of a range of additional public facilities and measures to facilitate active travel and encourage footfall. The Council shall engage in consultation with the local community on proposed measures.

Our Balbriggan 2019 – 2025 Rejuvenation Plan – A Socio-Economic Strategy

The Our Balbriggan programme office continue to support the Chair of the Leadership Group and its five pillars to progress work across a range of economic and social measures including: Growing the Local Economy, Public Realm & Infrastructure, Education, Skills & Employment, Community Affairs & Integration and Community Safety.



With regards Public Realm & Infrastructure tenders have been received for the appointment of an Integrated Design Team (IDT) for A Re-imagined Quay Street and Harbour area. Restoration of the RNLI Boathouse is scheduled to commence in advance of the summer period. Master Planning Consultancy Services have been procured to ensure coherency throughout the transformative public realm and infrastructural elements set to take place throughout the town.

The Education, Skills and Employment Pillar organised the inaugural Our Balbriggan Loves Learning Festival which took place online from 19th-30th April. The Festival encompassed four elements (a) Learning for Employment (b) Learning for Employers (c) Learning in your community and (d) Digital Learning. The Festival showcased the breadth and diversity of local schools, it featured 8 live events including SME engagement, Musical events and Digital Learning, with over 25 Learning resources and video's showcasing learning opportunities. Resources and materials can be accessed at www.Balbriggan.ie/loveslearning. Other Pillars continue to meet on a periodic basis to work through

substantial work programmes and actions as identified in the Our Balbriggan Town Rejuvenation Plan 2019 – 2025.



This month the programme office applied for funding of €120,000 (p.a for 3 years) from the Arts Council under the Creative Places award. The submission, which aligns with the Our Balbriggan Rejuvenation plan, will forge sustainable, deep connections to place and people, resulting in many more quality artistic events and experiences building on the towns strengths and led by community ideas and participation. If successful a full time Creative Place Coordinator and attendant programme budget will be attached to the Balbriggan programme office in Georges Square.



Following a successful application in November 2020, the Our Balbriggan Programme Office will participate

in the second EU Programme "Europe for Citizens – It's our time, it's time for Europe". Balbriggan will partner with eight other European large towns with the inaugural online meeting due to take place in May 2021. The focus of the project is on youth and diversity, with groups: - Debating the future of Europe and challenging Euroscepticism – Promoting solidarity in times of crises – Fostering intercultural dialogue and mutual understanding and combating the stigmatisation of migrants and minority groups. Balbriggan will host a meeting of European Partners in September 2022, with the costs of the projects development and hosting met in full €15,280.

Following the programme offices successful application along with nine other European town partners to participate in the EUs URBACT/iPlace programme in 2020, an Iplace Transnational meeting was held on the 20th and 21st April hosted by Pori – Finland which included interactive workshops, masterclass sessions and presentations, with members of the Our Balbriggan Programme Office presenting and in attendance.

LOCAL & RURAL DEVELOPMENT

LOCAL COMMUNITY DEVELOPMENT COMMITTEE

The Fingal LCDC continues to oversee and administer the key areas of LEADER and SICAP and the various Local Development and Community Development funding programmes under its remit. The LCDC is also represented on the Fingal Community Call Forum and is supporting many of the LCDC member agencies that are also members of the Community Call in the delivery of their programmes. The LCDC is also supporting the work of the Community Call through the Healthy Ireland Initiative, the Community Resilience Fund and the Keepwell Campaign, and the many projects up and running under those funding streams.



Emergency Funding available for Community and Voluntary Groups in Fingal

The Fingal Local Community Development Committee (LCDC) had invited applications from community, not-for-profit and voluntary groups for funding under the COVID-19 Emergency Fund with a closing date at the end of February. The Scheme is being administered by the Fingal LCDC under the remit of the Local Authority on behalf of the Department of Rural and Community Development. Fingal LCDC received funding of €59,820.00 to be awarded to successful applicants. Under the scheme, 30% of available funds have been ring-fenced to provide small grants of €1,000 or less. 85 groups/organisations submitted applications totalling €125,865.77. The LCDC Evaluation Committee had approved 52 projects for funding. Approved funding amounts have been transferred to successful groups/organisations at this point.

SICAP

The SICAP Annual Plan for 2021 continues to be implemented. The €1.24m 2021 SICAP Plan has ambitious KPIs which take into account the many challenges arising from delivering services in a Covid 19 environment. The Fingal SICAP Programme continues to play an important role in the work of the Community Call Forum. Indications to date are that the 2021 SICAP Programme is progressing well and within expectations.



government supporting communities

The Dublin Rural LEADER Local Action Group and the Fingal LEADER Programme continues to deliver funding and support to eligible projects in the administrative areas of Fingal, Dun Laoghaire Rathdown and South Dublin.





An Roinn Forbartha Tuaithe agus Pobail Department of Rural and Community Development

The updated 2021/22 Transitional Funding Arrangements for the LEADER Programme were announced in April with the Dublin Rural LEADER LAG approved for €1,882,175 to cover both projects funding and administration funding for the period April 2021 – December 2022. Of this amount, €1,411,631 is now available for LEADER Project Applications under the categories of Rural Enterprise, Social Inclusion and Rural Environment. Historically, Fingal Projects comprisel of 65-70% of the total LEADER Projects Funding, roughly corresponding to Fingal's share of the Dublin Rural LEADER Geographical Area.

The LEADER Programme reverted on the 1st April to EU Transition Rules for the period 2021-22 with a new Dublin Rural LEADER Local Development Strategy to be put in place for 2023. Under the Transitional Arrangements the Dublin Rural LEADER LAG and the LEADER Programme will continue to be funded by the Department of Rural and Community Development under the same eligibility and LEADER implementation rules as before. LEADER will continue to approve and fund new projects as normal.

The most recent meeting of the Dublin Rural LEADER LAG took place in early March 2021. At this meeting two new Fingal projects in the areas of Enterprise and Rural Environment were approved with a total €67,786 in LEADER funding. The next LAG Meeting will be held in May.

LEADER PROGRAMME

Completed project claims continue to be paid out to promoters and priority has been given to getting this funding out to provide stimulus in rural areas. Over €1.55m in project claims have been paid out to completed/part-completed projects to date.

Going forward there is currently over €3 million in the new LEADER projects pipeline of which over €1 million is for Rural Enterprise.

Fingal County Council continues to deliver the financial and administrative oversight responsibilities for the approval and drawdown of LEADER funded projects following the national transfer of the LEADER Article 48 Administrative Checks from Pobal to the Local Authority Sector. There has been no interruption to the delivery of the LEADER Programme or the Article 48 Checks as a result of Covid-19.

The Dublin Rural LEADER LAG welcomed the launch of 'Our Rural Future – Rural Development Policy 2021-2025' and looks forward to incorporating the many opportunities this presents for Rural Fingal in the years ahead.

Shoplocal.irish

EETCD continues to support the Shoplocal.irish website resource, as a COVID 19 response measure.

ENTERPRISE CENTRES

Occupancy rates at the Council's three enterprise centres at the end of April were Drinan 84%, BASE 88% and Beat 88%. The three Enterprise Centres currently support 62 businesses and 320 direct jobs. A number of businesses in the Centres had been accommodated with rent moratoriums to help them through lockdown cashflow difficulties but all businesses have now returned to normal rental arrangements. All tenant businesses are being assisted in accessing financial and non-financial supports currently available through COVID-19 support measures. All three enterprise centres have limited common area access at present in line with national Covid 19 guidelines and centre risk assessments. All staff in the centres are currently working from remote.

The Drinan Enterprise Centre is currently seeking interest from businesses and remote workers who may wish to avail of remote working options and facilities at the centre. Bespoke options or generic office fit-out options can be considered. A number of expressions of interest have been received which are being evaluated.

The renovation works in the Beat Centre are temporarily suspended due to the Covid 19 lockdown but will resume as soon as national restrictions allow. Funding for these renovations has been provided by the Dublin Rural LEADER Programme. When completed, the renovations will allow Beat to expand its offering in the areas of remote working hub space and flexible start-up workspace.

The BASE Centre in Mullhuddart has received confirmation of over €80,000 in facilities upgrades from Enterprise Ireland. These works will begin shortly when national restrictions allow and will include new remote working hub options and I.T. infrastructure upgrades among others.

LEO Fingal continues to help small businesses and start-ups through the impact of COVID-19 and Brexit, with a broad suite of practical support services. Some of the LEO Fingal highlights for April 2021 are as follows:

Evaluation and Approvals Committee

The latest Evaluation and Approvals Committee (EVAC) meeting took place on Wednesday the 28th of April. Three applications were approved for €60,000

worth of funding. This brings the total number of companies approved in 2021 to twelve, with a combined value of €270,945.

Digital Business Skills Webinars in partnership with Google Digital Garage







Local Enterprise Office Fingal, in partnership with Google's Digital Garage, is hosting a series of five free digital skills training webinars for small businesses in the Fingal Region.

The webinars take place on Wednesdays from the 14th of April to the 12th of May. These webinars have garnered great interest with over 1,300 bookings so far. The Fingal agreement with Google is now being rolled out to all LEOs in the country to coincide with the planned re-opening of the economy.

Since January 2021, 236 applications were approved (including applications from 2020) in the amount of €538,049.

Business Advice Clinics and Mentoring

Business Advice Clinics and mentoring continue to be offered online. We currently have a panel of over 60 Mentors who have a wide range of Mentoring skills including Finance, Business Management, social media, Sales and Marketing, HR, Food & Drink, Social Enterprise, Design & Craft, IP & Legal Services, Technology, Green, Sustainable & Circular Economy.

The Mentor programme is designed to match the knowledge, skills, insights, and entrepreneurial capability of experienced business practitioners, with managers/owners of small businesses who need practical and strategic one-to-one advice and guidance.

In April, 9 Business Advice Clinic days were held, offering advice to 82 Fingal Businesses. In addition, 15 companies received one to one general and COVID-19 related mentoring.

Start Your Own Business (SYOB)



In 2021, 83 Fingal participants have participated in 4 online SYOB Programmes.

The SYOB programme continues to be highly popular, with the first two dates in May booked out, and a third date added on the 18th to cater for demand.

Business Development Workshops

LEO Fingal continues its delivery of Training programmes to support SME and Micro Enterprise clients through the current challenges. In April 1,212 clients availed of online training across 17 different on-line courses.

The ever-popular Instagram course has been split into two half-day programmes:

to better cater for learners at different expertise levels. These workshops continue to book out.

Green for Micro Initiative

Green for Micro will allow businesses to avail of advice and technical support, covering topics such as:

Food Starter



In April, 4 Fingal Businesses participated in the 'Food Starter" Programme: a short, intensive programme designed to help those with a food idea or those at an early stage of starting up a food business (typically the first 24 months).

LEAN for Business



The LEAN Business Programme is designed to increase efficiency and drive companies' growth with by enabling the implementation of key LEAN principles. The programme includes training workshops and on-site mentoring. Two new LEAN cohorts will commence in May.

Microfinance Ireland COVID-19 Loans

LEO Fingal provides a loan scheme through its partnership with Microfinance Ireland. These are loans of up to $\leq 25,000$ with a six-month (0% interest) moratorium on repayments.

As businesses prepare for the reopening of the economy, LEO Fingal is actively promoting the availability of loans from businesses that have difficulty raising finance from their bank. Six applications have been processed, assessed and submitted to MFI to date this year.

Dublin Breakthrough Innovation Programme



Seven Fingal Businesses are currently participating on the Breakthrough Business Innovation Programme which brings established businesses through a disciplined framework to discover where the innovation potential lies in their enterprise and how they can capitalise on those opportunities.



Revised Signage for Dogs in Regional Parks & Open Spaces

Newbridge Farm Fencing

Phase 1 Refurbishment of the fencing at Newbridge Farm has commenced. The initial essential replacement investment amounts to €45,000, however it is planned to repeat this value as part of a second phase of refurbishment works.

There is also a separate fully certified 'Changing Places' toilet room that is being installed as part of a 4-location installation across Fingal.

Glebe Park Balrothery Wheelchair Accessible Footpaths

The construction of a new two section wheelchair accessible path is almost complete at Glebe Park Balrothery. The final addition of an anti-skid surface will be applied over the next week.



Mulhuddart Cemetery – Improvement Works

The Operations Department recently commenced improvement works in Mulhuddart Cemetery with the removal of the dividing wall to the newer part of the cemetery and re-landscaping of the area. This has opened the cemetery allowing clear views from the carpark. New Yew and Birch trees have been planted in addition to pollinator friendly plants such as African Lily (Agapanthus), Goldsturm (Rudbeckia), Feather reed grasses (Calamagrostis), Woodland Sage and Catnips (Nepeta) which attracts lots of bees. New benches have been installed giving families an opportunity to sit and contemplate. Further works are planned on the boundary treatment, gates and car park.








Emergency Tree Works

Following a Tree Risk Management Survey carried out by a Consultant Arboriculturist on behalf of Fingal County Council a number of trees in the Millennium Park & the Ongar area were identified as being dangerous and a health & safety issue to the public. Therefore, unfortunately the trees had to be removed. All works were essential to the health, safety and wellbeing of members of the public who frequent our Public Parks.






New Gully Cleaning Program

An extensive gully cleaning program was carried out by Castleknock Mulhuddart team in Meakstown and Finglas to deal with flooding in the area. Substantial work has taken place in the areas around St. Margaret's Road, Cappagh Road & Lanesborough. This work was additional to the annual gully cleaning maintenance programme in place in the Dublin 15 area.

Bin Management and Servicing

Due to Covid 19 restrictions there is a large rise in the numbers of citizens using outdoor public amenities. Cleansing Crews have increased the servicing of bins in the Dublin 15 area and bins are being emptied more regularly. Areas requiring additional wheelie bins is currently underway and compactor bins are being ordered.

There has been a huge increase in the disposal of household waste in and beside street bins in addition to large quantities of bottles being left beside litter bins for crews to collect rather than recycling them at nearby bottle banks.

5,500 square meters of Bee Friendly Wildflowers Sown in April

Following are photos of wildflower areas that were sown across the Howth Malahide area in April. The area sown with these Bee Friendly Wildflowers was 5,500 square meters.

The seed mixture consists of a mix of Annuals, Biannuals and Perennials, is a Bee Friendly mix and it has a four-to-five-year life span. The bee-friendly mixture Bellona means you can enjoy a kaleidoscope of colour in gardens or parks. In addition, it provides essential pollen and nectar for honeybees, butterflies and bumblebees.

This mixture consists of 40 different flowers, including Reseda odorata, Echium vulgare, Dracocephalum mol. var. Moldavicum, Eschscholzia californica, Gypsophila paniculata, Papaver rhoeas, Centaurea cyanus, Calendula officinalis, Cosmos bipinnatus, Leucanthemum and Helianthus annuus.

Litter and Anti-Social Behaviour

Unfortunately, excessive littering and anti-social behaviour has continued in some areas which was again exacerbated by the fine weather. Liaison with the Gardai continued throughout the month of April to deal with the Anti-Social behaviour being experienced.

Temporary green wheelie bins continue to be placed to combat littering. More additional capacity compactor bins have been ordered for the area and will arrive in the coming weeks. They have proven to be very successful due to their larger capacity and compaction action. Cleansing staff, manual litter picking staff and Park Rangers continue to be rostered to work additional overtime hours to cope with the issues.

Malahide Demesne Protection

Unfortunately, the overnight anti-social behaviour continued in April at Malahide Demesne and a Security Firm continues to carry out additional overnight on-site monitoring and patrolling to protect the Demesne and grounds. Incidents and littering have now reduced however the situation is being closely monitored in cooperation with the Gardai.

Malahide Demesne Good News

Planting of Tasmanian Tree Ferns on Keegan's Avenue

We have planted 250m of Keegan's Avenue in Malahide Demesne with 44 Dicksonia Antarctica tree ferns imported from Tasmania. The Dicksonia Antarctica tree ferns, looks the same today as it did in the prehistoric age. Detailed fossil records show that these plants date as far back as the Jurassic period. They rubbed shoulders with herds of dinosaurs, survived cataclysmic eruptions and witnessed the emergence of Man.

We have complimented these tree ferns by planting over 25 different varieties of Phormiums in groups along the avenue. Phormiums are endemic to New Zealand and Norfolk Island and have been used by humans since 30,000 B.C. The uses of the flax fibre (from phormiums) were numerous and varied. Clothing, mats, plates, baskets, ropes, bird snares, lashings, fishing lines and nets were all made from flax leaves. Floats or rafts were made out of bundles of dried flower stalks. The abundant nectar from flax flowers was used to sweeten food and beverages.

Planted between the Phormiums are 45 different varieties of Hydrangeas all underplanted with narcissus and Irish Blue Bells (Hyacinthoides non-scripta).



Additional Parking Enforcement measures continued a Countywide basis throughout March and April 2021, focusing on specific areas where reports of illegal parking have been recorded. The Fingal County Council Parking Control Bye Laws 2020 provide for additional parking enforcement of illegal parking throughout the County.

Speed Limits Project

Following ratification of the Speed Limit Review in February, two tenders were prepared. The first has been awarded and is for delivery of a large number of required speed signs to FCC depots. Manufacturing of the signs has already commenced with delivery of all signs expected by beginning of June 2021.

Fingal Bridges Rehabilitation Programme 2021-2023

A Single party Framework Tender was advertised in Etenders on 22nd of January 2021 for the procurement of consultants for the 2021 – 2023 FCC bridge stock repair programme. FCC completed evaluating the tender submissions. Next steps will be sending the successful and unsuccessful letters to the tenderers, 2 weeks stand still period, and the award of contract is estimated to be mid-May 2021.

Principal Inspections at 60 of Fingal Bridges

The 60 no. Principal Inspections on Fingal Bridges has been completed. and the Consultant provided the executive summary and PI reports last week of April 2021. FCC to review the report and PI's.

Emergency Works following partial bridge deck collapse, Balbriggan.

Work has been ongoing with the Consulting Engineers who carried out the emergency. structural assessments at several pedestrian bridges across the County following on from a partial bridge deck collapse in Balbriggan. The bridge continues to be closed off to the public whilst work is in progress. A surveying contractor has been appointed for the bridge works. The Contractor has also been engaged for site investigation and repairs at Vauxhall Street Footbridge in Balbriggan.

Bridge repairs at (4 bridges- One contract) Santry, Kilshane Cross, Ballough and Seatown Roundabout Bridges

The areas have been made safe and fenced off. Work on the preparation of the Bill of quantities and tender documents is ongoing.

Emergency bridge repairs (4 bridges- One contract) at Rallekaystown, Old Yellow Walls Bridge Malahide, Ratharten, Rowlestown

These four emergency bridge repairs were previously advertised and awarded to the successful contractor in November 2020. Works complete and snagging in progress.





9. Road Opening Licences

The Licensing unit continues to process and manage the licensing system for the County, applications are allocated by area for examination and conditioning which includes reviews of the existing carriageway, footpaths, cycleways and grass verges. Applicants submit temporary traffic management plans for review to ensure all works are carried out safely within the public domain. Road Opening licences are a cross functional process for the department and is essential for the asset management of Fingal County Council Road network.

222 applications have been received for licences during April 2021 and 164 granted.







T1 Application: The T1 is not a licence. It is notification of intent to perform works of high impact due to extent or complexity.

T2 Applications: An application to carry out works of moderate impact due to the location, extent, amount or duration of the work.

T3 Applications: An application to carry out works of low impact due to the location, extent, amount or duration of the work. A T3 licence requires a short application period and does not require a works programme notification.

T4 Applications: A notification of emergency works (as defined under legislation). Notification must occur at the time or as soon as possible after commencement and works must be carried out during a limited time period.

Road Closures

The Operations department has advertised notice that it intends to close the Old Corduff Road pedestrian way under the N3 and Snugborough Road between Main Street Blanchardstown and the Old Corduff Road in order to facilitate construction of the N3 Snugborough Road Interchange Upgrade, including upgrade of existing Snugborough pedestrian underpass, from 13th May 2021 to 12th May 2022.

Quality Control

The technical team continues to carry out quality control reviews on the quality and standard of works carried out by the utilities on Fingal's Assets. The review's identified a number of non-compliances which are currently been addressed by the associated utilities.

10. Water Services

Water production and distribution, wastewater collection, treatment & disposal continue to be provided as agreed in the Service Level Agreement with Irish Water.

The Council continue to have responsibility for the Storm Water Network

Storm Water (surface water) Network – Operations

Operation and maintenance of the stormwater network is ongoing, in line with Covid 19 restrictions. Works' summary:

 Castleknock Storm water network upgrade is almost completed, with the remaining work comprising of relining of the pipe on Main Street. A Contractor is currently being procured to undertake these works.

- Phase 1 (Advance works) to install a section of new stormwater (surface water) network in Ballyboughil is ongoing, in conjunction with FCC's Housing Department. An estimated 80% of the works are completed approximately 195m of a 300mm diameter storm sewer has been constructed, with 160m of footpaths reinstated following these works.
- The Storm water manhole covers and frames programme for replacing assets at the end of life is ongoing – Covers and frames were replaced at various locations in Balbriggan, Howth, Donabate and Dublin 15 area.
- Works were undertaken, directed by Operations Dept, to repair a section of collapsed pipe at the Jones Garden Centre in Donabate.
- Works to install 100m of at 225mm diameter storm water pipe on the Hearse Road.
- Other maintenance and minor works ongoing, including the checking and cleaning of surface water outfalls county wide.

Storm Water (surface water) Network – Projects

- Burrow Beach Surface Water Outfall Pipeline Repair



Planning Applications

There have been 393 planning applications received to the end of March 2021, 20 of these applications were invalid leaving a total of 373 valid applications. The volume of applications received by Local Electoral Area (LEA) is detailed in the table below.

Up to March 2021, 1 Strategic Housing Development (SHD) application was made to An Bord Pleanála for 198 units. 3 decisions were made by the board up to end of March 2021. Of these, 2 were granted, 1 in February and 1 in March (470 units). 1 application was Refused in March. There is a total of 1 SHD (198 units) currently in the formal application process.



Planning Decisions

A total of 370 planning decisions have been made to the end of March 2021. There have been 308 decisions to grant permission (83%) and 62 refusals of permission (17%). There have been 20 grants of permissions in respect of single house construction, 198 grants of permission for domestic extensions, 74 commercial/retail grants of permission and 8 grants of permission in respect of housing developments of which 4 relates to development of 2 - 20, 1 relates to development of 20 – 50, 1 relates to 50 -100 and 2 of which relates to development of 50 - 100 housing units.

Building Control Admin

Up to the end of March 2021, there were 32 Disability Access Certificate applications submitted, of these 14 have been granted and 4 are currently on time extension. There were 3 Revised Disability Access Certificate applications submitted, of these 2 have been granted. There were also 2 Dispensation/Relaxation applications submitted, of which 1 is currently on time extension.

There were 40 Fire Safety Certificate applications submitted, of these 12 have been granted, 2 were invalidated and 9 are currently on time extension. There were 10 Revised Fire Safety Certificate applications submitted, 2 were granted and 1 is currently on time extension. There were 4 Regularisation Certificate applications submitted, 2 were invalidated and 2 are currently on time extension. A total of 347 building control decisions were made up until the end of March 2021, this includes decisions that were made on applications submitted pre 2021 in addition to applications submitted in the first 3 months of this year. This is made up of 109 decisions to grant, 4 invalids, 3 amendments and 231 extensions of time.

Building Control Fire Safety, Disability Access, Regularisation and Dispensation/Relaxation Certificate applications can be submitted online via the new BCMS applications module. We are currently still accepting hard copy applications directly into the office, although there has been a marked change with agents utilising the online system more.

Transboundary Environmental Public Consultation

In accordance with the United Nations Economic Commission for Europe Convention on Environmental Impact Assessment in а Transboundary Context (the Espoo Convention) and Convention on Access to Information, Public Participation in Decision-making and Access to Justice in Environmental Matters (the Aarhus Convention), the Minister for Housing, Local Government and Heritage received notification from the Belgian Minister for Energy, Environment and Sustainable Development, of the intended extension of the operational life of the Doel 1 & 2 nuclear power plants and the associated nuclear safety-related improvement works, inviting Ireland to participate in transboundary public consultation. Details and documentation with respect to this transboundary public consultation are set out on the Council's website, the Council's Consultation portal and the Department of Housing, Local Government and Heritage website. A member of the public may make a written submission or observation in relation to the potential transboundary environmental effects of the project, by sending them to their local planning authority, to be received by close of business on Wednesday 23 June 2021 at the latest. Due to the highly specialised nature of this project, a restricted tender procedure in the form of a Suitability Assessment Questionnaire was published to invite submissions from economic operators with the relevant expertise and capability. Demonstration of previous experience in constructing synthetic sports surfaces conforming to World Athletics and FIFA performance standards form part of the assessment criteria. Following this, a shortlist of suitable firms will be compiled who will then be invited to the Design Build stage of the tender over the subsequent months.

The scope of requirements within the brief also includes led floodlighting, access and spectator path networks, perimeter fencing and accessible / blue badge parking in the vicinity.



Tidy Town Groups in Fingal

Fingal County Council are working with 23 Tidy Towns groups Countywide to develop a suite of local Biodiversity Action Plans. We have engaged Ecological Consultants to work closely with each group to develop a list of up to 10 Biodiversity actions per town or village. These actions will be centred around Education, protecting and enhancing Biodiversity, Identifying knowledge gaps & Nature Conservation within the Urban setting. The actions identified and agreed upon by all relevant stakeholders in the Biodiversity Action Plans for Tidy Towns project will be implemented over the next 3 – 5 years.

Strategic Policy Unit

Fingal Development Plan 2023 – 2029

Fingal County Council has commenced the review of the current Fingal Development Plan and preparing the new Fingal Development Plan 2023-2029. The beginning of an eight-week public consultation on the Strategic Issues Paper, was launched on 12th March.

An Information Booklet, summarising the seven themes contained in the Strategic Issues Paper, has been distributed to households across Fingal and can also be viewed at <u>www.fingal.ie/developmentplan</u>

The seven themes are: People and Place, Climate Action, Connectivity and Movement, Employment, Economy & Dublin Airport, Cultural Heritage, Green Infrastructure & Natural Heritage and Infrastructure & Utilities.

Four online consultation seminars were held in April for members of the public:

- Webinar 1 People and Place
- Webinar 2 Heritage & Green Infrastructure
- Webinar 3 Employment & Economy
- Webinar 4 Connectivity and Climate Action

These were well attended and featuring eight presentation and questions and answers on the topics raised in the Strategic Issues Paper. The recordings can be viewed at <u>www.fingal.ie/developmentplan</u>.

A Minecraft workshop will be held in early May and has been developed to encourage the participation of younger citizens. Information sessions with prescribed bodies are also ongoing.

The Development Plan process is scheduled to run for the next two years and will involve three public consultation stages before the final plan is adopted by Councillors in February 2023. The current stage, which is known as the pre-draft, sets out the strategic direction for the Plan and will form the framework into which objectives and policies at the subsequent stages will sit.

Vacant Sites Register

There are currently 9 sites on the Vacant Sites Register (VSR). These include 3 residential sites and 6 regeneration sites.

Invoices for the VSR levy have been issued with regard to VS/0016, VS/0117 and VS/0018 for 2019. The demands for payment for these sites had been delayed until recently as each demand was appealed to An Bord Pleanála, who did not make a decision on same until December 2020. The total amount being invoiced for the above sites is $\leq 1,344,000$. These sites will also be liable for the vacant site levy for 2020 for same amount. A demand for payment for the VSR levy has been issued for VS/0124 (Weavers Row, Clonsilla, Dublin 15) for $\leq 129,500$ and for VS/0119 (Lands at Howth Road, Co. Dublin) for $\leq 2,310,000$. A market valuation has been received (13/04/2021) for VS/0129. The site was valued at $\leq 450,000$. There have been notices of intention to place 4 sites on the VSR and these are being assessed at present. A number of sites throughout the county are currently being investigated for compliance with the VSR legislation.

Donabate UFP

Work continues to progress on the preparation of a Draft Urban Framework Plan (UFP) for Donabate Village Centre.

Sheridan Woods Architects and Urban Planners (SWA) are the consultants appointed to prepare the Public Realm and Traffic Management Strategy (PRTMS) which will form an integral part of the UFP. They provided us with a Draft Strategy Document in February 2021 with suggested public realm works for key sites within the village. We have reviewed this Strategy in consultation with other internal (including Departments within FCC Parks. Conservation, Water Services, Transportation) and have responded to SWA with feedback and recommendations. SWA will progress to the next stage in the coming weeks.

Consultants will also be appointed in the coming weeks to prepare AA and SEA screening for the UFP.

Heritage

The Heritage Officer will be presenting with David Dodd of the Dublin Climate Action Regional Office at the CHERISH projects' online international conference: Coastal Cultural Heritage & Climate Change on the 12th May 2021. The presentation entitled Climate *change adaptation – A national and local perspective* will outline the preliminary results of the Fingal's Cultural Heritage & Climate Change risk assessment.

Grants: The Heritage Office successfully applied for a total of €30,000 under the Heritage Council's *County Heritage Plan Projects Scheme 2021*. This is divided across three projects and will aid in the undertaking of the following;

- Fingal HeritageXClimate project 2021- the development a citizen science programme for the monitoring of our heritage assets in the face of Climate Change.
- Swords Castle: Digging History Publicationthe publication of the results of the community excavations at Swords Castle
- Dublin GIS Project 2021- working with the three other Dublin local authorities to update of the GIS dataset of licensed archaeological activity reports currently on heritagemaps.ie. It streamlines access to archaeological information for the archaeological, architectural, and planning professional, as well as for researchers and the general public.

Built Environment Division

1. Development Management/ Forward Planning (Water Services)

Development Management

- Our work as internal consultee on planning applications continues remotely and has resulted in 125 reports being prepared in March 2021.
- Pre-planning consultations During March, • staff from Planning (Water Services) have engaged in discussions with developers at pre-planning stage to discuss issues related to the provision of water services and to ensure the implementation of flood risk management and sustainable drainage systems on site. These meetings have also included discussions on drainage and flood risk management relating to economic development, including pharma and logistics development and also to strategic infrastructure project, such as Bus Connects & MetroLink.
- SHDs staff are engaged as internal consultees in discussion on approx. 20no. SHD applications
- The Built Environment Intern, Mai Yan, is working on a report for Building Regulations



Flood Risk Assessments/ Drainage Strategies

- FCC staff are currently managing the preparation of Surface Water Management Plans to inform Belcamp LAP, Dunsink Masterplan and the Balbriggan Masterplan.
- FCC staff have met with the appointed consultants and kicked off the development of the Strategic Flood Risk Assessment for the upcoming County Development Plan.
- FCC staff are working closely with the Consultants for the Barnhill LAP in order to develop this area with state of art SUDs complete with metrics to show the performance of the various SUDs systems.

Irish Water

- Staff continue to liaise with Irish water regarding existing constraints within the water/wastewater networks and identifying solutions to resolve.
- Connection and Developer Services staff continue to provide a planning review of water/wastewater connection applications on behalf of Irish Water with 24no. applications processed requiring Water Services planning during March with an average turnaround of 4 working days.

2. Building Control/Taking in Charge

Building Control

- COVID19 crisis Works continuing on a number of sites where buildings were close to completion and those sites authorised through legislation – Covid Commencement Notices. Also, we have seen a recent ramp up in activity in March/April as the lockdown lifted for house-building.
- BCMS CNs for 360 units received in March and 30 Completion Certificates processed. Building Control Site inspection for March is at 10% of new buildings. Almost all DAC, FSC and Dispensations are now coming through electronically via the BCMS applications module.
- Enforcement Compliance with part C moisture ingress remains an issue on several developments. Part B Fire Safety is also an issue on a high-rise development. Building control continued with inspections on sites which continued in lockdown where they had houses nearly completed. All non-houses must have fire Safety Certificates and Building Control issued a number of warning letters in relation to this requirement.

Taking in Charge

- Bremore Castle Mews was formally Taken in Charge at the full Council meeting in April – see photo below.
- We have 47 Developments with formal TIC requests and a further 281 developments on our system, of which 62 are likely to remain private.
- Phase 1 Tender for TIC works on the following estates - Chieftain's way, Martello, New Haven Bay is now evaluated and will be awarded to the winning Contractor shortly. Phase 2 Tender for TIC works – Drynam, is now on eTenders due back at the end of the month.

Dangerous Structures

- We currently have 45 active dangerous structures. There were 2 new notifications in March.
- On Portrane Beach, our Contractor is on site now, reinstating the compounds. Furthermore, the trees which were very close to the edge of the dunes have been removed by the landowner.



Transportation Planning

Fingal Coastal Way

The FCW project route options were published in April and were viewed by significant numbers through our social media channels and on our consultation portal, with a large number of submissions already lodged. Two webinars took place also which had in excess of 100 registered participants. Design and consultation with elected members and local residents and landowners will continue over the coming months to refine the various route options down to the Preferred Route option, which will be the subject of a further consultation in late 2021.



Snugborough Interchange Upgrade Project

Site clearance works, including vegetation clearance that took place under the supervision of a specialist ecologist to minimise wildlife disturbance, and compound set up are now complete and construction activity will considerably ramp up over the coming weeks. Works will now commence on utility diversions and the main 9C sewer diversion to allow commencement of the construction of the main structures. A newsletter relating to the project will issue in May and the Snugboroughinterchange.ie website containing information on the project will go live in May also. The contract was formally signed by the Chief Executive and BAM, in the presence of the Deputy Mayor, on 27th April.


Following the non-statutory consultation process in late 2020, the design and preparation of planning documentation and environmental reports has been ongoing. It is expected that the planning application will be formally lodged with An Bord Pleanála in May at which stage a further round of consultation will take place where interested parties can submit observations to An Bord directly.

Park Road Rush

This project has been designated as essential under the Government Covid 19 restrictions. The contractor has returned to site to complete outstanding minor work items. The project team would like to take this opportunity to thank the local residents and elected members, St. Maurs GAA and the school community of Gaeil Scoil Ros Eo for their cooperation and patience during these works.

Broadmeadow Way

Detailed design is ongoing on the Broadmeadow Way Greenway. RPS Consulting Engineers, Irish Rail and the Council project team have been workshopping design, construction and contract strategy with respect to the Malahide Estuary Crossing. The landward design work is also progressing with a view to expediting those elements of the project, as per attached schematic. The application for Foreshore Lease and License has been submitted to the Department of Housing, Local Government and Heritage. Options for improved connectivity between the greenway and the village centres of Malahide and Donabate are also currently being developed. Topographical survey advance contract is programmed to commence on Monday 26th April, with ground investigation contract to follow. This work will inform the ongoing design process and allow more clarity on expected timelines for this extremely challenging project.



Churchfields

Detailed design is complete for the Churchfields Link Road Project. Stage 1 of the two-stage tender process to procure a main works contractor is complete twenty submissions have been shortlisted to six candidates who will be invited to tender for the project. This project is programmed to commence on site in Q3 2021. The project team are working with the Architect's Department in relation to contract interfaces with respect to housing and parks and open spaces projects at Churchfields.

Hole in the Wall Road/Mayne Road Upgrade

One of the key pieces of infrastructure in this project is the new bridge over the River Mayne and the precast bridge beams and parapets were installed in recent weeks. The River Mayne which was temporarily diverted to facilitate the construction of the bridge, has now been rediverted back to its original course. Works are continuing on the roadway, cycle tracks, footpaths, utilities, traffic light crossings and flood defence structures, with the project due to be substantially complete in the Summer.



Sustainable Swords:

Work has commenced on the significant transport element of the Sustainable Swords project. The initial baselines studies are underway, with traffic data collection and review of existing studies ongoing to gain an understanding of how residents of Swords and its environs travel in and around Swords. Consultation has commenced with an initial informal meeting with the Councillors from the Swords area, where valuable feedback and insight was provided on some of the transport issues and concerns that arise in and around Swords.

Dunsink Feasibility Study

Work has also recently commenced on an Area Based Transport Assessment on the Dunsink lands to support a feasibility study to look at the potential to develop the lands, as per FCC Objective Blanchardstown 13. An internal workshop took place in recent weeks, with various other Council Departments to discuss the potential opportunities and constraints. The ABTA will consider sustainable and public transport, roads and multi-modal interchanges from existing and proposed infrastructure.





Housing Asset Management Report

Energy Efficiency/Retrofitting Programme (Housing Circular 8/21)



The newly revised 2021 Energy Efficiency Retrofit Programme is the first of a ten year programme which is expected to grow to meet the Programme for Government retrofit commitment. This revision will require local authorities to move to a 'deeper retrofit' programme, thus building on what has been completed in previous years. The revised programme provides for significant upscaling in the level of funding available and focuses on ensuring that the fabric of the home is upgraded and an energy efficient heating system is provided.

An initial national preliminary allocation of \notin 35m which is calculated on a stock percentage basis is being made available immediately. The final approved allocation for Fingal County Council is \notin 1,759,475 with a target of 65 properties to be retrofitted to a B2/Cost Optimal standard.

Planned Maintenance Programmes

Boiler Servicing

The Council provides an annual boiler servicing facility, including all maintenance and upgrade works, for a nominal fee of \in 3 per week to participating tenant. While the 2021 servicing programme was suspended at the beginning of the year, a review of the current Covid restrictions and confirmation of the essential nature of this service, the suspension has been lifted and the programme recommenced in early March 2021. The programme is released in batches throughout the course of the year. To date 8 of 20 batches with a total of 1,774 properties have been provided to the Contractors and servicing is progressing well.

Cyclical Maintenance

This programme provides for external painting and joinery repairs to council housing stock which currently operates on a 6/7 year cycle. Painting works are currently ongoing in the Wellview Estate and will commence in the North County in the next phase. The remaining estates will be completed as part of the current programme between now and the summer of 2021. (listed below: Batch F & G).

Social Housing Applications

The Minister for Housing, Mr Darragh O'Brien TD, gave direction through the issuing of Circular 11/2021 of the changes to the Social Housing Assessment Regulations which have come into operational effect from **April 19th 2021**.

The main changes introduced by the amending regulations provide for a revised Social Housing Application Form and the removal of the CAP on percentage increases on the income eligibility threshold in respect of each household member aged less than 18 years.

Medical/Welfare Update

With effect from **April 19th 2021**, an application form for those wishing to seek priority on Medical/Disability Grounds has come into effect.

It is available to download via <u>www.fingal.ie</u>, or, upon request a hard copy can issue to an applicant by way of post.

The form is called the **HMD-Form 1 Disability and/or Medical Information Form**, and has been brought into operational effect following the implementation of Circular 11/2021 Social Housing Assessment (Amended) Regulations 2021.



About this form This form is for anyone who is applying for social housing or a social housing transfer due to a disability or medical grounds. The information provided will be used to assess if priority status should be awarded to an application.

The Housing Support Team are continuing to progress applicants' requests for medical priority, with the continuance of virtual medical/welfare meetings in collaboration with the HSE, and meetings have continued through March and April, and are being scheduled for May.

Choice Based Lettings

Choice Based Letting (CBL) is an approach used for allocating dwellings which allows housing applicants to express an interest in being considered for the allocation of designated Social Housing Units. The Lettings team are currently working to provide a range of dwellings to be allocated under Choice Based Lettings.

Fingal County Council will be providing information on our website, from Tuesday 4th May 2021, on a selection of developments and individual units which have been designated for allocation using this approach. Expressions of interest will be accepted for the initial period up to 5pm on 12th May, 2021. Access to the Choice Based Letting (CBL) system is via the Council website at https://www.fingal.ie/choicebasedlettingscheme.

A letter has issued to all applicants eligible for social housing, an advert has been placed in the 3 local papers in Fingal. We are also using our social media to inform applicants of the available dwellings.

The first developments on the website, managed by Respond! Housing, is in the following locations:

- Charlestown, Finglas
- Carrs Lane, Balgriffin
- Northwood, Santry

It is expected to include additional dwellings over the coming weeks across all delivery streams and in other areas of the County.


The HAP Team in Fingal County Council continues to operate as normal with the public making contact through email and phone during **COVID-19** restrictions. Additional resources have been deployed to assist with the volume of calls/emails from those who have been affected by the current crisis (in relation to a change in income).

Since its inception in Fingal County Council in 2017, the HAP team have set up over 2,700 tenancies.


Homeless Services

The Council's Homeless Team continue to engage with those experiencing homelessness to offer advice and support. Homeless Assessments were conducted over the phone during the Level 5 Public Health Restrictions which were re -introduced on 1st December 2020.

In April 2021 there were 49 new homeless presentations, comprising 27 families and 22 singles/couples.



During April 2021, 34 households, comprising 19 families and 15 singles/couples, exited homeless circumstances into various forms of social housing support- including into private rented tenancies under Homeless HAP.



Homeless HAP accounts for 26 of these tenancies.

Traveller Specific Supports

Covid-19 Continued Support

Measures have continued within Fingal to ensure that Traveller families receive as much assistance as possible during these unprecedented times, and particularly having regard to relevant and current public health guidelines and restrictions levels.

Daily site visits by Housing Inspectorate and Senior Council Officials are continuing with due care to maintain public health guidelines while checking on vulnerable tenants and advising on the continued supports available. In addition, the Council's designated Social Worker Service for Travellers continues to make regular contact with the most vulnerable, in order to assist with additional needs arising from the current circumstances.

Senior Officials are engaged on an ongoing basis with the HSE pertaining to Covid Public Health Guidelines.

Illegal Occupation of Lands

Incidents of illegal occupation of both Council owned lands and privately-owned lands has been a recurring issue within the Fingal administrative area. Statutory Notices were served on a large group occupation at Portrane WTP and within the Dublin Enterprise Zone who have since vacated the sites. The Housing Department continues to engage with our colleagues from Economic Development, Environment and Operations Departments to ensure all appropriate actions are taken to prevent incidents of illegal occupation and deal with accordingly when they occur.

An Inter-Agency Task Force is proposed as the ramifications of an illegal occupation fall within the remit of several other statutory agencies outside of the Local Authority.

Traveller Accommodation

A programme of works in relation to the refurbishment upgrading and of existing accommodation on specific sites is currently in development with the County Architect. Preparation and site specific works are continuing in order to progress Traveller Specific Accommodation at Stockhole Lane and Cappagh in accordance with the Traveller provision of the Accommodation

Programme 2019-2024. Site works at Stockhole lane are progressing well with significant progress made in recent weeks and an approximate completion date in July 2021.

General site maintenance has continued on all Traveller Specific Sites throughout every level of Covid restrictions, however there have been instances where the progression of works have been hindered by the actions of some residents which has prevented access to sites and progression of works.

The decommissioning of Collinstown Halting was finalised in April and the site/land is now under the remit of the Dublin Airport Authority. All of Traveller families who resided on the site have been allocated alternative accommodation.




Decommissioning of Collinstown Halting Site

Housing Welfare Service

The Social Workers attached to the Housing Department are available to support vulnerable tenancies and to work with housing applicants who have medical/welfare needs.

In response to **Covid-19**, the Housing Social Workers have been actively engaged with their most vulnerable cases at this time providing support, information and inter-agency linkages when and where required. Tenants were identified by the Social Workers and Housing Inspectors who may be considered particularly vulnerable during **Covid-19** and follow- on action has been initiated through various mechanisms including the Fingal Community Response Forum.

Maintenance Requests



During Level 5 Restrictions essential maintenance works such as electrical, water and heating are being complete with all other non-essential maintenance requests being postponed pending easing of restrictions. With planned lifting of restrictions imminent in the second quarter of 2021, progression of any outstanding requests, not of an urgent nature will be prioritised.

Anti-Social Behaviour/Inspectorate Unit

The ongoing management and sustainment with regard to social tenancies and good estate management falls within the remit of the ASB/Inspectorate Unit. Alleged breaches pertaining to tenancy agreements are investigated and pursued in accordance with housing legislative guidelines.

There are occasions when the vulnerabilities, complexities and heath related issues associated with a tenancy require tenancy sustainment intervention and supports. Ongoing case management and review with a variety of external agencies, including Approved Housing Bodies, An Garda Síochána, Tusla and the HSE is a necessity to ensure all agencies work collaboratively with a view to achieving best outcomes.





Fingal County Council Community Centres

A condition survey of all Fingal County Council owned community centre has been carried out by the Architects Department on the instruction of the client department -Housing and Community.

15 Fingal County Council owned facilities were identified as needing work under 5 core headings; Upgrading, Emergency Work, Legislative Compliance, Capital Projects and Insulation. The Centres are

- Corduff Resource Centre
- Mulhuddart CC
- Blakestown CC
- Rush Youth Facility
- Mountview RC
- St Macullins

- Corduff SS
- Mountview CC
- Fortlawn CC
- Parslickstown House and Hall
- Donabate Portrane CC
- Mourne CC
- Castaheany CC
- Diswellstown CC
- Baldoyle CC

The condition survey reports have been reviewed by the Architects department who has put a plan in place to prioritise safety and emergency works in these centers. An initial budget of €2m has been assigned to the programme in the Fingal Capital plan. Five Centres have been prioritised for works identified in the condition surveys – Corduff RC, Donabate Portrane CC, Baldoyle CC, Mulhuddart CC & Mourne Estate CC.

The tender for Integrated Design Team was completed to oversee all the required works in the five selected facilities and one library building. Work has commenced by the Design Team to prepare tender

Packages for the appointment of Contractors to carry out the works. The works will be procured in Q3 and commenced in Q4 2021 with a planned completion date in Q1 2021.

In parallel, an integrated design team has been engaged to design, bring to planning, tender and oversee the construction of two new community Centres at Meakstown and Baldoyle.

It is proposed to bring the first of these at Meakstown before Council for planning in Q3 2021.

Fingal Communities in Focus Webinar

Work is well underway in preparation for the Fingal Communities in Focus Webinar, being hosted and organised by the Community Development office. The webinar, on the morning of May 26th is aimed at Resident Associations, Community Groups and Tidy Towns groups all over the county. The event will provide a platform for a lively discussion on how best these groups can learn from each other and discover the many supports available from the Community Development Office and other FCC Departments to support the great work they are already doing in their communities. Filming of three showcase videos took place in April which will be aired at the event. Inputs from the Mayor, Cllr David Healy and FCC CE Annmarie Farrelly have also been completed, in partnership with film-makers Coalesce. Boru Court and Castlegrange Estates, Swords

The Community Development Office is supporting residents' groups in two Fingal estates in Swords, Boru Court and Castlegrange with community enhancement projects. New and existing groups in each estate have re-organised, safely, to carry out community works in partnership with the Community Office. Boru Court has adopted a patch at the entrance to the estate and is planning further projects over the summer. All activities have been carried out with full Covid compliance and social distancing. Castlegrange residents will install a name stone funded through the Community Activities funding scheme later this month. The residents have identified two further projects, tackling an open space and graffitied wall, and hope to access support from the environment department with these. Both groups plan to take part in the forthcoming Communities in Focus Webinar, happening in late May.





Corduff Cuppa Chat

The Community Development Office is a member of Corduff Task Group along with TUI, Empower, Corduff residents, Corduff Sports Centre, Foroige and Corduff Resource Centre. This initiative started on the 23rd of March for four weeks to support the residents of Corduff and the surrounding areas to engage with one another on a weekly basis to provide support over a cuppa and due to its success has now been extended until May. Lots of residents coming on to chat about what is happening for them and sharing their lockdown stories, tips for hobbies etc.



Mulhuddart Photography Project

Mulhuddart Photography Project was developed and funded by Fingal Community Development Office in collaboration with Healthy Ireland and Mulhuddart Community Centre. This initiative began on the 22nd of April and aims to mitigate the effects of social isolation and loneliness and the adverse effect on physical and mental well-being through photographic images. This 8-week photography course with guest speakers will give viewers insight into local community life in Mulhuddart. It supports the community of Mulhuddart to stay connected, connectivity. enhances well-being and The participants will engage with online learning so that we can continue to work and engage with our communities in a virtual way during government restrictions due to Covid 19.



Balbriggan Integration Forum

The funding sub-group of Balbriggan Integration Forum held a series of meetings to advance an application to the Department of Rural and Community Development for a Community Development Pilot Programme. The application was made for 3-year project funding and totalling €390k. The application included the resourcing of a programme manager and youth resource worker position and associated programme costs. The application was made jointly between Balbriggan Integration Forum and Cairde and required a coordinated effort from a range of other supporting organisations that included Fingal Children and Young People Services Committee and the Fingal Community Development Office of Fingal County Council. A decision on which projects have been successful will be made by the Department by the end of April 2021.



Strategic Unit:

PPN Linkage Groups

Linkage Groups are the thematic networks at the core of the PPN. They are the main vehicles through which the PPN advocates for the Community.

Public Participation Networks Handbook

This Handbook sets out the best practice now in place across PPNs across all 31 Local Authority areas. As the PPNs continue to grow and change with the needs of their Member Groups and communities, the Handbook will also change with those needs. Fingal PPN setup a working group to oversee this piece of work. The PPN handbook review report is currently being finalised for consideration by the Secretariat.

Free Insurance for Covid 19 Volunteers

To support the community nationally, BHP Insurance has provided an umbrella insurance policy for new groups set up in each County to cover the fantastic work being carried out by all the volunteers involved in response to Covid 19. This insurance policy is being provided free of charge by BHP. Fingal PPN renewed Insurance policies again this year through BHP Insurance. This Insurance is offered for volunteer groups who had no Insurance or whose Insurance Company did not insure them for this type of volunteering work. This is a huge asset to the groups.



Summer Projects

Fingal Community Development Office called for expressions of interest from groups intending to run a Summer Project in February 2021. Currently the Community Development Office team are supporting over 30 summer projects in their application for funding, safeguarding training, garda vetting and programmed planning. Application for funding will be present at the Council Meeting in June for approval.

Funding Support

The Community Development Office supports volunteer led community groups and community services in either their application funding or through the direct provision of funding. The office works through the following

The Sláintecare Report in the Department of health, through the Healthy Ireland Fund (HIF) has allocated funding for a new initiative the "*Community Resilience Fund*" allocated to Local Authorities.

The Age Friendly Fingal team working in collaboration with the local community groups established the opportunity to source and allocate funding aligned to the themes '*Staying Connected' and 'Managing Your Mood*' through the funding of 18 ACORN Tablets for an Age Friendly initiative for ageing local citizens.

The Donabate Portrane Active Age for All will receive 10 ACORN Tables under the initiative "Creativity in Older Age".


The Castleknock Community Centre will receive 8 ACORN Tables to connect and develop technology skills for local Seniors.





Comhairle Na nÓg:

- On the 12th of April 2021 Fingal Comhairle na nÓg participated in an in-depth discussion group on Climate with the Department of Children, Equality, Disabilty, Integration and Youth.
- 2. Comhairle members continue working on their main topic of mental health for 2021. They have completed a survey to gain feedback from the Young People in Fingal on the effect of Covid 19 on their mental health in areas such as school life both school and home based experiences, lockdowns. The results from this survey will inform their workplan for 2021.
- Comhairle are continuing to work an animation for Climate Action which will go live as part of Cruinniu na nOg the 12th of June in colloboaration with Fingal Economic Development Department.





Community Facilities Unit:

"Bringing inside - out" in FCC supported Community Facilities

Community centres although not open to the public have been working in the back ground providing a range of supports to the local community. They have had to look at new ways to engage with communities in a safe way by supporting a range of on-line activities, linking with communities through phone calls and providing back up support to key agencies and service providers while promoting activities outdoors. Community facilities are now looking to provide outdoor spaces to support community activities which in turn will support summer project / activity programs and encourage small community groups to meet for activities such as outdoor yoga, pilates, art therapy and gardening programs. The Community Development Office is supporting funding applications under its activities funding stream to purchase a range of hard-wearing pop-up gazebos that can be used for a wide range of programs and initiatives outdoors. The Community Development Office has negotiated a reduced rate with the provider to ensure that each community facility that applies receives high quality equipment that is weather resilient. This equipment will be made available to community groups registered with the community centres who can provide activities within government guidelines.



Community Development Pilot Program 2021

The Community Facilities Management Support is working in collaboration with the steering group of the Mulhuddart Priority Task Group and has submitted a funding application to the Department of Rural and Community Development for the new pilot Community Development Program. If successful, a new community development project will be established in Mulhuddart which will spread across to Tyrrellstown and Mountview. The proposed project will see the implementation of several key actions identified by the Mulhuddart Priority Task Group as part of their community consultation. It is envisaged that all key agencies and stakeholders will collaborate to trial community development initiatives that will aim to address social exclusion, promote greater around climate action, provide awareness opportunities to engage with unheard voices and address inequality in these marginalised communities.

The project has the potential to receive funding for up to three years and will be hosted by Parslickstown House Management CLG. It aims to facilitate an empowering collaborative approach that will reach out to those not currently engaging in their local communities through the introduction of a range of projects and initiatives that will aim to address racism, support minority groups and promote and encourage communities to be proactive in addressing positive change in their communities.

Fingal Community Development Office - Spring Summer Masterclass Training Programme.

The Masterclass Program was established by the Community Development Office in conjunction with TU Blanchardstown to provide training and support targeted at the management and operation of community facilities. This provides training at an introductory and intermediary level to managers and volunteers involved in the day to day management and operation of Fingal County Council supported community facilities. This initiative played a key role in the establishment of the Fingal Community Facilities Network.

The schedule of master classes for Spring Summer are as follows:

- Role of a Chairperson this is aimed at existing and aspiring chair persons
- Recruiting new board members this is a huge challenge for voluntary management committees this training program aims to set out several alternatives to board recruitment and looks at developing a strong recruitment process for board members.
- Introduction to Strategic Planning- aims to set out a standard framework for community facilities so they can monitor and evaluate their work and its effectiveness
- Introduction to Risk Management explores challenges experienced by voluntary board and helps to mitigate risk
- **Developing an effective annual report** establishes a frame work for the compilation of writing a winning and effective annual report
- Understanding and preparing budgets the key to any good project is strong financial management and realistic budgeting. This course aims to provide guidance to volunteers and staff responsible for managing budgets.

The above training programs will take place between April – June and will be delivered over zoom. These training sessions will assist board members, directors, chairpersons, managers and staff in the Fingal Community Facilities Network to improve service delivery. In the first quarter of 2021 - 78 people have engaged in training as part of the master class program.

Sports Office:

Tyrrelstown Football Club

The Community Sports Hub Officer based in Tyrrelstown and FAI Development Officer responsible for Tyrrelstown have developed a strategy to set up a community football team in the area. While work has been taking place over the last few months (and continues to take place) around the recruitment and training of volunteers, talks are at an advanced stage with the FAI regarding the delivery of an FAI Community Summer Camp in the area to take place in August 2021. This will see 90 children take part in the week-long camp at a reduced price and delivered by qualified coaches. This camp is part of the strategy to kickstart the beginning of a vibrant football club in the area which will be supported in its infancy by both the FAI and Fingal's Sports Office.

Fingal HomeFit Sessions

Three new Fingal Home-Fit live exercise sessions facilitated by Fingal County Council Sports Office and delivered by qualified personal trainers and exercise professionals will start in May. To date over 3,000 people have subscribed to the HomeFit Sessions.

MarathonFamilies

We have started work on developing this year's MarathonFamilies programme, which is a running/walking programme to encourage families to complete a Marathon in 4 weeks during June. This programme provides families with a safe, fun and healthy activity and encourages families to exercise together, achieve a goal and ultimately improve the overall health of the Family unit.

Funding & Grants

The Sports Office have increased the promotion of grants (pic below) available to sports clubs and groups who focus on promoting sports and physical activity. All sports clubs/groups on our database have been contacted, communications have been initiated through the Sport Development Officers and a social media plan to reach out to as many sports clubs/groups as possible about the opportunity for funding has been devised. Normally approximately 10 clubs receive Sports Equipment Funding in any given year and to date in 2021, 22 clubs have applied for Sports Equipment funding. To date 10 clubs have been successful and it is expected that this will increase in the coming weeks as further applications are processed.



The focus of such fora is to share ideas, to develop better communication, to ensure clubs are supported and aware of all potential grants and to help develop and grow clubs to enable them to better serve the communities they operate in. The first forum eetings are due to take place over the last week in May.



Climate Action:

The Climate Action and CARO teams facilitated a Citizens conversation which was organised by the Environmental Linkage group of the PPN as part of a series of conversations happening across the country connected to the government's National Dialogue on Climate Action and the development of its 2021 Climate Action Plan. The evening event was well attended, and feedback provided to the Department of Environment Climate and Communications. Litter Management Animal Welfare Services Waste Enforcement Flood Schemes Active Travel

The Fingal County Council Development Plan review is underway, a strategic issues paper has been drafted and put out to public consultation. A series of webinar events were held recently, and climate action featured as a central and cross cutting theme for consideration by the public.

Action 165 of the national Climate Action Plan 2019 states that 'Each local authority will identify and develop plans for one Decarbonising Zone. Decarbonising Zone's can be described as spatial areas identified by the LA in which a range of mitigation measures can co-exist. A cross departmental team has been formed to consider the requirements, identify potential areas and work towards selecting an area. This work is ongoing.

A Sustainable Energy Community (SEC) information session was hosted by Codema on 29th April. This session introduced the SEC Programme to the region's elected representatives (from Dublin City, DLR, Fingal, Kildare, Meath, South Dublin & Wicklow), and described how the programme worked, Codema's role as County Mentor coordinator, and the role of the Dublin Local Authorities as Lead Partner Applicants.

The SEC programme is a SEAI programme. The Council is working to promote, facilitate and support the programme and low value grants will be made available to SEC's once established and up and running.



Sustainable Energy Communities information evening for councillors

Funding: Codema have lodged an expression of interest to the Government Climate Action Fund (CAF) on behalf of the 4 Dublin Local Authorities for grant funding for an Urban Solar Farm across suitable LA rooftops potentially piloting Photovoltaics with Green Roofs. If successful, this will include certain Fingal libraries and community centres. Codema have been successful in drawing down funding to produce an Energy masterplan for the Dublin region on behalf of the Dublin LA's.

Environmental Awareness:

GRANT Launched: Anti-Litter Anti-Graffiti Grant launched. Community groups (Tidy Towns, Residents and estates groups, men's sheds, sports and marine groups, schools etc) can apply for funding for projects, further information at: <u>https://www.fingal.ie/anti-litter-anti-graffiti-fund-</u> 2021

Adopt a Patch kits have been distributed to 50 individuals, groups and schools in Fingal, these include litter pickers, gloves, bags and high vis.

Green Schools online flag assessments and presentations are ongoing.

In cooperation with Community Department, the Environmental Awareness Officer delivered presentations to the Fingal Age Friendly Alliance and Age Action Fingal groups. Wildflower masterclasses and Sustainable Gardening courses have been completed. Over 70 community groups participated and feedback has been very positive.

Sarah Fogarty from Malahide Community School won the Best Evening Wear category for her creation in the secondary schools ReLove Fashion Competition. Our Environmental Awareness Officer presented the trophy to Sarah this week at Malahide Community College. The Fashion Up-cycling competition raises awareness the environmental cost of fast fashion and seeks to address textile waste.



Water Quality Protection

Bracken (Matt) River, Balbriggan Water Quality Report

"Biodiversity Management Plan & Point Source Investigative Assessment"



A report was commissioned by Balbriggan Tidy Towns Committee with the assistance from Thomas Carolan, Water Community Officer (LAWPRO). The area of the River Bracken that was investigated is shown in the photo above. Funding for the plan was jointly provided by Fingal County Council through Our Balbriggan Rejuvenation Project and LAWPRO.

The scope of the project

- Desk study & background information reviews
- Point source investigative assessment (with stream walk)
- Wet and dry weather surveys
- Samples of discharges
- Samples upstream and downstream
- Habitat and biodiversity assessment
- Habitat Mapping
- Field survey of habitat and biodiversity
- Samples of the macroinvertebrate community

The report identified a number of biodiversity stressors;

- 'urban pressures' and 'hydromorphology'
- Barriers to fish passage (e.g. weirs part of Balbriggan's industrial heritage)
- Stormwater overflows
- Urban run-off
- Misconnections 6 no.
- Dumping (in-stream)
- Invasive species
- Scrub encroachment



Several recommendations have been provided in the report and the findings have been shared with relevant staff responsible for those areas. Fingal Water Project:

Fingal County Council and The Technological University Dublin (TU Dublin) established a water research initiative known as the **Fingal Water Project** to investigate the challenges of managing freshwater pond systems in the Fingal County area. This challenge is being tackled, through the use of floating islands with vegetation that absorb the pollutants present in the water. To measure the effectiveness of this approach plant growth and water quality are being monitored over the period of the study.

The chemical composition of the plants growing on the floating islands will be assessed as how effectively they absorb pollutants. The research team are also assessing the microbial populations in the ponds to identify the nature of microbial communities. This gives a strong signal on the general health of the waters. Monitoring will, over time, determine if contamination is present and continuous or sporadic. The TU Dublin team will also use microbial source tracking to evaluate the source or pathways of pollutants. This type of insight, combined with the existing data on the effectiveness of the floating island plants to absorb pollutants and the spatial data obtained through multispectral remote sensing will greatly aid the management and decision making process in optimising water quality control and in protecting public health. The project is ongoing with an expected completion date in late 2022.



Bathing Water Quality

The EPA have published the Bathing Water Classifications for 2021 Season on their website <u>www.beaches.ie</u>. The classification is based on water quality data for the previous four years (2017-2020). The full EPA report is due to be published in early May.

Three beaches have improved ratings. Two beaches have declined in rating due to diffuse pollution associated with Storm Francis in 2020:

- Balbriggan bathing water is now at "Poor" status
- Loughshinny which has dropped to "Sufficient" rating.

A Management Plan for the beach at Front Strand, Balbriggan has been prepared and submitted to the EPA. A temporary "All season" notice "advice not to swim" will be in place at this bathing water for the start of 2021 bathing season.

Waste Enforcement

Fingal County Council's Waste Enforcement Unit assisted the Garda Divisional Crime Task Force in another successful search operation at a metal recycling facility in North Dublin. A multi-agency approach was used with assistance from Revenue, Customs, National Trans frontier Shipments Office (NTFSO) and the Waste Enforcement Regional Lead Authority (WERLA). The search was part of an ongoing investigation by Gardai into the theft of catalytic converters throughout the Region. A total of 2,150 catalytic converters and 14 drums of milled catalytic converters, with a combined value of €2.2 million were seized and a man in his 20's was arrested for offences contrary to Section 17 of the Criminal Justice (Theft and Fraud Offences) Act, 2001. The theft of catalytic converters has become more popular in recent years as the move to a cashless society has meant fewer opportunities for thieves. Each converter can be sold on the black market for between €300 and €600 and more for high-end brands.

This comes on foot of a similar operation where the Waste Enforcement Unit assisted the Garda Divisional Crime Task Force and other Agencies (Customs, Revenue) in a search whereby 300 catalytic converters were seized at a metal recycling facility in the south Fingal valued at €150,000. The search was carried out by Dublin Metropolitan Region (DMR) Divisional Crime Task Force and was based on intelligence gathered during recent investigations on the theft of catalatic converters throughout the Region.





RMCEI: National + Local Enforcement Priorities -Inspections for 2021



RMCEI Inspection Plan 2021

Significant work has been undertaken in relation to the RMCEI Inspection Plan 2021 during Q1. In relation to waste enforcement regular patrols are being undertaken with assistance from Local Gardai at known blackspot areas where illegal dumping and illegal End of Life Vehicle activity has been an issue in the past. Work continues in relation to the End of Life Vehicle Project with several inspections undertaken during April at suspected illegal breaking yards. Clearing and closing down these illegal sites is a key priority for 2021 to build on the good work completed last year where over 30 ELV sites were closed and hundreds of cars removed for recycling/disposal at authorised treatment facilities.

Waste Complaints

A total of 65 waste related complaints were received and investigated during the period January – March 2021 involving 3 waste enforcement officers and over 110 working days. The majority of complaints related to backyard storage of waste and burning of waste (70%) while illegal dumping and fly-tipping accounted for another 20%. Awareness and education around the management of domestic waste in a sustainable and environmentally safe manner is crucial to ensure all households participate in waste collection service as per the waste presentation byelaws and use all three bins (black, green and brown) to manage their waste. A new public information campaign called **"Stop Dumping on Us"** is currently underway to help raise awareness and to encourage people to report incidents of illegal dumping and illegal waste collection in their area. A podcast and video highlighting the key issues around littering and illegal dumping was also produced to make people aware that fly-tipping is an issue. If found guilty of dumping waste illegally or providing waste to an illegal waste collector a householder can be fined up to €5,000 in the District Court and receive a criminal conviction.

Illegally dumped waste costs Local Authorities hundreds of thousands of euro each year, money which could be better spent on providing better services to businesses and Local Communities. To report unauthorised waste collectors or dumping contact **environment@fingal.ie** or **Tel: 01 8905000**.



Litter Management

Routine Litter Patrols

A total of 264 routine Litter Warden patrols were carried out between Monday to Friday during April.

Additional Litter Patrols

In addition to the planned routine litter patrols, the Litter Wardens carried out an additional 48 Patrols across the county in a direct response to the elevated levels of footfall during the current Covid restrictions. These patrols were targeted at business premises providing take away services and were primarily to make them aware of their obligations under the Litter Pollution Act, including providing waste bins at their premises and keeping the front of their premises litter free.

In addition to the additional weekend patrols, a Litter Warden has been assigned, on a temporary basis to patrol River Valley Park. He has met with various members of resident groups including tidy towns and discussed issues around littering and illegal dumping.

Special Initiatives

April saw the launch of the "Don't Dump On Us" campaign designed to highlight Littering and Illegal Dumping. This campaign involves podcasts and videos of staff members from the Litter Management and Waste Management Sections, including Litter Wardens.

A Littering App began testing in April and it is hoped to roll it out to all Litter Wardens during the month of May. This App will produce maps of littering blackspots and enable the efficient allocation of resources within the Litter Management Section, including when permitted covert CCTV.

Animal Welfare Services

Dog Warden Patrols

Additional Dog Warden patrols continue to be provided during the current Covid restrictions. These additional patrols are targeted at beaches, parks, open spaces and urban centres.

Procurement of Dog Warden and Dog Shelter Service

The submission date for tenders in relation to the provision of a Dog Warden services was 4th May 2021 and the submission date for tenders in relation to the Dog Shelter Service is 10th May 2021.

Horse Welfare Project Dunsink Lane

The horse welfare project facilitated by the Council in conjunction with the DSPCA and the Department of Agriculture is continuing. Regular welfare visits by the DSPCA to the Landfill are ongoing and clinics to begin to microchip and register all animals on the landfill have commenced.

When Covid restrictions permit, a clinic to castrate the stallions on the landfill will commence to reduce the levels of indiscriminate breeding among the horse population on the landfill.

Active Travel Section


Bleeper Bike Share Scheme -

Bleeper's bike rides have almost doubled in the last month. From 1097 rides in February to 2085 rides in March. This is a 487% increase in rides on the same period in 2020. It was at this time last year when the Covid 19 pandemic arrived in Ireland and popularity of cycling began to escalate. Sundays were the most popular days for rides and accounted for 17.55%, followed by Wednesday which recorded 16.88% of rides. Bleeper had 87 bikes in operation in Fingal during March, 7 more than the month of February.

Howth remains the most popular location to hire a Bleeper bike and high levels of activity continued along coastal routes during March, with a longer duration of bike hire.

We will continue to promote usage of Bleeper through our social media platforms.

The hire of Bleeper's bikes continue to be free for all Fingal staff.




Bike Racks

Bike racks will continue to be installed throughout the County during 2021 as cycling's popularity continues to grow. Fingal County Council are currently rolling out the installation of more than 400 new bike racks around the county. The Active Travel Department are also currently investigating suitable locations where bike racks can be placed in the future.

Schools looking to encourage their students to cycle may still apply for bike racks and can do so by completing the online application and submitting it to <u>Road.Safety@Fingal.ie.</u>

Applications will also be accepted from Community Centres and Sports Clubs.



Cycle Bus

Four schools have submitted expressions of interest in starting their own Cycle Bus. The Active Travel section will support these schools by providing high viz vests, bells and lights to encourage safe cycling.



Pedometer Initiative

Active School Week took place from 26th – 30th April. Pupils from St. Marnocks National School in Portmarnock were gifted 200 pedometers as part of ASW to encourage walking to and from school.





School Wardens

The school wardens continue to operate at crossings throughout the County in line with Government and HSE covid prototcols.

FCC Active Travel Programme 2021

NTA funding has been secured for a number of projects, details of progress outlined below:

Hartstown / Huntstown / Mountview Road, Dublin 15

This project involves the construction of a Kerb Protected Cycle Lane along the length of Hartstown, Huntstown and Mountview rd. The installation of the kerb along the cycle path was completed at the end of 2020 and design works are currently under way on the next section of the scheme. We are aware of reported issues with the new infrastructure and are taking these into consideration as part of the design process. The planned works include junction build outs which will provide a safer crossing location for pedestrians, roundabout modifications which will provide a safer path for cyclists through roundabouts and finally bus stop build outs which will allow cyclists to pass safely behind bus stops and remove the current conflict with busses. These works are expected to begin in Q2 of 2021.



Hartstown/Huntstown Kerb Protected Cycle Lane.

Rivervalley / Rathingle Road, Swords

This project similar to the Huntstown/Hartstown project involves the construction of a Kerb Protected Cycle Lane along the length of Rivervalley and Rathingle rd in Swords. The installation of the kerb along the cycle path was completed at the end of 2020 and the buff coloured surfacing along the scheme has been placed in recent weeks. We are aware of reported issues with the new infrastructure and are taking these into consideration as part of the design process. The planned works for the next section of the scheme include junction build outs which will provide a safer crossing location for pedestrians and roundabout modifications which will provide a safer path for cyclists through. These works are expected to begin in Q2 of 2021.

<u>Grange Rd, Warrenhouse Rd - Baldoyle and</u> <u>Howth/Dublin Rd, Howth</u>

This project like the previous two projects involves the construction of a Protected Cycle Lane along the length of the scheme. Design works for this project is almost complete and works are likely to begin late in Q3 of 2021.

St Cronins Rd is a Protected Cycle Lane project. Design works on this project is now complete.

R132 Ministers Road to Blakes Cross

Works proposed along the R132 include the installation of a protected cycle lane along with junction modifications as well as additional measures around Corduff National School and Killhedge Lane to allow for additional safety for students attending the school. Design works on this project are underway.

Upcoming Projects

The Active Travel Unit will also be commencing design works on the following schemes pending staff recruitment:

- Bus Gate at Littlepace
- Protected cycle Lane on Snugborough Road

 NAC to Ongar

Town & Villages Mobility

Currently the Active Travel Department are reviewing towns and villages around the county with a view to identifying projects and measures which will allow for people to make meaningful journeys using active travel modes such as walking and cycling. This review will inform our works programme over this and coming years.



St. Cronin's Road, Swords

We are pleased to announce the launch of the *Safe Routes to School* (SRTS) Programme, which is open to all schools in Ireland for active travel funding and delivery. The programme is an initiative of the Department of Transport and supported by the Department of Education. It will be operated by the Green-Schools Programme in partnership with the National Transport Authority (NTA) and the local authorities.

The *Safe Routes to School* Programme is designed to encourage as many pupils and students as possible in primary and post-primary schools to walk and cycle. It has three aims:

- 1. To accelerate the delivery of walking/scooting and cycling infrastructure on key access routes to schools.
- 2. To provide "front of school" treatments which will enhance access to your school grounds.
- 3. To expand the amount of bike parking available at schools.

The Safer Routes to School programme is currently in the early assessment and design stages, involving the identification of suitable sites. Fingal County Council is currently working with the NTA in terms of the schools' expressions of interest that they have received. Both the assessment and the expressions of interest will inform our works programme which will commence shortly.

Connectivity Review

Currently the Active Travel Unit is collating information on areas around the county where we can enhance connectivity. A multi criteria analysis is being used to assess the proposed interventions and will inform our works programme in this regard.

Mapping

The Active Travel Unit is currently in the process of compiling a county wide cycling infrastructure map. This map will detail all of Fingal's current active travel assists such as cycle lanes, bike parking locations, existing and proposed and kissing gate locations.
