Rules of the Competition



- 1. Awards are confined to those young people who are aged between 13 and 21 years of age on the 25th of June 2021.
- 2. Permanent residence of the young person must be in the Garda Division in which they are nominated.
- 3. Awards are confined to individuals and groups of two or more people.
- 4. The Judges decision is final.
- 5. The Judging Panel will decide upon one nominee in each category to go forward to represent the Division at the National Garda Youth Awards. Details of theses nominees will be passed on to the Judging Panel of the Garda National Youth Awards. The Judging Panel will consist of up to six members, chaired by a member of An Garda Síochána not below the Rank of Inspector.
- 6. Details of all nominees will be retained for a period not exceeding 6 months after the closing date, at which time details will be destroyed, in compliance with General Data Protection Regulations.
- 7. Any member of the public may nominate anyone whom they feel deserves an award.
- 8. Nominations may be submitted by family members or relatives.
