
Fingal County Council is proposing the development of a neighbourhood play space, designed for children aged 4-12. The proposed play space will encourage imaginative play and physical activity while offering an attractive leisure amenity that will benefit residents, businesses and children, bringing significant environmental, economic and health benefits to the wider community. - Opportunities for passive surveillance








