NOW THEREFORE it is hereby ordered that—

- 1. Subject to the provisions of this Order the housing authority is hereby authorised to acquire compulsorily for the purposes of the Housing Act, 1966, the property described in the Schedule hereto which property is shown on a map marked Drawing no. 21-0099-PT-1003 and sealed with the seal of the housing authority and deposited at the offices of the housing authority (hereinafter referred to as "the deposited map").
- 2. Subject to any necessary adaptations, the provisions of
 - (a) the Lands Clauses Acts (except sections 127 to 132 of the Lands Clauses Consolidation Act, 1845, and article 20 of the Second Schedule to the Housing of the Working Classes Act, 1890), and
 - (b) the Acquisition of Land (Assessment of Compensation) Act, 1919, as amended by the Acquisition of Land (Reference Committee) Act, 1925, the Property Values (Arbitrations and Appeals) Act, 1960, and the Local Government (Planning and Development) Act, 1963 (as applied by section 265 (3) of the Planning and Development Act, 2000), and Planning and Development Acts 2000 to 2020 as modified by the Third Schedule to the Housing Act, 1966 (as amended and substituted) are hereby incorporated in this Order and the provisions of those Acts shall apply accordingly.
