Chief Executive's Foreword

As we approach the end of 2021 it is a good opportunity to look back and review all that has been achieved this year under challenging circumstances. Whilst we didn't get the respite from Covid 19 that we would have hoped for at this point in time we can still look back and be proud of what has been accomplished through the dedication and commitment of the Elected Members and staff alike.

We have delivered quality services to the people of Fingal across all our departments and new projects, initiatives and services were rolled out. We all acknowledged early on in the pandemic how fortunate we are in Fingal to have such wonderful amenities in our county and these have been a great source of respite during these testing times. Our teams in the operations department provided additional cleaning, litter bins and litter picking, additional staff resources were applied to key areas including the beaches, parks and open spaces and new public benches were installed. There was

increase in street furniture licensing to support business and enhanced outdoor dining in all areas. There was significant investment in public new EcoToilets and Changing conveniences and Places units were installed in a number of key locations and there were extended opening hours to end of October. 2022 will a Refurbishment Programme for existing Public Conveniences in Howth. Skerries. Rush, Portrane and Donabate. There is provision for an additional spend in Regional Parks, Open Spaces & Beaches of €1.2m which will greatly enhance these amenities for all.

Important work was done this year with much cross departmental collaboration to ensure that many of our ambitious capital projects will see activity on the ground and reach key milestones in 2022. Next year will see us planning for Greenways, expending a significant annual budget not to mention our capital programme, Active Travel projects, Biodiversity, Digital Innovation, Integration and the provision of quality homes and infrastructure in Fingal and I think this clearly demonstrates the ambition we have and the desire to consistently enhance the lives of our citizens and stay aligned to our mission of being a

vibrant, outward looking, well run Council that shows leadership and embraces diversity and opportunity.

The Development Plan review is going to be a busy time for both the Elected Members and staff first thing in the New Year. Work is ongoing to ensure arrangements are in place to facilitate the development plan meetings in January whilst being in a position to comply with the public health guidance in place at the time.

On behalf of myself and the Executive Management Team I would like to thank the Elected Members for their support and commitment this year and I also wish to thank each and everyone of our indoor and outdoor staff who adapted so well in an ever changing environment and responded with such positivity to all that was asked of them.

I would like to wish you and your families a Merry Christmas and a happy and healthy New Year.

Major Emergency Management



The Major Emergency Management structures in place within the Council continue to be effective and serve us well as we continuously review and respond to advice issued by Government and ensure compliance with public health measures.

Fingal County Council's Executive Management Team and senior management continue to meet regularly to ensure continuity of services and put measures in place to align with public health advice.

Human Resources

The Human Resource Department continues to plan for and respond to the challenges brought by Covid19 in line with the Government's **COVID-19** Reframing the Challenge, Continuing Our Recovery and Reconnecting. Staff continue to be kept up to date on relevant Government directives and are provided with useful information through text alerts and a dedicated staff information webpage.

Training and development of our staff, including statutory Health & Safety training, continues throughout the pandemic ensuring that critical services are not adversely affected.

The HR Department is currently engaging in large scale recruitment campaigns for a range of roles.

Health & Safety Unit (HSU)

A safety award entry submission prepared by the HSU on behalf of FCC for the National Irish Safety Organization/Northern Ireland Safety Group's 'Occupational Safety Awards 2021' has secured two awards for Fingal County Council - a Higher Distinction Award and an Exceptional High Achiever Award. The staff quiz draw as part of the recent European safety week promoting safety and health in the workplace was held with prizes delivered to six successful staff entrants. The HSU is currently utilizing the staff messages communication platform to deliver public health messages on ventilation, meetings and layering up to protect from Covid-19. Site safety inspections, audits and accident investigation are in continuation.



Building Facilities

The Energy Team completed the last surveillance assessment for ISO50001:2018 on the 22nd November 2021. The audit found that Fingal's energy management system is meeting the needs of the organisation with continual improvement and conforms to the requirements of ISO 50001:2018. No Non-Conformities were found.

The audit covered Energy Planning, Objectives and Targets, Internal Audits and Evaluation of performance. Site operational visits took place with the Significant Energy users' public lighting and fleet.

In November 2022 the energy team will start the re-certification process for ISO 50001:2018 for a further 3 year cycle.



Customer Services

During the month of November a total of 1,539 people called to the offices to conduct business in person. As of Wednesday 1st December, our offices are open to the public on an appointment only basis. This will be kept under review in line with public health guidance.




CRM

Staff continue to work on the Customer Relationship Management System (CRM) and issue responses to Councillors representations and complaints submitted by the public.

The month of November had a total of 440 Councillor's representations.





Information Technology

Digital Working

In November staff took part in 9,384 Teams meetings, 33,466 Calls took place, and 872,610 emails were received or sent by the Council.



IT Infrastructure & Support

749 support calls were logged by Council staff with the IT Service Desk in the past month and 19 calls were logged by Councillors with Sord. 100% server availability and 99.99% network availability was achieved in the month of November.

Document Management System

The implementation of the FinDocs Document Management system is continuing on schedule. Operations went live in November bringing to nine the number of Departments who are now up and running on the new system. Work is in progress with Environment who are due to go live in January. There are now 707 staff working with the system.

Security Upgrades

The IT Department carried out a security software replacement on 1,071 Council laptops and PCs over a twelve-week period from September to November.

Smart Balbriggan Schools Hackathon



A group of students from Coláiste Ghlór na Mara were winners at Balbriggan's 'Hackathon' for their innovative proposal to tackle food waste through the development of a website to educate people about it.

Alisha Ní Riain, Ruaidhrí Ó Baoill, Cathal Mac Aoidh and Síofra Nic Mánais took part in a Transition Year challenge run by Smart Balbriggan - an initiative of Fingal County Council - for secondary schools in the town.

Over the first week of October, a series of workshops were delivered to the students in collaboration with the Academy of the Near Future and What the Hack organisations which engage the public in seeking solutions to challenges they face.

Participants were mentored to create innovative solutions to answer the question "How can we build a stronger, cohesive and more vibrant community?"

Ardgillan Community School, Bremore Educate Together Secondary School and Coláiste Ghlór na Mara were among the schools which took part, involving nearly 100 students.

Through workshops, the students learned about how new technology and innovation can improve our community and developed their own creative ideas to tackle local issues.

Finally, the students 'pitched' their ideas to a panel of judges with a prize for the best concept.

The team from Coláiste Ghlór na Mara came up with a solution which aimed to tackle food waste with the development of a platform to educate people about food waste and meal preparation - prompting them to make changes to their food consumption habits.

Communications

Podcast

Episode 15 of the Inside Fingal Podcast which will be published later this week will feature an interview with County Arts Officer Rory O'Byrne. The interview will cover the establishment of the Arts Office and reflect on the work that it has done over the past 27 years to develop the Arts across the county.

To date the Inside Fingal podcast series has had 5,775 downloads or internet listens and all podcasts in the series are available at www.fingal.ie/podcast.

Website

There were 114,200 visitors to our website, fingal.ie, during November which is the second highest monthly total achieved in 2021 and was 800 more than in October. The average number of visitors per month is 103,973. There were a total of 290,300 page views with the average page views per month being 291,518. So far this year there have been 1.14million visitors to the website and 3.2million page views.

The Choice Based Letting Scheme accounted for the most views in November ahead of Planning Application with the Business Directory, Jobs, and COVID-19 information pages also performing well.

Social Media

Our Social Media Channels have all increased their number of followers since the start of the year and are closing in on major follower milestones

- Facebook 402 short of 25,000
- Instagram 518 short of 5,000
- LinkedIn 110 short of 5,000
- Twitter passed 20,000 in 2021
- You Tube passed 500 in 2021



Our Twitter account, @fingalcoco, had 535,000 impressions during November and an average engagement rate of 1.2% for 307 tweets.

The best performing tweet, with 13,900 impressions and 385 engagements was a notice that Council crews would be out salting the usual routes.

Our 266 Facebook posts during November had a reach of 856,454.

Projects and Campaigns

During the month of November the Communication Unit worked with departments and sections across the Council to promote their projects and campaigns.

The Unit assisted the Aircraft Noise Competent Authority with the promoting the publication of their Draft Regulatory Decision and commencement of a 14-week public consultation process.

The Unit also assisted the Human Resources Department in promoting the Council to job-seekers at Jobs Expo in the RDS.

A campaign was also developed by the Communication Unit to support the work of the Council's Integration Officer. The "We Are Fingal" campaign ran across social media channels as well as roadside billboards, digital displays in shopping centres and on bus shelters across the county. The Unit was also involved in the promotion of Fingal Inclusion Week.





Videos

For Innovation Week, the Communications Unit, in conjunction with the Digital Strategy Unit, produced a series of videos highlight examples of innovative projects carried out by the Council. These ranged from the use of handmade mud and straw bricks in the conservation of Rolestown Mills to the Fingal Instruments Project which is a waste prevention initiative.

Press Releases and Media Queries

We issued 26 press releases and media invitations during November and dealt with 13 media queries.

TOURISM

FINGAL TOURISM RECOVERY CAMPAIGN

Last month on Love Fingal Dublin we reached **447,432** people on Facebook ads. We also had **51,611** impressions on our Instagram ads on the Dublin Coast and Fields page.

FINGAL FOOD TOURISM NETWORK

Work with food producers, restauranteurs and other stakeholders on establishing a Fingal Seafood Trail is continuing. The trail will have 3 main elements: food experiences, dining and scenic locations. Fáilte Ireland will incorporate this new trail into their Dublin Coastal Trail campaign.

TOURISM DEVELOPMENT GROUPS

Skerries Tourism about to launch the Winter in Skerries illumination, dovetailing with Fáilte Ireland's Winter in Dublin campaign. This event is being supported by Dublin Rural LEADER.

Howth Tourism is surveying local businesses for input into priority tourism actions for 2022. A Howth app is being developed in lieu of paper.

Balbriggan Tourism is focused on developing a closer relationship with Fáilte Ireland and completing the new visitbalbriggan.ie website for launch in early 2022.

Howth, Skerries and Malahide's engagement in Fáilte Ireland's Dublin Coastal Trail trade activation work is ongoing in preparation for its launch in early 2022.

Dublin 15 tourism is in the process of establishing a dedicated events calendar for 2022 and is working with stakeholders on developing a new visitor focussed event for 2022

HERITAGE PROPERTIES



UPDATE ON HERITAGE PROPERTIES CONSERVATION WORKS:

Malahide Castle – The Great Hall conservation works have commenced and are scheduled for completion in Q1 2022.

Ardgillan Castle – the painting of the public areas of the Castle is complete. Further minor works to enhance the overall look of the public rooms have been identified

Consultants have been appointed to undertake the Ardgillan Conservation Management Plan and work is to commence shortly.

MARKETING/PROMOTION OF HERITAGE PROPERTIES





Malahide Castle - Visitor numbers are up by 10:6% on the same period last year and there are signs of small numbers of International tourists returning. Wonderlight's at Malahide Castle is underway and is proving very popular. Due to demand, extra dates have been added and it is now extended into January. The Santa Experience at the Castle is also underway.



Newbridge House - Visitor numbers up 34% on the same period last year.

A new walkthrough aviary is currently under construction on the Farm. Final preparation for Santa experience at Newbridge which commences on 11th December

Malahide Casino -Various marketing initiatives have been activated including paid advertising on social media, Christmas gift vouchers and mailshots to local men's sheds.

Ardgillan Castle – As the painting of the tour rooms at Ardgillan is now complete, the craft shop will now re-open and tours will re-commence.

The Ardgillan Christmas Fair and the Ardgillan Ladies Day, which were both indoor events, have both been postponed in line with Covid 19 public health advice.

CREATIVE FINGAL PROGRAMME 2021

2021 has proved to be yet another difficult year for the citizens of Fingal however despite the challenges, the Fingal Creative Ireland Programme 2021 has been a resounding success.

A budget of €343,000 has been allocated to 42 different creative projects/initiatives across the 3 separate funding streams of Creative, Cruinniú na nÓg and the Decade of Centenaries Commemoration programme.

In 2022 the Creative and Cultural team will continue to provide support and engage our citizens in creative initiatives that will enhance their lives and contribute greatly to their wellbeing. https://www.fingal.ie/creative-ireland

PUBLIC ART – PLANNING COMPLIANCE



Following a successful competition featuring 3 artists from Fingal County Council's Buildings and Public Places Panel, Cosgrave Developments has commissioned a new permanent work for the Blackwood Square development in Santry.



The work titled "the gathering" is comprised of selected stone from every province in Ireland and will form an attractive visual feature for the new housing estate. The Artist has begun working with the team to realise the project for April 2022. This is one of many permanent commissioned works currently underway across sites in Fingal. We are working with Rohan, IPUT, TU Blanchardstown, TOT and Gannon Homes on suitable works for their developments.

LIBRARIES

Acquisitions from Howth Castle

The Mayor of Fingal, Cllr Seána Ó Rodaigh visited Local Studies and Archives on 10th November to view acquisitions from the collections of Howth Castle. Following the sale of the Castle and estate in 2018, the contents of the Castle and its library were auctioned in September 2021.

The items acquired by Local Studies and Archives include **The Earl of Howth Estate Atlas**, a manuscript atlas produced in 1863, which contains over 20 hand coloured maps, with details of every field in the estate and the names of the tenants. The **Howth Castle Rent Book** dates from 1766–1780 and contains 140 pages of hand-written entries of tenants, the rents they paid and any amounts owed. Also obtained was an **Illuminated Address**, illustrated by the illuminator J. Hopkins and sent on behalf of the tenants in North County Dublin to the Earl of Howth on the death of his father in 1874. It is signed by nine of the tenants. These three items alone are extremely important as sources for local and family history in North County Dublin.

Other items acquired at the library auction were **Almanacs** from 1765, 1775 and 1776 along with an 1840 edition of **The Antiquities of Ireland** by Francis Grose.

At the Howth Castle contents auction Fingal Local Studies and Archives also acquired a **George Petrie** pencil and water colour drawing "Howth Castle" dated 1819, a watercolour "Ireland's Eye" by **Frederick Lawless** dated 1879, a **Francis Grose** original watercolour "St. Mary's Abbey, Howth" along with 6 original hand-coloured **James Malton's** Views of Dublin and several photographs of Howth Castle. These items will greatly add to the knowledge and understanding of the history of the Howth Castle

Battle of the Book launched in Donabate

The Mayor of Fingal, Cllr Seána Ó Rodaigh launched the Battle of the Book at St Patrick's Boys NS Donabate on 22nd November.

The Battle of the Book is a Fingal Libraries reading Programme designed to encourage children to read, gain confidence and to discuss a common book. It provides a shared experience of reading which will encourage reading for life.

This year the featured books are "The Legend of Gobán" and "The Legend of Joseph Daw" by local Fingal author Gerard Ronan. These books are one of a series of four designed to introduce a younger audience to the rich store of folklore, history, and wildlife that is to be found on the Portrane Peninsula. The schools involved this year are St. Patricks Boys NS, Donabate, Scoil Phádraic Cailíní, Donabate, St. Catherine's National School, Rush, Rush National School and Hedgestown National School, Lusk.

The children will participate in different activities organised by Fingal Libraries surrounding the themes presented in the book. The programme will culminate in a "Battle" to be held in 2022 with prizes awarded to the winning school.



First 5 Little Library

One of Fingal's mobile library vans provided the backdrop to the launch of the second phase of the First 5 Little Library initiative by Minister for Children, Equality, Disability, Integration and Youth, Roderic O'Gorman, T.D., on 5th November.

The First 5 Little Libraries book bags contain books chosen by librarians and materials developed to support storytelling and reading with children. The project supports Early Learning and Care (ELC) and School-Age Childcare (SAC) services to further develop little libraries in their settings with quality book titles in English and Irish. The reading materials are made available to approximately 200,000 children around the country. ELC and SAC services in Fingal are currently being invited to collect a First 5 Little Library book bag from their local library.



New Mobile Library Stops

A new mobile library stop which began in September 2021 in Balrothery village is proving to be very popular. Figures for the first two months, show 442 visits and an average of almost 50 people per visit. Arrangements are in place for a mobile library van to visit Balseskin Reception Centre in the coming weeks.

Fingal Makerspace at Blanchardstown Library

The Fingal Makerspace is a community creative and education space focused on maker-centred learning amongst our diverse population in Fingal County and surrounding areas. Over the past 10 weeks the Fingal Makerspace team has developed a series of activities and workshops designed to engage young people such as: Design and Make a Tunnel Book, Paper Circuits, Design a LightBox, BlingBling LED - Stay Safe in the Dark, Build a Stereo Speaker, Introduction to 3D Printing, and Introduction to the Laser Cutter. There are Makerspace activities scheduled to take place before Christmas including indoor and outdoor workshops, open nights,

STEAM School (blended learning programme with local secondary schools), in addition to Fingal library staff tours and training on Makerspace activities.

Europe Direct at Blanchardstown Library

The topic of this year's online Europe Direct Soapbox regional competition was: 'Lies, damned lies and statistics - Establishing the truth is impossible in today's world of misinformation, disinformation and propaganda. April Bracken was the worthy winner and she receives the prize of an ipad and the opportunity to compete in the National Final on 9th December. The regional Soapbox competition is organised by the Europe Direct Information Centre based at Blanchardstown Library.

ECONOMIC DEVELOPMENT

DUBLIN BELFAST ECONOMIC CORRIDOR



On the 23rd November the Oversight Board of the Dublin Belfast Economic Corridor met and elected Cllr. Pete Byrne from Newry, Mourne and Down District Council as Chair of the DBEC Oversight Board, with Mayor of Fingal, Cllr Seána Ó Rodaigh, elected as Deputy Chair.



The eight local authorities involved in the development of the Corridor are:

- Armagh City, Banbridge and Craigavon Borough Council
- Belfast City Council
- Dublin City Council
- Fingal County Council
- Lisburn & Castlereagh City Council
- Louth County Council
- Meath County Council
- Newry, Mourne and Down District Council

The DBEC Oversight Board will work collaboratively to develop a regional proposition for economic growth with the assistance of KPMG to deliver a development plan to identify priority areas of cooperation between the local authorities. DBEC members will examine how the local government network can collaborate to deliver jobs and sustainable growth and engage with the private sector to stimulate economic development along the corridor.

FINGAL IN IT TOGETHER



The Council continues to support business under the Fingal In It Together Charter and has commenced the Fingal In It Together Christmas campaign. county, outdoor, print and online advertising, an online Christmas competition and an updated Shop Local Brochure for 2021.



Outdoor Dining Scheme



The Outdoor Dining Scheme funded by Fáilte Ireland with the purpose of assisting the hospitality and tourism sector to increase their outdoor dining capacity closed on the 30th September 2021. The Economic, Enterprise, Tourism & Cultural Department has issued to date c. €435,135 in funding to 143 applicants.

Fingal Skills Strategy



The Fingal Skills Strategy Implementation Group has met four times since its establishment in April 2021. Sub-groups for Transport & Logistics and the Construction Sectors have been established to examine the requirements of these sectors. A Fingal Skills webpage is in development to signpost skills and training opportunities.

Sustainable Fingal





The Council announced Welgro Produce in Rush as the winner of the **Sustainable Fingal** competition. The 3 acre cucumber farm delivers locally grown produce to retailers around the country and is one of the few commercial cucumber producers in Ireland. Welgro Produce will receive a sustainability assessment and action plan from Balbriggan based Patel Tonra Ltd. Environmental Solutions who will advise Welgro on how to introduce more sustainable practices to their business and help the business become a more sustainable producer.

Urbact Playful Towns

The Rush Urbact Local Group (ULG) launched Let's Play Rush on the 20th November 2021 with 4 events aimed to increase the playfulness of the residents of the town.



With funding from Creative Ireland, Rush Library hosted 2 outdoor lego-building sessions for kids from 4 – 12 year with the town's pirate heritage as the theme. The event was organised with the help of Rush Community Council and Rush Tidy Towns and was led by Bricks4Kidz.





Rush Community Centre helped the town's senior citizens discover their creativity with painting sessions delivered by artist John Carpenter.





Rush ULG is drafting an Urbact Transfer Plan to capture best practice lessons from lead partner Cork City Council and prepare a playful action plan for implementation in the town.

Our Balbriggan 2019 – 2025 Rejuvenation Plan – A Socio-Economic Strategy



The Our Balbriggan Programme Office continues to support the Leadership Group and its five pillars, who meet regularly, to progress work across a range of economic and social measures including: Growing the Local Economy, Public Realm & Infrastructure, Education, Skills & Employment, Community Integration, Health & Well Being and Community Safety.

The Safe Balbriggan Pillar met on the 23rd November and continues to progress pillar actions of the workplan, having established 2 sub-groups to advance various actions. The Education, Skills and Training Pillar are scheduled to meet on December 9th and work will begin on the Loves Learning Festival 2022.



Minister Darragh O'Brien visited Balbriggan on the 12th November to inspect the URDF funded projects in the town. Minister O'Brien and local Councillors visited sites at Bridge Street, Quay Street and the Harbour and were briefed on the progress of the projects.



Following the completion of the acquisition of 14 Bridge Street the Council has secured the building and completed minor improvement works to the front of the property.



The acquisition of 2-4 Dublin Street completed in November 2021. An Integrated Design Team has been appointed and design work will commence in January 2022. The vision for this listed building is to develop it into creative arts/studio spaces with an adjoining a state-of-the-art digital learning, innovation and maker space which will strengthen the public, civic and creative heart of the town.

The demolition of the former O'Shea's Night Club building (Harbour) continues with ongoing archaeology monitoring of the site. The demolition of the building is due to complete in January 2022.



Paul Keogh Architects, the appointed Integrated Design Team (IDT) for the re-imagined Quay Street & Harbour Area, continue to progress design work on this project, including engagement with a wide range of internal and external stakeholders.

DBFL Consulting Engineers, Our Balbriggan Active Travel and Transport Consultants, are progressing preliminary work on the town's transportation and active travel plans and are liaising closely with ad relevant stakeholders, including The Paul Hogarth Company (Masterplanning Consultants) and Paul Keogh Architects, IDT for Quay Street & Harbour Area.



With funding from Science Foundation Ireland SUBSET completed the mural "Our Climate Future" at Vauxhall Lane. Another mural was also completed at Church Street – Seapoint Underpass.



Our Balbriggan established a Placemaking & Social Innovation Fund as an action under its Year 1 "20 things in 12 months" Plan. A call for applications under the Placemaking fund issued in October 2021. 20 applications were received and are currently being assessed with notifications due to issue shortly.



The re-developed Our Balbriggan website, Balbriggan.ie launched in October with updated information on the public realm improvement projects. Our Balbriggan also celebrated the 3 year anniversary of our Facebook/Twitter/Instragram Account.





Balbriggan's Urbact Local Group (ULG) continues to meet regularly and is progressing a series of Small Scale actions. A combined two partner city transnational meeting took place between the 29th November and 3rd December in Grosseto and Kocevje with each partner city presenting their progress on their Action Plans for local economic development

Following a successful application in November 2020 to participate in the EU Programme "Europe for Citizens – It's our time, it's time for Europe", the kick-off meeting hosted by Mislata took place between the November 25th and 29th. Balbriggan is partnering with eight other European large towns with the project focus on youth and diversity. Partners will be involved in debating the future of Europe, challenging Euroscepticism, promoting solidarity, fostering intercultural dialogue and mutual understanding and combating the stigmatisation of migrants and minority groups.

Local & Rural Development

LOCAL COMMUNITY DEVELOPMENT COMMITTEE

The Fingal LCDC continues to oversee and administer the key areas of LEADER and SICAP and the various Local Development and Community Development funding programmes under its remit. The LCDC also manages the Healthy Ireland Initiative, the Community Resilience Fund and the Keepwell Campaign, and the many projects up and running under those funding streams.



FINGAL LOCAL ECONOMIC COMMUNITY PLAN 2022-27

The Guidelines for preparing new LECPs were published by the Department of Rural and Community Development during November. A series of information seminars on the new guidelines are to be held shortly in advance of the new LECP planning and consultation process in 2022. The new Fingal LECP will be a 'Whole-of=Council Plan' and will involve extensive consultation and engagement with internal and external stakeholders.

COMMUNITY ACTIVITIES FUND

Details of the new Community Activities Fund under the Community Enhancement Programme were received during November. Fingal LCDC has been allocated €301,042 to distribute to qualifying community and voluntary groups. The Community Activities Fund will support groups, particularly in disadvantaged areas

- With their non-pay running costs for example utility bills (electricity costs, refuse charges, heating charges) or other non-pay operating

- costs for example rental/lease costs, insurance bills.
- Groups will also be able to use the funding to carry out necessary repairs and improvements to their facilities, purchase equipment such as tables and chairs, tools and signage, laptops and printers, lawnmowers, canopies and training equipment etc.

This funding is about giving a helping hand to communities, local groups and clubs. This new fund is being administered by the Fingal LCDC and will be open for applications in January.



SICAP

The SICAP Annual Plan for 2021 continues to be implemented. The €1.24m 2021 SICAP Plan has ambitious KPIs which consider the many challenges arising from delivering services in a Covid 19 environment. The mid-year review of the 2021 annual implementation plan is complete and a positive delivery of the programme for 2021 is expected.

The annual engagement meeting with Pobal was held during November. The Fingal SICAP Programme received very positive feedback and it was recognised by Pobal that the programme is progressing well. Confirmation of the 2022 Fingal SICAP budget is awaited from the Department of Rural and Community Development.

The current SICAP Programme has also been extended for a further year to include 2023.



LEADER PROGRAMME

The Dublin Rural LEADER Local Action Group and the Dublin Rural LEADER Programme continues to deliver funding and support to eligible projects in the administrative areas of Fingal, Dun Laoghaire Rathdown and South Dublin.



The updated 2021/22 Transitional Funding Arrangements for the LEADER Programme has the Dublin Rural LEADER LAG approved for €1,882,175 to cover both projects funding and administration funding for the period April 2021 – December 2022. Of this amount, €1,411,631 is available for LEADER Project Applications under the categories of Rural Enterprise, Social Inclusion and Rural Environment. Historically, Fingal Projects comprise 65-70% of the total LEADER Projects approved, roughly corresponding to Fingal's share of the Dublin Rural LEADER Geographical Area.

The LEADER Programme reverted on the 1st April to EU Transition Rules for the period 2021-22 with a new Dublin Rural LEADER Local Development Strategy to be prepared and put in place for 2023 onwards. Under the Transitional Arrangements the Dublin Rural LEADER LAG and LEADER Programme will continue to be funded by the Department of Rural and Community Development under the same eligibility and LEADER implementation rules as before. LEADER continues to approve and fund new projects as usual. During November, the Dublin Rural LEADER Local Action Group, which oversees the LEADER Programme in Dublin, approved €230,748.76 in funding for 5 new projects in Rural Dublin. This brings the total number of projects approved during the LEADER Transition Programme to 15 since it began on April 1st, 2021, with a total value of €543,984.52.

The approved projects are in the areas of Economic Development, Rural Environment and Social Inclusion.

The projects approved for funding were:

Balbriggan Meals on Wheels which is approved for €24,063.75 for an outdoor dining area which will be of enormous help to facilitate the provision of meals to their clients in a safe outdoor setting.

Donabate Portrane Community Centre CLG which is approved for €24,354.00 for a Feasibility Study to capture the needs of existing groups that use the facilities to assist and guide them in expanding in line with community needs.

St Maur's GAA Club Rush which is approved for €89,154.58 to install rainwater harvesting and irrigation in St Maur's GAA Club premises and for use on the pitches. The Project will reduce the demand on the public water supply and reduce the volume of water going into the public drainage system.



Ballyboughal Boxing Club CLG which is approved for €47,051.43 to upgrade the Ballyboughal Boxing Club Premises.

Skerries Tourism CLG which is approved for €46,125.00 for a Winter in Skerries Event from December 1st, 2021, to January 1st, 2022. It is intended that several locations across Skerries will be transformed with colourful projections and lighting displays to cheer locals and, more importantly, visitors alike in what have been a challenging 18 months. It is hoped that Skerries winter lights will become an important part of the local Christmas tradition with the primary ambition of increasing footfall and economic activity.



The next meeting of the Dublin Rural LEADER Local Action Group (LAG) will take place in December. Going forward there is currently over €3 million in the new LEADER projects pipeline of which over €1 million is for Rural Enterprise.

Fingal County Council continues to deliver the financial and administrative oversight responsibilities for the approval and drawdown of LEADER funded projects following the national transfer of the LEADER Article 48 Administrative Checks from Pobal to the Local Authority Sector.



ENTERPRISE CENTRES

Fingal's Enterprise Centres continue to participate in ConnectedHubs.ie . ConnectedHubs.ie is a one-stopshop for remote working hubs throughout Ireland. Launched in May 2021, it is designed to simplify and standardise the process of sourcing and booking spaces, desks, offices and events in hubs for a day, a week, a month, a year or longer. ConnectedHubs.ie is operated by The National Hub Network, a Government of Ireland initiative that provides a vehicle for individual hubs to come together under a shared identity to maximise the economic opportunity of remote working. The National Hub Network has the support of Government, remote working advocacy groups and industry representatives. In this way, ConnectedHubs.ie also encompasses a range of key features that deliver significant benefits to member hubs, hub clients, employers, local communities and the wider economy.



All three Enterprise Centres have space available to businesses who wish to avail of remote working options and facilities. Bespoke options or generic office fit-out options can be considered.

The renovation works in the Beat Centre are now complete. Funding for these renovations has been provided by the Dublin Rural LEADER Programme. The newly fitted out space allows Beat to expand its offering in the areas of remote working hub space and flexible start-up workspace.



Work has also re-commenced in BASE to further upgrade and expand remote working facilities with the addition of new dedicated space and desks.













Occupancy rates at the Council's three enterprise centres at the end of November were Drinan 84%, BASE 88% and Beat 88%. The three Enterprise Centres currently support 62 businesses and 320 direct jobs.



LOCAL ENTERPRISE OFFICE FINGAL



LEO Fingal provides a broad suite of support services to stimulate enterprise and enable small businesses to succeed. Some of the LEO highlights for November 2021 are as follows:

Look for Local – Shop Fingal



A new campaign was launched in November 2021, seeking to encourage consumers to look local when they are shopping for products, services and experiences this Christmas. The Look for Local & Shop Fingal campaign, supported by Enterprise Ireland and Fingal County Council, aims to raise awareness of the benefit of spending in your local area during the shopping period leading up to Christmas. It features a widespread promotional campaign through multiple media, featuring small Fingal producers and suppliers. The campaign is backed up by a National Look for Local initiative.

Evaluation and Approvals Committee

In November 2021, LEO Fingal approved four applications for funding totalling €51,250, bringing the total approved year to date to 34 businesses, with a combined value of €745,980.

The final assessment of grant applications in 2021 will take place on Wednesday 15th December.

Green for Micro Initiative – Mentoring/Consulting Programme for SMEs



LEO Fingal have approved 11 applicants for the Green for Micro programme, 6 of whom have successfully completed the Programme thus far. The Green for Micro is an initiative from the Local Enterprise Office to help prepare small businesses for the low carbon, more resource efficient economy of the future. This programme is available to businesses with up to ten employees.

Trading Online Voucher (TOV) Scheme



An initiative under the Government's National Digital Strategy, the TOV scheme supports small businesses to enhance their online offering by providing a grant of up to €2,500 for ecommerce and digital marketing activities. A final Trading Online Voucher webinar was hosted by Fingal Local Enterprise Office on the 5th of November and attended by over 120 clients and the TOV Webinars will begin again in January 2022. Since January 2021, 318 applications were approved in the amount of €702,878.50.

Fingal Enterprising Women's Network



Fingal Enterprising Women's Network will conclude 2021 by hosting a special Christmas event, which will take place on Tuesday the 14th of December 2021. The online networking event will feature Hotelier, Entrepreneur, Author and Co-Presenter of "At Your Service", John Brennan who will be discussing "Hope, Ambition and Making It Happen. Fingal Enterprising Women's Network hosted six networking events throughout the year with 1,585 female entrepreneurs attending the online networking events.

Business Advice Clinics and Mentoring

Business Advice Clinics and mentoring continue to be offered online. Since January 2021, 99 Business Advice Clinic days were held, offering advice and support to 912 Fingal businesses. In addition, 356 entrepreneurs received one to one mentoring.

Management Development & Training

LEO Fingal provides a series of management development initiatives and workshops to assist the growth of small businesses. In 2021 to date, some 3,150 bookings for these programmes have been received. Programmes currently on offer include: Instagram for Aces; Consumer and Market Research; Canva Workshop; TicToc for Business; Completing Your Tax Returns.

Start Your Own Business (SYOB)



The SYOB programme continues to be highly popular. The final Start Your Own Business course for 2021 commenced on the 30th of November, which brings to fourteen the total number delivered year to date, with 268 participants.

Microfinance Ireland COVID-19 Loans

LEO Fingal provides a loan scheme through its partnership with Microfinance Ireland, with "soft" loans of up to €25,000. LEO Fingal is actively promoting the availability of loans from businesses that have difficulty raising finance from their bank. Seventeen applications have been processed, assessed and submitted to MFI to date this year.

Showcase 2022



Subject to Covid restrictions, Showcase Ireland 2022 is planned to take place from 23rd – 26th January 2022 at the RDS, Dublin. Showcase is the country's largest international trade show for the craft & design sector. Following a competitive process, eight Fingal producers were selected to exhibit at Showcase: Pamela and Suzanne Hughes - Love the Mug, Gillian Halpin - Jane Darcy, Aisling Howley - Little Paper Mill, Lorna Venton - Berry Be Beauty, Sarah Rossney - Sarah Rossney Art, Julie Peelo - Julie Peelo Accessories, Sandra Hickey - Milkbath, Yvonne Kelly - Yvonne Kelly Art.

Disability Programme - Self Employment for People with Disabilities

LEO Fingal is one of five LEOs that have joined forces with TU Dublin to deliver the new 12-week online pilot programme called "Self-Employment for People with Disabilities". Three Fingal participants have been selected for the pilot.

An excellent package of supports has been developed for the participants to help them to develop and evaluate the viability of their business idea including Mentoring from Fingal LEO Mentor Panel.

Student Enterprise Programme



The Fingal Student Enterprise Programme 2021/22 is underway, with 23 schools participating. The virtual county final is scheduled for Tuesday 22nd March 2022.

Sarracenia Collection at Malahide Demesne



Sarracenia, commonly known as pitcher plants, are carnivorous plants mainly from North America. They bear flowers that grow singly on tall leafless stalks and most have long tubular 'pitchers. Inside these pitchers is a well of digestive fluid that breaks down prey, which is then absorbed by the plant. Sarracenia' s are perennial plants that should be grown in full sun and watered from beneath, by keeping the plant pot in a tray of water. Rainwater is best as pitcher plants dislike hard, lime-rich water.

The Operations team in Talbot Botanical Gardens have built up a collection of over 61 different Sarracenia's. This collection includes all Sarracenia's bar four which have received the RHS AGM. This is the only collection in the world at present that houses this number of Sarracenia's that hold RHS AGM in the one collection.


A review on the Recycling Centres at Coolmine and Estuary is currently underway. This review will look at net cost to the Council alongside the current charges.

8. Road Opening Licences


The Licensing unit continues to process and manage the licensing system for the County, applications are allocated by area for examination and conditioning which includes reviews of the existing carriageway, footpaths, cycleways, and grass verges. Applicants submit temporary traffic management plans for review to ensure all works are carried out safely within the public domain. Road Opening licences are a cross functional process for the department and is essential for the asset management of Fingal County Council Road network.

225 licences were granted in November 2021

- **T1 Application:** The T1 is not a licence. It is notification of intent to perform works of high impact due to extent or complexity.
- **T2 Applications:** An application to carry out works of moderate impact due to the location, extent, amount, or duration of the work.
- **T3 Applications**: An application to carry out works of low impact due to the location, extent, amount, or duration of the work. A T3 licence requires a short application period and does not require a works programme notification.
- **T4 Applications:** A notification of emergency works (as defined under legislation). Notification must occur at the time or as soon as possible after commencement and works must be carried out during a limited time period. **Ongoing Projects**

There are a currently a number of significant road opening licence projects on going including under the supervision of the Operations Engineering Team.

9.Water Services

Water production and distribution, wastewater collection, treatment & disposal continue to be provided as agreed in the Service Level Agreement with Irish Water.

The Council continue to have responsibility for the Storm Water Network

Storm Water (surface water) Network – Operations

Operation and maintenance of the stormwater network is ongoing, in line with Covid-19 restrictions.

Works summary:

- Phase 1 (Advance works) to install a section of new stormwater (surface water) network in Ballyboughal is completed, in conjunction with FCC's Housing Department. Phase 2 will comprise of the installation of 35m of 450mm diameter pipe. These works are currently on hold pending the agreement of wayleaves. Agreement has been reached with one landowner negotiations are ongoing with the adjoining landowner.
- The Storm water manhole cover and frame replacement programme for replacing assets at the end of life is ongoing – Covers and

- frames were replaced at various locations in Ballyboughal, Malahide, and Castleknock areas.
- Works to Jet, drag and to carry out a CCTV survey along the Old Bawn and The Bawn in Malahide on the Storm water networks are ongoing. A feasibility project has been undertaken to ascertain if improvements can be made to the network to reduce the likelihood of flooding events in the future.
- CCTV surveys are ongoing in the St Benedict's estate in Malahide and La Verna in Baldoyle to ascertain the location of misconnections to the Stormwater network from the foul system.
- Other maintenance and minor works programmes are ongoing. Works to CCTV, drag and clean the Storm Water network in Inbhir Ide, Texas Lane and Yellow Walls road in Malahide are nearing completion. FCC are awaiting the removal of a gas service by Gas Networks once removed this programme will be complete. Works were recently carried out to clean a Stormwater ditch that Inbhir Ide drains to help alleviate and future flooding events.
- Works are ongoing at No: 18 Dublin Rd, Bayside to fit a Tideflex flap on an overflow culvert to resolve a rodent issue and stop material being washed up the from the coast. These works will also include a full CCTV and some patch work will be carried out.
- A Contractor is being procured to jet, drag and CCTV survey the Stormwater network in Chalfont, Malahide to assist road operations with the alleviation of ongoing road flooding.



Planning Applications

There have been 1,313 planning applications received to the end of October 2021, 80 of these applications were invalid leaving a total of 1,233 valid applications. The volume of applications received by Local Electoral Area (LEA) is detailed in the table below.

Up to end of October 2021, 9 Strategic Housing Development (SHD) applications were made to An Bord Pleanála, plus 1 for amendments totalling 5,119 units. 9 decisions were made by the board up to end of September 2021. Of these, 6 were granted, 1 in February, 1 in March, 3 in September (2,104 units). 1 was one granted in July for amendments. 3 applications were Refused, 1 in March, 1 in June and 1 in July. There is a total of 3 SHD's (2,876 units) currently in the formal application process.



Planning Decisions

A total of 1,264 planning decisions have been made to the end of October 2021. There have 1,089 decisions to grant permission (86%) and 175 refusals of permission (14%). There have been 73 grants of permissions in respect of single house construction,

696 grants of permission for domestic extensions, 265 commercial/retail grants of permission and 29 grants of permission in respect of housing developments of which 15 relate to development of 2 - 20, 2 relate to development of 20 - 50, 7 relate to 50 -100 and 5 of which relate to development of 100+ housing units.

Building Control Admin

Up to the end of October 2021, there were 132 Disability Access Certificate applications submitted, of these 124 have been granted, 1 was invalidated and 2 are currently on time extension. There were 9 Revised Disability Access Certificate applications submitted, 8 have been granted.

There were also 17 Dispensation/Relaxation applications submitted, all 17 have been granted.

There were 209 Fire Safety Certificate applications submitted, of these 152 have been granted, 2 were refused, 7 were invalidated and 29 are currently on time extension. There were 28 Revised Fire Safety Certificate applications submitted, 19 were granted and 2 were invalidated.

There were 19 Regularisation Certificate applications submitted, 2 were granted, 2 were invalidated and 14 are currently on time extension.

A total of 1,113 building control decisions were processed up until the end of October 2021, this includes decisions that were made on applications submitted pre 2021 in addition to applications submitted in the first 10 months of this year. This is made up of 399 decisions to grant, 4 refusals, 13 invalids, 3 amendments and 694 extensions of time.

Building Control Fire Safety, Disability Access, Regularisation and Dispensation /Relaxation Certificate applications can be submitted online via the new BCMS applications module and in hard copy directly into the office.

Planning Enforcement/Derelict Sites

260 Warning Letters and 26 Enforcement Notices issued by the end of October 2021 with further warning letters and enforcement notices to issue before year end. On-going referral of enforcement files for legal action. 13 enforcement files referred to the Law Department in 2021 to initiate legal action bringing to 21 the number of cases currently with the Law Department or at varying stages in the court system.

The Derelict Sites Section have issued correspondence to site owners/occupiers of 19 sites around issues of dereliction in 2021 with on-going engagement arising from this.

Statutory Notices have been issued under the Derelict Sites Act with respect to 2 sites in 2021 with both sites placed on the Derelict Sites Register.

Sustainable Swords

The next stage of public consultation for the Sustainable Swords project was launched on 28th September. This follows the 'Your Swords, Your Say' survey which was carried out in May and the briefing session with Elected Members in July.

The ambition of Sustainable Swords is to create a multi-faceted approach to the planning, design and management of the town, in order to achieve better quality places as the physical setting for life in Swords. Sustainable Swords plans to consolidate and strengthen the historic town centre of Swords. The project will also set specific objectives for the town centre with the goal of increasing the resilience of the local economy and fostering an enhanced, accessible, inclusive, child friendly and healthy urban environment. A vibrant town for all.

An online webinar took place on 12th October 2021 and heard from the project team and members of the public took the opportunity to ask questions about the project. Submission were invited until 4th November and these are now being considered. The draft Strategy is expected to issue early next year.



Vacant Site Register

There are currently 11 sites on the Vacant Sites Register (VSR). These include 3 residential sites and 8 regeneration sites.

Invoices for the VSR levy have been issued with regard to VS/0016, VS/0117 and VS/0018 for 2019. The total amount being invoiced for the above sites is €1,344,000. These sites will also be liable for the vacant site levy for 2020 for same amount. A demand for payment for the VSR levy has been issued for VS/0124 (Weavers Row, Clonsilla, Dublin 15) for €129,500 and for VS/0119 (Lands at Howth Road, Co. Dublin) for €2,310,000.

The demand for payment for VS/0124 was appealed to An Bord Pleanála (ABP). ABP confirmed the demand for payment on the 15/09/2021. FCC is awaiting a decision from ABP on VS/0119.

A market valuation has been received (13/04/2021) for VS/0129. The site was valued at €450,000.

2 sites were placed on the VSR on the 29/09/2021. These include VS/0128 and VS/0130. Valuations are currently being sought for these sites.

Heritage Office

The Heritage Office was delighted to support Castleknock Tidy Town's Virtual Heritage Tour which was recently launched by Fingal's Mayor Cllr. Seána Ó Rodaigh. Featuring contributions from well-known local personalities including Bernard Brogan, Senior Dublin GAA footballer; Dr. Noëlle Healy, Senior Dublin GAA ladies footballer and Sarah Hawkshaw, Irish Olympian, the video focuses on the historic village of Castleknock from the 'hurry up bell' and Harry Clarke window of St Brigid's church to the Myo's pub, the site of a former blacksmiths. The eight Fingal projects funded by the Community Monuments Fund 2021 and administered by the Heritage Office were successfully completed. These included works at Castleknock Castle, Kilsallaghan Graveyard; Burial site in Ward River Valley; Surveys of St Columba's Towers, Swords, Malahide Demesne Church, Lanistown Castle, St Catherine's and St Marnock churches, Rush Tower House and an archaeology audit of the Donabate-Portrane Peninsula. Minister for Housing, Local Government and Heritage, Darragh O'Brien was briefed on the Fingal projects ahead when he visited Lanistown Castle, Newbridge Demesne ahead of the launch of the Community Monuments Fund 2022 which is open for submissions from the public to the Heritage Office until 15 February 2022. Forest of Fingal - A Tree Strategy for Fingal

Forest of Fingal, A Tree Strategy for Fingal was approved at the November Council meeting. This ambitious new strategy aims to use every opportunity to continually develop a thriving, diverse and sustainable tree population in Fingal, in line with the County's sustainable urban development. The aims and objectives provide clear guidance to enhance the delivery of significant improvements to tree cover in Fingal for the future. The approach to urban tree management has evolved significantly in recent years and the new tree strategy takes account of these changes and innovation. The Council is aware of the value of our trees and the Strategy is proof of the Council's continued commitment to one of the most important natural assets in the County.

The Strategy applies to all trees, woodlands and hedgerows managed by the Council, as well as seeking to ensure due consideration is given to trees in the planning and development process.

As environmental awareness improves, more and more of us are conscious of the importance of our trees. This was made very evident with the considerable number of quality stakeholder submissions received as part of an active public consultation campaign earlier in the year. It is anticipated that the official launch and publication of the Strategy will take place early next year.

Building Control/Taking in Charge Section - 29/11/2021

Building Control

- BCMS –134 CNs for 344 units were received in September and October 2021 and 525 Completion Certificates were processed. Building Control Site inspection rate for September and October is at 0.77% and 5.88% respectively of new buildings. Almost all DAC, FSC and Dispensations are now coming through electronically via the BCMS applications module.
- Enforcement There has been Part K, Part B and part M non-compliance issues for which we are awaiting responses.

Taking in Charge

- There are two estates, Rahillion in Swords and Hampton Green in Balbriggan proposed to be Taken in Charge in December and there is foul sewer & watermains in St. Marys, Baldoyle and also a hammerhead at Old Golf Links, Malahide to be Taken in Charge in January 2022.
- We have 46 developments with formal TIC requests and a further 306 developments on our system, of which 62 are likely to remain private.
- Phase 1 TIC Fingal contractor works on the following estates - Chieftain's way, Martello, New Haven Bay are currently underway.
- Phase 2 TIC Fingal contractor works Drynam, are under construction at the moment.
- There is also works ongoing in Thornleigh Swords by a completion contractor on behalf of the bondsman.
- The contract documents for engagement of Consulting Engineers to manage the Ongar remediation works necessary to bring the estates in Ongar up to Taking in Charge standard will be going up on Etenders.ie within the next week.
- There are currently 26 developers set up on our External Taking in Charge Sharepoint Site to upload Taking in Charge documentation.

 A yearly review of the Taking in Charge Policy and Specifications is underway and meetings between Building Control and other Sections responsible for producing the Policy and Specifications have been carried out with the intention to release an update to the Policy and specifications in January 2022.

Dangerous Structures

 We currently have 49 active dangerous structures. There were 2 new notifications in September and 2 new notifications in October.


Works in November included completion of the new cycleways and footpaths and surfacing and lining of the road pavement. Remaining tasks include electricity connections for the traffic lights at the Mayne Road/ Drumnigh Road junction and fibre optic installation. Following the completion of these tasks, this project will be substantially complete and the new road can be opened to traffic for all road users which we are aiming for in early December. A road safety audit will then be carried out on the road. This FCC and LIHAF-funded project will serve to underpin the ongoing residential development in the area and significantly enhance road safety on the local transportation network.

Donabate Pedestrian Bridge

Córas lompair Éireann issued a draft legal agreement to Fingal County Council at end November which is currently being reviewed by FCC appointed solicitors. Liaison with Developers east and west of the proposed bridge is ongoing. The Planning and Strategic Infrastructure project team are liaising with the FCC Property Section on the transfer of lands for the proposed bridge landing areas and the necessary agreements required to ensure access to the bridge for construction, long term maintenance and for the general public. The procurement process for a main contractor was issued to the market in May and a panel of shortlisted tenderers was formed. Construction on this NTA-funded project is expected to commence in 2022. Tender documents for the

appointment of an engineering consultant to undertake site supervision duties during the construction stage are currently being finalised.



Snugborough Interchange Upgrade Project

Main 9C sewer diversion works were completed in November, a significant milestone in the project with the opening up of extensive areas for the construction of the main structures. Piling works for the main structures is now significantly progressed (Photo Attached). Foundations of walls are ongoing with the picture above showing the completion of the earthworks to the southwest. Works will continue to be progressed off the main carriageways until January 2022. The website www.snugboroughinterchange.ie containing information on the project is now live and will continue to be updated with information relating to the project over its life term.

Works are advancing to prepare for pre-construction site clearance works through the coming Winter and Spring to allow for commencement of the main project works in Q2 2022. It is expected that tree planting and tree felling works will commence in January 2022.

Expression of Interest: Advance Purchase Arrangement for Residential Development Through Turnkey Agreements

Home builders and housing developers in Fingal are being asked to consider offering unbuilt houses or apartments with planning permission, to local authorities under an advance purchase turnkey arrangement.

Fingal County Council is seeking to enter into advance purchase arrangements to secure turnkey homes in areas where the need, in particular, for social and affordable housing, is most acute. This call is targeted at advance purchase opportunities for a minimum of 10 and a maximum of 150 dwellings in any one scheme.

It is anticipated that, depending on circumstances and proposals, Fingal County Council enter into an

advance purchase agreement for an approved number of homes, with payment on completion. The advance purchase agreement also provides for the direct sale of homes by the developer to an eligible purchaser nominated by the local authority. Joint venture arrangements that include an Approved Housing Body (AHB) will also be considered.

Housing Asset Management Report

Energy Efficiency/Retrofitting Programme (Housing Circular 8/21)



The 2021 Energy Efficiency Retrofit Programme is the first of a ten year programme which is expected to grow to meet the Programme for Government retrofit commitment. This revision will require local authorities to move to a 'deeper retrofit' programme, thus building on what has been completed in previous years. The revised programme provides for significant upscaling in the level of funding available and focuses on ensuring that the fabric of the home is upgraded and an energy efficient heating system is provided.

The approved allocation for Fingal County Council is €1,759,475 with a target of 65 properties to be retrofitted to a B2/Cost Optimal standard. Works are now complete under the 2021 programme.

Voids Programme 2021 (Circular 17/21)

The 2021 Voids Programme supports the refurbishment of circa 3,000 vacant properties nationally. Two refurbishment options are being funded this year which afford greater flexibility to local authorities, thereby facilitating maximum impact on the level of vacancy. The Standard Refurbishment programme provides for a maximum funding of €11,000 per property and Non-Standard provides for an average of €50,000 per property. The emphasis under the 2021 Voids Programme is on minimum refurbishment works to comply with the Housing (Standards for Rented Houses) Regulations 2019 to ensure quick turnaround and letting.

Funding approval to the value of €1.9m has been granted on the submission for 110 properties with the understanding that work will be completed and the property either tenanted or a tenancy offered and accepted in 2021.

Planned Maintenance Programmes Boiler Servicing

The Council provides an annual boiler servicing facility, including all maintenance and upgrade works, for a nominal fee of €3 per week to participating tenants. The Council releases batches of work to dedicated Contractors throughout the course of the year. To date, the Council has provided Contractors with 20 of 20 batches totaling 5131 properties and servicing is progressing well.

Cyclical Maintenance - Scheme Painting

The programme provides for external painting and joinery repairs to council housing stock which currently operates on a 6/7 year cycle.

The remaining dwellings are nearing completion as part of this current programme (listed below: Batch F & G). A new programme will be issued shortly.

Housing Tenancy Services Report

Housing Assistance Payment (HAP)

The new HAP online portal is well underway and over 60 tenants have submitted applications since it was introduced. The HAP team also continue to work through the remaining paper applications.

Since its inception in Fingal County Council in 2017, the HAP team has set up over 3,100 tenancies. The 714 new tenancies set up to date in 2021 is 2nd highest nationally.

Housing Support

The Housing Support Team are continuing to prepare a Social Housing Assessment Summary in accordance with Section 21 of the Housing (Miscellaneous Provisions) Act 2009.

The Council has contacted certain applicants who have applied for social housing support <u>after</u>

30thJuly 2020 to confirm they still require social housing support. Each applicant must confirm their requirement to the Council by completing and

returning the Assessment Form. The assessment is due to be completed by 15th December 2021.

Social Housing Assessment Packs issued by post in early October, which included a copy of the Assessment Form to be completed along with a prepaid return envelope.

A Reminder Letter has also issued by post, and the Housing Support Team have ensured follow up with phone contact with those who have returned their assessment form to date.

Further details, including a copy of the Assessment Form requiring completion, is available on a dedicated page on Fingal's Website, and the Housing Support Team will continue to ensure that every effort is made to connect with our applicants over the duration of the assessment to ensure their records are updated.

Choice Based Lettings

Choice Based Letting (CBL) is an approach used for allocating dwellings which allows housing applicants to express an interest in being considered for the allocation of designated Social Housing Units. Access to the Choice Based Letting (CBL) system is via the Council website at https://www.fingal.ie/choicebasedlettingscheme

Fingal County Council continue to offer dwellings through CBL. Information on new CBL dwellings are made available on our website on a selection of developments and individual units which have been designated for allocation using this approach.

Applicants have been encouraged to follow Fingal County Council on social media to stay informed of new dwellings available through CBL.

OpenSky

Fingal County Council are engaged with OpenSky in implementing the online-based CBL system. This system has been successfully delivered to other Councils in Ireland. The system enables a range of self-service functionalities for four specific types of user i.e. the housing applicant, the housing administrator, Local Councillors and the housing staff. The CBL system will be easily accessible to approved social housing applicants via a web-enabled portal that will protect and secure personal data of applicants. The system is due to go live in December with secure log in details being made available to all applicants.

Access will also be facilitated to Councillors to review availability of CBL properties. A short information session will be scheduled for Councillors as soon as possible.

The facility for applicants to express interest in a property online has worked well to date and the provision of the OpenSky system is expected to optimise the social housing allocation process and


positively enhance the overall experience of the housing applicant with the added outcome of reduced refusal rates of housing allocations.

Right -Sizing Initiative – Ladyswell, Clann Housing

In mid-November, letters were sent to Council tenants aged over 55 who are currently living in the Dublin 15 area to inform them of the opportunity to consider right-sizing their home to a more age friendly accommodation with Clann, an Approved Housing Body. Clann is a dedicated age-friendly Approved Housing Body committed to providing quality housing and services that enable people to remain residing within their community as they age. The recent construction of three apartment buildings providing 22 apartments in Ladyswell for Clann has been identified as an ideal opportunity for Council tenants to consider right-size. To date, there has been a positive response to this initiative.

Offers of Housing Support


The Housing Allocations Team has continued to provide offers of social housing throughout all levels of **COVID-19 restrictions** and this is demonstrated in the chart below.



Homeless Services


The Council's Homeless Team continue to engage with those experiencing homelessness to offer advice and support. Homeless Assessments continued over the phone through all levels of Public Health Restrictions.

In November 2021 there were 56 new homeless presentations, comprising 34 families and 22 singles/couples.



During November 2021, 32 households, comprising 23 families and 9 singles/couples, exited homeless circumstances into various forms of social housing support- including into private rented tenancies under Homeless HAP.

Homeless HAP accounts for 23 of these tenancies.



Cold Weather Strategy 2021/2022

The Dublin Region Homeless Executive (DRHE) has activated its Cold Weather Strategy 2021/2022 which runs from November 2021 to the end of March 2022. This is in order to meet a likely increase in demand for homeless services and to have the appropriate contingency plan in place for cold weather conditions. Should there be a cold weather or any emergency event, the DRHE will co-ordinate the response to homelessness on behalf of the four Dublin Local Authorities. Whilst services continue to operate throughout the year to support people experiencing homelessness, during the winter period, services are increased and enhanced to mitigate against the health risks that the bad weather poses.

Draft Homeless Action Plan 2022- 2024

The DRHE is currently reviewing the Homeless Action Plan Framework for Dublin 2019 -2021. As part of the consultation process for the development of the new Statutory Homeless Action Plan 2022- 2024, the DRHE has planned a consultation session with Councillors of the four Dublin Local Authorities to take place via Team/ Zoom at 10am on Friday 10 December, 2021. An invitation has been circulated to all Councillors in this regard.

Traveller Specific Supports

Covid-19 Continued Support

Measures have continued within Fingal to ensure that Traveller families receive as much assistance as possible during these unprecedented times, and particularly having regard to relevant and current public health guidelines and restrictions levels.

Daily site visits by Housing Inspectors are continuing with due care to maintain public health guidelines while checking on vulnerable residents and advising on the continued supports available.

Senior Officials are engaged on an ongoing basis with the HSE pertaining to Covid Public Health Guidelines.

Traveller Accommodation

programme of works in relation to refurbishment upgrading existing and of accommodation on specific sites is currently in development with the County Architect. Ongoing site works is continuing on a number of sites in order to maintain and Traveller Specific progress Accommodation in accordance with the provision of the Traveller Accommodation Programme 2019-2024.

General site maintenance has continued on all Traveller Specific Sites throughout all levels of Covid restrictions.

The construction of a new Group Housing Scheme at Stockhole Lane/ Baskin Green has concluded and new tenants recently attended tenant induction training in advance of signing their Tenancy Agreements and occupying their new homes.








Housing Welfare Service

The Social Workers attached to the Housing Department are available to support vulnerable tenancies and to work with housing applicants who have medical/welfare needs.

The Estate Management Section continues to work with the most vulnerable and complex of our Tenants in collaboration with our Housing Welfare, Tenancy Sustainment Officers and external statutory agencies to protect and assist the most vulnerable of our tenancies.

Maintenance Requests



During all levels of Covid restrictions essential maintenance works such as electrical, water and heating were maintained, and 14,342 maintenance requests have been received year to-date.

Anti-Social Behaviour/Inspectorate Unit

The ongoing management and sustainment with regard to social tenancies and good estate management falls within the remit of the ASB/Inspectorate Unit. Alleged breaches pertaining to tenancy agreements are investigated and pursued in accordance with housing legislative guidelines.

There are occasions when the vulnerabilities, complexities and heath related issues associated with a tenancy require tenancy sustainment intervention and supports. Ongoing case management and review with a variety of external agencies, including Approved Housing Bodies, An Garda Síochána, TUSLA and the HSE is a necessity to ensure all agencies work collaboratively with a view to achieving best outcomes.

Estate Management

The Estate Management Section engage with several internal Departments during the course of our daily duties, however a recent working collaboration with our colleagues in the Community Department emanated in a very successful Community Engagement Day at Racecourse Commons in Lusk on Saturday 6th of November. The event was well received by the Community of Lusk, the residents of Racecourse Commons, Elected Representatives and Lusk Community Gardaí who were in attendance, resulting in a fun day for our residents and built community relationships.



The Fingal Community Office brought local agencies such as Balbriggan Integration Forum- Balbriggan Youth Forum, Aster Family Resource Centre, Empower, Foroige, "Outcomers" Services, Mental Health Ireland, Flemington Community Centre together in the community centre to highlight the services and activities available for the people of Balbriggan, to share knowledge, build networks and future collaborations on projects, and to discuss Fingal Community and Sports Hub.

The Community Hub is a dedicated space to encourage and support the development of our local groups and services and to develop and increase awareness of activities in our Community Center's.

The Community Hub will provide free meeting space for new and re-emerging Community groups, support group development through training and funding opportunities and develop relationships between stakeholder's, community services and agencies. This showcase is the first of 6 showcases associated with the Community and Sports Hub in Flemington Community Centre.

Racecourse Commons Community Engagement Pilot in Lusk





The Community Office, in partnership with Estate management/Housing department delivered an innovative community engagement programme with the residents of Racecourse Commons and Green The Community Development Office, in in Lusk. partnership the local residents the North Fingal Community Development Team, the Sports Officer and the Integration Office developed and delivered a programme of community/sports outputs, culminated in this a family day/consultation day for the whole estate. Urbact Playful Paradigm -Rush





Rush is following Corks City's lead to becoming a playful Town. On Saturday 20th November 2021 a day of playful events was organised in collaboration with Rush Tidy Towns. The event was for both young and old with morning and afternoon workshops in two locations in the town. Two children's Lego workshops took place in Rush Library, and two painting workshops in Rush Community Centre. These events mark the first of many more playful initiatives in development for the people of Rush.

Fun with Families from Afar – Migrant Literacy Project



On the 5th of November, the Migrant Family Literacy Project 'Fun with Families from Afar' began its first session of a 5 week 'right to read' family literacy programme.

This is a collaborative pilot programme between Fingal Libraries, the Community Office, Aster Family Resource Centre and The Educate Together Primary School in Flemington Balbriggan and Fingal Integration Officer and is set for further roll out across the county in 2022. The literacy content of the project was developed through libraries by facilitators from DCU (Dublin City University) who are teachers and home liaison officers.

In Balbriggan the Migrant Literacy Project has families participating whose children have been identified through the Educate Together and is open to wider family members outside of the traditional

unit. The children participate with entertainment focusing on drawing, reading and fun whilst parents can connect with each other and exchange experiences and ideas.

Creating spaces for Inter-Cultural Dialogue

On the 14th of October The Fingal Community Office in partnership with Fingal Children and Young People's Services Committee brought the Chief Executive, Anne-Marie Farrelly and agencies such as Fingal County Council, The Childrens Rights Alliance, Tulsa, The Ombudsman for Children, The Irish Primary Principals Network and The National Association of Principal, the Ombudsman for Children, The Irish Primary Principals Network and The National Association of Principals and Deputies and together on a discussion panel for the webinar called *'Creating Spaces for Intercultural Dialogue'*.

The webinar brought black, mixed race, Traveller and Roma youth together to share their experience of racism. The energy displayed by all involved lead to a very successful and worthwhile event.

UN International Day for the Eradication of Poverty - Balbriggans Call to Action



On the 18th of October 2021 Mayor O Rodaigh gave the opening address to mark the UN international day for the eradication of poverty. Aster Family Resource Centre in Balbriggan in collaboration with Balbriggan Educate Together and support of Fingal Community Office joined in solidarity to raise awareness on "Child Poverty in our Community." This event was in collaboration with the 6th class

students of The Balbriggan Educate Together National School and was a huge awareness campaign success.

The UN International Day for the Eradication of Poverty is a worldwide event that marks the significant gathering of 100,000 people in Paris to honour the victims of extreme poverty, violence and hunger. This gathering declared that poverty is a human rights violation and called for international effort to address it. Every year people come together to show solidarity with those who suffer under the violation of poverty throughout the world.

Building our Community Coping with Change

On October 28th, 2021, the project 'Building our Community Coping with Change' doubled its LGBTQ+ group participants who were welcomed into Flemington Community Centre, Balbriggan.

The project began on the 29th of September and is a 24-week programme encompassing resilience training, reading materials and room space while the group will identify and train potential group leaders. It encourages community participation through engagement, accessibility, and training. LGBTQ+ Community makes up approximately 10% of our community. Those who have been isolated during covid remain a priority and a support group in Flemington Community Centre is underway. Isolation can be a key theme for members of the LGBTQ+ community leading to social exclusion and community isolation. This project offers support to the group/individuals to identify group culture, individual resilience, and life participation in civic in Balbriggan. This programme for LGBTQ+ resilience training, group development and materials is in line with government directives, the Fingal Integration Strategy, and the the work of Community Development Office.

Fingal Community Facilities Network Website Launch



Fingal Community Facilities Network have launched their new website, showcasing a wide range of information on 31 community facilities. This project is supported and funded by Fingal County Council's Community Development Office. The website features a page on each community facility and includes information on activities taking place in the facility, location, photos, and spaces available for hire. It is hoped that the website will be used as a resource by communities around Fingal and will provide weekly updates and information on activities and events happening across Fingal.

Each facility featured is a member of the Fingal Community Facilities Network which was set up by the Community Development Office in 2017. The main role of the Facilities Network is to provide a forum for discussion, training, and collaborations.

As well as the facility information pages, the new website also features pages for resources for community groups as well as news and events pages for all that's happening in Fingal County Council supported Community Centres.

Parslickstown House Refurbishment completed



Refurbishments to Parslickstown House Community Centre in Dublin 15 have been completed including the new Annex Hall. Funding was received from the Department of Tourism Culture Arts Gaeltacht Sport and media under the sports capital program of €113,000. Matching funding of €50,000 was also awarded from the Community Development Office to reconfigure, insulate and make the hall accessible for the whole community. This will be a fully accessible multipurpose space available for community enjoyment, comprising of a large dance studio, accessible toilets, and two small meeting rooms. A number of youth, sport, dance, fitness, education and training groups will be encouraged to use the facility. This space will also complement the existing facilities in the area.

Fingal Comhairle na nÓg

On the 11th of November the Fingal Comhairle na nÓg held their online AGM. Over 17 schools participated. Cllr Daniel Whooley, Deputy Mayor of Fingal opened the meeting with a warming speech. The event was also attended by a number of Councillor's from across the county. Leigh Kenny, Therapist and Pieta House Regional Manager for the greater Dublin area spoke with the young people and guests about suicide

awareness and services available, finishing with a short Q&A session. During the AGM there were a number of breakout rooms where young people chose topics to discuss as a group and participated in games. This year's topics were: Climate Action; How the pandemic affected Mental Health; Improve School Curriculum to educate students on racism, sexism and Misogyny, LGBTIQ+. The young people engaged extremely well and had a lot to say on these topics.

This year over 70 groups participated with a wide variety of events and workshops. This is the third year of the project which really highlighted the positive work that communities, agencies and other organisations are involved in to reduce social exclusion and poverty in Fingal.

EU Direct Blanchardstown Library partnered with the Fingal Integration Officer and

Fingal Comhairle a nÓg to work on a consultation project which would feedback to The Conference for Future of Europe. The topic Fingal Comhairle na nÓg was Education and Youth. The Mayor Seána O'Rodaigh welcomed Comhairle to the Council Chamber in County Hall on Monday 15th November to begin the consultation and commended the young people on their commitment to ensuring the voice of the young people was heard across the county. This scheme has been reviewed for 2022 with additional elements being added such as (i) Delivery and Programming of Small Scale and New Festivals, (ii) Events Delivery and Programming of Medium and Large-Scale Festivals & Events and Festival and (iii) Events that promote Economic Development/ Diversity and Sustainability.

EU Direct Partnership with Fingal Integration Officer and Fingal Integration Forum



EU Direct Blanchardstown Library partnered with the Fingal Integration Officer and Fingal Integration Forum to work on a consultation project which would feedback to The Conference for the Future of Europe. The topic for Fingal Integration Forum was Migration. The Mayor Seána O'Rodaigh welcomed Forum members to an online facilitated consultation session on Tuesday 16th November 2021 and spoke about the importance of hearing the migrant voice at local, national and international levels. The Economic, Enterprise, Tourism and Cultural Development Department has supported 15 market days, 11 illuminations of buildings and awarded funding/ supports to 15 Festive projects in Fingal.

Fingal Ethnic Network Showcase



Fingal Ethnic Network held an open evening on Thursday 18th November 2021 to showcase their network to the residents of Fingal. The Fingal Integration Officer attended and gave an overview of the Integration Officers role, the Fingal Migrant Integration and Social Cohesion Strategy followed by a question and answers session. The Ethnic Network membership was on hand to give an overview of roles and of their workplan including their Service Level Agreement with Fingal County Council's Community Development Office.

STRATEGIC UNIT

Fingal PPN Plenary

Fingal PPN hosted their Plenary on 10th November online with over 70 groups in attendance. Members voted to accept a number of constitutional changes to bring Fingal PPN into compliance with the DRCD PPN Handbook. This Plenary session also the launch of Fingal Inclusion Week.

PPN Policy Hub



Fingal PPN are delighted to launch the PPN Policy Hub at their recent Plenary session. This policy hub is an invaluable resource which will support and guide linkage groups and their reps in building their capacity in how they engage with their relevant committees and assist in impacting the decision-making processes in Fingal.

SPORTS OFFICE

Women in Sport Coaching Masterclass

This practical element of the Women in Sport Masterclass Series was part of the overall plan to develop and encourage greater female involvement in coaching positions in sport. This event was delivered by Dublin Ladies Football Manager Mick Bohan. The 2-hour workshop took place in Tyrrelstown AWP with 68 coaches in attendance from all over Fingal (50% from D15). Mick spent time coaching the newly formed Tyrrelstown GAA Girls u10 team and worked with coaches on the principles of coaching children. We are looking at developing similar practical sessions in other sports in 2022.

PE Teacher Training Day

The Fingal Secondary School PE Teacher Training Day was held at the National Indoor Athletics Arena and seen 25 PE teachers attended from schools across Fingal and South Dublin. The event was supported by our co-funded NGB's (cricket & Tennis) and non-co-funded (badminton & Volleyball) who provided a practical & theory-based approach to learning. The practical element of the workshops was a great success and both teachers and NGB's welcomed the engagement and it has presented further coaching development opportunities to support the work done by teachers in schools. We are looking at developing this as an annual event with an option for primary school teachers also.

Fit for All

The Daughters of Charity Adult Day services are participating in Fingal's Outdoor Inclusive Exercise Programme. The Day Services in the Blanchardstown area meet every Thursday in Millennium Park to walk/run the park route as well learning from our tutor how to use the outdoor gym equipment. It is hoped this will develop into a regular indoor gym programme in 2022.





Fingal HomeFit Yoga

The Sports Office is facilitating a 6-week online yoga course aimed at beginners that concludes up on December 8th. The 1hr class guides participants through the session and introduces them to the benefits of yoga through breath work, yoga postures and relaxation. Each week looks at a incorporating different postures and techniques helping participants to feel more at ease in their body and mind.

Men's Walk & Talk

We are in the process of launching Men's Walk and Talk Groups in Balrothery, Dublin 15 and Tyrrelstown to accompany the very successful pilot programme taking place in Lusk. The group is led by local volunteer walk leaders and the group meets once a week for 30min/5km walk where they can talk about anything and everything. This free initiative encourages men who wouldn't normally be targeted on Sports Programmes to get more physically active.

Sports Funding

Although the equipment and youth sports funding has closed for Sports Clubs, we have committed to funding over 105 clubs (9 applications to be approved at full council meeting in December) approximately €130.000 in 2021.

AGE FRIENDLY

Activities for Older People: Taster Sessions



While community centres and facilities open, many older people are reluctant to reengage with their group and community centre. To support volunteers and community centres in their efforts to encourage older people to re-engage and re-establish their groups, taster sessions of suitable activities for older people were organised during Fingal Inclusion Week.

With support from the Community Office, Donabate

Active Age held a demonstration of activities available in the club for members to try. The Community Development Office invited volunteers, coordinators and older people from groups based in Fingal Community Facilities in Dublin 15 to participate in the taster sessions. The activities focused on wellness and included different levels of physical activities such as 'Sit and Get Fit' and 'Stronger for Longer' as well as 'Mindfulness'.

Flexibus provided the transport for participants from Dublin 15 to Donabate. The event provided an opportunity for groups in Dublin 15 to experience new activities, meet with potential tutors

and share their own experiences of activities which worked well for them.

Corduff Senior Café: Information Sessions Pilot



Every Friday morning throughout November, Corduff Community Centre held a coffee morning for older people which provided a space for older people to meet and obtain information from invited guests. The local Community Garda attended the first week and was available to discuss safety issues with individuals.



Fingal Active Travel provided transport on the trishaws in week two. Fingal's Healthy Age Friendly Homes Coordinator attended the centre in week three, providing information on services.

Towns & Villages

Connectivity/Permeability

We are continuing to receive various requests for Permeability and Connectivity improvements from various stakeholders across the county. These requests are being recorded in detail for evaluation and if appropriate identification of a means of delivery on the ground.

A number of meetings has taken place with Councillors with regard to some of the requests received to evaluate the issues and examine how best to deliver a solution.

Where there are existing other Projects in close proximity to the areas highlighted, at design or construction stage we endeavour to include these Connectivity and Permeability improvements within overall schemes. Some of the current projects that are included are as follows.

- St Cronan's Junior & Senior school Safer Routes to school and Brackenstown Road Cycle lane and resurfacing included within the scope of works under St Cronan's Avenue project.
- Safer Routes to School treatment at St Philip the Apostle included under the scope of works for the Hartstown/Huntstown Protected Cycle Lanes Phase 2 project.
- Safer Routes to school for Holy Family NS is currently being considered for inclusion under the Rivervalley / Rathingle Phase 2 protected cycle lanes works.
- Similarly we are looking to include permeability connectivity and SRTS measures under our Towns & Villages scope where feasible.

Greenway connectivity support teams have been convened to review, design and deliver active travel infrastructure that will enhance accessibility betwen the proposed strategic greenways and residential,

educational, amenity and commercial zones. These support projects have been set up for Fingal Coastal Way, Broadmeadow Way/Sutton to Malahide Greenway and Royal Canal Greenway. This will help to optimise the use of the proposed greenway by both leisure and commuter users.

Road Safety

'Light up your Bike' Road Safety Campaign

The four Dublin Local Authorities, An Garda Síochána, the Road Safety Authority, and the Dublin Cycling Campaign teamed up to launch the 'Light Up Your Bike' campaign on Tuesday 2nd November at the Mansion House. Now that the clocks have gone back, road users may be faced with darker commutes and those that cycle are reminded that the use of bike lights is a legal requirement when cycling during lighting up periods.

The use of bike lights helps increase cyclists' visibility to other road users and reduce the risk of serious accidents on our roads.



World Remembrance Day

Sunday, 21st November marked the 26th annual World Day of Remembrance for Road Traffic Victims. Fingal County Council lit our County Hall and Civic Office buildings in Amber lighting in memoriam along with Councils across Ireland, as we remembered those who have tragically lost their lives in road traffic accidents. We also asked people to shine a light in their homes and businesses on the evening of Sunday 21st.

This year marks the start of the new Decade of Action for Road Safety 2021-2030. The objectives of World Day of Remembrance 2021 are to provide a platform for road traffic victims and their families to:

- remember all people killed and seriously injured on the roads;
- acknowledge the crucial work of the emergency services;
- draw attention to the generally trivial legal response to culpable road deaths and injuries
- advocate for better support for road traffic victims and victim families;
- promote evidence-based actions to prevent and eventually stop further road traffic deaths and injuries

WDoR 2021 puts the spotlight on the reduction of traffic speeds – Low speeds, which have the potential to prevent many deaths and serious injuries, in particular those of pedestrians and all other vulnerable road users – children, elderly and the disabled.





Road Safety Authority and An Garda Siochana Christmas and New Year Road Safety Appeal

The Road Safety Authority (RSA) and An Garda Síochána have called on drivers to act responsibly and to not be tempted to drink and drive this Christmas and New Year period. This year's Christmas and New Year road safety appeal focuses on the dangers of driving under the influence of alcohol and the devastating loss of life and serious injuries it can cause.

- 83 fatalities and 709 serious injuries in Christmas / New Year period over last five years
- Morning after highlighted as one in four drivers admit to driving over the limit the morning after drinking
- o Drivers reminded that all drink driving offences carry a disqualification
- Almost 4,500 drivers arrested for drink driving to date in 2021

Fingal County Council's Road Safety Section fully supports this appeal and we will publicise this on all our Social Media platforms in the build up to Christmas.

Recently some of the members of the Active Travel Team together with Senior Management, Cllrs, and members of the Planning & Strategic Infrastructure Department embarked on an Educational Trip to Netherlands to research some of the Cycling & Walking Infrastructure and Public Realm enhancements that has been introduced there over the years. We left on Wednesday the 27th October 2021 and returned late on the Saturday 30th October 2021. The trip was busy and it would be fair to say we packed five days into three in order to take in as much as possible

Our trip took us to Amsterdam and onto Utrecht where we based ourselves over the few days and travelled by train to Eindhoven and back to Amsterdam for our flight home to Dublin.

Each day we embarked on a different trail by bike and over the three days over 110km were cycled by the group. We had a number of informative and thought provoking presentations from city officials and active travel experts.

While the Infrastructure, active lifestyle culture and behaviour towards walking and cycling is well ahead of where we are currently at in Ireland, everybody took something from the trip and identified with some small and large element of change that will help build the blocks of what can be achieved here in Fingal on our Active Travel Journey.

The trip was well received by everybody and has opened our minds and understanding of what can be achieved if we all work together.

Climate Action

The Fingal Climate Change Action Plan 2019-2024 (CCAP) was launched in Sept 2019, and actions are ongoing.

The CCAP and the One Year Progress Report can be viewed at https://www.fingal.ie/climate-change-action-plan-2019-2024

The CCAP Second Annual Progress Report is being drafted at present and will be presented to the Climate Action SPC in December 2021.

COP 26 'Conference of the Parties' concluded in early November in Glasgow. This was a Global Climate Action Summit and a follow up to COP 21 in Paris December 2015, where agreement was reached on limiting global temperature increases to "well below 20 DegC" with an aspiration to limit rises to 1.50 C above pre-industrial levels. However, national pledges on emissions – known as nationally determined contributions, or NDCs – have been insufficient to fulfil either goal.

The main outcome of COP26 was the agreement of the Glasgow Climate Pact, which includes the following:

 Agreement that the current NDCs, are inadequate to limit temperature rises to 1.5C, and a roadmap for more frequent revisions of NDC's starting at COP27 next year in Egypt.

- Countries agreed to come back next year with new strengthened commitments.
- Commitment to "phase down" coal-fired power generation. Unfortunately, this text was watered down from "phase-out", at the last minute. Nevertheless, agreement on this was important.
- Commitment to significantly increase funding for developing countries hardest hit by the effects of climate change.

The Climate Change Action Plan 2021 (CAP 2021) was published in November 2021 in line with the requirements of the Climate Action and Low Carbon Development (Amendment) Act 2021. This plan sets a roadmap for taking decisive action to halve Irelands emissions by 2030 and reach net zero no later than 2050, in line with the Programme for Government. The Plan sets out emissions reductions targets for each sector of the economy and actions to achieve these. In relation to local authorities, the Plan states:

The Climate Action Regional Offices will continue to play a central role in supporting and coordinating climate action by local authorities including: developing capacity through training; supporting behavioural change initiatives; identifying and sourcing funding opportunities; and measuring and recording performance.

- Each local authority will prepare a Climate Action Plan at least once every five years, containing both mitigation and adaptation measures
- Each local authority will develop a decarbonisation zone within its administrative area that will become the focus for a range of climate mitigation, adaptation and biodiversity measures. This process will include the identification of projects and their associated outcomes that will contribute to achieving our national climate targets.

Environmental Awareness

Anti Litter Anti Graffiti projects are ongoing and nearing completion in several communities including murals in Swords, Rush, Balbriggan and Corduff Dublin 15 and biodiversity areas in Mountview/Fortlawn Community Youth and Youth Community Sports Hub and Castlefield Park Clonsilla.

Teachers from 17 Fingal schools received online training for composting and had a site visit to assess opportunities for composting at the school. Several leaf mould cages were set up to compost leaves. Oberstown Childrens Campus young people are making the wormeries and pallet bins for the project. This is all part of the funded Composting for Schools Pilot in the Dublin area.

In support of ReUse month, repaired bicycles and instruments were gifted to a number of schools including a full drumkit to New Cross College, 10 guitars and 5 keyboards to Lusk Community College & Lusk Senior National School.



Bring Bank Expansion

The Environment Department continues to work to expand the network of Glass and Textiles recycling facilities throughout Fingal.

A Bring Centre shall shortly be installed at the community centre at the Red Arches in Baldoyle.

Textile Recycling

A new contract for the collection and recycling of textiles in Fingal commenced on 15th November 2021. The contract will focus on confirmation of textiles end destinations, tonnages collected, and percentage waste collected. The contract has also provision for expansion of the textile bring network as required.

A total of 20.07 tonnes of textiles was collected and recycled in October 2021 from our 29 Textile Banks locations throughout Fingal County Council. Textile tonnages for November shall be available by mid-December.

The total tonnage for textiles collected and recycled between January and October was 206.37 Tonnes.

Horse Welfare Programme



This Plan is required for the implementation of our obligations under the *EU Water Framework Directive*. The Plan is for all of Ireland and it's the third planning cycle of the plan and aims to protect and restore to

good water quality in our rivers, lakes, estuaries, groundwater and coastal waters by 2027. **Appendix 2** sets out the proposed programme of measures of which there are 111 in the Plan. They aim to tackle the impacts on water quality from human activities.

Public participation is key to giving a voice to communities and water users in the production of this Plan - which is hoped will be finalised in 2022. Our first public consultation meeting in Fingal took place online on Wednesday 24th November, 2021 and additional dates will be scheduled in 2022 (dates will be posted to our website; https://www.fingal.ie/council/service/river-and-lake-water-quality-monitoring).

Waste Enforcement

The Department of the Environment, Climate Action and Communications has issued the National Waste Enforcement Priorities for the period 2022 – 2024. At a recent meeting of the National Waste Enforcement Steering Committee it was agreed that going forward, the national priorities should be set for a three year period, subject to annual review.

The 2021 priorities remain broadly relevant therefore, the following high-level priorities have been agreed for the 2022 to 2024 time period:

- Tackling significant illegal waste activity
- Construction and Demolition Activity
- End-of Life Vehicles (ELV) Directive & the Waste Metal Industry
- Waste Collection- Household & Commercial
- Producer Responsibility Initiatives and additional local priorities

These high-level priority areas have associated annual (2022) and multi-annual (2022-2024) deliverables. It is the intention to maintain the multi-annual programme constant for three years subject to review on an annual basis by the National Waste Enforcement Steering Committee.

The Waste Enforcement Regional Lead Authorities will provide further guidance on the implementation of the National Waste Enforcement Priorities for 2022 and the enforcement network co-ordination team in the EPA will ensure that activity and outcome measures relating to the national waste priorities are incorporated into performance assessment and the RMCEI system.





RMCEI Inspection Plan 2021

The RMCEI inspection plan for 2021 is nearing completion with inspections undertaken in key areas such as:

- Packaging/Significant Major Producers/Self Compliers
- WEEE/Batteries/Mercury
- Hazardous Waste/Garages
- Tyres/Imported Vehicles
- Waste Facility Permits/Waste Collection Permits
- Authorised Treatment Facilities
- Unauthorised Scrap Yards
- C & D Skip Operators of Concern
- Man in the Van/Illegal Waste Collectors
- Waste Complaints/Back Yard Storage/ Burning of Waste
- Waste Presentation Bye-Laws
- Construction & Demolition waste/Article 27 Notifications
- End of Life Vehicle Project
- Metal Theft and Metal Traceability Project

A total of 932 inspections have been completed to date across the 5 key priority waste areas:

- 1/ Tackling significant illegal waste activity,
- 2/ Construction and Demolition Activity
- 3/ End-of Life Vehicles (ELV) Directive & the Waste Metal Industry
- 4/ Waste Collection- Household & Commercial
- 5/ Multi-Agency Sites of Interest.









Two significant projects were also undertaken during 2021 which have had a direct effect on reducing and eliminating illegal activities both within Fingal and throughout the country:

A/ End of Life Vehicle Project - 400 work days (2 waste enforcement officers).

B/ Metal Theft and Metal Traceability Project - 200 work days.

Several legal files have been prepared for each project to ensure that enforcement actions are complied with, illegal activities stopped, and sites are cleaned up preventing environmental pollution. Efforts will continue into 2022 to ensure that these illegal activities don't return and that the individuals involved are prosecuted for breaches of the Waste Management Act 1996 as amended.
