- You should ensure that no vexatious, libellous, or confidential information, including confidential information relating to a third party (in respect of which the third party has not, expressly, or impliedly in the circumstances, consented to its disclosure) is included in your submission/ observation. The Planning Authority reserves the right to redact any submission/observation or part thereof that does not comply with this requirement.

Written submissions or observations with respect to the Draft Plan that are made to the Planning Authority within the period stated will be taken into consideration before the making of the Plan.

The Closing Date for receipt of submissions or observations is before 11:59pm on the 12th May 2022.

Please note LATE submissions/observations will not be considered.
