The proposed development consists of the rejuvenation and upgrade of the existing Wellview Park, situated at Church Road, Dublin 15, as well as two existing areas of public realm at Wellview Green and Terrace, totalling approximately 5.5ha. The proposed development includes: landscape and external works; pedestrian access points to existing footpath on west side of Church Road; paving and associated drainage works; regrading of existing grassland areas; planting; public lighting; play areas, signage, street furniture and associated fixtures and fittings; including all ancillary site development.
