1. Minutes

6. DRIVE Project

Brid Walsh nDRDATF and Inspector John Moroney AGS gave a joint presentation on DRIVE, (Drug Related Intimidation and Violence Engagement) initiative, circulated to members prior to the meeting. A DRIVE Co-ordinator, Siobhan Mahon has been appointed. BW and JM responded to questions from the members, and requested that DRIVE be put on workplan of the Joint Policing Committee.

7. Study of Women and Children's Safety in the Public Realm.

MTD advised that this could form part of JPC Work Strategy and agreed to give consideration to scope and how to progress it and to report back to the JPC. Suggestions from members as to range of agencies i.e. AGS, Community agencies, Third Level research. Agreed that it should be evidence based. MTD agreed to convene smaller group off line to discuss.

8. Draft Fingal Joint Policing Strategic Plan 2022 - 2024

MTD advised this is under development and will be co-ordinated with AGS to align with AGS policy. Draft to be prepared and brought back to the next JPC Meeting.

9. Reports from Safer Blanchardstown

Items circulated in advance of the meeting, members noted. Philip Jennings advised members there are 5 x 30 minute podcasts from Safer Blanchardstown. The Summer Festival is scheduled for 11th June. The Dublin 15 Domestic Violence Working Group is now back with face to face meetings, PJ stressed the importance of this.

PJ requested to make presentation on "Think Before You Buy" at next IPC meeting.
