Chief Executive's Foreword

I hope everyone had an enjoyable summer break and took some time to spend with family and friends. We are now in September and the remainder of 2022 is set to be an intense period for staff and Elected Members with the upcoming development plan meetings, the capital and revenue budgetary process and major projects reaching key milestones.

Ten development plan meetings have been scheduled as follows - 20th, 21st, 26th & 29th of September and 3rd, 4th, 7th, 11th, 12th & 14th of October. These meetings are in addition to Council, Area Committee, SPC and other commitments the Members have making it a particularly busy time. The executive management team and staff are happy to give any support needed to assist the Members.

The Swords Cultural Quarter development is with the Members for decision this month and if approved it is intended to move immediately to the next stage of detailed design and procurement. Another major project is Quay Street in Balbriggan and this will come before the Members in October.

We continue to apply for funding streams available to us and recently welcomed new funding that will help develop outdoor amenities in the County. The allocation of over €150,000 to Fingal under the Outdoor Recreation Infrastructure Scheme (ORIS) will support advancement of walking trails, beach access and look at the feasibility of a tidal pool. The funding covers four projects across Fingal: Balbriggan Historical Walking trail: Provision of new off-road waypoints (€28,800), Balbriggan Tidal Pool: Feasibility study for a tidal swimming pool (€50,000), Castleknock: The development of

historical walking trail (€23,400), **Balscadden Beach** (**Universal Access**): Feasibility study for the popular secluded beach in Howth (€50,000). This new funding compliments the efforts of the Council to support our towns and villages as we encourage people to get out and enjoy the great outdoor locations we have in the County.

Last week I was so pleased to launch a Wellbeing Strategy for the staff of Fingal County Council. This is a three year programme setting out our vision and aims for employee wellbeing in areas including mental, physical, social and financial wellbeing.

Blended working arrangements are now formally in place. There are many positives associated with blended working including the desire of FCC to be a modern employer, giving staff flexibility, assisting with recruitment of new staff to the organisation and making the best use of the investment in digitisation to name but a few. Staff not availing of blended arrangements have returned fulltime to the office.

Wellbeing Strategy

This month saw the launch of the Council's first ever Wellbeing Strategy 2022-2025. This strategy supports the Council's vision of ensuring that wellbeing is embedded in everything we do and is championed, at all levels, and across all functions. The Council has also engaged Spectrum Life, who work with a number of other local authorities, to provide a bespoke Employee Assistance Programme which will include a wide range of supports for welfare issues. This service, which will

supplement the current work of the Council's own Staff Welfare Officer, will be available to every staff member through a confidential helpline that will be accessible 24 hours a day and will also include a Wellbeing App delivering expert content on mental health. fitness and nutrition.







Digital Fingal at Flavours of Fingal.



The Digital Fingal Team along with representatives from Smart Dublin showcased a variety of innovative digital projects at this year's Flavours of Fingal. The team demonstrated the **Balbriggan 3D model** using a virtual reality (VR) headset, this proved highly popular with people of all ages.

Using the VR headset attendees were able to walk around the reimagined Quay Street and Harbour areas of Our Balbriggan's Rejuvenation Plan. The

team were also on hand to show attendees how to use the new **Fingal Connect App**, highlighting the many features, including real-time event info, surveys and competitions.

At the event the team were also showcasing the Fingal Digital Strategy, Environment's Weather Stations for Schools project and staff Smart Mobility Hub project.

Communications



The Communications Unit supported Heritage Officer Christine Baker to promote Heritage Week with video content from the Digging Drumanagh excavation and Digital Heritage Projects such as The Fingal Thatch Survey, Heritage from Above and the Heritage X Climate project. There was also a publicity campaign for all the Heritage Week events.

The Communications Unit also assisted the Planning and Strategic Infrastructure department in holding a three-day Wild Bee Festival in August. The event was in collaboration with National Biodiversity Data Centre, and Charlie and Marion Heasman from Sustainable Skerries to educate groups on the Large Carder Bee (Bombus muscorum) which are thriving in Skerries, as a direct result of the hard-working Skerries Tidy Towns group.

The Communications Unit also created an awareness campaign around the public consultation on the Swords Cultural Quarter which included a leaflet drop to households in Swords.

There was also an information day in the Pavilions Shopping Centre which was manned by staff from Architects and Libraries. A static stand was also placed in Swords Library, the Chapel at Swords Castle and the Atrium at County Hall. An edition of the Inside Fingal podcast was also produced which featured County Architect Fionnuala May, Architect John Tuomey, County Librarian Betty Boardman and County Arts Officer Rory O'Byrne. Website

Visitor numbers to the Fingal County Council website, fingal.ie, for the first eight months of this year are up four per cent on the same period in 2021 with 836,911 visitors logging onto the site compared to 804.552 last year. Page views are down slightly from 2,335,367 to 2,265,617 while the average time spent on the site has risen from one minute 28 seconds to two minutes and four seconds. Apart from the home page, the most popular topics for visitors between January and August were Planning, Choice Based Letting, Contact Us, Recycling and Jobs.

Social Media

Posts about the discovery of the Lion's Mane jellyfish on Fingal beaches proved to be most impactful over the past two months with one Twitter post in July recording a 33.6% engagement rate while another in August had 9.195 impressions. A Facebook post in August about the jellyfish had a reach of 69,705 and attracted 234 comments



The number of followers on Facebook has now risen to 28,561 after 647 were added over the past two months while Instagram saw a rise of 199 to 5,524 followers. Twitter now has 21,852 followers with 125 added in July and 92 in August. The You Tube channel has 800 subscribers while LinkedIn has broken the 6,000 mark and now has 6,008 followers.

Videos

Video is a very important communications tool for the Council and through our Communications Unit we have the ability to record, edit and publish our own videos. Among the videos produced over the past two months were a series of films on behalf of the Fingal Skills Strategy which featured different people from across Fingal speaking about the skills requirements and job opportunities in the Logistics industry within the county. Media Queries

Across the summer recess, the Communications Unit dealt with some 45 media queries through to August 31, with topics covered including rent arrears, data centres, Ukrainian refugee response, homes built across the County and litter left at the likes of Burrow Beach. The Council also issued 30 press releases in this time, including announcements on consultations for the

Balbriggan rejuvenation and Swords Cultural Quarter, launch of the Fingal Connect app and in season testing of bathing water. Alongside this, radio and TV pieces were focussed around people flocking to Fingal beaches and the clean-up efforts of Council staff to make them tidy for beachgoers the next day. Coverage of the influx of Lions Mane Jellyfish along the coastline also generated great interest, as did the role that goats were playing in helping reduce the risk of fires in Howth, particularly as this was an initiative called for to help future proof the likes of Killiney.

Award Nomination

The Communications Unit has received a Chambers Ireland Excellence in Local Government nomination for its promotion of the biodiversity initiative which saw a herd of Old Irish Goats being returned to Howth Head as part of a plan to prevent wild fires. The nomination is in the new Communications Award category. It is the second successive Excellence in Local Government nomination for the Communications as they were nominated last year for Best Local Authority Innovation for the Inside Fingal podcast.

Irish Language

Irish Language courses for Councillors will commence at the end of September with five Councillors set to avail of the course.

DCU Intra Programme

The Communications Unit has continued its partnership with Dublin City University's Intra Programme and has facilitated one student from the Masters in Public Relations and Strategic Communications on a three month work placement.



MALAHIDE CASTLE





The official re-launch of the Great Hall and Library at Malahide Castle will take place on Friday 16th September following extensive restoration of the rooms and conservation and specialised cleaning works on the art collection and artefacts.

NEWBRIDGE HOUSE AND ARDGILLAN CASTLE



Following the appointment of building contractors, conservation work on the roofs and windows are due to commence in mid-September at both Newbridge House and Ardgillan Castle.

These projects will last for approximately 9 months in both sites. On-site meetings with the contractors took place with all key stakeholders on 1st September to discuss mobilisation, health and safety and operational issues during the lifetime of the contract.

Work is also commencing on the issue of a catering tender in respect of Newbridge House and Ardgillan Castle - current contracts are due to expire in March 2023.

SKERRIES MARTELLO TOWER



An inception meeting was held in mid-August with the consultant architects who are working on design proposals for the refurbishment of the Red Island Martello tower at Skerries.

SKERRIES MILLS



The 5 sail windmill at Skerries Mills has been fully restored following storm damage in October 2021. The new hand crafted sail was erected on 1st September by a specialised engineering firm.

ARTS OFFICE

Seanchaí Micro Forest has been shortlisted in the Chambers Ireland Local Government Awards 2022 under Sustaining the Arts category. Fingal County Council Arts Office is working in partnership with Superprojects to deliver an art and ecology programme to students and teachers of Blakestown Community School, titled 'Seanchai Micro Forest' - a micro forest planted on the school grounds by artist Gareth Kennedy and the members of TY art class along with their teacher Mary Quinn and woodworker Eoin Donnelly. The programme consists of artist-led activities to teach young people about contemporary art practices. The students and artists erected tents and lit fires and used the circular space of the micro forest as a location for learning about art and our environment outdoors. Students learned variety of old techniques such as wood splitting and turning, digging and tree planting and mulching. 450 native trees now exist on the school grounds. The intent of this project is

to bridge the gap between art, nature and our daily lives. This year the students are developing the micro forest's habitat for insects and birds under the guidance of artist Gareth Kennedy, Eoin Donnelly, Eileen Hutton and Michael Fortune.

Micro forest will benefit local biodiversity and future students for years to come and was presented to a national conference on the theme of 'weaving wellbeing into school life.' It is an exemplary model of how art can provide us with opportunities to learn about and care for ourselves and our environment. Nationwide visited the project during the summer. We are delighted to have it shortlisted at this year's Local Government awards.



Fingal County Council Arts Office welcomes everyone to Culture Night Fingal 2022. Now in its seventeenth year, Culture Night, an annual national public event celebrating culture, creativity and the arts, returns on Friday 23rd September. For one night only arts and cultural organisations, castles and historic houses in Fingal will extend their opening hours to the public, highlighting the wealth of cultural facilities and talented people in the locality. This year's eclectic programme comprises of free live cultural activities at participating venues and locations.

Audiences of all ages can enjoy a variety of music, poetry, performance, workshops art, architecture, tours and talks specifically programmed for Culture Night in Fingal.

Our Balbriggan will welcome visitors to the Hub and St. Georges' Square with music from North Fingal Comhaltas Ceoltóirí Éireann. Also taking part in Culture Night is The Irish Institute of Music and Song, a superb music facility in Balbriggan, who will host a music trail through their campus and visitors to Ardgillan Castle will have the opportunity to meet the resident artists and designers in their bespoke artists' studios.

Join Astronomers at DIAS Dunsink Observatory for self-guided tours and cosmic talks among the stars. Visitors can also explore the beautiful interiors of Fingal's finest heritage properties such as the recently reopened great hall at Malahide Castle and the servant's quarters at Newbridge House and Farm or why not experience the amazing Fry Model Railway housed in the Casino Museum, Malahide.



Fingal County Council has partnered with The Dublin and Dún Laoghaire Education and Training DDLETB and Music Generation to improve music education opportunities available to children and young people in the county. Following a research, planning and application phase, the partners now have a Music Development Office in place – Lucy Coady (G6), Damien Byrne has started as administrator (G3) employed by DDLETB.

Lucy Coady working with Julie Clarke of Fingal Arts Office have implemented in-person meetings with local stakeholders invited to participate in a pilot programme this year.

Pilot 1: in Castlemills Education Centre Balbriggan Song Development course July - Aug as a summer camp in partnership with Foróige. 15-18 yr old Youth Reach group, will involve youth worker from Foróige with experience in recording technology to liaise with Music Educator and help build trust with young people.

Pilot 2: Remember Us, Balbriggan; Social Club for people with special needs and their families. Soundbeam programme 2 weeks in August. Targeting 12-18 yr olds as recommended by RU director, hoping to expand if successful. MEs to use own instrument & technology. Specific training will be required and will take place in July with Apple Soundbeam expert.

Pilot 3: Oberstown Children's Detention School Expected end of September. Project to teach vocals, guitar, bass & drums with aim to have group playing. Drum project to be adjusted to suit available ME skills

LIBRARIES

Increased opening hours at Balbriggan, Baldoyle and Rush Library

We increased opening hours at both Baldoyle and Rush Libraries from 42.5 to 54 hours per week with effect from 20th June this year. Baldoyle Library now opens on Tuesday and Thursday mornings at 9:45am and Rush Library opens on Monday and Wednesday mornings at 9:45am. The opening hours at Balbriggan Library were increased to 54 hours per week in May 2021.

'My Open Library' at Baldoyle Library

We have been piloting the 'My Open Library' (MOL) system at Baldoyle Library during the month of August. MOL gives access to the Library outside of normal staffed hours. This means that library services are available to registered MOL library patrons from 8am – 10pm, 365 days of the year. During this pilot phase, we have asked a number of our regular library patrons to use the services during unstaffed hours and to provide us with feedback, before we officially launch MOL at Baldoyle Library. All MOL members will go through an induction process in order to access the library building during unstaffed hours.

The Write Time Festival

Autumn brings a new program of festivals, events, talks and workshops to Fingal Libraries. Now in its seventh year, The Write Time Festival, celebrating creative writing, begins in September and runs throughout the month. The Write Time, which was recently launched by the Mayor of Fingal, Howard Mahony, is designed for anybody interested in the craft of writing. If you would like to make a start on a short story, personal reflections or even a novel, check out the program of workshops online and in library branches. - Covid Care concerts: Mobile Music Machine's 50 care concerts between July-December 2022 in residential care homes, hospital settings and day care centres in Fingal. Artists performing in Fingal include Claudia Boyle, Des Keogh and Mary Coughlan.

Codema Home Energy Saving Kits

Home Energy Saving Kits were developed by Codema in 2016 in a pilot scheme with Dublin City Council and introduced to other local authorities including Fingal in late 2017/early 2018. The kits contain 5 practical energy tools that allow people to identify the easiest and most key areas in which they could save energy, as well as a small guide that can be kept full of useful energy saving tips. Initially introduced in Fingal in 2018 with the original version of the kits, ten new updated versions of the kits were purchased and distributed among our libraries in July 2022. Irish Times Digital Access in Libraries

Digital Access to both the daily paper and archive of The Irish Times has been made available free of charge to library members in nine of our branches recently. Every public PC in the designated branches has bookmark links set up to take patrons directly to the daily paper or the archive.

Department of Rural and Community Development Funding

Fingal Libraries has been approved for funding of €274,050 for the provision of a My Open Library service at Blanchardstown and Malahide Library. We have also been successful in our application for Dormant Accounts funding to provide Library Supports for Marginalised, Socially Excluded and Disadvantaged Communities. A Dormant Accounts Fund contribution of €26,902.39 has been approved which will fund licenses for the interactive reading programme Lexia, C-Pen Readers and the Story Steps programme.

Blanchardstown Library signs up to the Age Friendly Charter

The National Age Friendly Library Recognition Programme initiated by Age Friendly Ireland acknowledges the key role libraries play in enhancing the lives of older citizens. In 2019 Malahide and Rush Libraries were nominated to take part in the first phase of this programme and were awarded the Age Friendly Charter. In 2021 Blanchardstown Library took part in the second phase of the programme. Following training, staff engaged with older customers regarding current service provision and a short survey was also distributed. Positive observations on current age

friendly practice included the bright spacious building, friendly helpful staff, and a good selection of large print, audio books, DVDs and online services. Areas identified for improvement included more age friendly comfortable seating, improved accessibility to bookshelves, clearer signage and help accessing technology.

To address difficulties accessing technology, weekly workshops (suspended during the pandemic) have been reintroduced at the Library. Patrons are encouraged to bring their iPads, laptops or mobile phones into the Library where staff guide them through the process of accessing online resources. Other commitments i.e. age friendly shelving, seating and clearer signage will be put in place as part of ongoing renovations in the branch. When these initiatives are fully implemented Blanchardstown Library will be recognised as an Age Friendly Public Library providing an inclusive service for all.

FINGAL IN IT TOGETHER



The Council continues to support business under the Fingal In It Together Charter and is developing a Fingal In It Together App offering businesses a digital platform to engage with customers.

Fingal Skills Strategy



Frank Kilbride (Chair of Fingal Skills Strategy Transport and Logistics Subgroup)

The Fingal Skills Strategy Implementation Group is scheduled to meet on the 6th September. Subgroups for Green Skills and the Services Sector held their first meetings in June with the Green Skills and Construction Sub-groups scheduled to meet in-person in September.

Development on the Fingal Skills Hub on the FCC website continues with the addition of a section on Careers in Transport and Logistics. This includes information on the logistics sector and video contributions from industry participants.

There has been ongoing engagement with businesses to provide assistance to secondary schools in Balbriggan with speakers for Careers Talks, with volunteers from companies in the logistics, construction, wind energy and hospitality sectors.

The Fingal Skills Strategy Initiative has been shortlisted in the Economic Development category for the Chambers Ireland Excellence in Local Government awards.

Urbact Playful Towns









Rush Urbact Local Group (ULG) organised a National Play Day event in Kenure Woods on the 9th July with the theme 'All Play Together'. The event was funded by a grant of €3,000 from the Department of Children, Equality, Disability, Integration & Youth. The new boules track also had a trial with equipment supplied by Rush ULG.





Rush ULG organised a Sports Day event on the 6th August at Tayleurs Point which saw great attendance from the local community and a medal ceremony with medal presented by the Deputy Mayor Cllr. Cathal Boland.



There were running races for young people and adults, a wellie-throwing competition, three-legged races, a tug-o-war and lots of games for everyone to enjoy on a fun-filled day.

Our Balbriggan 2019 - 2025 Rejuvenation Plan - A Socio-Economic Strategy



The Our Balbriggan Programme Office continues to support the Leadership Group and its five

pillars, who meet regularly, to progress work across a range of economic and social measures including: Growing the Local Economy, Public Realm & Infrastructure, Education, Skills & Employment, Community Integration, Health & Well Being and Community Safety.

The Education, Skills & Employment Pillar Group met on August 29th and work continues to progress actions to develop a place with excellent Education, Training & Employment opportunities the Loves Learning Sub-group are scheduled to meet next on September 27th to begin work on planning and developing the Loves Learning Festival 2023. The Local Economy Pillar are also scheduled to meet on September 21st prior to the Balbriggan Leadership Group Meeting on September 28th.

Supt. Paul Franey chairs the Safe Balbriggan Pillar, community safety consultants have been contracted to assist in the development of the Pillar Group's work programme. A series of planning and stakeholder meetings, communications, and package of supports and initiatives will be launched Q4 2022.



The demolition of the former O'Shea's Night Club building (Harbour) has been completed and the site levelled out to create a 'meanwhile space', steel planters and seating are due to be installed in September.

Public Consultation on the Part 8 proposed redevelopment for Quay Street & Harbour commenced on 7th July 2022 and closed on the

19th of August 2022 (99 submissions). Three well attended public drop-in sessions were held at the Our Balbriggan Hub in this period, CE Report to full council anticipated to October 2022.





Paul Keogh Architects, the appointed Integrated Design Team (IDT) for 2-4 Dublin Street are progressing Stage 2a Detailed Design. The proposals on renovation of these buildings include the provision of artistic studios, a creative maker space, a public courtyard, and a gallery/multifunctional space. Internal and external consultations are ongoing with public consultation on the Part 8 on proposed redevelopment anticipated end Q4 2022.



DBFL Consulting Engineers, Our Balbriggan Active Travel and Transport Consultants, are progressing final preparations on a Balbriggan Draft Active Travel & Transportation Plan. DBFL are working closely with Paul Hogarth Company (Masterplanning Consultants) who are developing in tandem a Balbriggan Public Realm Strategy and Design Guide to ensure coherent, effective, sustainable transformative development. It is anticipated these plans will form part of a non-statutory public consultative process in Q4 2022.



Malachy Walsh & Partners have been appointed as the Consultant Engineer Design Team to deliver a small works package of improvements to the Harbour. Procurement has commenced for the works package to upgrade and enhance the facilities and amenities of the harbour, anticipated on site in Q4 2022, for completion in Q1 2023. Stakeholder engagement sessions have been held with local fishermen and harbour users. The Harbour Project will link in with other Public Realm Projects upgrades within the town. Funding of €289,000 for this project was secured by Operations Dept. in April 2022 from the Department of Agriculture, Food and the Marine. It is anticipated further upgrades and funding will follow for improvements including dredging of the harbour.





The second annual Beach Activity Festival took place on August 14th led by Sports Department the event saw local clubs and national governing bodies of many sports hold an array of activities for people of all ages, including fitness classes, yoga, music, and early learning activities. The Fingal Rowing Club also held its inaugural Balbriggan Regatta on August 6th with support from Event Unit.

Local & Rural Development



FINGAL LOCAL COMMUNITY DEVELOPMENT COMMITTEE

The Fingal LCDC continues to oversee and administer the key areas of LEADER and SICAP and the various Local Development and Community Development funding programmes under its remit. The LCDC also manages the Healthy Ireland Initiative and the Social Enterprise Grants Scheme.





FINGAL LOCAL ECONOMIC COMMUNITY PLAN 2022-27

The Guidelines for preparing new LECPs have been published by the Department of Rural and Community Development. The new Fingal LECP will be a 'Whole-of-Council Plan' and will involve extensive consultation and engagement with internal and external stakeholders. Introductory seminars on the statutory role, consultation process and suggested thematic areas to be addressed in the new LECP are currently being held online and recordings of these can be viewed on the Department of Rural & Community Development's website.



SICAP

The 2022 Fingal SICAP Programme has seen a considerable increase in budget to €1.39 million for 2022.

The resources and staff of the Fingal SICAP Programme have been leveraged to assist with the emerging Ukrainian Refugee Crisis. The SICAP Programme will continue to help where required in the response to this crisis and is a central resource to the work of the Ukrainian Refugee Community Response Forum. Additional funding has been received from the DRCD to help with the delivery of services to Ukrainian Refugees in Fingal and additional staffing resources from the Ukrainian community have been employed to assist with this.

The Fingal SICAP Mid-Year Review for 2022 has been completed. The Programme is performing

very well and in line with the 2022 Annual Plan. The Fingal LCDC and SICAP Programme welcome the announcement of additional SICAP funding in 2022 to help with the Ukrainian Refugee response in Fingal. And the annual plan has been reconfigured accordingly.





LEADER PROGRAMME

The Dublin Rural LEADER Local Action Group and the Dublin Rural LEADER Programme continues to deliver funding and support to eligible projects in the administrative areas of Fingal, Dun Laoghaire Rathdown and South Dublin.

The 2021/22 Transitional updated Funding Arrangements for the LEADER Programme cover both projects funding and administration funding for the period April 2021 -December 2022. Funding is available for LEADER Project Applications under the categories of Rural Enterprise, Social Inclusion and Rural Environment. Historically, Fingal Projects comprise 65-70% of the total LEADER Projects approved, roughly corresponding to Fingal's share of the Dublin Rural LEADER Geographical Area. Under the Transitional Arrangements the Dublin Rural LEADER LAG and LEADER Programme will continue to be funded by the Department of Rural and Community Development under the same eligibility and LEADER implementation rules as before. LEADER continues to approve and fund new projects as usual. The most recent LAG Meeting was held in June.

The Total number of projects approved under the 2021/22 Transition Programme to date is 25. The total value to date is €1,011,023. The remaining Budget for the Transition Programme is €462,451.

A new Renewable Energy Training Programme will be delivered in Q4 of 2022. Advertisement and registration for this course will take place in Q3. Smart Village Training commenced in June for LAG Members, Independent Evaluation Committee Members and Executive Staff. This training will be rolled out across community groups in advance of the next LEADER Programme.

Two new Rural Development Officers were appointed in Fingal LEADER recently.

The next meeting of the LAG will be held in September

ENTERPRISE CENTRES

Fingal's Enterprise Centres continue to participate in ConnectedHubs.ie .

ConnectedHubs.ie is a one-stop-shop for remote working hubs throughout Ireland.



All three Enterprise Centres currently have space available to start-up businesses and businesses/ individuals who wish to avail of remote working options and facilities. Bespoke options or generic office fit-outs can be considered.

Occupancy rates at the Council's three enterprise centres at the end of August were all over 90%. The three Enterprise Centres currently support 65 businesses and over 320 direct jobs.

Drinan Enterprise Centre was successful in its application to the recent Connected Hubs Funding Call. Drinan secured €75,000, the maximum available through the funding call. The approved funding will develop and enhance the existing remote working facilities, making the remote hub more attractive to remote workers. This will involve the addition of 8 new work zones bringing to 10 the number of remote work zones that will be available at the centre. There will be enhanced and individualised secure wi-fi access per zone desk, with upgrades to the standard of desks available, new secure lockers and new zone décor. A new Creative Studio is to be incorporated into the

internal building improvements. Externally, new electric charging points are to be added with new solar panels to address sustainability, generate electricity for the remote working hub and to reduce operational costs.

The two new Remote Working Hubs in BASE were officially launched by an Tánaiste Leo Varadkar T.D. in July. The new hubs and associated building improvements were funded by Enterprise Ireland, the DRCD and Connected Hubs.





Town and Village Renewal Scheme 2022

The 2022 Town and Village Renewal Scheme was launched in early Summer by the Department of Rural & Community Development. As in previous years, Fingal County Council sought expressions of

interest from Community Groups / Promoters for potential projects in Fingal, that could be submitted for funding to the DRCD. A number of projects were submitted for consideration by the DRCD in the following Towns and Villages: Balrothery, Portmarnock, Donabate, Ballyboughal, Garristown, Naul, Loughshinny, Oldtown and Portrane. An application for funding to promote Fingal's Remote Working Hubs (Connected Hubs) was also submitted. A decision on these applications is likely to be received in guarter four.

Streetscape Enhancement Scheme 2022

The DRCD has approved the nomination of Rush as selected for funded town streetscape enhancement projects. Residents, businesses and community groups in Rush will be able to apply for grants for various enhancement measures such as painting, shopfront repair, signage, lighting and planting. Measures will be 80% funded by the DRCD, 20% co-funded Fingal County Council therefore successful applicants will be able to access 100% funding. The maximum funding per building is €10,000 overall. Further information and Expression of Interest forms will shortly be available on the Fingal County Council website.



LEO Fingal provides a broad suite of support services to stimulate enterprise and enable small businesses to succeed. Some of the LEO highlights for Summer 2022 are as follows:

New Service Level Agreement between Fingal County Council and Enterprise Ireland

A new Service Level Agreement (SLA) between the local authorities and Enterprise Ireland has been agreed and will cover the period 2022-2025. The Fingal/EI SLA sets out the agreed parameters, structure, modus operandi, funding and management of Local Enterprise Office Fingal.

Fingal Business Network



Fingal Local Enterprise Office announced the launch of the Fingal Business Network in August 2022.

The Network is aimed at owner/managers of small and medium businesses in the Fingal area to encourage information sharing, discussion, peer to peer learning and facilitated networking among local businesses. The network will promote interaction between local businesses while also exposing owner/managers to focused discussions on the latest trends. The first event hosted by Noel Davidson will take place on Tuesday September 27th in the newly refurbished surroundings of the Runway 28 Venue at the Carlton Dublin Airport Hotel.


Fingal Export Development Programme



A new export development programme has been launched by Fingal LEO running throughout Q4 2022. The programme is aimed at preparing SMEs to be 'export ready' by improving their strategy, sales & marketing, business planning, productivity, and leadership capabilities. mentoring sessions, and toolkits that will support the SMEs in developing their business capabilities to engage in new markets and export opportunities culminating in an export plan. The overall programme will aim to embed an understanding of the core business skills essential for SMEs to compete more effectively in new export markets.

New Fingal Training Schedule announced



LEO Fingal has launched an exciting new semester of business training and events for Autumn/Winter 2022. We have a host of offerings focusing on training for small business owner/managers including Start Your Own Business courses, Leadership Development, and business topics including Finance and Tax, Marketing and Sales, HR and Operations Management. We will also have a smattering of Digital Media courses to ensure our clients are capitalising on their online presence and increasing market share from their online channel.

Trading Online Voucher Scheme



An initiative under the Government's National Digital Strategy, the TOV scheme continues to support small businesses by allowing them to enhance their online offering by providing a grant of up to €2,500 for ecommerce and digital marketing activities. 82 applications have been approved in 2022, in the amount of €171,944



The next TOV Seminar will take place on Friday 9th September 2022 in the RIASC Centre. There is still strong interest in E-trading with applications and approvals running at nearly double pre-covid years.

Fingal Enterprising Women Network



Fingal Enterprising Women Network next event is Thursday 8th September at the Portmarnock Links hotel. This network event has a theme of Circle of Friends and has already a registered attendance of more than 100. The event will be opened by Fingal Chief Executive AnnMarie Farrelly with an introduction from Carol Ann Hickey and Barbara Nolan followed by a panel of inspiring women to share their business stories and supports from LEO on their journey. Wendy Stunt will introduce a new way to meet & connect to people by NetWalking. Allison Keating will talk about the Growth Mindset which is an amazing tool for any entrepreneur. The event will close following a Networking buffet lunch.

Evaluation and Approvals Committee

The August Evaluation and Approvals Committee (EVAC) meeting took place on Wednesday the 31st of August. Five applications were approved for grant assistance totalling €111,500. Year to date, 31 applications have been approved for a total of €740,895. The next EVAC meeting will take place on Wednesday the 28th of September.

Business Advice Clinics and Mentoring

Business Advice Clinics and mentoring services continue to be offered online. In August 2022, 9 Business Advice Clinic days were held, offering advice and support to 72 clients in Fingal. In addition, clients are continuing to receive one to one business mentoring with our panel of mentors and 310 Fingal clients have received this mentoring to date in 2022.

Student Enterprise Programme



The Official Launch of the Fingal Student Enterprise Programme 2022- 2023 will take place on Wednesday 14th September 2022 in County Hall, hosted by the Mayor and Chief Executive. Participating School Principals, Teachers and event Sponsors will be in attendance.

Microfinance Ireland Loans

LEO Fingal provides a loan scheme through its partnership with Microfinance Ireland, with "soft" loans of up to €25,000. LEO Fingal is actively promoting the availability of loans from businesses that have difficulty raising finance from their bank.

Ten applications have been processed, assessed and submitted to MFI in 2022 year to date.

The remaining roads on this year's POW (Barnageeragh Road and Fancourt Heights) are tendered and due to commence in early October.

Howth/Malahide Area

The Operation's Department continue to progress the Annual Programme of Works as well as day-to-day remedial works carried out by our in-house crews. The following are examples of the excellent work carried out by the Operations Department in Howth/Malahide.

Depot Works

The Roads Operations Crew for Howth Malahide installed 140m of Road drainage on the R124 between Hill Drive and The Bawn. The footpaths were replaced, and new barriers and tactile paving crossings were installed at the entrance to St Sylvester's Villas as part of this works.

This work was completed in advance of the 2022 Roads POW. The installation of a 225mm storm sewer and gully pots relieved flooding in the Bawn Grove.

Road Inlay Programme of Works

900 linear meters of Estuary Road was inlaid in early June from the junction with Yellow Walls Rd to just past the Malahide Rugby Club Grounds. This ties into the section overlaid by Howth Malahide in Q1 2021. 600m of the R124 was inlaid in June from the entrance to the Grange to the Low Railway Bridge this tied in with the inlays carried out on the 2020 and 2021 POW.

The road was also patched from the railway bridge to the Kinsealy Lane junction as part of the road inlay. The R124 between Seamount Rd and the Back Rd junction was also inlaid as part of the 2022 POW in July. In July, the final road from the 2021 POW was inlaid. The length of St Margarets' Ave was inlaid, and St Margaret's Road was inlaid from the junction with St Margaret's Avenue to Main Street Malahide.

Lifeguard Service

It was proposed to recruit 40 lifeguards this season, however only 35 accepted the offer of employment. The service operated weekends only in June and went full-time from 27th June until 28th August.

The lifeguards will also be working the first two weekends in September on our 3 Blue Flag Beaches: Portmarnock, Donabate and Rush South. The season was extremely busy this year with two heatwaves leading to an increase in numbers attending our designated bathing areas and an increase in demands on the lifeguard service.

The lifeguards dealt with major incidents to deal with this season and received praise from a number of individuals including the Captain of the Irish Coast Guard helicopter R116, which shows

how highly regarded they are by the emergency services.


Licences

Road Opening Licences:

The new efficiency functionality with respect to automated granting of T3 licences is operating well. Since 1st June 2022, the majority of T3 ROL applications have been granted by way of automation and 3 Clerk of Works has been appointed to Swords/Balbriggan, Castleknock/Mulhuddart and Howth/Malahide areas to carryout to improved post inspection of all road openings by utilities.

The Licensing unit continues to process and manage the licensing system for the County, applications are allocated by area for examination and conditioning which includes reviews of the existing carriageway, footpaths, cycleways, and grass verges. Applicants submit temporary traffic management plans for review to ensure all works are carried out safely within the public domain. Road Opening Licences are a cross functional process for the department and are essential for the asset management of Fingal County Council Road network.

182 Licences were granted in the month of August.



T1 Application: The T1 is not a licence. It is notification of intent to perform works of high impact due to extent or complexity.

T2 Applications: An application to carry out works of moderate impact due to the location, extent, amount, or duration of the work.

T3 Applications: An application to carry out works of low impact due to the location, extent, amount, or duration of the work. A T3 licence requires a short application period and does not require a works programme notification.

T4 Applications: A notification of emergency works (as defined under legislation). Notification must occur at the time or as soon as possible after commencement and works must be carried out during a limited time period.

Street Furniture Licences & Parklets

Street Furniture Licences are granted under Section 254 of the Planning and Development Act as amended. New licenses were issued on the 1st of June and will expire on the 31st of December 2022.

A new Enforcement Officer has been appointed to regulate the issuing of license's and to monitor the usage of street furniture by local businesses. To date in August three Street Furniture inspections have been carried out with a fourth planned for this week.

Fingal County Council is looking to build a positive working relationship with local businesses & help implement the positive use of Street Furniture throughout the county. In the coming months communication between the Operations Department & local businesses will increase significantly.

The Council will proceed with enforcement proceedings under the planning legislation where outdoor dining is taking place without a valid licence. Total number of licences is as follows for the 3 areas:

Casual Trading Licence

Casual Trading inspections have increased in recent weeks with the newly appointed Enforcement Officer carrying out inspections & engaging with traders about a variety of issues. Considerable interest has been shown in some of our vacant casual trading pitches with ongoing communication with several potential applicants.

Water Services

Water and Wastewater Connections

There are 25 applications in progress with Fingal as of 24th August 2022, this consists of 13 drainage connection applications and 9 water connection applications and 3 applications that request further information from applicant as per the Irish Water System Maximo/d365.

27 applications returned to Irish water so far in August 2022 .

Storm Water (surface water) Network – Operations Update

Operation and maintenance of the Stormwater Network is ongoing.

- The Stormwater manhole cover and frame replacement programme for replacing assets at the end of life is ongoing – Covers and frames were replaced in the Swords and Kinsealy.
- Funding is being procured for a property flood alleviation project in The Bawn & Old Bawn in Malahide. Currently a tender is being drafted for a detailed design on the stormwater element of this project while discussions between Fingal County Council and Irish Water are on-going with respect to attaining a design from Irish Water for the redesign of the foul aspect of the project. It is hoped that construction works on this new network will take place in early 2023.
 - CCTV surveys were carried out in Mulhuddart, Portmarnock and Malahide. A number of issues with root ingress, concrete rubble, displaced and partially collapsed sections were uncovered. These reports are now being analysed to identify the most cost-effective means of repairing these issues.
 - CCTV surveys were carried out in Balbriggan following poor bathing sample results. Extensive surveys were carried out around the Harbour area and a misconnection from the foul network was discovered next to the Bracken Court Hotel. This has now been removed from the network on the private side. As a follow up the line has been vacuumed and flushed to remove any residual pollution.
 - CCTV Surveys were also carried out in Castleknock Vale following reports of Malodours. Investigations discovered a large build-up of rubble, silt and tar in the line which was restricting flows and

causing the water in the line to become stagnant. Remedial dragging works were carried out to remove debris from the line. This line are now free flowing and there have been no further reports of Malodours.

- CCTV Surveys were also carried out in Pecks Lane following reports of Malodours. Investigations discovered a large build-up of FOGS and a large depression in the line. Remedial dragging works were carried out to remove debris from the line. A patch liner was also installed, and this line are now free flowing and there have been no further reports of Malodours.
- Works to jet, drag and CCTV survey the Stormwater network in Chalfont, Malahide to assist road operations with the alleviation of ongoing road flooding are now complete. Partial collapses were identified and works to repair this several collapses are being costed and quotes are due back this month.
- CCTV surveys were carried out in Heather Walk and Carrickhill Rise in Portmarnock to identify the cause of slow flows. Large root ingress and partial collapses were identified. A contractor is being procured to provide a quote for the repairs including robotic cutting and Part Liner installation. In some locations an open dig will need to be performed to remove the damaged sections and replace the failed pipes. These projects have now been costed and site works are planned to start in Q4 2022.
- The next section of the Stormwater network preventative maintenance cycle was completed at the end of May. Surveys were carried out in the Cardy Rock and Hamilton Place Estates in Balbriggan. In total 6000m of lines have been surveyed and recorded and 65 manhole reports have been created. The findings are now being analysed to identify remedial works required.

Storm Water (surface water) Network – Projects

Howth Culvert Stormwater Network Upgrade

Roughan O'Donovan (ROD) has completed the 1st phase hydraulic modelling of the existing Howth Stormwater Network. Fingal County Council are currently preparing the tender documents for a CCTV conditioning survey which is required as part of the second phase of the project.

Once the condition survey has been completed ROD will be able to determine the scope of upgrade works required to ensure the existing network has sufficient capacity for current and future needs.

Burrow Beach Surface Water Outfall Upgrade

The Department of Housing, Local Government and Heritage rejected Fingal County Council's application for the required pair works to the surface water outfall at Burro Beach be considered exempt works under the auspice of the Foreshore Licence Act. Fingal County Council is now commencing the process of applying for the required foreshore licence for the required works.

- The Bawn Malahide

Fingal County Council has prepared a scope of works to upgrade and future proof the existing stormwater network serving The Bawn, Malahide. The scope of works includes hydraulic modelling of the contributing catchment, condition survey of existing network and preliminary design of required upgrade.

- Wendell Avenue/Drewbury Park/Heatherfield Walk

Following a number of condition surveys of the stormwater network in Portmarnock, stormwater rehabilitation works are required in Wendell Avenue, Drewbury Park and Heather Walk Portmarnock. Fingal Council are planning to upgrade approximately 300 metres of stormwater network with works due to commence in October 2022.

The Council will continue to work to implement Government policy in regard to water.

Framework for future of Water Services

A new framework for the future of water services developed through an engagement process facilitated by the Workplace Relations Commission was announced by the Minister on 24th June 2022. The Framework will help to ensure a stable operational environment is maintained as the water sector completes the transition to a national water services authority, based on the full integration of public water services within Irish Water.

To facilitate the transition to a national water services authority, the Framework provides for:

- Irish Water to assume responsibility for the management and direction of water services operation and activities
- 2. The voluntary transfer, of existing local authority water services staff to Irish Water

- as permanent employees between now and 2026.
- 3. The identification of opportunities for water services staff not transferring to Irish Water to avail of opportunities to re-deploy to other areas within Local Authorities.
- 4. The commencement of water services staff recruitment directly by Irish Water to fill vacancies arising in Water Services.
- 5. A voluntary redundancy scheme for local authority water service staff; and
- 6. A new Irish Water-Local Authority agreement, replacing the existing Service Level Agreement arrangements, to ensure that Irish Water has full accountability for the delivery of water services and direct management of the water services staff who choose to remain employed by their local authority under contract to Irish Water for the transitional period to the end of 2026



Planning Applications

There have been 804 planning applications received to the end of July 2022, 61 of these applications were invalid leaving a total of 743 valid applications. The volume of applications received by Local Electoral Area (LEA) is detailed in the table below.

Between January and end July 2022, 18 Strategic Housing Development (SHD) applications were made to An Bord Pleanála totalling 10,430 units. 2 decisions were made by the board up to end of July 2022. Of these, 1 application was Granted in May (172 units). One application was Refused in March. There is a total of 20 SHD's (12,692 units) currently in the formal application process.



Planning Decisions

A total of 735 planning decisions have been made to the end of July 2022. There have been 615 decisions to grant permission (84%) and 120 refusals of permission (16%). There have been 54 grants of permissions in respect of single house construction, 376 grants of permission for domestic extensions, 153 commercial/retail grants of permission and 16 grants of permission in respect of housing developments of which 9 relate to development of 2 - 20, 4 relates to 20 – 50 and 2 relate to 50 -100 and 1 which relates to 100+.


Building Control Admin

In July 2022, 140 Building Control submissions were received. This was made up of 50 Commencement Notices, 31 Compliance of Completion Certificates, 32 Fire Safety related Certificates and 27 Disability Access related Certificates.

Commencement Notices and Compliance on Completion Certificates are submitted through the Projects module on BCMS.

Fire Safety, Disability Access, Regularisation and Dispensation/Relaxation Certificate applications can be submitted online via the Applications module on BCMS and also by hard copy directly into the office. The BCMS system is the preferred option.

The Building Control Admin team processed 110 decisions in July 2022, relating to Fire Safety and Disability Access Certificates. This was made up of 53 decisions to grant, 2 decisions to invalidate and 55 extensions of time.



Strategic Policy Unit

Draft Fingal Development Plan 2023 - 2029

The public consultation on the Draft Fingal Development Plan finished on 12th May. During the consultation period online and drop-in events were held for members of the public. Planning and Strategic Infrastructure Department staff were available to brief the public and answer questions on the Draft Development Plan.

More than 1,900 submissions have been received.

The Chief Executive's Report on submissions received was issued to the Members at the end of July. Meetings to discuss the submissions will take place later this month and into October.

The Development Plan process has been running for over a year now and the final plan is scheduled to be adopted by councillors in February 2023.


Sustainable Swords

Ward River Valley Regional Park Development Project



An integrated design team led by Dermot Foley Landscape Architects has been appointed to support the Ward River Valley Regional Park Development Project. The primary objective of the project is to engage and reach consensus with stakeholders to deliver a sustainable vision for the future Regional Park in the face of population growth and increasing levels of community participation in active leisure. The first phase of work (currently underway) for the appointed consultant is to undertake baseline surveys and detailed analysis to best inform future proposals. Notwithstanding the considerable work involved for this stage, it is anticipated that public consultation will commence later this year. An introduction and overview of the Park Development Project was presented to members at the September meeting of the Balbriggan/Rush-Lusk/Swords Area Committee.

Play Projects at Lanesborough Park, Howth Harbour, Garristown Library and Bremore Regional Park







Regional Park

The tender process to deliver quality play spaces at Lanesborough Park, Howth Harbour, Garristown Library and Bremore Regional Park has begun. The first of the two-stage tender process is underway with expressions of interest sought from firms with the experience and capability to deliver projects of a similar scale and nature. It is planned that a shortlist of up to five suitable firms will be compiled from stage 1 who will then be invited to take part in the Design Build stage of the competition. It is planned to complete the procurement and contract award phase of the project this year with works to commence in the first quarter of next year.

Porterstown Park All-Weather Running Track and Sport Pitch Facility



Since works began in April, progress with the construction of the new LED floodlit sporting facilities at Porterstown Park continues to run on schedule. The latest milestones achieved by the specialist contractor includes the installation of floodlight columns, kerbing, spectator fencing posts and the tarmac layer of the 3G pitch to meet exacting levels required to meet FIFA standards. Works over the coming weeks include the installation of surfacing for the 400 metre running track and 3G pitch. Other elements to complement the facility include additional path network, blue badge and bicycle parking spaces located for convenient access to the track and pitch. It is anticipated that the facility will be complete by Q1 of next year, becoming a valuable sporting amenity for the people of Dublin 15 and the wider area.

Recreational Hub at Ward River Valley Regional Park



Works are continuing on the construction of the Recreational Hub at Ward River Valley Regional Park. The 3G pitch has been covered with a tarmac base and is due to receive the first layer of the sports turf system in coming weeks. Perimeter sports fencing has been completed and the seeding and landscape works have commenced to ensure the successful integration of the facility with the surrounding area. The car park has also received the first course of tarmac and the grasscrete SuDS system has been prepared for seeding. The upgrade works to the adjacent soccer pitch are largely complete with proposed GAA Go

Games/Training Pitch still under construction. Having regard to the expanded scope of the project and to allow for the testing and commissioning of the new facility including the LED floodlights, it is anticipated the project will be completed in the last quarter of this year and will become a valuable sporting amenity for the people of Swords and wider area.

Bremore Regional Park Recreational Hub (Phase 1)



Works are progressing well on the construction of the new full size public GAA pitch at Bremore Regional Park (Adjacent to O'Dwyer's Gaa shown above). Seeding works are nearing completion after which the newly formed pitch will need to establish for 12 months before use to ensure the best outcome for future users of the new facility. In addition to the pitch, the works include provision of vehicular and pedestrian access and extensive boundary railing and fencing. The project represents the first phase of construction of the Balbriggan Sports and Recreational Hub. It is anticipated the construction works will be completed by year end.

Flood Risk Assessments/ Drainage Strategies

 FCC staff continue liaising with the appointed consultants developing the Strategic Flood Risk Assessment for the upcoming County Development Plan. The SFRA DRAFT flood mapping & DRAFT report has been completed. This mapping & report will be updated over the coming months subject to new information (Tolka flood study) & submissions received from councillors/public.



 A new document "Nature-based Solutions to the Management of Rainwater and Surface Water Runoff in Urban Areas -Water Sensitive Urban Design - Best Practice Interim Guidance Document" has been issued by the Department of Housing, Local Government and Heritage. It is intended as a high-level best practice interim guidance document for all those whose work impacts on the urban environment, for urban planners and all built environment professionals involved in the planning process such as engineers, architects and landscape architects and shows how to move towards a more systematic and sustainable approach to urban planning and design that seeks to mimic the natural water balance of rural areas through "water sensitive urban design".




 Sustainable Drainage System (SuDS) – The Fingal SuDS guidance document (Green/Blue Infrastructure for Development) has been reviewed to include changes in technical standards. This document along with the Draft SFRA documents have been incorporated into the new development plan.



Building Control/Taking in Charge Section

Building Control

- BCMS (Building Control Management System) 308 Building Control applications were made over the months of June and July 2022 comprising of 117 commencement notices, 69 completion certificate applications, 78 fire related applications and 44 disability access applications.
- There were 30 Building control site visits in June and July with 62 separate buildings being inspected.



Taking in Charge

 There are currently 5 estates/roads which will be submitted for Taking in Charge in the September meeting. These are Blackthorn place, Chieftains Way, Bay Meadows phase 1, Castleknock Tennis Club plaza area and Hollywoodrath Phase 1.

- The consulting engineers for the taking in charge works in Ongar have been on site and snagged the areas for taking in charge. They are currently reviewing the surface water drainage to see there are any items that should be repaired as part of the taking in charge construction works.

Transportation Planning

Snugborough Interchange Upgrade Project

Construction works have continued successfully over the summer months including the bridge deck over the River Tolka being poured during August. Ongoing installation of parapets and retaining walls is underway at present and traffic lanes on the N3 have reopened to traffic. The website www.snugboroughinterchange.ie containing information on the project will continue to be updated with information relating to the project.



Royal Canal Urban Greenway

The Project Team has just published the Public Consultation Report from the 2021 public consultation and this report is available to view at www.fingal.ie/royalcanalurbangreenway.

Following a review of all relevant legislation it has been established that the Royal Canal Urban Greenway exceeds the mandatory threshold for Environmental Impact Assessment. This means that an Environmental Impact Assessment Report (EIAR) will now be prepared for submission to an Bord Pleanála. An Appropriate Assessment Screening is also being undertaken. It is anticipated that the EIAR and associated reports and documentation, will be complete in Q4 2022. The stage gate process for the National Transport

Authority approvals process will take place in parallel to this also.

Fingal Coastal Way

The Public Consultation Report from the 2021 public consultation and the follow on review of proposals through the Quay St and Hoar Rock areas of Skerries is being finalised and will be published in September. The Project Team is currently developing the Emerging Preferred Route for Public Consultation in October. This phase of the project reduces the route options down to a single route corridor and the consultation period will run for six weeks with both on-line and in person engagement being planned.

Sutton to Malahide Pedestrian & Cycle Scheme

The Project Team is currently finishing its review of public consultation submissions and discussions at the successful drop-in information evening and webinars earlier this year. A Public Consultation Report will be published online outlining the results of the consultation. This process has helped the team to identify areas of concern for review or potential change and this design review process is underway while the Public Consultation Report is being finalised.

Following this design review, the preliminary design will be finalised and the scheme brought forward to the Statutory Approval Process – an application to an Bord Pleanála incorporating an Environmental Impact Assessment Report, Natura Impact Statement and Compulsory Purchase Order in 2023.

Church Fields Link Road

Construction work is ongoing on the link road up to formation (blacktop) level. The drainage attenuation ponds are now complete also. Works on the cycle network element of the project, including works around the schools campus and along Church Road and Damastown Avenue, will continue over the coming months. Photo attached.

This project recently entered a two-stage procurement process, with submissions for the first stage of the two-stage process recently submitted to the Planning & Strategic Infrastructure project team. The second stage will involve the return of priced tenders by a small number of competent contractors in October/November, with a view to appointing the successful tenderer in January and commencing work on site in Spring 2023, with an 18 month construction programme.

Heritage Officer

Fingal Heritage Week

National Heritage Week 2022 took place between Saturday 13th and Sunday 21st August 2022. In Fingal, National Heritage Week was marked but a number of in-person events and online projects including the launch of the *Donabate Portrane Heritage Audit* report by Fingal Mayor, Cllr. Howard and the Fingal Heritage Network's Heritage Night. The latter, in particular, was an opportunity for the members of Fingal historical societies and heritage groups to meet up again.



Fingal Thatch Project 2022

The survey of thatch structures surviving in Fingal by consultants Carrig Conservation has been ongoing over the summer. An important element is capturing the memories and social aspects of thatch in Fingal. To that end a video piece of those involved in thatching was produced in conjunction with Digital officer Mark Broderick which can be viewed at https://www.fingal.ie/news/fingal-thatch-project-2022

A very well attended tour of the thatch houses of Skerries was undertaken by the consultants with the assistance of the Fingal Walking and Cycling Officer Stephen McGinn for Heritage Week. This

Digging Drumanagh 2022

Season 3 of the community -based research excavation at Drumanagh Promontory Fort commenced during Heritage Week. Supported by the Heritage Council, community volunteers and archaeologists have uncovered an Iron Age structure and evidence for contact with the Roman world not seen anywhere else in Ireland before.

These results and analysis will not only add to the interpretation of the site itself but will add immeasurably to the understanding of this period in Ireland.

Church Fields, Dublin 15

The contractor is currently onsite constructing the Church Fields Link Road and Cycle Network which will facilitate the development of the entire Church Fields landbank with the potential to deliver 1,000 mixed tenure homes.

A public consultation workshop took place in July with local groups in Mulhuddart in relation to the rejuvenation and upgrade of Wellview Park and Public Realm at Wellview Green and Terrace, Mulhuddart. This project is part of the Church Fields development.



The formal Part 8 public consultation process for the park commenced on 25th July 2022 until 6th Sept, 2022. Approx 500 leaflets were distributed to local homes in Mulhuddart area advertising the Part 8 public consultation process.



Housing Loans Update


The Local Authority Home Loan continues to attract queries and applications from members of the public seeking to secure a mortgage with the Local Authority. There have been 164 applications so far.

To date €8.2 million of lending has been approved until the end of August, with applicants having gone sale agreed with €1.5 million of this approval. The scheme continues to be popular, and although the interest rate has risen marginally the product continues to be a relevant support for first time buyers.

Housing Asset Management Report

Energy Efficiency/Retrofitting Programme

Approval was granted to carry out retrofitting works on 81 properties in 2022. Works are complete on 41 properties in Jugback Estate in Swords, which included electrical upgrades, attic insulation, installation of triple glazed windows and doors along with PV panels where required to reach a B2/Cost optimal standard. Work on Lissenhall in Swords and St. Paul's in Balbriggan have recently commenced and is expected to be completed by the end of October. Retrofitting in Whitechapel Clonsilla will also soon be underway, with a completion date anticipated to be in early November.

Planned Maintenance Programmes

Cyclical Maintenance - Scheme Painting

The Scheme Painting Programme provides for external painting and joinery repairs to Council housing stock and currently operates on a 6/7 year cycle. Scheme painting has just been completed in Ringfort Estate, Balrothery and Remount in Lusk. Additional works involving render and bin stores were carried out in Dun Saithne, Balbriggan.

Work is currently underway in Hamilton Estate in Balbriggan and Saint Catherine's in Rush.

Housing Assistance Payment (HAP)

Since its inception in Fingal County Council in 2017, the HAP team has set up over 3,400 tenancies. In 2022 to date over 240 HAP tenancies have been set up for Fingal housing applicants.

The HAP Team are always available to assist applicants and landlords by email, phone or in person and the experience to date is that communication is mostly over the phone and the HAP team report that there have been very few issues with completing the online application process and any delays, such as they are, are generally around applicants and landlords submitting the correct supporting documentation. However, the team are aware of only a small number of cases where the applicant/landlord had difficulty and they were talked through the process.

The HAP team are on hand to deal with any queries from applicants and landlords in person at the Housing Department in the Fingal County Council Blanchardstown Office, by phone on 01 8905000 via the CCU or through email hap@fingal.ie.

Housing List Position

List Position letters issued to all applicants on 11th April. Choice Based Lettings information was communicated through this letter which advised applicants to obtain their secure username and password to access the Choice Based Lettings system. Applicants can view their list position at the 1st April 2022 through the CBL system. It is intended to update the list positions in January 2023 and applicants will be able to access them through the CBL system.

In accordance with Circular 32/2022 as released 11th August 2022, the Summary of Social Housing Assessment (SSHA) is due for return to the Department of Housing Local Government and Heritage by 29th November 2022. It is intended to provide a dual service for the completion of this assessment with an Online HNA system to go live in September and hard copy forms available from all Customer Care Counters and Libraries for those who wish to complete the form by hand.

Further communication will issue to all applicants required to take part in this Assessment in the coming weeks which will include details as to the Online System and instructions to complete their online SSHA.

Social Housing Application Form

The new social housing application form is in use since 14th March. Hard copies are available through the CCU. Amendments to the form – Part 8 of the housing application, identifying as an Irish Traveller is now being recorded on the Housing system, in accordance with Government policy.

In line with the Social Housing Assessment Regulations, the Housing Authority is required to assess a fully complete application within a period of 12 weeks of receipt.

Choice Based Lettings

The new online portal to facilitate the Choice Based Letting (CBL) scheme has proven effective and efficient with staff and applicants. CBL is an approach used for the allocation of designated Social Housing Units. It allows housing applicants to express an interest in being considered for the allocation of designated Social Housing Units.

Applicants with active applications can access Choice Based Letting by logging https://cbl.fingal.ie using their unique username and password. To access their unique username and password applicants must contact choicebasedlettings@fingal.ie with their housing reference number and phone number. The housing team continue to issue passwords and usernames. Applicants are actively encouraged to obtain their passwords and usernames to express interest in any properties advertised.

Approved Social Housing applicants log in each week to check the dwellings that are available using their username and password.

To date 2,208 passwords have been issued to applicants since the CBL portal opened (08/12/2021) of which 93 were issued in July and 92

in August. All new approved Housing Support Applications will receive their password and username upon approval. CBL advertised 8 properties during July and 12 properties during August. The total number of expressions in July for the 8 properties was 952. 1,727 expressions were recorded during August.


2021 offers shown for comparison



Homeless Services

The Council's Homeless Team continue to engage with those experiencing homelessness to offer advice and support. Homeless Assessments continued to be carried out.

In August 2022 there were **87** new homeless presentations, comprising 39 families and 48 singles/couples.



The presentations figure reported is not fully reflective of applicants/potential applicants who we are still engaged with in order to complete assessments.

Homeless Presentations

From January 1st to 31st August 2022, the Homeless Officers have carried out **517** Homeless Assessments (250 families & 267 singles) – see Table below for breakdown by month.

Approximately 36% of these cases are because of a **notice to quit** having been served. Many of these notices to quit are served on families who have been renting the same property for an extended period (over 5 years). The main reasons given for issuing the notice are the landlord intends to sell the property or that a family member will move into the property.

There are also a considerable number of people making contact stating that they are Homeless due to **family breakdown** (19%). Anecdotally, these presentations are aged in their 20's/30's and have

fallen out with family or state that they are living in **overcrowded conditions** (11%) and state that they cannot/will not return to the property.

Homeless Exits

During August 2022, 11 households exited homeless circumstances into various forms of social housing support - including into private rented tenancies under Homeless HAP.

Homeless HAP accounts for 9 of these tenancies.

Emergency Accommodation (including Fingal County Council Family Hubs)

Emergency Accommodation (EA) is managed on behalf of the 4 Dublin Local Authorities by The Dublin Region Homeless Executive (DRHE).

As has been recently reported in the media, the number of people in EA across the country reached more than 10,500 last month. Some of factors that have pushed these numbers up in recent months include an increase in Notices to Quit and a decline in available Housing Assistance Payment (HAP) properties. The provision of emergency accommodation remains challenging.

Homeless Action Plan 2022- 2024

The DRHE has finalised the draft Homeless Action Plan Framework for Dublin 2022-2024. This Plan is the first plan to be put into operation since Ireland signed the Lisbon Declaration on combatting homelessness in June 2021, which aims to end homelessness by 2030.

It will follow on from the previous Homeless Action Plan for 2019- 2021 and continues with the three key themes of **Prevention**, **Protection and Progression**.

The Plan is being developed as a result of a detailed consultative process including submissions from various Stakeholders, interested organisations, Service Providers, Members of SPCs of the four Local Authorities, the Dublin Joint Homelessness Consultative Forum and the Statutory Management Group.

A senior official from the Dublin Region Homeless Executive (DRHE) made a presentation on the Homeless Action Plan at the Housing SPC held on 27th June 2022.

TRAVELLER ACCOMMODATION PLAN

Traveller Accommodation

A programme of works in relation to the refurbishment and upgrading of existing accommodation on specific sites is currently in development with the County Architect for further progression in 2022. Refurbishment work is

planned for a number of sites in accordance with the Traveller Accommodation Programme 2019-2024.

Regular site visits by Housing Inspectors continues on all Fingal County Council Traveller specific sites while checking on vulnerable residents and advising on the continued supports available.

Inspectors received a welcome response from residents and children when they delivered play equipment to a number of our sites on behalf of the Community Department in conjunction with National Play Week.







Community Facility Upgrade

The Housing Department recently completed refurbishment and upgrade works at the Council's Resource Centre at Matt Lane, Balbriggan which is an integral resource for the Traveller community within our administrative area. The facility will be managed by the Balbriggan Traveller Project.




Housing Welfare Service



Boiler Servicing Programme

The Council provides an annual boiler servicing facility, including all maintenance and upgrade works, for a nominal fee of €3 per week to participating tenants. Contractors progress batches of work throughout the course of the year. Currently they are progressing 6 batches of work totaling 1,437 properties incorporating the following areas: Whitestown Estate, Sheepmoor Estate, Corduff Estate, Church Road, Bay Meadows, Allendale, Dunsoghly, Greenridge, Abbeylea, Ballygarra, Clonmethan Green, Earnan's Wood, Drynham Avenue, Lambeecher, Cardy Rock, Longstone Park, Glasmore Park, Seaview Park and Strandmill Road.

Anti-Social Behaviour/Inspectorate Unit

The ongoing management and sustainment of social tenancies and good estate management falls within the remit of the ASB/Inspectorate Unit. Alleged breaches of Tenancy Agreements are investigated and pursued in accordance with housing legislation and policy.

There are occasions when the vulnerabilities, complexities and heath related issues associated with a tenancy require tenancy sustainment and welfare intervention and supports. Ongoing case management and review with a variety of external agencies, including Approved Housing Bodies, An Garda Síochána. TUSLA and the HSE may be required to ensure all agencies collaboratively with a view to achieving best outcomes for our Communities. This work is ongoing in relation to a number of Tenancies in the county.

Within the remit of the Estate Management Section, a project team has been assembled to focus on the effective use of Council stock, including Permission to Reside Applications, illegal occupation, abandonments and legal matters arising with regard to breach of Tenancy Agreements. The Council has recently secured possession of two properties which were illegally occupied and other cases are pending.

In tandem with this, exclusion orders are also being sought in the Courts against individuals who are proven to be involved in serious anti-social behaviour in Council estates.





Fingal County Council is committed to supporting the humanitarian response to the crisis in Ukraine.

Where Households and individuals present to the Council's Homeless Services and identify as seeking refuge from the conflict, the advice to date is that they should be directed to the International Protection Accommodation Service (IPAS) ipasinbox@equality.gov.ie

Please note that if a situation arises where an immediate humanitarian response is required, Local Authorities are being asked to use discretion and provide Emergency Accommodation (EA) and in this instance FCC will refer the case to IPAS.

A cross-departmental update on Fingal's response to the Ukraine crisis was provided to elected members on 6th May and it is intended to provide a further update to elected members, most likely in October, with a date to be confirmed. However, it is a very fluid situation and the Council along with

partners are endeavouring to provide services in line with this changing need.

<u>Pledged Accommodation for Ukrainian</u> <u>Displaced Persons</u>

346 pledge properties (vacant and mainly house share) were assigned to Fingal County Council by the Department of Children, Equality, Disability, Integration and Youth (DCEDIY) to assess if still available and suitable for occupation, which was on foot of a call for pledged properties operated via the Irish Red Cross. The Council has sought to contact all 346 owners. The Council works with an implementing partner, the Peter McVerry Trust, to match Ukrainian displaced persons to their new pledged home where the properties remain available and suitable. To date, 77 of the properties have been occupied with circa 155 Ukrainians residing in same. The balance of the properties are either in a process of matching, not immediately available for occupation, deemed unsuitable, pledge withdrawn by the property owner or the property owner has not responded to contact to date

VACANT HOMES

The Vacant Homes office is now accepting applications for the recently launched Croí Cónaithe (Towns) Fund. This is a national fund administered by local authorities introduced under *Housing for All*. The Croí Cónaithe (Towns) Fund will provide new choices for people to live in towns and villages in Ireland, initially through the provision of

a grant to support the refurbishment of vacant properties.

Subject to meeting eligibility criteria, a grant of up to a maximum of €30,000 is available for the refurbishment of vacant properties for occupation as a principal private residence, including the conversion of a property which has not previously used as residential. Where the been refurbishment costs are expected to exceed the standard grant of up to €30,000, a maximum topup grant amount of up to €20,000 will be available where the property is confirmed by the applicant to be derelict (i.e. structurally unsound and dangerous) bringing the total grant available for a derelict property up to a maximum of €50,000. Ukrainian Response Unit

The Ukrainian Response Unit within the Community Development Office has been busy throughout the summer, with new people fleeing from the war in Ukraine arriving in Fingal daily. Full support is given to the 10 Ukrainian accommodation hubs across the county. Information sessions in each new location with all relevant service providers were organised and delivered by the Community Office in Deerpark, Howth, Quinns Guesthouse in Garristown and the Shoreline Hotel, Donabate. Ongoing supports were provided to the Ukraine Crisis Centre Ireland and the Fingal Ukraine Support Group volunteers.

Information meetings were held for families hosting Ukrainian guests in Skerries and Dublin 15 where the meeting in Castleknock GAA Club meeting was attended by Minister for Integration and Children, Deputy Roderic O'Gorman. projects in Donabate/ Portrane Community Centre has resumed on Tuesday's and Wednesdays after a brief summer break.



FESTIVAL IN A VAN

A cultural event took place in Emmaus centre, Swords, and Deerpark Howth in July where Irish and Ukrainian musicians entertained the residents of both centres. Supported by the community Development Office and Fingal Libraries, with support from Creative Ireland funding, the events were very well received and were attended by the Mayor of Fingal, Cllr Howard Mahony. The Deerpark Howth event involved singing and dancing and it was fantastic to see as the residents fully participating and enjoying themselves despite having only arrived from the conflict a few days earlier.







SWORDS CASTLE UKRAINIAN FAMILY DAY

In collaboration with the Sports Unit and Events Office, the Community Development Office developed a community family day for the Ukrainian residents and host families living across Fingal, which will take place in Swords Castle on

Sunday Sept 4th. The family day will be attended by the Mayor of Fingal, Howard Mahony, Chief Executive, AnnMarie Farrelly, and elected members. Music from Ukraine and Ireland will entertain the attendees, with sports, arts and crafts, photography, and children's activities available throughout the afternoon.

SUMMER PROJECTS AND APPLEWOOD SUMMER CAMP.

The Community Development Office provided places on Council funded summer projects across the county for Ukrainian children and organised a bespoke summer camp in Applewood Community Centre in early August. This was an opportunity for Ukrainian young people from several locations in Swords and the north county to have a week of fun, sports, arts, and crafts. Ukrainian speaking facilitators were on hand to deliver the fun and games, organised by the Fingal Sports Development Unit. Transport to and from the camp was provided each day from the various accommodation centres and with very positive feedback from the week.



UKRAINE JOBS CLUB AND ENGLISH LANGUAGE CLASSES

The Community Office is collaborating with Empower to provide a jobs club specifically for Ukrainian refugees taking place in Applewood Community Centre in Swords, twice weekly for four weeks in September. Jobs club times will be on Tuesdays and Fridays from 9.30am to 12 noon. English Language classes will also take place on Tuesdays and Fridays in September and October from 10am – 12 noon (Beginners) and Intermediate classes from 1pm – 3pm.

Activation of Rest Centre

On foot of a request from central government, the Liam Rodgers Centre was reactivated as an temporary rest centre from Saturday, 20th August 2022. The Community Department and staff from Events Section in EETCD worked round the clock to ensure the necessary logistics and wrap around support systems were put in place in time to receive the placement of residents by the Department of Children, Equality, Integration, Disability and Youth. Support was also provided to the various service users of the centre.

COMMUNITY DEVELOPMENT OFFICE NORTH, MID AND EAST FINGAL

SUMMER FAMILY DAY FOR FAMILIES OF CHILDREN WITH ADDITIONAL NEEDS

On the 6th of August 2022 Castlelands Community Centre in Association with ASTER Family Resource Centre, Empower and Fingal Community Office supported Balbriggan Families with additional needs to participate in a family summer event. This family programme for 'families of children with additional needs was designed for children and their parents to cater for the specific needs of the family. Thirty families across Balbriggan participated in a well designed summer event both inside and outside which incorporated a sensory space in Castlelands Community Centre with water play, a magician, face-painting, information stands, the order of Malta and a play therapist. This event enhances community participation and social inclusion.



SUPPORTIVE PARENTING PROGRAMME

On September 16th 2022, Fingal County Council Community Office in association with parenting consultant and accredited Play Therapist Melissa Moore will be hosting a 'Supportive Parenting' Programme in Balbriggan. This parenting programme will take place in the Irish Institute of Music and Song & will focus on parenting styles, emotional literacy, resilience and anxiety with a particular focus on the pandemic and the reopening of society, neuroscience and selfcare as a parent.



GRASSHOPPERS BALBRIGGAN

In July and August 2022, Grasshoppers festival engaged communities across Balbriggan in an integration and socialization process. The group is rooted in inclusively connecting communities to place, whatever their identities, through creative activities for early years audiences and families in order to drive a sense of belonging and creating a sense of pride of place across the community. The programme was collaborative, inclusive and participatory. Families shared language moments and lullabies from country of origin to country of home. These include China, Bulgaria, Brazil, Lithuania, Mauritius, Indonesia and Ireland. Fingal Community Office through its community activities funding supports this cultural awareness piece which creates social cohesion and integration. The workshops were delivered across the community Flemington Community Centre, Millfield Shopping Centre, preschools in the community and Balbriggan Beach.



Balbriggan Mens Shed

On Tuesday the 16th of August Balbriggan Men's Shed began firming up their plan to highlight the work undertaken by the members both within the shed and in the wider community in Balbriggan. This year Balbriggan Men's Shed have accepted the nomination to take part in Pride of Place under the 'Community Well-Being' initiative category. Pride of Place is a whole Island competition which takes place on the 13th and 14th of September 2022.

BALBRIGGAN INTEGRATION FORUM - A TASTE OF NATIONS

On the 5th of June 2022, Balbriggan Integration Forum held "Taste of Nations" which returned to an in-person event this year during Balbriggan Summer Fest for the first time since 2019.

The Taste of Nations is a cultural awareness piece which creates a space where people can meet and as such it is a key driver of integration in the town. This event strengthens the awareness of Balbriggan Integration Forum as a key vehicle for integration in the town. Balbriggan Integration Forum is a voluntary body established to develop positive intercultural relationships by respecting and sharing the richness, beauty, and potential of all people and their respective cultures which adds significantly to the quality of people's lives in Balbriggan. The communities that have come together to share their 'Taste of Nations' 2022 are represented from Congo, Ireland, Libya, Nigeria, Poland, Pakistan, Sierra Leone, Somalia, Tanzania, Turkey and Ukraine.



MEAKSTOWN COMMUNITY DAY

Meakstown Community Council ran a very successful community Family Day on July 31st in Lanesboro Park, Dublin 11, with the support of the Community Development Office. This was the first time since the pandemic that the community day, organised by the community council has taken place and was attended by hundreds of families and young people from the local area. Meakstown Community Council used the day to sign up new recruits for the group who will play a significant role in the roll out of the new community centre in Meakstown, being developed by the Community Development Office and Architects Department, and the major upgrading of Lanesboro Park in Meakstown, being led by Planning & Strategic Infrastructure Dept, over the next two years. The Community Day was attended by both the Mayor of Fingal, and Dublin City and local elected members.





LETS PLAY RUSH

Saturday 6th August saw another successful Let's Play Rush gathering, the fifth event in the Playful Paradigm series of the EU URBACT project, supported by the community office. Many families gathered at Tayleur's Point for a glorious day filled with sporting games and activities.

The Let's Play Rush initiative looks to create opportunities for people of all ages to connect with their local town and maximise the use of Fingal's many beaches, parks, libraries, theatres, playgrounds, green spaces, and harbours. The town celebrated its playfulness with laughter and

joy as people of all ages enjoyed the event which had youth and adult races with old style, tug of war and, egg and spoon side by side with Giant Jenga and Connect 4. The event was attended by Deputy Mayor Cllr. Cathal Boland, who participated in the tug of war and local elected members. Rush Tidy Towns used the event to award prizes for the best presented estate 2022, --Seafield Court and best presented business --joint winners were the Strand and Harbour Bars.









IPB PRIDE OF PLACE COMPETITION 2022

Judging in the annual IPB Pride of Place competition takes place on Sept 13th and 14th, with entries this year from Mountview in Dublin 15, Balbriggan Men's Shed and Oldtown Community Council. Preparations are well underway in Mountview, with the Community development officer supporting the residents of Mountview and Fortlawn to prepare for judging in the Urban Neighbourhood category. Oldtown will be competing with other communities across the island of Ireland in the populations between 300 and 1000 category, and support from the north county community office team is well underway. Finally, Balbriggan Men's Shed are in contention in the category for community wellbeing projects, again with support from the community office. All three Fingal entries will attend the All-Ireland finals, post judging in Dublin City next February, so the absolute best of luck to our three entries in this year' Pride of Place.







FINGAL WELL- BEING PROGRAMME - COMMUNITY PARTNERSHIP WRAP

Following the successful first round of WRAP training earlier this year, the Community Partner WRAP programme will be rolled out to the community in Dublin 15 from September 2022. Interest in this programme has grown with a large number of participants interested in undertaking training.

COUNSELLING SERVICE FOR TYRRELSTOWN

The Tyrrelstown Community Hub welcomed its first sessions of community counselling this month. This initiative came about as a partnership between the Community Office and PCI college, whereby a free space is provided for students to complete their therapy hours pre-qualification, with the counselling sessions being offered to residents living in the Tyrrelstown area. The community development officer in the area will continue working with both the service provider and the community centre to ensure the smooth running of this new service in the area.



CORDUFF COMMUNITY INITIATIVE

Corduff Park and Grove Residents Association partnered with Corduff Resource Centre and the Community Office to hold a Community Event in the Resource Centre on the 27th August. The event was very well attended with great entertainment bringing old and young members of the community together. Community groups set up stands to advertise their group and encourage new members. Overall, it was a wonderful success which will support continued community cohesion and development in the area going forward.



SUSTAINABLE FUNDING SUPPORTS

The Community Office team continue to support the application process for funding for groups. Community groups are accessing funding available from Fingal County Council as well as being supported to access funding from other agencies and stakeholders to ensure their sustainability and reduce reliance on single sources of funding. Most notably, three applications to the REACH fund have been submitted with the support of the team.



FACILITIES

Facilities Unit welcomes Balbriggan Traveller Project



Balbriggan Traveller Project have officially become the licence holders of a Fingal County Council Community Facility. The Community Development Office's Community Facilities Management Support Unit met with the Project on August 18 to hand over the keys to the Matt Lane Facility in Balbriggan. The newly refurbished facility has a hall space, office space, meeting rooms and a kitchen area and it will help the Balbriggan Traveller Project serve the needs of the Traveller community in the surrounding area of North Fingal.

Balbriggan Traveller Project Co-ordinator Sinéad Burke and Chairperson Eamon McCann were present for the handover from FCC Senior Community Development Officer from the CFMSU Janet Ivers. Also present was Leah Walshe, FCC Community Development Officer for the Balbriggan Area. The Matt Lane Facility will also become the 34th centre to receive assistance from the CFMSU and newest member of the Fingal Community Facilities Network.

AGE FRIENDLY

Information Event for Older People: Mountview Community Centre



Following the success of the pilot information event for older people in Corduff Community Resource Centre in May 2022, a second information event took place in Mountview Community Centre on 25th August 2022 in collaboration with the community development officer in this area. Similar to the previous event, organisations providing services locally for older people were invited to provide information stands. These included the HSE, An Garda Siochana, Age

Action, Alone, Fingal Age Friendly Homes, Fingal OPC, Fingal Community Department, Citizens Information, Sage Advocacy, Healthy Ireland, Senior Alert, AA, Phoenix FM and Mountview Community Centre.

It was a very busy afternoon with nearly 80 older people keen to learn about the services available locally, with one lady commenting that she never knew there were so many services available in their area. Many collected information to disseminate among members of their groups as well as friends and neighbours.

It is proposed to replicate this event in the future in other areas of need as it gives all parties involved an opportunity to link with local residents who may not have come to their attention until it was at crisis point. This event also provides a valuable networking opportunity for service providers who specialise in work in this area.

The event was advertised through local businesses such as the local shop, post office, hairdresser, barbers, pub, chemist, church, HSE and community centres, as well as Facebook, twitter and local radio. It is notable that when promoting this type of event it is invaluable to partner with local businesses and local radio rather than an over-reliance on social media. This approach will be adopted for future events.

Not only did this event provide much needed information to older people in the area, but it was also key to bringing a new audience into the Community Hub in Mountview to ensure the continuity of community development supports in the area.

Intergenerational Practice: Accredited Training

Following on from the success of Intergenerational Practice Masterclass held in April, Linking Generations Northern Ireland have agreed to deliver a one-day Intergenerational Practice accredited training/workshop (4.75 CPD hours). The workshop which is limited to 25 participants will take place on Thursday 22nd September 2022 in Parslickstown House, Dublin 15 (10.30-4.00) and will cover three modules:

- What is IG
- Bringing Generations Together
- Evaluating Social Impact & Promoting Sustainability.

Community and Sports officers as well as representatives from agencies working in Fingal who would benefit from the training were invited to attend.

Positive Ageing Week 2022

Positive Ageing Week will take place from 24th September to 1st October with the 1st October being the United Nations International Day of Older Persons. This year will continue on the theme of ageism in line with the UN Decade of Healthy Ageing.

The Community Department Age friendly team are currently working on various events/workshops to

promote Positive Aging throughout the week including ageism training for staff. Our flagship event '**Give it a Go'** will take place in Newbridge House on Tuesday 27th September 2022 (10.30-12.30). Various groups and sports organisations will demonstrate physical activities for older people with opportunities to partake in various activities on the day. The aim is to showcase what is possible, present a positive image of old age as opposed to one of frailty, and encourage older people to participate in activities. Transport will be provided from Dublin 15 and the North County to facilitate attendance by older people throughout the county.

FUNDING

Activity Funding Awarded in 2022

The Community Development Office has supported and processed 49 Community Activities Funding applications since 2022. A total of €99.418.19 has been awarded across the following

Integration

National Radio Day 2022

Pride Workshops for Pride Month

The integration Team rolled out three workshops as part of Pride Month, the first was on online workshop online LGBTQ+ in the workplace and two community workshops hosted by our Libraries in Blanchardstown and Balbriggan, How to be an Ally and Rainbow Connection. The aim of these workshops was to raise awareness of LGBTQ+ available supports.



SPORTS OFFICE

Her Outdoors 2022

HER Outdoors Week 2022 was a National Initiative that took place from 8th-14th August. Established by Sport Ireland Outdoors with the support of Women in Sport the week aimed to encourage more females to discover and enjoy the benefits of outdoor physical activity and provide them with an opportunity to join their local clubs. The Sports

Office partnered with Swords Cycling Club, Portmarnock Sub-Aqua, Fingal Orienteers, Maxo Triathlon and Balbriggan Rowing Club to host a number of come and try events. Some key highlights seen thirty-five female cyclists take part in the first permitted Cycle Event In Newbridge Park (thanks to Operations Department) and fourteen attended the snorkelling event in Howth alongside Her Outdoors Ambassador, Sarah Kerrigan, with 120 women attending the Yoga and Exercise Sessions at the Balbriggan Beach Festival.

MarathonKids 2022

Fingal County Council's Sports Office in partnership with MarathonKids and all 4 Dublin Local Authorities as part of Active Cities Dublin is launching the MarathonKids programme in September. We expect to have approximately 3000 students from 20+ schools from around the county participating in the programme which sees 5th and/or 6th class students run a marathon over 8 weeks and includes a 'Final Mile' event bringing all the schools together to complete their marathon journey.



New Boules Courts, Santry Demesne

Following consultation between the Sports Office, Local Active Retirement Groups, Operations and Active Cities two new boules courts have been developed in Santry Demesne. The two courts will be a huge addition to the Age Friendly Fingal Community and is a great example of inter departmental co-operation. The Sports Office would like to thank the team in Operations for installing the courts and we look forward to working closely with them on other collaborative projects. As part of the Cycling Without Age Project secure storage will be installed in the park which will also facilitate Boules storage.



Beach Volleyball Balbriggan Saturday 30th July;

The Volleyball Ireland Beach Tour took to Fingal's Balbriggan beach on Saturday 30th July, with a 'King/Queen of the Court' event. The unique format is based on the famous Utrecht Sportworx event which has become a global sensation with international events in Australia, Brazil & the Middle East. Ireland's first National Series of King/Queen of the Court was run on a trial basis at Balbriggan and was open to ten Men's Teams and twelve Women's Teams. Despite the inclement weather, a successful tournament was delivered, attracting the attention of all passers-by.

As Volleyball Ireland CE, Gary Stewart remarked:

"There was overwhelmingly positive feedback from participants about a) the location, access and facilities nearby, and b) the quality of the sand and general environment for the sport. The Harbour style horseshoe of Balbriggan really shields the courts from wind which in Ireland, can often ruin a good day's play. But the sand quality was the real

Active Travel

Strategic Planning

The non-statutory public consultation for the draft Active Travel Strategy closed on the 23rd of May. A total of 149 submissions were received by the closing date. Interviews with strategic external stakeholders are ongoing. All postal submissions have been processed and have been successfully uploaded onto the consultation portal. A draft report on the consultation phase has been submitted and is currently being reviewed by the Active Travel team.

Protected Cycle Lanes Baldoyle-Howth Protected Cycle Lane Scheme Phase 1

Upgrade works at Baldoyle Road/Dublin Road completed. Epoxy resin application on Howth Road completed and works have commenced on Grange Road, weather dependent.









St. Cronan's Ave and Brackenstown Road Protected Cycle Lanes

Our contractor is busy completing works on Brackenstown Road in front of the schools and church. They have constructed new wider footpaths along the front of the schools to safely cater for the volume of school children and parents accessing the schools. A new Zebra Crossing is constructed adjacent to Park Avenue to provide a safe crossing point for vulnerable road users and provide a safe crossing point for the School Warden.





Towns & Villages

Works are ongoing in the development of an Active Travel Plan for a number of our Towns & Villages. A brief has been developed by our Active Travel Team for Balrothery Village to look at the scope of works required to be delivered under our Active Travel pillars. This is going to tender in early September for the engagement of an Integrated Design Team to examine and develop a plan for the Balrothery area.

Works in relation to the Skerries Active Travel Plan have also moved on quite significantly over the summer period with the engagement of the ESRI who are looking at best International and National practice regarding Behavioural Change and Economic Benefits from Active Travel measures introduced in similar towns and villages. The Active Travel Project Team have also engaged the services of a Communications Consultant to assist own communications team in our management of communications and engagement with all stakeholders in the Skerries Active Travel project. They are currently working on a stakeholder list and it is intended to launch the project during European mobility week in mid-September. (Date to be confirmed) The engagement with stakeholders will be through public meetings, online portal and social media outlets to appeal to all persons to participate and contribute to the process. A Brief for Skerries Active Travel Plan has been developed in order to Procure and Engage with a multi-disciplinary Integrated Design Consultant to carry out a detailed review Options Report and concept designs for the project and the Skerries Area. This is currently out to the market, and it is planned to have them engaged by mid- October to commence with the plan.

New Street Public Realm project - A multidisciplinary design team has been appointed for the works. This month our contractors were on site carrying out a detailed topographical survey of works area. FCC expect to have ground penetrating radar and cloud survey contractors on site in the coming month.

Connectivity/Permeability

We are continuing to receive various requests for Permeability and Connectivity improvements from various stakeholders across the county. These requests are being recorded in detail for evaluation and if appropriate, identification of a means of delivery on the ground.

Where other projects being progressed in the area at either design or construction stage; we endeavour to include these Connectivity and Permeability improvements within those projects.

Greenway connectivity support teams have been convened to review, design, and deliver active travel infrastructure that will enhance accessibility between the proposed strategic greenways and residential, educational, amenity and commercial zones. These support projects have been set up for Fingal Coastal Way, Broadmeadow Way/Sutton to Malahide Greenway and Royal Canal Greenway. This will help to optimise the use of the proposed greenway by both leisure and commuter users.

Secure bicycle parking infrastructure

Concrete works completed for the provision of new bicycle parking infrastructure at Harbour Road, Balbriggan. Bicycle stands are to be installed in the coming weeks. Repair works to the existing wall have also been completed.



Works commenced to provide new bicycle parking infrastructure at Hartstown Park, Waterville Park and Tír na nÓg Park.





Road Safety

Safe Routes to School

The Active Travel department have continued works on the 2022 Safe Routes to School Programme. Design works for the first 3 schools has now been completed with design works for the second tranche of schools ongoing. The Active Travel Department and our consultants will be meeting with schools and stakeholders in September to discuss the works.

The tender competition for works contractors has just closed with the successful contractor expected to be awarded early September and expected to mobilise and commence works in October 2022.

School Warden Recruitment Update

Following a recent recruitment drive, 9 candidates were interviewed for the position of temporary reserve school warden on Wednesday 15th June. A panel has now been created with 6 successful applicants included.

All applicants will now be garda vetted and once this is approved, training will be arranged over the summer months so that Wardens can be included on the reserve panel for the new school year from September 2022. We wish all new wardens the best of luck in their new roles.



School Warden Refresher Training and New Reserve School Warden Training

The annual refresher training for School Wardens took place on Thursday 4th August in the Blanchardstown Chamber, and on Friday 5th August in the Swords Chamber. In addition to Refresher Training, the School Wardens received up to date Manual Handling Training from our Health & Safety Unit. These trainings are of vital importance for the School Wardens to ensure they are using the correct operational procedures and risk assessments before their return to service for the new school year. 77 School Wardens attended in total.

The newly appointed reserve School Wardens received a full training workshop, which took place on Wednesday 3rd August in the Blanchardstown Chamber. This Training comprised of the duties, legislation, health & safety, and correct operational procedures associated with the role of the School Wardens. Each new reserve School Warden also received child protection training and manual handling training from our Health & Safety Unit and our Child Protection Officer. These new reserves are now ready to be deployed once the new school year commences.



Cycling without Age Fingal

Cycling without Age is proving to be very popular in St Catherine's Park with 12 trips having taken place since bookings opened. We have also trained up several new pilots and are happy to report that so far, not a single request from a member of the public has gone unfulfilled.

The works related to the storage unit installation for the remaining locations are due to be complete in the next few weeks and we are looking forward to expanding the service.



Cycling without Age - Support to other Areas

We took one of our Trishaws to Trim, Co Meath to assist An Garda Siochana and Meals on Wheels as they begin their fundraising campaign to purchase their own Trishaw. The Fundraising Campaign was picked up in Local Media and publicised by Cycling Without Age Ireland as well.





TIER eBike Update

Since launch on the 20th June Tier eBikes have proved to be very popular around the County. Initially we launced 100 eBikes across Blanchardstown, Swords, Malahide, Portmarnock, Baldoyle and Howth.

At the beginning of August we deployed extra eBikes in the Dublin 15 area and expanded the service to Rush, Lusk and Donabate, bringing the number of ebikes in Fingal to 150. Skerries and Balbriggan are to follow by the end of August.

More bike parking is a constantly growing requirment and we are looking at ways of expanding the number of spaces we currently have through a combination of physical and virtual infrastructure.



Climate Action

Dublin Climate Action Week 2022

The second Dublin Climate Action Week is just around the corner! Climate Action at Flavours of Fingal

The Climate & Environmental awareness team were happy to take part in this year's Flavours of Fingal event, and credit to Councils Events Team for the positive steps they are taking in greening the event in numerous ways. The climate action stand featured a carbon calculator, allowing members of the public to calculate their carbon footprint. The stand provided an opportunity to learn how to reduce one's carbon footprint through more conscious lifestyle choices in the areas of energy use, travel, and diet. The stand also showcased sustainable alternatives to everyday household products, readily available in local supermarkets and a better choice for the environment. The aim was to encourage people to move away from single use items, reducing the amount of waste they generate by choosing products with less packaging, less plastic, made from recycled materials, natural and biodegradable, recyclable, and reusable.

Environmental Awareness

The Balseskin Reception Centre installed a new polytunnel in their community garden. This was funded under the Anti-Litter Anti-Graffiti initiative. Other projects at the centre include Reuse of musical instruments and bicycles – all originating at the Estuary Recycling Centre in partnership with the Rediscovery Centre.

The new Regional Dog Fouling Campaign was launched by the four Dublin Mayors and has gained traction with Tidy Towns and Community Groups in the region. The assets are available here. An awareness pack / resource is available to borrow from the Environment Department for community groups to use during community outreach events and festivals. Doggie dispensers are available in the seven hub Community Centres as listed on the website.

Beach Workshops were delivered in August on eight Fingal beaches to raise awareness of the

importance of litter-free beaches, marine habitats, and restoration of dune systems.

A bus shelter advertising campaign for Biodiversity was run for four weeks of August to raise awareness of actions that can be taken to enhance natural habitats.

Circular Economy

<u>Public consultation on eco-design for</u> <u>sustainable products (2nd August 2022)</u>

The Departments of Enterprise, Trade and Employment, and Environment, Climate and Communications invite submissions to help to inform the Irish position on negotiations on the EU Commission's Proposal for a Regulation on Ecodesign for Sustainable Products.

Background and aims of proposal

The European Commission made its proposal for a **Regulation** on Eco-design for Sustainable Products earlier this year. This initiative is a significant part of the <u>European Green Deal</u> and Commission's <u>Circular Economy Package</u>.

Its main objectives are to reduce the negative life cycle environmental impacts of products, improve the functioning of the internal market and to build on existing successful <u>eco-design rules</u>. It also aims to provide more meaningful information on the environmental aspects of products for consumers.

Ireland's Whole of Government Circular Economy Strategy 2022-2023 commits to the policy of significantly increasing the circularity of the Irish economy, with the aim of being above the EU average by 2030.

Supporting measures that impact on the design of goods and services will be most effective if they are agreed and implemented on an EU-wide basis. This provides a level playing field across the EU for producers and consumers and leverages the power of the Single Market to support the circular transition. The 'Right to Repair' is a case in point. Ireland fully supports the principle of enabling consumers to repair or have goods repaired at a reasonable cost and in a timely manner and will support ambitious proposals along these lines from the European Commission. As a small open economy, Ireland's ability to unilaterally establish a 'Right to Repair' for Irish consumers is limited at best and far more can be achieved through collective action at the EU level.



Litter Management

Dog Fouling is an issue on all our beaches and can have a potential impact to water quality. Dog fouling is an offence under the Litter Pollution Act. Planned bathing water sampling took place from May to September this year. To raise awareness of the issue of dog fouling on beaches, the Litter Wardens carried out extra inspections on the Sundays prior to the water sampling taking place. They carried out an awareness campaign over the summer on the following beaches, talking to dog walkers about their responsibilities as dog owners and handing out dog fouling bags.

Litter Wardens are also erecting anti dog fouling signage in areas where complaints are being received.



Water Quality Protection

The Third Cycle Draft River Basin Management Plan 2022-2027 Consultation Report has been published.

This report presents a summary of the issues raised in the submissions from the 6 month long public consultation undertaken from 27th September 2021 to 31st March 2022 on the draft River Basin Management Plan for Ireland 2022-2027. A total of 1401 submissions were received (259 with unique content) and reviewed by the consultant appointed by the Department of Housing, Local Government and Heritage (DHLGH) -RPS).

Key issues are raised within the most prominent themes listed below.




Figure 2-1: Top Ten Themes Raised Across Submissions (based on 259 unique submissions sent to RPS)

The 3rd cycle of River Basin Management Plan (RBMP) for the period of 2022-2027 is currently being reviewed and updated, where necessary, following these submissions and the final Plan will be prepared by the DHLGH in line with the EU Water Framework Directive (WFD) (2000/60/EC). Publication of this 3rd cycle RBMP is expected Q3/Q4 2022.

Bathing Water

Current Prohibition 'Do Not Swim' Notice at Front Strand, Balbriggan

From the start of the bathing season until mid-July, the bathing water results for the Front Strand Beach Balbriggan were excellent (4) and good (1).

Additional monitoring of the Bracken River indicated no significant impact from the Bracken River to the bathing area. PCR testing showed occasional contamination from dogs ruminants at the bathing area, no human marker was detected above the quantification limit.

On 26th July Fingal received the first 'poor' bathing water sample of the 2022 season. Following consultation with the HSE a prohibition 'do not swim' notice was erected, replacing the All-Season Advisory Notice. An investigation was started, together with additional monitoring of the River Bracken and bathing water, to determine the cause of the contamination.

No issues were reported by Irish Water or were evident during initial visual inspections. Further sampling of the bathing water and River Bracken continued to show elevated *E. coli* and Intestinal Enterococci (IE) readings. An in-channel river walk found a visible source of pollution, a surface water pipe with foul effluent discharging into the river within the town. Following detailed investigations, dye testing and tracing of the surface water line a source of contamination was suspected. A complicated pipe network connecting several buildings had to be investigated and potential sources eliminated as causes. On the 23rd of August a misconnected pipe serving several dwellings was identified and rectified.

Bathing water results from 25th August met the standard for 'good' water quality (as shown in table

above) however these results are still elevated compared to earlier in the season. Results from the Bracken River indicate that *E. coli* remains elevated above background levels within the town stretch of the river. Following consultation with the HSE and having regard to the elevated levels in the river the prohibition notice was not lifted at that time.

Irish Water and Fingal County Council are continuing to investigate other potential sources of contamination to the river and the bathing water. A CCTV survey of sewers in the town to check their integrity is ongoing. Results on the 29th August met the standard for 'good' and following consultation with the HSE a decision to extend the prohibition notice was taken as the investigative actions had not concluded on 31st August. Water quality testing will continue until the situation is satisfactorily resolved and an end of incident sample will be arranged.
