- Offering an attractive sustainable transport choice for residents, businesses, school children and commuters





There are also separate schemes being looked at by other departments in areas such as Lusk and Portrane.


Data from Previous Consultation

Submissions Received (April-May 2021)

529 submissions were received via the Fingal Consultation Portal, email or post.

262 comments were submitted from the questionnaire.

Code of Best Practise for National & Regional Greenways introduced in 2021 – guidance allows for three public consultations

Intention is to carry out four non-statutory public consultations before submitting to An Bord Pleanála



Engagement



A good number of submissions and questionnaires are being received.

Overall a positive response from the larger community, however, a number of concerns are also being received from residents in urban areas where the route passes through both segregated and shared spaces.

In accordance with the Code of Best Practise the next step is to consult with individual landowners. This will include residents groups.

Landowner Engagement commenced in Q3 2021 with over 40 landowners, including resident groups

Next Steps

- A review of all submissions made and report will be published
- Identify all affected landowners and re-commence engagement
- Identify any issues of local concern/local knowledge
- An Agronomist will be available
- Continue engagement with key project stakeholders
- All of the above will inform the development of the Preferred Route
- Which will facilitate the preliminary design process

Preferred Route Corridor

- > Services of Independent Agronomist made available to individual landowners
- > Minimise severance by following perimeter of farms / field boundaries where possible
- > Accommodation works discussed with landowners
- Farmers / Landowners may engage their own Farmer Agronomists / Property Advisor and hold discussions on a one-to-one basis (See Section 3.1.4 on Professional Charges)

Preferred Route

- Services of Farmer Agronomist / Property Advisors made available to individual landowners
- Accommodation works agreed between farmer / landowner and PLO with assistance from Farmer Agronomist / Property Advisor
- > Voluntary land acquisition process commences
- > Produce and make available Route Selection Report
- Farmers / landowners may engage their own Farmer Agronomists / Property Advisors and discussions held on a one-to-one basis (See Section 3.1.4 on Professional Charges)
