Notice is hereby given, that Fingal County Council, being the Planning Authority for Fingal, following the Special Council meeting on 20th, 21st, 26th, and 29th September 2022 and on 3rd, 4th, 7th, 11th, 12th, 13th, 14th, 17th, 18th and 19th October 2022, and having considered the Draft Fingal Development Plan 2023 – 2029 and the Chief Executive's Report in respect of the submissions received, have resolved in accordance with Section 12 of the Planning and Development Act 2000 (as amended) that the Draft Plan be amended.
