

# Newtown Bridge, Balheary Road, Swords

## Road Safety, Cycling and Walking Improvements

### Why is this scheme needed?

To make Balheary Road safer for everyone, particularly those walking and cycling, we are proposing the introduction of new traffic calming and road layout improvements on Newtown Bridge and on the approach to the bridge.

Fingal County Council is proposing to widen the footpath across Newtown Bridge, reduce traffic to one lane crossing the bridge and provide a cycle lane. These improvements will make the journey to the park and to local sports facilities safer, particularly for children travelling on foot or by bike. The works will also improve pedestrian and cyclist access to Broadmeadow Park.

Whether you're heading to sport, travelling to the shops or commuting, cycling is a free, healthy and environmentally friendly way to travel. These proposed works are in line with a vision for active and sustainable travel that contributes to safer routes to school, supports better mental and physical health and protects our climate by reducing carbon emissions.

### Works proposed include

- Pedestrian crossing with traffic lights on Newtown Bridge .
- Widen footpath to provide space for people to walk and cycle together safely.
- Extend and upgrade existing protected cycle lane to bridge from Swords.
- Reduce traffic on bridge to single lane using traffic lights.
- Measures to reduce speed on approach to the bridge.
- Improve pedestrian entrance to Broadmeadow Park and to Balheary reservoir lands at Swords Celtic FC.

### Where will the proposed work happen?

All works will take place at the approaches to and on Newtown Bridge, Balheary Road, Swords.



## Cén fáth a bhfuil gá leis an scéim seo?

Chun Bóthar Bhaile Anraí a dhéanamh níos sábháilte do chách, go háirithe do dhaoine a bhíonn ag siúl agus ag rothaíocht, molaimid go dtabharfar isteach ceansú tráchta agus feabhsuithe ar leagan amach an bhóthair ar Dhroichead an Bhaile Nua agus ar an mbealach isteach chuig an droichead.

Molann Comhairle Contae Fhine Gall an cosán trasna Dhroichead an Bhaile Nua a leathnú, an trácht a laghdú go lána amháin a thrasnaíonn an droichead agus lána rothar a sholáthar. Déanfaidh na feabhsuithe seo an turas go dtí an pháirc agus chuig áiseanna spóirt níos sábháilte, go háirithe do leanaí atá ag siúl nó ag rothaíocht. Feabhsóidh na hoibreacha rochtain coisithe agus rothaithe ar Pháirc an Mhóinéir Leathain freisin.

Cíbe má tá tú ag dul go háis spóirt, ag taisteal chuig na siopaí nó ag comaitéireacht, is bealach taistil saor in aisce, sláintíúil agus neamhdhíobhálach don chomhshaol é rothaíocht. Tá na hoibreacha seo atá molta ag teacht le físeán do thaisteal ghníomhach agus inbhuanaithe a chuireann le bealaí níos sábháilte chun na scoile, a thacaíonn le sláinte mheabhrach agus fhísiceach níos fearr agus a chosnaíonn ár n-aeráid trí astaíochtaí carbón a laghdú.

- An trácht a laghdú ar an droichead go lána singil ag baint úsáide as soilse tráchta
- Bearta chun an luas a laghdú ar an mbealach isteach chuig an droichead
- Bealach isteach do choisithe a sholáthar go Páirc an Mhóinéir Leathain agus go dtí tailte taiscumair Bhaile Anraí ag Celtic FC Sord
