Chief Officer and Chairperson Joint Statement



WW elcome to the 2022 Annual Report of the Fingal Local Community Development Committee (LCDC). The LCDC has primary responsibility for co-ordinating planning and overseeing local and community development funding and the preparation and review element of the Local Economic and Community Plan (LECP).

The Local Government Reform Act 2014 gives legislative effects to the commitments in 'Putting People First'. LCDC's were established in each local authority administrative area. Each LCDC has the responsibility of developing, coordinating, and implementing a coherent and integrated approach to local and community development.

Fingal LCDC provides governance, oversight and coordination of a number of programmes and funds, including the Social Inclusion and Community Activation Programme (SICAP), the Healthy Ireland Fund and various Community Enhancement funding streams which were administered by the LCDC secretariat. SICAP facilitates communities to work collaboratively with stakeholders using a broad range of supports and interventions to tackle poverty and promote social inclusion and equality at a local level. The LCDC is also central to the Dublin Rural LEADER Programme, which supports the local rural development in the rural areas of Fingal, Dublin Dun Laoghaire (DLR) and South Dublin.

Oversight and co-ordination of the programmes is supported and augmented by Fingal County Council, Pobal, the Department of Rural & Community Development (DRCD) and the Department of Health.

The Public Participation Network (PPN) is another cornerstone of the LCDC. The four PPN representatives on the LCDC link back to the PPN, providing input into decisions taken by the LCDC and allowing the voices of PPN member groups to be heard. This link is vital to the relevance of the LCDC for our communities and a valuable and positive contribution to civic life in Fingal.

During 2022, the LCDC continued to monitor the implementation and progression of the Local Economic and Community Plan (LECP 2016-2021). The changing landscape for individuals and communities due to Climate Change, Brexit, the continuing fall-out from the Covid 19 Pandemic, the Ukrainian crisis and the cost-of-living crisis all brought new challenges which were successfully met by the LCDC and its stakeholders.

Fingal is in a strong position to develop and grow. Many LCDC supported initiatives administered in 2022 will be the foundation for the development and success of our local communities well into the future.

The annual budget for SICAP 2022 was €1,383,217. A contribution comes from the European Social Fund (ESF) Programme for Employability, Inclusion and Learning (PEIL) 2014-2020 and the Youth Employment Initiative. The SICAP Programme Implementer, Empower, achieved its two key performance indicators (KPI's) and ensured that the programme and services were delivered within the financial parameters approved by the LCDC.

The arrival of Ukrainians displaced from their homes because of the Russian invasion impacted significantly on SICAP 2022. Empowers' response was swift and practical as they responded to the needs of Ukrainian arrivals.



We would like to commend the huge response of the staff, particularly over the double bank holiday in March when the first Ukrainians arrived into Ireland. The DRCD allocated a further fund of €189,502 to Empower to support additional actions to meet the needs of Ukrainians arrivals.

The Dublin Rural Leader Local Action Group (LAG) was established to deliver the LEADER element of the Rural Development Programme (RDP) in the Dublin area. The LAG is responsible for designing and implementing the LEADER Local Development Strategy (LDS). The allocated fund for the Dublin Rural area is €6.37 million and of this €4.74 million is available for local projects in the region. During 2022 the LAG continued to support community groups and enterprises in the aftermath of Covid 19.

The Healthy Ireland Programme continued delivery in 2022 with the support of the Healthy Ireland Committee and Fingal LCDC. The many community support grant schemes administered by Fingal County Council and Fingal Childrens & Young Peoples Services Committee (CYPSC) during 2022 helped our communities in maintaining services as we emerged from the Covid 19 Pandemic.

Fingal LCDC also administered the Community Activities Fund of €301,042 under the Community Enhancement Programme in 2022.

We would like to commend the Director of Services, Economic Enterprise Tourism & Cultural Department, and staff of the directorate for their work in supporting the LCDC and partnerships with communities, government agencies, the business community and stakeholder groups.

Finally, we would like to thank the LCDC members for their continued support during 2022 and for their excellent response to the challenges of delivering the various programmes during 2022.

LCDC FUNDING 2022

The Community Supports Fund under the Community Enhancement Programme 2022

The Community Activities Fund (CAF) under the Community Enhancement Programme was launched by the Department of Rural and Community Development on 11th November 2021 by the Minister for Rural and Community Development (DRCD), Heather Humphreys TD, and the Minister of State with responsibility for Community Development and Charities, Joe O'Brien TD.

The CAF was administered by Fingal Local Community Development Committee (LCDC).

The Community Activities Fund, a once-off fund supported groups, particularly in disadvantaged areas with:

- Operating and running costs such as utility bills, rental/lease costs and insurance bills.
- The cost of repairs and improvements to facilities, purchase of I.T. equipment, furniture, tools, signage, training equipment etc.

Fingal County Council was allocated €301,042 in funding for community & voluntary groups across the county. This total amount comprises, €183,970 Current funding for us towards running & operating and €117,072 in Capital funding. The LCDC evaluation committee agreed the criteria and recommended 30% of total funding be ring-fenced to provide small capital grants of €1,000 or less.

The projects were evaluated under the following headings:

- Expected impact arising from funding
- Degree of disadvantage of the area/group
- Deliverability

Three categories of disadvantage were identified:

- Groups operating in disadvantaged areas
- Group supporting disadvantaged people
- Groups disadvantaged from funding sources

228 groups/organisations submitted applications totalling €833,382.25 for a Capital fund of €117,072.00 and Operating & Running costs of €183,970

All completed applications were evaluated (viewed & discussed) by the LCDC Evaluation Committee and 111 groups were recommended for CAF Capital funding and 101 groups were recommended for CAF Current (Non-Pay) funding for use towards running/operating costs, with the approval of the LCDC.





HEALTHY IRELAND

Healthy Ireland, A Framework for improved Health and Wellbeing 2013-2025 is the national framework for action to improve the health and wellbeing of Ireland over the coming generation. It is being implemented on a local level as part of Fingal's Local Economic and Community Plan. The scheme is being administered by the Fingal Local Community Development Committee (LCDC) under the remit of Fingal County Council on behalf of the Department of Health.

Fingal County Council received an initial funding of €334,460. Further funding of €41,574 was received during the period Jan to May 2022 to extend the roles of the Social Prescriber and Healthy Ireland Coordinator. A further fund of €15,000 was also granted to extend the role of the Social Prescriber until December 2022. While the Covid 19 pandemic caused many restrictions and hurdles in implementing the actions, each group found a way to continue with their project. Round three was successfully completed at the end of May 2022.

The Healthy Ireland programme of work in Fingal is supported by a Healthy Fingal subgroup of the LCDC.

Healthy Ireland is a government led initiative aimed at improving the health and wellbeing of everyone in Ireland. The Healthy Ireland funding for Fingal 2022 was spread over two funding periods Round 3 (Jan-May 2022) and Round 4 (Jun – Dec 2022) with an additional €15,000 available as part of a social prescribing fund which ran from April – Dec 2022.



The Healthy Fingal Coordinator developed a **Community Engagement and Communications** Plan for Healthy Fingal which included undertaking brand awareness activities, creating a guarterly newsletter and information gathering. The first quarterly newsletter was published in early April 2022 and used community/sports activities to promote Healthy Fingal through the distribution of merchandise at events such as Community Centre Open Days, Men on the Move, Junior Park Run, Hello, How Are You Day. Healthy Fingal flyers were distributed through Fingal Libraries, Fingal Community Centers, HSE CH09 and Empower and pull-up banners have been distributed to continue to promote and raise awareness of the Healthy Fingal brand.

Empower, under the auspices of Healthy Fingal implemented a Social Prescribing Programme (SPP) for Fingal, to follow on from our Social Prescribing scoping action in the previous round. The funding was used to appoint a part-time Social Prescribing Coordinator and although Covid-19 restrictions required the service to initially be delivered online instead of in-person, Corduff Primary Care Centre



did hold a regular clinic throughout 2022. Healthy Fingal supported several projects throughout 2022 which were delivered by Aoibhneas Domestic Abuse Support, Blakestown & Mountview Youth Initiative Summer Project, Empower, Foroige, Mulhuddart Community Centre, Dublin & Dun Laoghaire ETB, Crosscare and Empower.



At the end of May 2022, Keira Brett the Healthy Ireland Coordinator from Empower, stepped away from the role. The position was advertised as a three-year contract through Fingal County Council. Niall McGuirk, was appointed as the new Healthy Fingal Coordinator

in December 2022. Niall's focus for 2023 will be around the reduction in smoking and vaping and a reduction in binge drinking.

In June 2022 Fingal County Council signed the funding agreement for Round 4 of the Healthy Fingal Programme with an initial fund for 2022-2025 of €175,000 awarded to Fingal County Council.

SECTION 2 Fingal Local Economic & Community Plan 2016-2022



The Local Government Reform Act 2014 provides a stronger and clearer role for local government in eco-nomic development and community development.

Local Economic and Community Plans (LECP) support the sustainable development of our counties. First described in Putting People First: Action Plan for Effective Local Government and then formalised in the Local Government Reform Act 2014, they form the local element of the national development framework and support collaboration to increase the quality of life in our communities. This has never been more important as we look to support a sustainable recovery from the impact of the pandemic.

The primary aim of the LECP is to set out, for a six-year period, the objectives and actions needed to promote and sup-port the economic development and the local and community development of Fingal, both by the Local Authority directly and in partnership with other economic and community development stakeholders. The LECP is an important way to set out how Government and other stakeholders can work together to en-sure that their initiatives, programmes, and projects support an improved quality of life for people living and working in the county. Part of the statutory responsibilities assigned to the Minister for Rural and Community Development (DRCD), under the Local Government Reform Act of 2014, is to support the de-velopment and implementation of the LECP.

The Minister for Housing, Local Government and Heritage (DHLGH) is charged with oversight of the Economic Elements of the LECP. Both Departments have worked together to develop guidelines to enable and support integrated planning for both community and eco-nomic elements as envisaged in the legislation. The process also included a broader consultation with input from other Government Departments, Local Authorities, Public Participation Networks (PPNs) and other members of the relevant Local Authority Committees, the Local Community Development Committees (LCDCs) and the Strategic Policy Committees (SPC). Fingal County Council looks forward to working with all stakeholders to support the development, through the LECPs, of strong integrated local frame-works that will provide the foundation for economic and social recovery and support sustainable develop-ment across the country over the next six-year period.

The overall vision for Local Government, "to promote the well-being and quality of life of citizens and communities".

The process for the development of the LECPs will initially consist of four broad phases: preparation, pub-lic consultation, development of High-Level Goals, objectives and outcomes, and finalisation of the LECP, in 2023. This will be followed by a fifth phase for implementation that will include the Implementation Plan process and a sixth stage of monitoring, evaluation and review of the plan.

SECTION 3 Social Inclusion Community Activation Programme 2018-2023

The Social Inclusion & Community Activation Programme (SICAP) is a key intervention for harder to reach groups and individuals.

Delivery of SICAP is overseen and managed by Fingal LCDC. SICAP aims to address poverty, long term unemployment and social exclusion through local engagement and partnership between disadvantaged individuals, community organisations and public sector agencies.

The budget for 2022 was €1,383,217 for which a contribution comes from the European Social Fund (ESF Programme for Employability, Inclusion and Learning (PEIL). The programme implementer achieved its two Key Performance Indicators (KPI's) for 2022 (see table 1 below) and ensured that the programme and services were delivered within the financial parameters approved by the LCDC. The Horizontal Themes of SICAP are Equality Community Development and Collaboration.

These themes are fundamental to Fingal LCDC and Empowers' values and are evident through the strategies reviews, programme planning and daily delivery.

Empower applies a person-centred approach to individuals under Goal 2 of SICAP. This allows individuals explore their options and identify the best course of action for them. The personal action plan agreed with a caseworker helps them jointly identify supports needed as part of their engagement with SICAP.

Based on completed personal action plans the needs more frequently identified among SICAP target groups included:

- Counteracting digital/food/fuel poverty
- English language skill deficits
- CV and interviewing
- Self-employment mentoring supports
- Access to affordable early-years services
- Lack of awareness of public health supports
- Housing supports





Empowers response to the Identified Needs of Individuals and Groups

FOOD POVERTY

Food Poverty is defined as the 'inability to have an adequate and nutritious diet due to issues of affordability or accessibility'. Target groups typically spend more of their overall budget on basic food essentials. Empower collaborated with Blanchardstown Traveller Development Group and the Vincent de Paul to provide a Traveller Foodbank. A Traveller Outreach Worker helped provide food parcels and fuel vouchers to the 7 Traveller Halting Sites in Dublin 15. Empower has also supported delivery of food parcels to the Roma community in Fingal.



ENGLISH LANGUAGE CLASSES

Classes were provided to New Communities, who made up 53% of the caseload in 2022. Both structured and conversational Failte Isteach Classes took place.





ONE STEP CLOSER

One Step Closer offered job-seeking skills and training, in groups or on a one-to-one basis. 160 people received supports digitally or via workshops. 97 people set up their own business and 56 received follow up self-employment supports for businesses started in previous years.





LOCAL COMMUNITY GROUPS

The Balbriggan Integration Forum, a volunteer-led group believes developing positive intercultural relationship enriches the quality of lives in the area. A SICAP staff member aided the group, including supporting integration, educational needs as well as voter education and active citizenship. Team Zimbabwe is a football club and support group. They act as an information and support service as well as providing health and fitness training. SICAP supported them with equipment and links to the FAI, Healthy Fingal Coordinator and the Fingal Public Participation Network. A SICAP staff member links in with the Corduff Women's Group providing information on activities, funding, healthy eating, DIY, arts & crafts and a HSE approved wellbeing programme. Empower was successful in leveraging g funding from different government department which helped support the target groups of SICAP.

EARLY YEARS SERVICES

Mulhuddart Parent and Child Group support young families. The local community centre provides a space to meet other families, receiving parenting support and information. Members of the group come from a broad range of ethnicities. Tyrrelstown Stay and Play Group meet up to support the development of their children and combat isolation. Empower also helped groups successfully source funding from Fingal County Council.





SOCIAL ENTERPRISES

In total SICAP supported seventeen social enterprises in 2022. 45 full-time and 36 part-time jobs were supported. These include Afro Diaspora Centre, Aster Family Resource Centre, BASE Enterprise Centre, BEaT Enterprise Centre, Eggheadz, Grow Remote, Huntstown Community Centre, Ladybird Lane Childcare Service, Loving and Affectionate Family, Musicantia CLG, One Step Closer, Parlickstown Childcare Facility CLG T/A Little Learners Creche, Phoenix FM, Way2Work Ireland and Work Equal.

EMERGING NEED 2022

'Children and Families' was the chosen theme for the emerging need 2022. In total, 1,473 young people and children and 856 parents and guardians benefited through activities encouraging access to further education & training, family supports, preschool as well as welfare & wellbeing supports.



SICAP Response to the Ukrainian Crisis

Empower first became aware of Ukrainian refugees in Fingal on Wednesday 16th March. Refugees approached a SICAP worker. Their needs were a ssessed quickly. The SICAP team established the Empower Ukrainian Emergency Support Service (UESS). The flexibility of SICAP allowed Empower to respond immediately. Central to this was the transformation of the Empower Head Office into a Ukrainian Community Hub. Over the next four days, the double St. Patrick's Day Public Holiday weekend, SICAP staff worked tirelessly to transform our premises. On Monday 21st March, within five days of their arrival, we were fully operational.

In June 2022 the government announced a budget of €5m in funding for SICAP in recognition of the ongoing contribution made to the local community response to the crisis. Empower received a contribution of €189,502.

The number of refugees in emergency accommodation across Fingal continued to rise. The lack of transport to access services was identified as a major barrier. SICAP engaged a bus service to collect refugees from their accommodation and bring them to amenities including the Post Office, Banks, Library, Citizens Information, DSP & shops. Other supports included establishing a Greeting Area, Social Spaces and a Parent & Toddler Room.

Key ongoing actions undertaken by Empower include establishment of English language classes, Ukrainian Jobs Club and opportunities to engage social with local communities.





SECTION 4 The Dublin Rural Leader Local Action Group


The Dublin Rural Local Action Group (LAG) was established to deliver the LEADER element of the Rural Development Programme (RDP) for the period 2014–2022 in the Dublin Rural Region. The LEADER Programme aims to improve the quality of life in rural areas and to encourage diversification of economic activity in rural areas.

2022 was a positive and productive year for Dublin Rural LEADER. The funding continued to support community groups and enterprises in the aftermath of Covid-19, enabling them to adapt their offerings and diversify to meet new needs. The LAG approved projects across all themes and committed the entire Transitional Budget. The LAG submitted an Expression of Interest for the 2023-2027 LEADER Programme and were successful to proceed to the next stage of developing a new Local Development Strategy for Rural Dublin which will shape the next programme.

A breakdown of the projects approved in the 2021- 2022 LEADER Transitional Programme:

- Total number of projects approved under the Transition Programme was 36 to the value of €1,523,776 €896,422 in 2021 & €627,354 in 2022.
- Theme 1: Economic, Enterprise & Job Creation 6 Projects, value: €194,393
- Theme 2: Social Inclusion 15 Projects, value: €648,336
- Theme 3: Rural Environment 4 Projects, value: €248,187
- EURI Projects: 11 Projects, value: €432,860
- Dublin LEADER total money committed to date: €6,580,651 (2014-2021 LEADER Programme plus Transition)

Project Description

Lambay Island is an offshore island 3 miles from the coast of north county Dublin. It is part of Fáilte Ireland's UltraLuxe market and attracts tourism from all over the world. The island is classified as an off-grid system from the point of view of its electrical supply and this is generated on the island using wind turbine and solar panels, a battery bank, and a backup generator.

Increased tourist requests and the reopening of the island for functions after the Covid 19 pandemic ended all visits to the island for approximately 18 months, has required that the island upgrade its renewable energy facilities to both cope with increased visitor numbers and to further decarbonize the energy load on site. LEADER funding assisted with the capital expenditure of additional solar PV panels to increase renewable energy generation on the island, renew the associated battery facility to ensure the matching of load and resources on the island and the upgrade of monitoring and reporting facilities on the island to make the carbon-free nature of the island more accessible and marketable by the island operators to visitors and guests alike.

Project Description

Man O 'War GFC developed a walkway track around the perimeter of the grounds for use by the local community. The walkway is approximately 1km in length circling the full inside perimeter of the grounds. The walkway will be available for use by the local community, Man O 'War club members and local businesses such as Country Crest and Oberstown Detention Centre, both of whom are directly beside the club grounds.

The recent COVID-19 pandemic highlighted several ways that the club could serve the local community more and the development of a walkway is one such way. Developing this facility will bring more of the community into their grounds for more than just Gaelic games. It will serve the local community, many of whom are elderly, by provisioning a safe place free of traffic to get exercise. It would also be possible to facilitate organised walking groups, for example, men's walk and talk groups etc. The pandemic has highlighted how isolation for many has a detrimental effect on individuals and by creating a



walking hub, the club will be providing an avenue and an opportunity for people to meet up for exercise.
