#### **Chief Executive's Foreword**

In towns and villages all across Fingal, a dedicated collective of volunteers work tirelessly week in, week out to improve their localities and enhance public spaces for the enjoyment of all. We have all seen Tidy Towns groups working hard by planting, cleaning, litter picking and painting around our areas, in all kinds of weathers! Their enthusiasm and commitment is unparalleled and I was very pleased to attend the Mayors Awards on Wednesday May 1st at which these groups were honoured. Hosted by Mayor of Fingal Cllr Adrian Henchy and MC'd by broadcaster Deric Hartigan, the event was an uplifting celebration of the people who make up Tidy Towns groups. Collaboration with communities is a key element of the work we do in Fingal and we are fortunate to enjoy a productive and rewarding relationship with Tidy Towns in the county. I would like to offer my congratulations to the representatives of all the groups who attended the awards and who are so deserving of our recognition and sincere thanks.

In 2024, Fingal County Council is offering more than 450 homes in 11 locations for purchase under the Affordable Housing Scheme. Applications are currently open for 339 of these homes and are available to first time buyers or fresh start buyers who qualify under the criteria to buy. The locations of these homes include Church Fields in Mulhuddart; Balmoston, Donabate; Ballealy Rise, Lusk and Kilmartin Grove, Dublin 15. Working with the Department of Housing, the Land Development Agency and developers like Glenveagh, GEM, Ballymore, Lagan, Gannon and Manley has ensured that our dedicated Housing team can facilitate the roll out of beautifully finished homes in these latest schemes. Cognisant of the many different requirements of families, single persons or couples, there are homes ranging from 2-bed units to spacious 3-bed homes as well as larger 4-bed houses for bigger families. We are absolutely committed to delivering under Housing for All and I am pleased with the progress we are making in this area. It is a priority for most people to be in a position to have their own home and affordable housing and cost rental schemes such as these are helping people to realise that dream. Providing an excellent standard of accessible services to members of the public who call to our offices or use our online services is a strong focus for Fingal County Council. Cathal Kearney was appointed as the council's Access Officer last year and is overseeing the preparation of Fingal's first Access Strategy. The plan will contain actions and objectives to ensure service users will be provided with an inclusive and accessible experience in their dealings with us. Cathal invites everyone to have their say on the draft strategy by taking

part in a survey to gather public insight. The survey, which will close on May 17<sup>th</sup>, is designed to capture the views of the entire community and particularly those with an experience of a disability. You can have your say by viewing the survey in hardcopy form in our public offices, online on the Fingal Consultation Portal or by recording or videoing your responses. Your input on this important matter is acknowledged and valued and will help to inform the direction of our services for all.

The rejuvenation of the harbour area and Quay Street Balbriggan took another positive step forward on Monday April 29th as contracts were signed with the developer John Craddock Ltd. This is another milestone in the journey of this project which, when completed, will offer the people of and visitors to Balbriggan an exciting and attractive public realm experience in the Quay Street and harbour environs as well as improvement works in Bridge Street to take advantage of the position of the Bracken River. Further large infrastructural improvements such as the introduction of a Green Corridor, which will extend from Stephenstown, following the River Bracken, through Millpond Park, will create a new street edge and park entrance on Bridge Street, flowing down to a transformed Quay Street, Viaducts and reimagined Harbour. The busy railway station area will undergo huge changes thanks to public realm and streetscape improvement works as well as works to integrate Active Travel and support footfall in the area. This is an exciting time for the town as the works commence and the carefully crafted vision for this dynamic place edges closer. I look forward to seeing the process of change over the coming months and welcome these latest developments.

Some highly anticipated events are taking place in Fingal over the coming weeks and months. The hugely successful Fingal Proms took place from May 3rd to May 5<sup>th</sup>. Accomplished artists including Paul Byrom, Leah Barnville, Tom Dunne and Dermot Byrne gave incredible performances which were much appreciated by audiences in Shackleton Gardens in Clonsilla, The Seamus Ennis Centre in the Naul and Baldoyle Community Hall. Continuing on the theme of musical performances, the ever popular Nathan Carter will be returning to Swords Castle on Friday July 26th bringing his own rousing style of country music guaranteed to have everyone dancing and signing along! The weekend doesn't end there as 80's superstars Sister Sledge plus support take to the stage on Saturday July 27th for performances of their greatest hits - one not to be missed. Details on all upcoming events in Fingal, including the highly popular Flavours of Fingal, are currently on our social media channels. I hope you enjoy some of the fantastic events taking place over the summer.

#### **Wellbeing Update**

Fingal County Council will launch 'Elephant in the Room' to staff in May. This is an awareness initiative created to help give people everywhere permission to talk openly about their mental health. The initiative uses art to help promote an open culture and start conversations.

A number of art sessions were successfully offered to staff during April as part of our 'Creativity for Wellbeing' programme. Artistic activities such as painting have been proven to Enhance mental health, Reduce Stress, Foster Resilience, Fuel Joy. Further sessions are scheduled throughout May.

#### **HSU - Health & Safety Unit**

The HSU during the month of April 2024 completed a number of incident investigations, site safety inspections and safety audits within the various directorates in Fingal County Council. The HSU continued to field staff requests of a variety of safety issues including advice on smoking cessation, VDU assessments/remote working and advice on evacuation during fire alarm activations. The HSU towards the latter part of April began to compile Fingal County Council's submission for the 2024 NISO safety awards all-Ireland competition.

#### VR for Libraries Shortlisted for a Digital Town Award

Virtual Reality (VR) for Fingal Libraries, has been shortlisted in this years' .ie Digital Town Awards under the award category: Digital Education.




The VR for Fingal Libraries project is a joint project between Fingal Libraries and Fingal Digital Services Department, which aims to introduce the wider population to an emerging technology. Giving access to digital twins of Fingal County Council (FCC) planning models, 3D videos of heritage properties, Irish language content, and a curated set of apps designed to engage and inspire. Fingal Libraries also have access to Unity Learn on their public PCs, enabling the next generation of VR creators. FCC is the first local authority to develop this kind of VR programme.



#### **Communications**

The Communications Unit provided support to several departments during April including the signing of the contract for the public realm works to Quay Street and the Harbour in Balbriggan. Support was also provided to the People Services Department who took part in the Jobs Expo in Croke Park; to the Strategic Infrastructure Department who opened the new playground at Lanesborough Park and to the Heritage and Conservation units who hosted a visit to Fingal by Minister Malcolm Noonan.



#### Website

In the period of April 1 to April 30 the fingal.ie website attracted 166,721 visitors, reflecting an increase of 24,104 compared to March. The number of page views soared to 402,370 marking a 25.6% rise from March and an impressive 39.6% growth from the same month last year. The most frequented pages were those featuring news about the Affordable Housing Scheme, Contact Us section, information on Recycling Centres and Job listing section.

#### **Social Media**

The Affordable home scheme post on Facebook and X collectively reached 39,561 people with an engagement rate of nearly 25%. Furthermore, the post seeking nominations for the Quiet Streets trial to address rat-running on streets had a cumulative reach of 28,972 and an engagement rate of 10.21% across the three platforms: X, Facebook, and Instagram. With an engagement rate of 8.14% the post about vandalised public toilet at Ward River emerged as the post with the third most reach for April.

In terms of follower growth, the Instagram account saw an increase to 9,489 followers, while Facebook is at 34,000. X and LinkedIn saw substantial growth with 54 and 166 new followers respectively, bringing X's following to 23,409 and LinkedIn's to 9,000.

Overall, the corporate social media channels now have an accumulated following of 75,896.



#### Videos

During April, nine videos were created and uploaded onto the Council's YouTube channel. Among them was a video featuring 'Xplore your future 2023', showcasing testimonials and feedback from teachers and students who have participated in the program. Additionally, videos were created to highlight topics such as the Community Monuments Fund grant; coverage of the Minister of Heritage visit to various heritage sites across Fingal; and the Conservation of Balbriggan's Boat House and Bath House. Moreover, there was a video showing the various job roles within Fingal County Council and the benefits of working here.

#### **Press Releases**

Throughout April, the communication unit issued ten press releases covering various events and initiatives. Among them were the opening of the new Lanesborough Park playground for the community in Meakstown; the opening of the first exhibition in Carnegie Library, and the return of the Dublin Canvas public art project. In addition, the launch of an Access Strategy survey aimed at understanding how the citizens of Fingal engage with the Council's services was also highlighted.



#### Media Queries

The Communications Unit responded to 32 media queries in the month of April. These inquiries covered various topics, including discussions on Tenant-in-situ, developments concerning a large site on the Rathbeale Road in Swords, and concerns regarding Soil & Water contamination in Dublin Airport.

#### **Building Facilities / Energy Improvements**

The first 6 Months of the EPC have seen valuable savings for the Council (Reconciliation period 1 – September 2023 – March 2024). These savings are set to increase as the energy conservation measures are optimized and increased energy awareness is encouraged with the ongoing day to day management of the offices. The combined total energy savings achieved amounted to 19% which represents a reduction of 176 tonnes of carbon emissions.

This is the result of 34% day time electrical savings, 27% nighttime electrical savings, and 12% gas energy savings. The combined total cost savings are 25%.

During this reconciliation period, building facilities have installed some energy meters to support energy monitoring. As the program develops it is beneficial for both parties (the council and the Energy Savings contractor) to seek and explore new opportunities which will lead to more energy savings

The total electrical cost reduction achieved through reconciliation period 1 is 32% based on the agreed contract rates. The total day and night consumption reduced from 967,274 kWh to 656,252 kWh which represents the 32% reduction. The main electrical daytime savings have been achieved in Swords County Hall with a reduction of 42%. This is mainly due to the lighting upgrade (LED light fittings).



#### **Operator continues to win awards**

## Malahide Castle & Visitor Centre Energy Centre Upgrade


Contractors are now appointed and with a series of stakeholder meetings now completed on-site the works are scheduled to commence in early May 2024. This project will deliver a more sustainable and enhanced energy efficiency across the site.



#### **Skerries Martello Tower - Restoration Project**

The process of restoring and conserving the Martello tower on red island has begun. A consulting engineer has been appointed to investigate the stability of the structure overall, including the external render and windows, internal fabric, flagstones, foundations and viability of an annexe to the tower, and possibility of a viewing gallery at the top.

It is hoped that this enabling phase will complete by the end of June, with a design solution proposed over the summer and proceeding to formal permission and consent in the Autumn or Winter this year.

#### **Ardgillan Castle Alarm Upgrade**

Having last year completed the roof project a series of works and upgrades in Ardgillan Castle have continued this year. A pressing issue identified during the construction was the need to modernise the intruder alarm system, which protects the house and collection therein.

Working with our contractors the new alarm spec was developed and commissioned and the project is now complete and snagged. Security of the site is now enhanced to a high standard.

#### **Youth and Education**

### Space Crafts – and arts & science initiative for DEIS schools in D.15

Fingal Arts Office and DIAS Dunsink have formed a unique partnership that will expand over a two-year period and allow for significant collaboration between contemporary artists and scientists on site. DIAS is a rich source of scientific information and ripe for creative investigation. Artists Aileen Murphy, Julia McConville and Mary Jo Galligan have begun working with DIAS scientists to research and develop methodologies for engaging with children in and through science and the arts.

Through a series of collaborative science and arts workshops children will be introduced to STEAM subjects they will soon study in secondary school in a fun way. Activities will stimulate interest in the exciting space research taking place at Dunsink and contemporary art practice. Castaheany Educate Together National School and St. Philip's Senior National School, Mountview, are the first of 8 primary schools to participate. The initiative is primarily funded through a successful application made to Science Foundation Ireland Discover Programme.

#### **Dance in Schools**




Choreographer and dance instructor Mariela Mira visited Swords Community College this month to explore contemporary dance techniques with students through fun and inclusive dance workshops. This forms part of a larger research project Fingal Arts is commissioning in partnership with Dublin Youth Dance Company to map and asses dance provision countywide.

#### **Public Art**



Adam Gibney has commenced his engagement with participants from the Thrive programme Balbriggan on his groundbreaking public art commission Tidal Composition. A series of interactive sculptural works will live in the home of participants for a lunar month. The work is accompanied by a logbook which is designed to work with the artwork so that the participants can share their thoughts on how the sea supports our mental health. Workshops are being facilitated by writer and playright Louise Lewis on the project at the Base Centre. Sculptor Jackie McKenna has presented a new proposal for the final artwork on the St Patrick's Way & Art Trail which will celebrate St.Patrick in Skerries.

#### **Artist Funding & Support**



Applications have been received from professional artists under the 'Fingal Artists' Support Scheme 2024'. This scheme arose as а recommendation from the Council's Arts Development Plan 2013-2017. Now in its eleventh year, demand for the funding scheme has increased from 37 applications received in 2014 to 263 eligible applications received this year.

The funding allows professional artists in Fingal to avail of funding support towards professional development opportunities, a residency, or towards the development of their careers as artists.

Open to practicing artists at all stages in their professional careers working in music, visual art, drama, film, dance, and literature, eligible applicants must have been born, have studied, or currently reside in the Fingal administrative area. Following the recent adjudication by an independent panel of assessors, 86 awards, amounting to a total sum of €250,000, have been recommended to the Council for approval at the May meeting.

#### **Draíocht**



#### **Draíocht - Nest Closing Event**

On Saturday 13th April 2024 Mayor of Fingal, Councillor Adrian Henchy accept the formal gifting of forty-six commissioned artworks by Draíocht to Fingal County Council's Municipal Art Collection at the closing event of Nest. Nest, a significant multidisciplinary and community-based project, included 23 new performances created by theatre, dance and music artists for 23 host children and young people aged between 7 weeks old to 22 years old. These performances took place in schools and homes all over Dublin 15. Two significant visual art portraiture projects were also commissioned:

- **NEST The Portrait Project** in the Ground Floor Gallery presented a new series of specially commissioned artworks in paintings and drawings from four of Ireland's leading artists, Zsolt Basti, Sahoko Blake (ARHA), Dorothy Smith (ARHA), Una Sealy (RHA). The exhibition featured works of portraiture and companion pieces inspired by the 23 children and young people participating in NEST.
- NEST You, Me, Us in the First Floor Gallery featured a photographic and collage installation of portraiture, drawing and testimonials made by 153 young people from Dublin schools 15 participating in NEST and investigated identity and self-representation. Led by photographer-in-residence Liadh Connolly, the young people were invited to compose, stage, costume and style portraits of each other.

Rooted in portraiture, the exhibitions were multiple in their perspectives and consistent in the depth of feeling that a generation of children and young people living in Dublin 15 attach to the idea of 'Nest'. The vibrancy and diversity of the works presented on paper, canvas and vinyl mirror those same characteristics in the young people at its core. The works reflect Fingal's young, diverse and growing population.

#### **Fingal Studies**

It also aims to showcase the wealth of historical research and writing talent in the county. An editor and editorial board have been appointed and a Call for Papers has been issued. Originally published from 2010 to 2015, it will be re-launched as an annual journal in October 2024 during the Fingal Festival of History. The journal will be distributed through branch libraries with an e-book version also made available through BorrowBox

#### Children's programming



Creative workshops for children in April included a graphic novel drawing course with author and illustrator Alan Nolan, spring crafts workshops with artist Kim Jenkinson, journalling for mental health sessions with author Megan Wynne, Musical Tots sessions and sensory-friendly events. 'Spring into Storytime' story sessions with library staff took place as part of the national Right to Read programme, which promotes literacy and reading development.

On 16th May, students from Blakestown Community School, Scoil Mhuire Senior School, Philip's Mountview, will and Blanchardstown Library for an afternoon with comedian and celebrated children's book author, David O'Doherty. This special occasion celebrates the One Book, One Community project, where pupils from different schools come together to explore the themes and characters in David's book 'The Summer I Robbed a Bank'. This project involves paired reading sessions as well as literacy and art activities. Children will get to meet the author for a reading and Q&A session in the library.

#### **Literary Events**



Novelist Anne Griffin joined author Dermot Bolger for a discussion of her writing in Malahide Library on 13th April. Louise Nealon discussed her novel Snowflake, this year's choice for One Dublin One Book, with author Kerri Ní Dochartaigh in Blanchardstown Library on 16th April. One Dublin One Book aims to encourage everyone in Dublin to read a designated book connected with the city during the month of April every year.

#### **Bealtaine Festival**



Fingal Libraries will celebrate the Bealtaine Festival 2024, Ireland's national festival of the arts and creativity for older adults, with over 31 events and workshops taking place across the library network during the month of May. This year's programme begins on May Day, 1st May, with a guided walk of Turvey Nature Reserve, Donabate, with Birdwatch Fingal.

Musical events include concerts by Bohemian Strings and Rush Musical Society Singers, in addition to an African Percussion workshop. There is a broad range of creative workshops and classes on offer including art, smartphone photography, crafts, sustainable flower arranging, gardening, poetry, and creative writing. People can also sign up for Tai Chi sessions and classes on how to play bridge. The Bealtaine programme features talks by author Éilís Ní Dhuibhne and the Balbriggan Heritage Group, as well as talks about genealogy and assistive technology. Fingal Library staff will facilitate e-services clinics to help people get the best out of library e-services.

#### **Commemorations Funding**

Minister Catherine Martin T.D. has approved a grant funding allocation of €15,000 (€5,000 of which is for an Arts initiative) for every local authority in 2024. This funding will support community-led commemorative initiatives to mark the centenaries of locally significant historical events in 1924 and in the early years of the State, as well as other significant anniversaries and associated themes. The Fingal project will concentrate on local government in North Dublin/Fingal in the early years of the State and will result in an arts commission, a publication, exhibition, and talks.

#### Cruinniú na nÓg

Cruinniú na nÓg is the national day of creativity for children and young people and will take place on 15th of June. This year, highlights will include the library programme with over 20 events for children across library branches including storytelling, makerspace activities, movie making workshops and more. Orchestral Odyssey will see a full orchestra visiting schools in Swords and a performance piece in the Carnegie Library. Garage Galaxy will bring a youth festival to Millennium Park, where young people can showcase their musical talents on two stages.

#### **Autism-Friendly Libraries**

Fingal Libraries are in the process of making libraries more autism-friendly, with the guidance of autism charity AslAm. This process will involve further training sessions for library staff and AslAm accreditation for libraries.

#### **Book Bike Project**

The Fingal Libraries Book Bike project has a €15,000 grant from the Chief Executive Innovation Fund. With the funding Clíodhna from Libraries and Emma from Active Travel will purchase an electric cargo bike and begin the process of outfitting it for its new role as a Fingal Libraries Book Bike. The Book Bike will be an excellent promotional tool, particularly at festivals like the Fingal Festival of Children's Literature later in the year.

## Landscape oil painting on display at Balbriggan Library



Balbriggan Library are thrilled to display a beautiful landscape oil painting by Sean Molloy called 'The Banks' in the Turret Room – one of meeting rooms in the Carnegie part of the Library. Sean is a Fingal artist and was commissioned to paint this prominent coastal site in Balbriggan, known locally as the Banks. The painting is part of the Fingal County Council Municipal Art Collection and was produced as part of a public art commission initiated in collaboration between Irish Rail, Our Balbriggan and Fingal County Council's Arts office.

#### **ECONOMIC DEVELOPMENT**

#### **Fingal Skills Strategy**

Preliminary planning is underway for the 2024 "Xplore Your Future TY Expo" which will be held in The Helix, DCU on the 15<sup>th</sup> of October 2024 with procurement underway for the provision of event management support services for the event.

Invitations to the Expo have issued to TY School Co-Ordinators in the Fingal area.



A contract for the engagement of consultants to prepare the next iteration of the Fingal Skills Strategy 2024 – 2029 has been awarded and work on the new Strategy has commenced with the completion of the Project Inception Document.



A Delegation from Fingal County Council recently travelled to Florence, Italy (Lead Partner) of the SKYLA Project to share examples of Good Practices and learn from partner Good Practices in the green and digital twin skills transition.

Fingal County Council shared two Good Practices with our project partners which were identified in collaboration with key stakeholders DRSF and Baldoyle Training Centre.

The Fingal SKYLA Project team intend to further examine the shared Good Practices by our partner Skane Industrial Development Centre in Sweden who shared their "Mind the Gap" tool which assists in identifying specific needs in the business region and in doing so offers collective results that could be made available to the education system and VET providers. Mind the Gap assists in matching between supply and demand when it comes to skills development and VET in the region.

**Economic Development Strategy** 



The Future Fingal Economic Development Strategy builds on the socio-economic profile prepared as part of the Fingal LECP process and sets out a vision, key opportunities and actions to support the local economy to 2040.

Preparations are underway for the official launch of the Economic Development Strategy scheduled for the 17<sup>th</sup> of May in the Carlton Hotel, Blanchardstown, Dublin 15.

To align with the Economic Development Strategy work is also ongoing on the development of a Marketing Plan for the County in consultation with key stakeholders.

#### **URBACT - EcoCore**



Fingal County Council is leading the URBACT EcoCore Project which comprises a network of 9 small cities/towns in Europe focussing on challenges and opportunities for green growth and sustainable economic development along transport corridors. Balbriggan is the lead town and the other partners committed to the network are Albu Iulia, Romania; Dubrovnik, Croatia; Kekava, Latvia; Ormoz, Slovenia; Parnu, Estonia; Santo Tirso, Portugal; Tuusula, Finland; Villena, Spain.

Fingal County Council has recently been selected by EMRA to host the URBACT National Campus comprising a two day networking event which will be held in Balbriggan later this year.

The EcoCore Project Team accompanied by Deputy Mayor, Cllr Gráinne Maguire and Chief Executive of Fingal Chamber of Commerce (members of the Project ULG) travelled to Santo Tirso, Portugal for our third transnational city visit.

Santo Tirso is a region famed for its industrial magnetism, not a result of luck, but of the strategic proactive and evidence based approach taken by the Municipality to attract investment.

There were many good practice examples demonstrated during the visit to Santo Tirso and invaluable learnings for the Balbriggan delegation.









## Citizen, Equality, Rights and Values Programme (Cerv)

CERV is an EU Funding Programme for citizens' engagement and the implementation of EU rights and values. Fingal County Council has been awarded CERV funding to participate in 2 separate projects, which commenced in January 2023 and will continue for 18 months.





#### **Green It Your Work**

Work is continuing on the objectives of 'Green IT Your Work' project which are:

- Youth Debates about European Digital Age project highlighting the role of young people in the green transition
- Promote green jobs with the aim of contributing to greener European cities



Following a very successful meeting in Balbriggan in March 2024, the next Green IT Your Work meeting will take place in Kocevje, Slovenia in May 2024 with a focus on *Green Portals for You(th)*.

Representatives will be present from Romania, Spain, Greece, Cyprus, Slovenia, Croatia, Italy and Ireland.



## GREEN IT InclusEU YOUR WORK

The InclusEU project aims to encourage volunteer action as a social response for an inclusive Europe. Work continues on the project with partners from Italy, Poland, Hungary, Spain, Portugal, the Netherlands and Romania. Representatives from Fingal's Sports Office and Foroige attended Viana do Castelo, Portugal, in April with the Italian event taking place in June 2024.



#### **Sustainable Fingal**



The Council met with representatives from DCU and DAA in March to discuss a work programme for 2024 to progress sustainable projects and work in ongoing to identify projects and potential funding streams.

A further meeting was held with the DAA in April to explore opportunities between both organisations for synergies on biodiversity and circular economy projects. The Council's Biodiversity Officer was also in attendance.



Work continues on the development of an action plan to advance the objectives of Circular Cities in Fingal. Fingal's profile has been published on the Circular Cities website and the first annual report on Fingal's transition to the circular economy under the Circular Cities Declaration was submitted in October 2023.

The Circular Cities Declaration 2024 Report has now been published featuring Fingal County Council as one of the signatories to the Declaration.

#### **Dublin Belfast Economic Corridor**



Fingal County Council's Feasibility Study for the development of regional innovation/enterprise hubs along the Dublin Belfast Economic Corridor has been completed. The Council continue to liaise with DBEC to consider potential funding streams to progress the implementation of the Study's recommendations and has submitted a concept proposal to the Enterprise Ireland Smart Regions Fund for a priming grant for a pilot implementation of the recommendations. Fingal County Council continues to liaise with DBEC on a series of potential projects for DBEC.

#### **Enterprise Ireland - Smart Regions Funding**

The Council has submitted 5 no. concept proposals to the Enterprise Ireland Smart Regions Fund. Concept proposals include applications under Stream 1 for Capital Infrastructure Investments in the Council's Enterprise Centres and Under Stream 4 for Feasibility Studies/Priming Grants.

## Fingal Local Community Development Committee


The Fingal LCDC continues to oversee and administer the key areas of LEADER and SICAP and the various Local Development and Community Development funding programmes under its remit. The LCDC also manages the Healthy Ireland Initiative and the Social Enterprise Grants Scheme. The LCDC met on the 7<sup>th</sup> of February 2024 and reviewed progress on various programmes under its remit, approved the SICAP end of year 2023 review and discussed the annual plan for 2024 which has been forwarded to Pobal for review.





## Fingal Local Economic Community Plan 2023 - 2028

The LECP was adopted by the Council in January 2024 and includes a two-year LECP Implementation Plan with actions to implement the Goals and Objectives set out in the LECP.



#### **Local Enhancement Programme 2024**

The Local Enhancement Programme 2024 which is funded by the Department of Rural and Community Development allocated a total of €220,842.98 in funding to community groups/organisations within the Fingal administrative area.

The LCDC Evaluation Committee met and a report of successful applicants has been issued to the Department for approval.

The Minister of State at the Department of Rural and Community Development is due to announce the successful applicants in the coming weeks.



#### We Can Quit

Healthy Fingal have teamed up with Empower to deliver two pilot We Can Quit programmes with the Blanchardstown Training Centre and the Tolka River Project, Mulhuddart. The We Can Quit programme, was developed by the HSE and is aimed at encouraging people to quit tobacco/vaping. The programme with the Tolka River project started in January 2024 and will run for 10 weeks with participants enrolled to take part in both quit smoking sessions and weekly yoga sessions to encourage a healthier lifestyle.



#### **Woodlands for Health**

Healthy Fingal have partnered with Mental Health Ireland, HSE, Empower and the Sports Office to organise the Woodlands for Health walk. The programme brings service users from the HSE mental health services and other key target groups in Swords & Balbriggan to Newbridge Demesne to interact with other service users and avail of health expertise in the calming and quiet atmosphere of the walking paths around the park. The programme is due to start in May and run for 10 weeks.

Community Recognition Fund 2023/2024
The Community Recognition Fund (CRF) 2023, funded by the Department of Rural and Community Development, approved the Council's project proposals in March 2023. Fingal County Council has received an allocation of €1,748,912 for 26 projects across Fingal.

All projects are required to be complete by 18<sup>th</sup> October 2024 and work is progressing on the implementation of the project with the Council submitting an initial drawdown in 2023 of €243,000 with a further drawdown 0f €176,000 submitted in respect of works completed to date in 2024.

In March the Council received an allocation of €1,538,573 in respect of the **Community Recognition Fund (CRF) 2024.** The funding will support capital projects which will be delivered over the time period 2025/2026. The fund aims to recognise the contribution made by communities welcoming and hosting arrivals from Ukraine and other countries.

A public funding call (call 1 of 3 calls) issued in early April 2024 followed by an online information webinar. Call 1 has now closed and all applications received will progress to the Evaluation Committee for consideration.

#### **SICAP**



The new SICAP contract for the provision of the SICAP programme over the period 2024-2028 has been awarded to Empower CLG and contracts have been signed.

The annual SICAP budget for 2024 is €1,520,811 and there is a separate funding provision for new arrivals to the value of €375,372. The SICAP Annual Plan for 2024 has been approved by the LCDC and reviewed by Pobal.





#### **Leader Programme**

Following the outcome of the Local Development Strategy (LDS) selection process Fingal LCDC and Fingal LEADER Partnership were selected to run the LEADER Programme 2023 – 2027 in the Dublin rural area. The Dublin Rural LEADER (LAG) includes rural areas in the administrative areas of Fingal, Dun Laoghaire Rathdown and South Dublin.

The new LEADER programme launched at the end of February, following the signing of the LEADER Funding Agreement by the Minister for Rural & Community Development, Heather Humphreys, TD. The new Dublin Rural LAG met for the first time on the 27<sup>th</sup> February 2024 and were briefed on the new LEADER Programme by Fingal LEADER Partnership.

The Dublin Rural Leader team have scheduled an online information session on the LEADER application process and an overview of the procurement process.



#### **ENTERPRISE CENTRES**

Fingal's Enterprise Centres continue to participate in ConnectedHubs.ie a one-stop-shop for remote working hubs throughout Ireland.

To inform the Council's future policies on such facilities, the Council is currently undertaking a survey of residents and organisations in the County with regard to the demand of co-working hubs. It is a short 5 minute survey as per the link below:

All three Enterprise Centres have space available to start-up businesses and businesses/individuals who wish to avail of remote working options and facilities. Bespoke options or generic office fitouts can be considered. Occupancy rates at the Council's three enterprise centres are all over 90%. The three Enterprise Centres currently support 65 businesses and over 320 direct jobs.

Fingal County Council was approved for €50,000 in new funding to promote Remote Working Hubs in the County under the Town and Village Renewal Scheme Marketing Measure. A cross-departmental team within the Council have implemented initiatives to promote Fingal as a Remote Working Hub base for remote workers with an active marketing campaign carried out during Q1. across various media platforms and includes an article in the Business Post, radio advertisement and significant coverage across a range of social media platforms.

#### **TOWN REGENERATION OFFICE**

Our Balbriggan 2019 - 2025 Rejuvenation Plan - A Socio-Economic Strategy



Dr. David Begg was appointed Chair of the Balbriggan Leadership Group following the departure of Brian MacCraith earlier this year. The Balbriggan Leadership Group provides oversight and stewardship for the town plan's implementation. A 'Review and Renew' process, conducted by the Leadership Group, of the town plan, its governance and delivery structures is due to be completed shortly.

The review process confirmed the extension of the Rejuvenation programme until 2030, bringing it in line with its main funder the Department of Housing, Local Government and Heritage, URDF unit. Further, the review process has confirmed new governance arrangements for existing, merged and new Pillar Groups.

The Our Balbriggan Programme Office will support the Leadership Group and its five new pillars - Economic Development, Public Realm & Placemaking, Education, Skills & Employment, Community and Sustainability, Climate Change & Biodiversity, as part of the 'Renew' process to develop high level objectives and actions to be adopted in Q4 and implemented 2024 - 2030.

Contracts were signed between Fingal County Council Ltd and John Craddock Ltd on 29/04/2024 for the €15 Million transformation of Quay Street, Harbour & Environs. The contractor will be on site in early May 2024 and the project is due to be substantially completed by December 2025.

A Communications plan including an update to every Balbriggan household and business has commenced and includes detailed information on alternative car parking and frequently asked questions, all materials are available on Balbriggan.ie



A call for tenderers for 2 – 4 Dublin Street is scheduled for June 2024. 2-4 Dublin Street is to be transformed into a new Creative Hub with 8 workspaces at 2 Dublin Street and an ancillary connected space at 4 Dublin Street which will support STEAM education, training and enterprise activities supported by SMART Balbriggan and the Fingal Arts Office. Planning permission was granted at council in October 2023.



Demolition works on 14 Bridge Street (house known locally as Keelings) have been completed and a temporary Pocket Park has been installed. Demolition contractors continue excavation works to the rear of 6a – 14 Bridge Street.

An Integrated Design Team has been appointed and a project initiation meeting is scheduled to take place in May 2024. The IDT will look at preparing a design based on best possible uses and options in line with site constraints. Early and on-going stakeholder engagement will commence shortly to inform options and will continue throughout the design process.



Donnelly Civil Engineering Ltd and MWP Engineering have delivered a package of improvement works at Balbriggan Harbour. The main Harbour upgrade works and shoreside services are complete, with some lighting improvements awaiting final completion further to new electricity connections. ESB have been on sight in early May.

The programme office is progressing the phase 2 element of the Balbriggan Tidal Pool and Swimming Platform Feasibility Study. Phase 2 will include an economic demand analysis. To be concluded in end Q3 2024.

An Internal Project Team has been established from the Town Regeneration Office, Our Balbriggan and FCC Architects to progress the Boathouse and Bathhouse project. FCC has met with local stakeholders and potential end users for the Bathhouse and Boathouse. Enabling works commenced in February. Works include full surveys and assessment of the site, which will inform the full works design and planning proposal.

#### **Town Centre First - Lusk**

The structure, membership and Terms of Reference for the Lusk Town Team were agreed in the third quarter 2023. Together with the Town Team there are three Pillar Groups representing the Community, Business and Economy and Public Realm / Climate Action & Sustainability (to include Vacant & Derelict Buildings). Consultants were appointed to support the preparation of a new Town Plan and to work with the Community, Businesses and Public Realm Pillars in Lusk to get their views for inclusion in the new town plan. The Town Centre First Plan for Lusk was signed off on by the Town Team on the 25<sup>th</sup> April. The plan will be noted at the next Local Area Committee Meeting before being published.

Two applications for Project Development Measure funding have been submitted to the Department of Rural and Community Development for their consideration. These applications, if approved, will support the development of projects listed within the Plan.

#### **Town Centre First - Rush**

At the National Town Centre First Day held 28<sup>th</sup> February in Limerick, the Minister for Rural and Community Development, Heather Humphries T.D. announced that Rush had been selected as Fingal's second Town Centre First Town. The Town Regeneration Office welcomes the selection of Rush as a Town Centre First Town and engagement with the Local Elected Members, the Community and the Business Sector in Rush will be invited shortly to establishing a new Rush Town Team. This new Town Team will prepare a new Town Centre First Plan for Rush. During March, there was a walk-about in Rush by the Town Regeneration Office team, local elected members, Rush Tourism and Rush Community Council.



#### **Town & Village Renewal Schemes**

The Town Regeneration Office was notified in April that two applications under this scheme from 2023 have been successful. A Phase 4 development of Floraville Park in Skerries (€55,800) and upgrades to the Rush Community Centre (€64,350) have been approved by the Department of Rural and Community Development.

In 2023, the Town Regeneration Office completed the implementation of projects in Rush, Donabate, Oldtown, Naul, St. Margaret's and Balrothery. With respect to these 6 schemes, the local authority has invested €282,276.00 in total funding drawn down from the Department of Rural and Community Development to support the revitalisation of our Rural towns.

#### **Streetscape Enhancement Scheme 2024**

Streetscape Enhancement Scheme 2024 was launched on the 15<sup>th</sup> March, 2024 and expressions of interest were sought from qualifying commercial and community premises located within areas designated as "Major Town Centre", "Town and District Centre", "Local Centre" or "Rural Village" within the Fingal County Development Plan 2023-2029. Under the scheme, up to 50% of the cost of improvements, up to a maximum grant amount of €1,500 per eligible property, is available, subject to terms and conditions. A total of 40 applications were received by the closing date and are currently under review. Organisations who expressed their interest will be notified of the status of their applications in the coming weeks.

#### **Outdoor Recreation Infrastructure Scheme**

An application under the Outdoor Recreation Infrastructure Scheme for a feasibility study for facilities for sea swimmers in Skerries was successful in November. In March 2024, the Town Regeneration Office has commenced the study process by engaging with local stakeholders, gathering and collating feedback to inform future options and study scope. A request for tender document has been prepared and the formal procurement process is now underway.

#### **Urban Regeneration Development Fund Call 3**


In 2023, the Town Regeneration Office was successful in securing €7 million for a new revolving fund that will acquire vacant or derelict properties to renovate, bring back into use and sell back into the market for housing purposes. An initial 19 properties under this fund have been approved for inclusion by the URDF Call 3 Fund administered by the Department of Housing Heritage and Local Government.


A further 5 properties were approved by the Department of Housing, Heritage and Local Government in February. These are being assessed and progressed where appropriate. A further 20 properties are under consideration to be added to the list of properties going forward. In April 2024 the Council was notified that an additional €3 Million had been allocated to fund this Call.

#### **Derelict Sites**


83 statutory notices have issued to owners of Derelict properties to the end of April 2024. This shows a significant increase in notices issued by the Council compared to a total of 7 at this point in time in 2023.

The Derelict Sites team continue to focus on engagement with the owners of these existing derelict sites and identifying further derelict sites across the county.

#### **Fingal Business Network**

The theme of the meeting is "Using Al for Business" and will explore the transformative potential of Chat GPT, Microsoft CoPilot and Gemini by Google in enhancing business operations, improving customer engagement, and driving innovation. Participants will discover practical Al applications that can streamline processes and boost competitive edge. The session will also include some valuable facilitated networking sessions, providing opportunities to connect with likeminded professionals and industry leaders.

#### **National Enterprise Awards 2024**



The National Enterprise Awards is taking place in the Mansion House, Dublin City Centre on Thursday 23rd May 2024. PRM Assist will represent LEO Fingal as the winner of the Fingal Enterprise Awards. PRM Assist based in Dublin Airport is a global leader in innovative Passenger with Reduced Mobility (PRM) services within airport environments. We wish Conor Halpin and the team in PRM Assist all the very best in the National competition.

#### **Student Enterprise Programme**



Twenty-six second level schools across Fingal competed in the 2023/2024 Student Enterprise Programme. Over 1300 Fingal students developed their own real-life businesses, researching, resourcing and trading services and products, with the guidance of business mentors. Loreto Secondary School, Balbriggan and Mount Sackville will represent Fingal at this year's Student Enterprise Programme National Final which takes place in Mullingar on May 9th.

#### **Fingal Enterprising Women Network**

The LEO Fingal Enterprising Women Network is hosting a "Mind, Body and Business" themed lunchtime networking event on June 20th at the Portmarnock Resort Hotel. Three experts will feature in a panel discussion focused on optimising female business performance.

The next business supports briefing is scheduled for Tuesday 7th May at the Riasc Centre, Kinsealy.

#### **Food Supports**



LEO Fingal is hosting the latest Dublin region Food Starter programme, which commenced on 8<sup>th</sup> April 2024, working with small food producers who are starting out on their food business journey. The Food Starter programme is the industry specific Start Your Own Business training for the food sector.

As part of the programme, businesses are given a thorough grounding in what is required to set up their business, including the health and safety implications and how to capitalise on market opportunities. Participants also benefit from the network of other food businesses on the course and leave with a new set of mentors and business advisors to help them on their journey.

#### **Evaluations and Approvals Committee**

The Evaluation and Approvals Committee (EVAC) has approved €300,074 across 12 Business Feasibility, Priming and Expansion Grants to date in 2024. Eight Technical Assistance for Micro Exporters grants to the value of €20,000 and two Digital for Business grants amounting to €9,000 have been approved year to date. The next EVAC meeting will be held on 29<sup>th</sup> May 2024.

# LEADERSHIP FOR BUSINESS ACCELERATION



The Leadership for Business Acceleration Programme provides an exceptional opportunity for SME Owners and Managers to build on the necessary leadership skills and knowledge needed to successfully compete in existing, new and international markets. This highly successful "International Best Practice" training programme which commenced on March 26th is delivered to small groups by way of onsite skills development workshops and online workshops. As part of the programme, the owner/manager participants each produce Work Based Assessments which document their strategic plan and acts as a living document as well as a point in time reference for where their business is now and the actions they need to take to grow.

#### **Energy Efficiency Grant Scheme**



Applications are open for the Energy Efficiency Grant Scheme, which enables small businesses to invest in technologies and equipment to make their businesses more energy efficient. The grant will cover up to 50% of the costs to a maximum amount of €5,000. The goal is to reduce the impact of small businesses on the environment and help them to reduce costs to enable them to become more competitive. As part of the process, applicants complete the Green for Business Programme, a customised initiative whereby the business develops a strategy to become sustainable.

#### **Trading Online Voucher Scheme**



An initiative under the Government's National Digital Strategy, the Trading Online Voucher (TOV) scheme supports small businesses by allowing them to enhance their online offering by providing a grant of up to €2,500 for ecommerce and digital marketing activities, as well as giving businesses a better understanding of how they can exploit E-Commerce opportunities for their business. A total of 37 applications have been approved in the amount of €84,609 to date in 2024. The next Trading Online Voucher seminar will be held on Friday 17<sup>th</sup> May in Riasc, Kinsealy.

#### **Business Advice Clinics and Mentoring**



LEO Fingal provides one to one business support services through Business Advice Clinics and a Mentoring programme, both online and in person. These services are provided free of charge to small businesses. The Fingal mentor panel consists of a variety of skilled and experienced mentors from a range of business backgrounds. So far this year, 268 clients have availed of one-to-one advice in our Business Advice Clinics. The Mentoring Programme has already seen 144 clients receiving expert mentoring so far this year.

#### **Microfinance Ireland Loans**

LEO Fingal provides a loan scheme through its partnership with Microfinance Ireland, with loans of up to €25,000 per approved applicant. LEO Fingal is actively promoting the availability of loans from businesses that have difficulty raising finance from their bank. Applications are processed and assessed by LEO Fingal and submitted to MFI (Microfinance Ireland). Applications submitted through LEO Fingal are eligible for a reduced interest rate. LEO Fingal has processed and submitted 7 MFI loan applications to date in 2024.

#### **Training and Events**

2024 training is continuing apace with over 1,530 participants in events year to date. The fourth Start Your Own Business course started on April 22nd bringing to 48 the number of participants at the multi-day event YTD. There have been two Social Media and Digital Marketing QQI courses with 24 participants year to date and a third course will start in mid-May.

#### **Internationalisation and Export Development**



Five Fingal businesses are currently participating in the 2024 Export Development Programme. The purpose of this programme is to provide clients with the skills and the confidence to identify, target and exploit new business opportunities in the Benelux Region. The most recent workshop "Selling Skills" was held in the Carlton Hotel on 17th April with very positive feedback from participants. In addition, the TAME (Exporter) grant enables small businesses to explore and develop new market opportunities by providing up to €2,500 to businesses investigating and researching export markets. Eight Fingal businesses have been approved for Export Grants (TAME) for Quarter 1 2024.

#### **Fingal Business Expo**



#### **Public Conveniences Balbriggan/Swords Area**

The Part VIII planning process for replacement toilet facilities at Rush South Beach was approved by the full Council at its April meeting. Civil works on site will commence in early May, followed by the installation of the unit which is constructed off site. It is anticipated that the new facilities will be fully operational by the start of the Bathing Season in early June.

Reports in relation to screening for Appropriate Assessment and Environmental Impact Assessment in respect of proposed facilities at Portrane and Donabate beaches have been received and will be reviewed by the Planning Department as part of the internal planning consultation. Once concluded, we will move to commence the Part VIII process for each of the two sites.

Site surveys have commenced at the sites of existing public conveniences at Rush, an Skerries Harbour and Loughshinny in order to progress plans for these locations.

## **Howth Malahide Area Programme of Works**

Grey's Lane in Howth was inlaid as part of the 2024 POW. The roads crew installed additional road drainage and gullies in advance of the inlay. The defective road kerbs were also replaced in advance of the works.


# Road Opening Licenses

The Licensing unit continues to process and manage the licensing system for the County. Applications are allocated by area for examination and conditioning which includes reviews of the existing carriageway, footpaths, cycleways, and grass verges. Applicants submit temporary traffic management plans for review to ensure all works are carried out safely within the public domain. Road Opening Licences are a cross functional process for the department and are essential for the asset management of Fingal County Council Road network.

**198 Licences** were granted in the month of **April**, **39%** of which were granted by way of **automation**. Clerk of Works in each area continue to carry out regular inspections following road opening works by Utilities.







# - Casual Trading License

Fingal County Council have a total of 31 valid Casual Trading Applications for 2024/2025 trading year throughout Fingal administrative Area covering the trading of Hot Food Tea & Coffee/Ice Cream and Flowers.

5 more additional applications are currently being processed.

Any remaining applications will be taken on an Ad Hoc basis.

The Operations Department is in regular communication with our traders and area inspectors to assist in delivery of quality service and ensure compliance.

#### **Street Furniture Licences**





A total of 32 Street Furniture Licences have been issued in 2024 with a further two currently been processed.

Any new street furniture applications will be dealt with on an ad hoc basis.

# **Stormwater Capital Programme 2023-2025**

Fingal County Council are continuing to progress projects recently adopted in the 2024-2026 Stormwater Capital Programme. The 3-year programme includes 17 projects estimated at €2.5 million with this figure under review as the projects are developed. Below is a brief update in relation to the status of some of the projects that have commenced and planned upcoming projects.

#### > Howth Stormwater Culvert

Preliminary design reports are being updated with received survey information and updates of associated drawings. An Investigation and Optioneering report for Work Package B has been approved by FCC. A GPR survey will be procured to finalise design and progress contract documents. Investigation and optioneering, followed by design and tender documentation for Work Package A (the main works) will follow. An updated programme is due.

#### Burrow Beach

The proposed remediation of the surface water outfall pipe has gone through all stages of design and various consents. Due to receipt of nonconforming tenders a non-competitive procurement procedure is being followed for the supply of anchor blocks.

However, the works window for Spring 2024 was missed and construction has been rescheduled for Spring 2025. Works will be executed by FCC Direct Labour with technical assistance to be provided by design consultants.



#### - Lusk Network Remedial Works

The above project consists of Stormwater infrastructure provision and improvement in the Lusk urban area. It will include second level/follow up investigation, surveys, non-invasive interventions jetting, root removal, pipe lining, replacement and new lay – using conventional cut and cover plus reinstatement of surface.

To date Direct Labour crews have completed the first tranche of repairs on localised damaged pipelines. Sections of the network along **Station Rd & Dublin Rd** have recently been surveyed and dye-tested. The findings from these surveys are currently being analysed. Most of the repair/replacement will be undertaken By Direct Labour with some input by contractors. The overall project is likely to take 24 months to complete.











# Clonsilla/Mulhuddart Network Improvements

Following historical reports of flooding CCTV surveys were carried out to determine the condition of the Stormwater infrastructure in the **Rusheeney and Manorfield estates in D15**. So far, several large restrictions have been found and a manhole was completely blocked with household waste. Following attempts to remove a blockage robotically, the line must now be excavated to remove this blockage. Quotations are currently being sought from Contractors. Additional collapsed sections have also been identified in other locations along the same network.






## **Carpenterstown Road SW Pipe Refurbishment**

Following survey work and analysis in 2023, various remedial works were identified for sections of network along Carpenterstown Road. These include part liner repairs on damaged sections Following tender issue in March, submissions have been evaluated and the appointment of a Contractor is in the final stages. Works will be planned to commence during May.

#### Storm Water Maintenance

Maintenance of the network and much of the capital works programme is generated by inspections which are tabulated on a Works Planner. The types and volumes of issues reported are shown in the chart.



#### Storm Water Connections:

9 new connection applications including one diversion application have been processed to date in 2024.

#### Lusk - Barrack Lane

To address historical road flooding along Treen Hill & Minister's Road. CCTV surveys were carried out and restrictions were identified along **Barrack Lane**. In total 60m of damaged and collapsed pipeline has been replaced and the roadway has been permanently reinstated. An 8m part liner repair was installed during April and this completes all outstanding works in this area.

#### **Donabate**

Maintenance work was undertaken on the **Beaverstown stream** to remove restrictions and clear and overgrown ditch to create storage and to remove flow restrictions, thereby alleviating risk of road flooding. Further examination of the catchment will follow to improve surface water management.



#### Malahide/Portmarnock

Chalfont – CCTV surveys are currently being carried out to ascertain the condition of the network within the estate and the cause of localised road flooding during periods of intense rainfall.

Coill Dubh - Following reports of footpath flooding along the R124, a Contractor has been engaged to carry out surveys of the local network.

#### Assets

#### **Ironworks**

The Stormwater manhole cover and frame replacement programme for replacing assets at the end of life is ongoing. 15 Nr manhole cover and frames (C&F) are being replaced along the Swords Rd in Malahide. A Contractor has been procured with works commencing in March. Offline replacements were carried out in Columbus Rise and Elmwood Road in Swords. The Stormwater unit also supplied 12 Nr manhole C&F to replace existing older poor condition assets for the recent road resurfacing on Strand Street in Skerries.

# Water Quality

#### **Seagrange Park**

Assistance and engagement are being given by the Storm Water Unit to *Baldoyle Tidy Towns* who had secured funding for a Biodiversity project on the Seagrange Park stream, Baldoyle.

Drainage Inspectors are still assisting with this matter. Further sampling was carried out to narrow down the area of focus or to eliminate potential sources of contamination.

There have been 411 planning applications received from 1<sup>st</sup> January 2024 to 31<sup>st</sup> March 2024. This is including 18 E applications via the LGMA portal. 120 applications were invalid leaving a total of 316 valid applications. The volume of applications received by Local Electoral Area (LEA) is detailed in the table below.

From 1<sup>st</sup> January 2024 to 31<sup>st</sup> of March 2024 there have been no Large-scale Residential Development (LRD) full applications made to the Local Authority. From 1<sup>st</sup> January 2024 to 31<sup>st</sup> of March 2024, 5 decisions have been made on Large Scale Residential Developments. Of these 5 decisions made, 3 have been to grant Permission (1,020 Units). 2 decisions have been made to refuse permission.

An Bord Pleanála have issued one decision on SHD applications in the period from 1<sup>st</sup> January 2024 to 31<sup>st</sup> of March 2024, this decision was to refuse permission. There are now four SHD's (3,932 units) remaining with An Bord Pleanála for decision.

# **Planning Decisions**

A total of 308 planning decisions have been issued from 1<sup>st</sup> January 2024 to 31<sup>st</sup> Of March 2024. There have been 240 decisions to grant permission (78%) and 68 refusals of permission (22%). Included in the 240 grants there have been 20 grants of permissions in respect of single house construction, 136 grants of permission for domestic extensions/works, 27 commercial grants of permission, 6 retail grants of permission and 9 grants of permission in respect of housing developments of which 7 relate to developments. The breakdown of housing developments is outlined in the table below.


# **Building Control Admin**

In March 2024, there were 174 building control submission made via BCMS.

This was made up of 99 Commencement notices, 28 Compliance of Completion Certificates, 27 Fire Safety related Certificates and 20 Disability Access related Certificates.

Commencement notices and Compliance on Completion Certificates are submitted through the Projects module on BCMS. Fire Safety, Disability Access, Regularisation and Dispensation/Relaxation Certificate applications can be submitted online via the Applications module on BCMS and we are also still accepting hard copy applications directly into the office. Most applications are now being submitted via the online system.

The Building Control Admin team processed 199 decisions in March 2024 relating to Fire Safety and Disability Access Certificates. This was made up of 37 decisions to grant, 1 refusal (FSC) and 161 extensions of time.



# **Strategic Policy Unit**

Local Area Plans, Masterplans and Framework Plans

In July, the first round of Plans falling out of the development plan was agreed. This comprises Swords and Flemington LAP's, the Dunsink Plan, Kilbarrack and the Old School House Masterplans and the Stephenstown, Folkstown and Clonsilla Framework Plans.

Work has begun on the Flemington Local Area Plan and the Clonsilla Framework Plan.

# Flemington Local Area Plan

The proposed LAP boundary has been designated in the Fingal County Development Plan 2023-2029. Local Area Plans play an important role in setting the framework for the achievement of integrated and balanced communities within a specified area. They seek to provide the optimal development framework to ensure the protection and enhancement of the existing areas, key features and the environment within an area, while providing for a high quality living environment through the use of robust urban design principles. Fingal County Council has commenced the consultation process which is a key feature of the Local Area Plan process. The pre-draft consultation period ran from 1st February to 1st March. A targeted workshop for local members, landowners and community groups took place on Friday 2<sup>nd</sup> February and a very well attended information drop in session for member of the public was held on 19<sup>th</sup> February, 4pm – 7pm in Bracken Court Hotel, Balbriggan.

Work has now begun on the drafting of the Local Area Plan and it is hoped to publish this in summer 2024.

#### Clonsilla Framework Plan


The Fingal Development Plan 2023-2029 provides for an objective to prepare a Framework Plan for lands at Clonsilla (Plan Ref. FP 13.C).

The proposed FP boundary has been designated in the Fingal County Development Plan 2023-2029 and includes an area of land south of Clonsilla Road/Larch Grove, bounded by Diswellstown Road to the east, Callaghan Bridge to the west and extends just south of the railway tracks.

The Kellystown Local Area Plan, located to the south of the Clonsilla Framework Plan area, was adopted in January 2021 and provides for the future development of that particular area. A specific and separate Masterplan will also be prepared for the Old School House area in the near future.

Public consultation is a key element in the preparation of the Clonsilla Framework Plan and the pre-draft consultation period ran from Tuesday 6<sup>th</sup> February to Tuesday 5<sup>th</sup> March. A targeted workshop for local members and community groups took place on Tuesday 6<sup>th</sup> February and a separate information drop in session for member of the public was held on 19<sup>th</sup> February, 4pm – 7pm.

Work has now begun on the drafting of the Framework Plan and it will be published in summer 2024.



#### Residential Zoned Land Tax

The Residential Zoned Land Tax (RZLT) is a tax aimed at activating serviced and residentially zoned land for housing. Local authorities are responsible for identifying the land that is subject to RZLT.


On 1st February 2024, Fingal County Council published the annual draft maps for 2025 identifying land currently in scope for the tax, land proposed to be removed from the current scope and land proposed to be added for the first time. 37 submissions were received by the closing date for submissions (1st April 2024). All submissions received in relation to the annual draft map have been published on the Fingal Consultation Portal. Where a landowner requests the exclusion of their site from the annual draft map on the basis that it does not meet the criteria for being in scope, or challenges the date from which land on the map met this criteria, the Local Authority must notify the owner of its decision not later than 1st July 2024.

An appeal of the Local Authority decision on a landowner's submission on the annual draft map, must be lodged by the landowner with An Bord Pleanála by 1st August 2024.

It is noted that the second phase of the Residential Zoned Land Tax (RZLT) Annual Draft Map 2024 consultation remains open for landowners only seeking a land use zoning change. Submissions in this regard can be made up to 31st May 2024 (inclusive).

#### Queen's University Belfast

The Planning & Strategic Infrastructure Department recently welcomed planning students from Queen's University Belfast. Six groups of MSc Planning & Development students visited Fingal and to carry out a study and analysis of Swords, Rush and Portrane. The results of their studies was published and presented to the P&SI Department in April.

#### **Built Environment Division**

Building Control/Taking in Charge Section – 30/04/24



- There were 17 building Control Inspections in April 2024 so far (up to 24<sup>th</sup> April) with 32 buildings inspected.
- There were 2 section 11 requests for further information following building control inspections, issued in April and there have been no enforcement notices issued.
- There were 4 developments taken in charge in the council meeting of 8th April 2024 (Riverwood gardens Carpenterstown, Emsworth Kinsealy Lane in Malahide, Golden Ridge phase 2 in Rush and Coopers Wood in Kinsealy.
- We have 7 developments scheduled for Taking in Charge in May 2024 – Barnageeragh Cove Phase 3 in Skerries, The Park in Skerries, Hyde Court in Rush, Lusk Village in Lusk, Thornleigh in Swords, Blackwood Estate in Ongar and Fairhaven in Castleknock.
- The Ongar remediation works are at substantial completion and we are working on the taking in charge drawings to take the estates in charge. We have the blackwood estate already up for taking in charge in May.
- The Mount Eustace and Cruisepark Taking in Charge works are complete, and we are working on the Taking in Charge drawings.
   We plan to advertise Cruise Park for the September meeting and Mount Eustace shortly after
- We are working on procurement documentation for consulting engineers to manage some of the large taking in charge works where we have bond money available.

# **Dangerous Structures**

There were 5 dangerous structures notified in March 2023. There are a total of 101 dangerous structures active in our database.

# **Transportation Planning**

# PSI 001 Snugborough Interchange upgrade

The Snugborough Interchange is currently programmed to be completed at road level at the end of May 2024. The last element of the scheme to be completed will be the shared active travel route through the underpasses. FCC are waiting on Uisce Eireann to repair a watermain and this will delay the opening of the scheme at the lower level until late summer.

The scheme has been delayed mainly due to the complexity of the scheme and the number of utility diversions involved. South bound traffic on Snugborough road was relocated to the older N3 overbridge in late April following its refurbishment. In early May the traffic signals at the junction with Waterville Road will be switched on. This will allow the temporary roundabout to be removed and replaced with a new junction at the on ramp for the N3. Currently the junction at Main St is being formed into its final layout. Some of the current works which include surfacing, duct installation and road marking are being carried out in at night to limit impact on traffic flow. An update for the scheme was given to local Councillors in mid-April. Updates will be posted on the scheme web site www.snugboroughinterchange.ie



# PSI 002 Ongar Barnhill Road

Bam Civil Ltd. have constructed some of the north and south abutment the proposed bridge over the railway. Many of the culvert units for the stream under the proposed Ongar Barnhill road have been installed. The construction of the road embankments will continue during May.

During the summer months it is intended to construct the northern part of the scheme between Barnwell Road and Barnwell roundabout. Improvement works were carried out to Barberstown Lane North and South during March in conjunction with the scheme. An update briefing for local Councillors was given in mid-April. Updates for the scheme will be posted on www.fingal.ie/ongar-barnhill



PSI-039 R132 Connectivity Project

Consultation with the National Transport Authority with Transport Infrastructure Ireland and regarding the connection with Metro Link is ongoing with Monthly meetings. Detailed design underway and progressing stage programmed. Meetings continue to be held with the various department of Fingal County Council to gather information for detailed design. The tender documentations have been published for CCTV drainage contractor and for the Ground Investigations to inform the detailed design process and de-risk the project.



PSI-005 Harry Reynolds Road Pedestrian and Cyclist Route

Construction works is progressing on the Harry Reynolds Road Pedestrian and Cyclist Route for this key infrastructure project for Balbriggan. The Project is now approx 50% completed. The work is ongoing and progressing well at three locations on the project on Hamilton Road, Harry Reynolds Road just south of the R122 and at Moylaragh Road.

An update project briefing for the Harry Reynolds Road Pedestrian and Cyclist Route was held in early April with the local Councillors for the Balbriggan Electoral Area.

Another update project briefing has been arranged for early May with the local Councillors for the Balbriggan Electoral Area, members of the Residents Associations and tidy town committee on the progress and remaining programme of works for the Harry Reynolds Road Pedestrian and Cyclist Route.

To assist with communication to the community a dedicated project website is setup which is updated throughout the project, highlighting the projects progression and key milestone stages; Harry Reynolds Road Pedestrian & Cycle Route Fingal County Council

Consultancy Framework for Dublin 15 Walking and Cycling Projects

The Planning & Strategic Infrastructure Dept has commenced the procurement process for a Single Party Framework for Engineering Consultancy Services for Pedestrian and Cycling Route Projects in the Dublin 15 Area. The procurement process has now moved to Stage 2 with the tenders submissions recently received .

## PSI – 004 Royal Canal Urban Greenway

Dialogue continues to be held with key stakeholders the National Transport Authority and Waterways Ireland along the route of the greenway to ensure a coordinated, high quality final design is achieved at interfaces between existing facilities and the proposed scheme.

The project is currently at preliminary design stage and requires the need to hold additional meetings with all the relevant key stakeholders to agree a revised design in lined with the new National Cycling Manual. These meetings will continue over the coming monthly to ensure a coordinated, high quality final design which compiles with the new cycling manual is achieved at interfaces between existing facilities and the proposed scheme. Landowner searches and land referencing are ongoing also.

Following completion of the preliminary design, all the required documents including the Environmental Impact Assessment Report will be prepared for a planning application to An Bord Pleanála.

#### S2M Pedestrian and Cycle Scheme

The preliminary design drawings are being finalised. The recently published Cycle Design Manual has led to some improvements being incorporated into the overall scheme design including revised layouts for crossings and bus stops to comply with the new standards. A surveyor has recently completed topographical surveys of public and private lands within the proposed scheme.

Ground Investigation Works will be required along the route at all locations where new structures are being proposed. These works have been procured and are scheduled to begin in May 2024. A tree surveyor will be procured in the coming months and a survey of all trees along the proposed route will be carried out. Following this process, the preliminary design can be finalised, and documents will be prepared for a planning application to An Bord Pleanála. Engagement with potentially impacted property owners, businesses and stakeholders is ongoing. A search of unregistered lands is ongoing for production of the deposit maps for the land acquisition. Draft documents are being prepared for the submission to An Bord Pleanála.

## Kinsealy Walking and Cycling Routes

The Kinsealy Walking and Cycling scheme aims to provide a high-quality walking and cycling route between Kinsealy and Portmarnock train station, and between Kinsealy and Malahide Castle and Gardens. The two walking and cycling routes will form a link from Kinsealy to sustainable transport at Portmarnock and Malahide Train Stations. The Planning & Strategic Infrastructure Department awarded a consultancy framework contract to Barry Transportation for this project.

The Options Selection phase is progressing on both routes from Kinsealy (north towards Malahide and east towards Portmarnock).

Traffic and topographical surveys on public lands have concluded and the various constraints along all route options are now being analyzed, this will lead to the Emerging Preferred Route (EPR). A public consultation strategy is being planned to progress from the EPR stage to the Preferred Route stage and the ensuing statutory process required to deliver this project.



# Fingal Coastal Way

Meetings between the Independent Agronomist and affected landowners with farming, equestrian and horticultural businesses are nearing completion. These meetings will identify site specific issues and opportunities with a view to agreeing the final position of the route in rural areas.

Preliminary design work is progressing along urban roads. Updated traffic counts in Skerries and Rush will take place in May.

Liaison with Irish Rail continues for the structure required to cross Rogerstown Estuary.

#### **Broadmeadow Way Greenway**


Contract for the manufacture and supply of precast concrete units for the 12-span 180m long precast bridge deck units awarded to Shay Murtagh Precast Ltd. Main estuary bridge Civil Engineering Contract awarded to Jons Civil Engineering Ltd.

Design options for the northern causeway have been developed using recently acquired ground investigation data from the ground investigation (GI) contract. These options will then be workshopped with the NTA and Irish Rail to seek approval to proceed with single preferred design option that meets the project objectives and ensure the safety and integrity of the railway causeway.

The Underwater Archaeology Unit in the Department of Local Government and Heritage have requested that Fingal County Council undertake an underwater archaeology desktop assessment as part of planning and foreshore commitments. Archaeological Management Solutions were procured. The study is complete and report will be finalised and issued to DHLGH. Brady Shipman Martin have been appointed as project ecologists for the Council. Various ecological surveys are being undertaken preconstruction, during construction and post construction. These surveys have commenced.

The Department of Housing, Local Government & Heritage has advised that the Minister has approved the granting of the Foreshore Lease, Licence and Consent. Fingal County Council has received the documents for execution.

The OHLE mast strengthening works are nearing completion. Jons, Irish Rails Contractor for the main estuary bridge will be mobilising to site on 7th May. Progress on the detailed design phases of the various elements that form this project continue. Works contracts in Donabate, Malahide and the northern and southern causeway will take place in 2024, 2025 and 2026. It is expected that the greenway will be complete in 2026.



OHLE Mast Strengthening Works – Southern Access Haul Road – Broadmeadow Estuary

#### Church Fields Link Road

Works at the Church Fields Link Road and Cycle Network project, which includes the upgrade and reconfiguration of the existing Wellview Avenue, Damastown roundabout and the installation of 670m of high-quality pedestrian and cycling facilities through the eastern parklands linking up with existing networks and future proposed facilities in the vicinity, are progressing and nearing completion. Based on the Contractor's programme, the contract completion date is estimated as 30<sup>th</sup> July 2024. Substantial Completion is estimated for the middle of May 2024.

Recent works completed to date include the following:

#### Turvey Avenue & Portrane Road, Donabate

Fingal County Council has lodged an application to An Bord Pleanála (ABP) for a Compulsory Purchase Order (CPO) for the Portrane Road Enhancement Project. Two landowner objections have been lodged with ABP in this regard. Further consultation regarding landowner concerns has resulted in one of the landowners withdrawing his objection. Consultation continues with the other landowner to try to reach an agreement.

The project involves works to widen the existing narrow footpath on the northern side of Portrane Road in order to provide a suitably wide and safe footpath for pedestrians to use in the vicinity of two national schools (St. Patrick's Boys National School and Scoil Phádraic Cailíní). The project also involves works to provide safe pedestrian crossings and appropriate traffic calming facilities. Subject to approval from An Bord Pleanála, the CPO will allow Fingal County Council to purchase privately-owned land that is required to widen the path and deliver the project. Fingal County Council awaits the decision of An Bord Pleanála in this regard. Separately, Priority Construction Ltd, working on behalf of Fingal County Council, has completed a significant amount of work on the Turvey Avenue Footpath Enhancement.

A new footpath has been built on the northern side of the road where no footpath previously existed. The new footpath provides a continuous and safe walking route along Turvey Avenue for pedestrians travelling to and from Donabate Village and train station. The project also includes drainage improvements, footpath improvements on an existing path nearby, road resurfacing, additional kerbing, line markings, speed ramps and signage. Work continues on site to finish off the remaining elements of the project, including hedge planting, tree planting, installation of driveway gates at affected properties, etc. The project is due to be substantially completed this summer.

# Donabate Pedestrian Bridge

License agreements are being finalised with the developers of adjacent lands to facilitate access to, and construction of the bridge. Procurement for a main contractor for the works is nearing completion. NTA have allocated funding for this for 2024. Construction is expected to commence in the coming months.

# **Donabate Transport Projects**

Fingal County Council has appointed Roughan and O'Donovan, a leading multi-disciplinary consultancy firm, to provide engineering, planning and environmental services for the Donabate Transport Projects, which comprise a number of major projects with the objective of improving transport and active travel infrastructure and road safety on the Donabate-Portrane peninsula.


The projects include:

 Phase 2 of the Donabate Distributor Road project, to improve access to Donabate and Portrane from the M1-Lissenhall Interchange for all road users, particularly vulnerable road users such as pedestrians and cyclists;

- Blakes Cross Junction Upgrade, to provide a safer junction layout that caters for both motorised traffic and active travel modes of transport such as walking and cycling;
- A study of the M1-Lissenhall Interchange, in collaboration with TII, to assess all technical and operational traffic issues associated with this strategic motorway junction;
- 7no. Active Travel Routes which encompass a number of related local projects which aim to increase local connectivity for pedestrians and cyclists.

Work on the initial data-gathering, concept development and option assessment stages of the Donabate Transport Projects is underway including topographical surveys of relevant areas of Donabate. Fingal County Council and Roughan and O'Donovan are currently analysing traffic data and carrying out traffic modelling on the M1-Lissenhall Interchange.

Separately, a number of potential route options have been identified for Phase 2 of the Donabate Distributor Road. These options are shown below and will be subject to multi-criteria assessment to determine the preferred route. Once the preferred route is established, a non-statutory public consultation will be held.



Further stages of work, relating to environmental assessment, planning consent, etc. will follow on in subsequent years as appropriate.

#### Parks & Green Infrastructure Division

Nature Based Solutions - Infrastructure

On Tuesday the 26th of March, Fingal hosted an international "NBSINFRA - City Labs Meeting". Fingal County Council is participating in a EU funded international project called NBSINFRA (Nature Based Solutions - Infrastructure). Teams from several European countries are working on "City Nature-Based Solutions Integrated for Local Urban Infrastructure Protection for A Climate Resilient Society". Fingal is partnering with University College Dublin on the Irish project which focusses on Sustainable Swords and the Ward River Regional Park Development Project to showcase the use of Nature Based Solutions to resilience protect/increase the of urban infrastructure. Around 20 people including representatives from Germany, Portugal, Bulgaria, Czechia and UNESCO attended the Fingal workshop which included a tour of Swords Main Street and the Ward River Valley.



# **Playground Updates**

The completed Lanesborough Park Playground in Meakstown was officially opened to the public on Friday 5<sup>th</sup> of April last by Councillor Adrian Henchy, Mayor of Fingal.



Cardy Rock Playground in Balbriggan has been completed and will open to the public in the near future.



Works are ongoing at the Garristown Library Garden and Playground and on the Playground Upgrade works at Howth Promenade have commenced.

## **Heritage Officer**

Ministerial Visit



Fingal received a visit from Malcolm Noonan T.D. Minister for Nature, Heritage & Electoral Reform in April 2024. It was an opportunity to showcase the heritage projects and cross departmental initiatives undertaken by Fingal County Council. The Heritage Officer highlighted the Community Monuments Fund; Digging Drumangh and Fingal's long-standing community archaeology programme; the Heritage X Climate project; Fingal Traditional Skills and the upcoming phase of Blas: Fingal's Food Heritage project.



Community Monuments Fund 2024

A total of €410,855 has been awarded from the Community Monuments Fund 2024 for five projects in Fingal. Under Stream 1 consolidation works that will take place at St Columba's towers, Swords (€120,000), Lanistown Castle, Donabate (€120,000) and Balrothery tower house (€110,905). Under Stream 2, conservation management plans will be undertaken for St Fintan's Church and graveyard, Sutton (€30,000) and St Douloughs church, Kinsealy (€29,950). The Community Monuments Fund has been instrumental in the preservation of our archaeological monuments for the future generations of Fingal. # **Balleally Rise, Lusk**

# **Kilmartin Grove, Dublin 15**

On March 3rd, Fingal County Council announced a new affordable home purchase scheme in Kilmartin Grove, Dublin 15. Fingal County Council has partnered with Glenveagh Homes to deliver 36 affordable homes at Kilmartin Grove, Dublin 15. The scheme will comprise of the following:

- 22 2 bed properties
- 14 3 bed properties

- 52 no. 3-bed units

The scheme was advertised on April 2<sup>nd</sup>, 2024, and the application portal opened on April 16<sup>th</sup>, 2024. The portal will remain open.

## **City to City Exchange**

Following a successful collaboration between the Housing Delivery team and the Economic, Enterprise, Tourism & Cultural Development Department, Fingal County Council were successful in an application for funding under the European Urban Initiative City-to-City exchange programme. The funding is facilitating a learning exchange between Fingal County Council and Helsinki City Council in March and May 2024. A team of five from Fingal County Council visited Helsinki in March and all members of the team gained significant learning and insight from the hosts.

Housing Europe recommended Helsinki as an exemplar for affordable housing initiatives in Europe. The city of Helsinki has a long track record of house building with the ability to influence housing supply as well as affordability. The City Council targets a balanced range of housing options for inhabitants while not being dependent on the market for delivery and also not excluding the private sector. It also prioritises new developments to be low carbon while actively retrofitting existing housing stock to become more energy efficient.

A return trip to Dublin by Finnish representatives will take place in May which will include meetings in County Hall, Swords and a site visit to new housing delivery site at Balmoston, Donabate.

# **Housing Asset Management Report Energy Efficiency/Retrofitting Programme**

Fingal County Council's Energy Efficiency Retrofit Programme is progressing well. The 2024 Programme has begun with Phase 3 of the Strandmill estate, Portmarnock.

Feasibility & tender preparation works are currently underway in several other housing estates throughout the county for inclusion in this programme.

# **Cyclical Maintenance - Scheme Painting**

The Scheme Painting Programme provides for external painting and joinery repairs to Council housing stock and currently operates on a 6/7-year cycle. Works are currently reaching completion in Derham Park, Glover Court, The Lodge, Goldenridge and Chapel Street Flats and works are ongoing in Pinewood Green, Balbriggan.

#### **Housing Assistance Payment (HAP)**

HAP continues to be the primary source of rent support for those in private rented accommodation. Fingal County Council has set up over 113 new tenancies in 2024 to date with approximately 4040 tenancies set up since HAP began in 2017.

The HAP team is on hand to deal with any queries from applicants and landlords in person at the Housing Department in the Fingal County Council Blanchardstown Office, by phone at 01 8905000 via the CCU or through email at <a href="https://hap@fingal.ie">hap@fingal.ie</a>.

# **Rents**

The new rent review process continues, and tenants are required to return their Rent Assessment Form with the relevant documents so that an assessment can be carried out and the correct rent charge applied to the account.

The Rent Arrears team is working methodically through accounts in substantial arrears to encourage tenants to engage with the Council in reducing their arrears. In cases where there is no engagement, despite repeated efforts, proceedings will progress through the legal arena, and to date, the Rents Section has secured two Possession Orders with 4 others due before the courts in June.

We have recently resolved two cases to a satisfactory conclusion for both the tenant and the council. Regarding the two possession orders secured, both tenants are engaging with the team to address their arrears.

The Rents team encourages any tenant who is having trouble paying their rent to engage with the Council to examine possible solutions. However, there are instances where tenants do not engage or make alternative payment arrangements, and, in those situations, the Council needs to take further action.

# **Housing Loans**

The Local Authority Home Loan (LAHL) is a government-backed mortgage for first-time buyers and certain other applicants who are unable to obtain home loan financing from a commercial lender. Interest rates are fixed for the term of the loan and loan terms are available for up to 30 years. The LAHL can be used to purchase new-build homes (including affordable homes); second-hand homes & self-build.

#### **Eligibility Criteria:**

- Income Limit Single Applicant = 70,000 / Joint Applicants = 85,000
- Employment 2 years continuous employment / if joint application with a second earner, second earner to be 1-year continuous employment
- **Residency** legal right to live & work in Ireland & be habitually resident in Ireland
- Insufficient Offers of finance from 2 commercial lenders
- 10% Deposit 3% to come from own resource savings
- Satisfactory savings record
- Fresh Start Principle

# **Private Rented Inspections**

The Department of Housing Local Government and Heritage (DHLGH) have released 2024 targets for inspection of private rented dwellings. The most recent RTB data available to the DHLGH, which includes private rental, AHB and, where appropriate, student-specific accommodation, indicates that the number of tenancies to be inspected by Fingal County Council in 2024 is 4,711. Currently, 1,815 inspections have been conducted in 2024, with over 350 of them inspected in April.

The Private Rented Inspections team recently met with Arthurstown Construction (ACL) who were recently awarded the contract for the provision of inspection services of private rented dwellings. Fingal County Council look forward to continued engagement with Arthurstown Construction to support the inspections programme, achieve 2024 targets and improve on compliance.

# **Housing Tenancy Services Report**

#### **Housing Support and Housing Position**

Housing List positions for 2024 were issued on 17<sup>th</sup> April for all social housing applicants with an active Social Housing Application. The list positions were issued through the CBL portal. Applicants who do not have access to this portal should contact Choicebasedlettings@fingal.ie to request their unique username and password.

These list positions are static and will be updated again in 2025.

## **Changes to Income Eligibility Thresholds**

By Circular 48/2022 and changes being implemented via the Social Housing Assessment (Amendment) (No. 3) Regulations 2022, the Social Housing Eligibility Bands increased with effect from 1st January 2023.



The chart below shows the breakdown of allocations per month.





#### **Homeless Exits 2024**

During March 2024, 22 households exited homeless circumstances into various forms of social housing support - including privately rented tenancies under the Homeless HAP Scheme.




#### **Homeless Assessments**

Fingal's Homeless Team continues to engage with those experiencing homelessness to offer advice and support. Homeless Assessments continued to be carried out.

In March 2024, there were a total of 40 full homeless assessments completed – comprising 25 families and 15 singles/couples.



During March 2024, of the 40 Homeless Assessments carried out, 39% cases resulted from a Notice to Quit (NTQ) having been served. Most of the other presentations to the Homeless Section are from family/relationship breakdown (19%), living in overcrowded conditions (6%) and state that they cannot/will not return to the property. The remaining 36% comprise various reasons outlined in the chart below



# Emergency Accommodation (including Fingal County Council Family Hubs)

There continues to be a high demand for Emergency Accommodation across the region for both families and individuals.

#### **Rough Sleepers**

The Homeless Services Team continues to liaise with the DRHE Outreach Team regarding any reports of rough sleeping, to establish their names and circumstances and to offer support. Regrettably, some rough sleepers are reluctant to engage with service providers and may refuse offers to access emergency accommodation. Any rough sleeper who is willing to engage with the Outreach Team and/ or the Council will be assisted.

The Council will carry out homeless assessments and every effort is made to encourage them to avail of homeless services.

A weekly Rough Sleepers Coordination Group monitors the reports of rough sleepers. The reports come from various outlets, including the DRHE Outreach Team, Elected Representatives, the FCC Operations Department, and the general public.

There have been 31 reported rough sleeping cases in 2024.

6 of the clients have taken up Emergency Accommodation and we continue to work with 2 others in an effort to provide a suitable solution.

There are currently 4 registered long term entrenched rough sleepers (1 couple and 2 males). The couple and 1 male have been nominated to Housing First tenancies in March 2024. We continue to work with the last client in an effort to secure him long term accommodation.

# Dublin Street Outreach Service Tel: 01 872 0185 from 7 am to 1 am

The DRHE in partnership with Dublin Simon Outreach and the PMVT Intake team are assertively working on the streets offering accommodation to all rough sleepers. The teams are very familiar with the locations of people sleeping rough across the Dublin Region and persistently work with individuals to support them into emergency accommodation.

This process can take time and multiple contacts, as some people do not want to engage but the teams persevere with every person working to achieve a successful outcome.

The service operates 365 days a year, until 1 am. The Outreach Teams also ensure that people sleeping rough are linked with other appropriate health services such as addiction and mental health services to prevent further rough sleeping. PMVT's Housing First Intake team links rough sleepers to permanent accommodation with long-term support.

All emergency accommodation is now 24-hour, with food and shower facilities provided.

# National Housing Strategy for Disabled People 2022-2027 Implementation Plan

Action 1.2.2 of the National Housing Strategy for Disabled People 2022-2027 Implementation Plan states that Local authorities and the HSE must work together to plan and deliver on housing targets for disabled people in the community (including decongregation) in line with the forthcoming Disability Services Action Plan.

The HSE Mental Health Housing Coordinator from Parkgate Hall liaises with the Homeless Services Team on a monthly basis.

Currently 11 Fingal County Council clients have been identified, one was housed in January, a second is going through the nomination process after a property has been identified and the teams continue to liaise in relation to the other clients.

#### **Homeless Action Plan 2022- 2024**

The DRHE, with the approval of all 4 local authorities in the Dublin region, has finalised the Homeless Action Plan Framework for Dublin 2022-2024. This Plan is the first plan to be put into operation since Ireland signed the Lisbon Declaration on combatting homelessness in June 2021, which aims to end homelessness by 2030.

It will follow on from the previous Homeless Action Plan for 2019- 2021 and continues with the three key themes of **Prevention**, **Protection and Progression**.

The Plan was developed based on a detailed consultative process including submissions from various Stakeholders, interested organisations, Service Providers, Members of SPCs of the four Local Authorities, the Dublin Joint Homelessness Consultative Forum and the Statutory Management Group.

# Preventing Homelessness, Notices to Quit and Tenant In-situ Acquisitions

Fingal County Council is aware that households in the Fingal area who may have received a notice to quit, which is also referred to as a notice of termination, from their landlord may be worried or unsure of what to do.

Fingal County Council and the Dublin Regional Homeless Executive (DRHE) would like to advise anyone affected of the services that are available to them in these circumstances.

We strongly encourage tenants residing in the Fingal area, who have been issued with a notice of termination, to contact Fingal County Council as soon as they receive a notice from their landlord. The contact details for Fingal County Council are provided at the bottom of this page.

When the tenants contact Fingal County Council, staff in the Housing Department will take note of the termination date.

The Council advises the tenant to refer the notice to Threshold, a service funded by the DRHE to provide a Tenancy Protection Service for private renters in the Dublin Region, including Fingal. Threshold can also be contacted directly on Freephone 1800 454 454 or via their website <a href="www.threshold.ie">www.threshold.ie</a> which contains more information and advice on the validity of your notice.

The Council's first response will be to try to prevent homelessness. This includes assessing the person's position on the social housing list, providing advice on applying for Choice Based Lettings, advising the person on the level of Housing Assistance Payment (HAP) they may be eligible to receive, and, in some cases, assessing if the Council can acquire the dwelling where the tenants reside if it is being offered for sale.

Placement in emergency accommodation will be a last resort if no other alternative can be identified.

The Council has been engaging with tenants who have been issued with a notice of termination, as well as their landlords, and following assessment, 259 tenant in-situ properties are at the sale closed stage. A total of 87 properties are at the sale agreed stage with a further 43 cases in the negotiation process. In addition, the Council is assessing a further 314 queries concerning notices of termination and tenant-in-situ acquisition.

The Council will continue to deal with notice of termination queries and cases as expeditiously as possible and progress tenant in-situ acquisitions while taking account of circulars and guidance issued by the Department of Housing, Local Government and Heritage.

Fingal County Council continues to liaise with other Dublin and neighboring local authorities to deal with tenancy issues that may require an interauthority approach. In particular, we are working closely with our colleagues in the other Dublin Local Authorities on the implementation of the Government policy and guidance, with a focus on the needs of tenants.

Whilst the Council will, in the context of current circumstances, adopt flexibility in dealing with potential acquisitions of properties with tenants in situ, any acquisition is subject to appropriate due diligence and checks before any commitment is made to acquire, including, for example, determining that a valid notice of termination is in place, the tenant has a social housing need, and the condition and valuation of the property.

The Government has put forward options to allow tenants who are not eligible for social housing to remain in their homes, including schemes to support the purchase of homes and a Cost Rental in-situ Scheme. The Cost Rental Tenant-in-Situ Scheme is available for tenants who are not eligible for social housing and are at risk of homelessness. The DHLGH has advised that local authorities are to be the first point of contact for this scheme, but it is managed by the Housing Agency. Under the scheme, the Housing Agency can purchase a property and rent it to the tenant. Fingal County Council will undertake an initial assessment of the tenant's circumstances and refer details to the Housing Agency for consideration, where the tenant is at risk of homelessness and the Cost Rental Tenant-in-Situ scheme applies. The Housing Agency will then contact the landlord about the purchase of the property.

Where a tenant wishes to purchase their home from the landlord, local authorities can provide advice about the Local Authority Home Loan scheme. The Government is examining implementing a 'right of first refusal' for tenants to purchase their homes, as well as expanding the First Home shared equity scheme. The Council will be able to provide more information on these when available.

Works around preventing homelessness, assessing notices of termination, and responding to tenant and landlord in-situ queries are being led on by the Council's Homelessness section, taking a tenant-centred approach, supported by staff dedicated to dealing with tenant in-situ housing acquisitions.

Regular site visits by Housing Inspectors continue all Fingal County Council Traveller specific sites while checking on vulnerable residents and advising on the continued support available.





The Council's Fingal Ukraine Response Forum chaired by the Mayor continues to meet regularly to co-ordinate the response of the various statutory agencies and voluntary groups in the county to assist the Ukraine community with the most recent meeting held on the 30<sup>th</sup> April 2024.

The Forum will shortly be renamed the Community Integration Forum. This takes into account Departmental guidance in this regard, the work of the forum members and the Council's newly formed Local Authority Integration Team (LAIT) in assisting the target cohorts under the remit of the LAIT -

- 1. Applicants for International Protection (IP Applicants)
- 2. Those with Refugee, Subsidiary Protection, or Permission to Remain status
- 3. Programme Refugees
- 4. Beneficiaries of Temporary Accommodation (BOTPs).

### **Liam Rodgers Rest Centre**

The centre has been stood down as a rest centre for Ukraine Beneficiaries of Temporary Protection since Mid-March 2024 and the building has recently returned to use for community activity. The centre provided shelter and support for circa 700 Ukrainians since the war began in the main new arrivals to the country.

#### **Vacant Homes**

The Vacant Homes Team continues to engage with owners of vacant properties to encourage owners to bring them back into use and advise of schemes that are available to assist this with on-going follow up of properties reported as vacant to the Council and those identified by way of survey.

The Croí Cónaithe Refurbishment Grant Scheme is in utilisation to address vacancy and assist citizens in getting a home with increasing enquiries, applications, and grant approvals. The grant can also be used to bring a vacant property back into use for the private rented market.

# Croí Cónaithe Vacant Homes Refurbishment Grant

On the 1st May 2023, the scheme was further extended with the eligibility criteria now allowing for properties built pre-2008 to qualify and grants increasing to €50k (vacant) and €70k (vacant and derelict).

The scheme now also allows for a grant for approved properties to be rented on the private market when refurbishment is complete. Before this change, the grant-approved property had to be the principal private residence of the grant.

124 applications have been received under the scheme with a steady flow of new applications, 64 of which have been approved with further applications moving to the approval stage. In addition, staff are engaging with numerous other expressions of interest which have the potential to lead to further applications.

Promotion of the scheme is ongoing by the Vacant Homes Team who have been present at various Housing Information Events most recently the event held in the Crown Plaza, Hotel, Santry on the 1st December 2023 and at Donabate Golf Club on the 7th March 2024. #### **Community Development Office**

Community development is a process where community members come together to take collective action and generate solutions to common problems. Community wellbeing, economic, social, environmental and cultural challenges are often solved through collective action being taken at a grassroots level. Community development ranges from small initiatives within a local group to large initiatives that involve the broader community.

Building community capacity, strengthening community participation, and involving people in decisions that affect their lives is a complex process and can only be achieved by working with local communities and agencies who have responsibility to the people in those communities. In April/May the Community Development Office worked in partnership with a number of community groups and partners to support many projects/Initiatives including;

**Fingal Mayors Awards 2024** 



The Community Development office with support from the Corporate Department and Comms team hosted the Fingal Mayors Awards 2024. This years theme was 'Celebrating Tidy Towns' and the event, which was held last Wednesday night in the Crowne Plaza hotel in Santry, was a great success.

The event allowed the Mayor of Fingal, Cllr Adrian Henchy, to acknowledge the outstanding contribution the different Tidy Town groups across the county make in promoting cleanliness, environmental projects and community pride through their various Tidy Towns initiatives.

There were over 200 guests in attendance on the night with a representative from each of the 21 Tidy Towns groups involve in the evening receiving a specially commissioned glass trophy from the Mayor. They were also interviewed on stage by Virgin Media's Deric Hartigan who was the MC for the evening.

A promotional video for each Tidy Towns' group was commissioned by the Council and launched to all on the evening. The groups can use the video as promotional collateral to support funding applications or for recruitment drives.



The Award winning St Brigid's National School Choir, Castleknock opened the evening by performing a number of beautiful songs.

#### **Fingal Rural Community Forum**



The first meeting of the new Fingal Rural Community Forum took place on 11<sup>th</sup> April with attendance from all 8 member communities. The forum has been set up by the Community Development Office to provide a platform for rural communities in North Fingal for resource and knowledge sharing, support, upskilling and to address common community issues and goals. The members represent the communities of Ballyboughal, Balrothery, Balscadden, Man O'War, Naul, Oldtown, Rolestown and Garristown. The meetings will take place quarterly and in different member communities.

# Fingal She Leads: Raising the Voice of Fingal Women Pioneers



On the 13th & 14th of April, Naomi Fein and Heather Mullin, supported by the Community Development Office, commenced a five-month training programme - *Raising The Voice of Fingal Women Pioneers* in Swords Castle. The programme was attended by 13 women from diverse backgrounds and nationalities.

The workshop aimed to enhance the participant's understanding of pioneering qualities and how they can use creative methodologies to bring positive changes to their communities.

The 13 women valued opportunity to come together and share their stories finding the workshop "engaging, thought-provoking, and empowering".

Moving forward, the women will each host three outreach events in their communities, gather stories, and use the art techniques shared during the workshop to create unique visual boards that will be displayed in the final exhibition on the 11<sup>th</sup> July 2024. This public event will showcase the journey undertaken by the women, the stories collected and will present a collective vision for change through an art Installation.

**Fingal Climate Action Heroes Challenge** 



The Community Development Office are delighted to announce that 18 groups are taking part in the Fingal Climate Heroes challenge. This is an initiative of Global Action Plan.

The competition commenced on the 15<sup>th</sup> April and will run for two weeks. Over 96 people from across Fingal are participating and have saved a total of 7,899KG CO2 to date. A big thank you to those groups taking on those daily climate-friendly activities such as using a keep cup, taking public transport, airdrying clothes, buying second hand, taking shorter showers, eating locally produced food etc.

**Launch of Thrive Swords** 



Thrive Swords, a community-led mental health project, supported by the Community Development office and Mental health Ireland was officially launched by Fingal Mayor, Cllr Adrian Henchy at the Carnegie Hotel on 22<sup>nd</sup> April.

Following on from the success of Thrive Balbriggan, this community-led project aims to create a happy and healthy community in Swords by conducting projects and events aimed at improving mental health and wellbeing. Thrive in Conversations was the first in a series events, in person and online which will see participants from local groups, organizations, Fingal County Council and public representatives coming together to identify and discuss mental health and wellbeing opportunities and expectations in Swords. Thrive Swords will take part in the national Hello How Are You Day later this month.

#### **GLAS @ TU Dublin Volunteer Celebration**



A volunteer celebration event took place on 26<sup>th</sup> April at the GLAS @ TU Dublin Community Garden in Corduff. This event was attended by Mayor of Fingal Cllr. Adrian Henchy and Minister O'Gorman as well as many Elected Members from the Dublin 15 area.

This community garden is a partnership between Global Action Plan, TU Dublin and Fingal County Council Community Development Department. The event recognised volunteers for their efforts in helping to establish this hub of activity over the last 12 months.

Workshops continue in this space and support for community and voluntary groups in Dublin 15 is being further developed onsite and in other community spaces throughout the area.

# **Meakstown Community Centre Update**

Great strides are being made onsite in Meakstown with works progressing well on the building of the new Meakstown Community Centre. Elected members from the area and some staff got their first glimpse of the new centre recently during a site visit. The local community volunteers are working hard along with Community Development staff to ensure the centre is well managed and the community are supported and involved in the day to day running of the centre when it opens later in the year.

Following the recent open call for volunteers to become involved in the management of the centre the selection process for the Board of Management is well underway and it is anticipated that this Board will be in place shortly and will be supported with appropriate training and advice from the Community Development Staff which will provide a solid foundation for the Centre going forward.

The Community Development Office will support the formation of this BOM and support a subgroup with a project to conduct a needs analysis of the local area over the coming months.

Fingal Comhairle Na nÓg



Fingal Comhairle Na nÓg hosted a delegation of adults and young people from Tokyo, Japan in Blanchardstown Youth Service in April.

They presented to the visitors on Youth Participation, prompting plenty of discussion on youth participation and youth work in Ireland. The group are also busy working on their project about Youth Spaces in Fingal and sent out survey to young people in Fingal which was completed by over 200 young people.

The young people attended Dail na nÓg, the topic chosen was 'school stress'.

Two members attended the National Assembly on Climate.

One young person served on an interview panel for Hub na nÓg.

Fingal PPN welcomes the appointment of the new Resource Officer Samantha Byrne. Following on from a very well-attended linkage group meeting on 6th March, the Secretariat recognise the need for training for member groups and representatives. We have collaborated closely with DCU to design the upcoming PPN Summer School programme, which takes place from 27th-30th May. It covers media training, introduction to the PPN, grant writing and how to engage effectively with the Council. Sessions are a blend of in-person and online. The initiative is a collaboration between the four Dublin PPNs and helps provide essential training on participating in deliberative democracy in your local county, as well as a wonderful opportunity to network with other organisations.

Fingal PPN looks forward to celebrating the 10-year anniversary of the establishment of the PPN network which now represents 19,950 groups nationwide. The official anniversary will be announced later this year in Limerick at the annual conference. The PPN Workers' retreat took place in Meath on 25th & 26th April and was attended by workers from all over country. It was an excellent opportunity to share ideas and find common ground.

#### **Local Authority Integration Team (LAIT)**

The role of the Local Authority Integration Team (LAIT) is to provide ongoing integration supports to International Protection (IP) applicants, Programme Refugees and Beneficiaries of Temporary Protection (BOTP) to enable them to live independently in the community.

The full LAIT are now in place within the Community Development Department and the team are currently visiting all IP/BOTP centres in Fingal and meeting with stakeholders. The information gathered from these visits/meetings will enable the team to signpost clients to the appropriate services and ensure clinics are meeting the needs of the client.

The team have completed a series of information sessions and service informed training sessions such as Trauma Informed Practice, GDPR and Domestic, Sexual and Gender based violence.

The team attended the first National Network Meeting hosted by the LGMA / DCEDIY and where the 31 LAIT's met to share case studies and showcase the work of agencies / NGO's across Ireland.



### **Ukrainian Supports:**

Work to support Ukrainians across Fingal continues with staff from the Community Development Office providing support and information to support groups on available funding and service access.

The Local Authority Integration Team looks forward to playing a key role in the newly reconstituted Fingal Community Integration Forum this year. Working alongside their statutory and voluntary forum partners, the LAIT will be focusing on identifying and addressing any gaps in service provision and supports to international protection applicants, programme refugees and beneficiaries of temporary protection (eg Ukrainians) across the county going forward.

# **Age Friendly Fingal**

Age Friendly Fingal is committed, through this strategy, to driving a collaborative, multisectoral approach which supports interventions that will significantly help to improve the quality of life of the current population of older people in Fingal and future generations.

# Fingal OPC Annual Conference 2024: Ageing Well in Fingal



Fingal OPC's Annual Conference 2024 will take place on Tuesday 21<sup>st</sup> May 2024 in Kettles Hotel, Swords. The theme of the Conference is "Ageing Well in Fingal".

The morning session will consist of presentations by experts from the HSE (Decision Supports) and Fingal County Council (Housing for Older People), followed by Q&A sessions, with entertainment in the afternoon.

A number of service providers such as Citizens Information, Fingal Age Friendly Healthy Homes, An Garda Siochana, FCC Housing, HSE and MABS will be present during the day to provide information and advice to delegates.

#### **Cross Border Intergenerational Project**



The final meeting of the intergenerational groups on the Cross-Border project took place on Saturday 23<sup>rd</sup> March in Carlingford with a visit of the last Leprechauns of Ireland, followed by lunch and a discussion in Bagnel's Castle, Newry.

Each participant gave feedback on the project, the positive impact it has had on them and their view of the opposite age group, as well as their community.

While the project as outlined for the Shared Island Fund is now complete, both groups agreed to continue to meet and work on joint initiatives and hope to meet up in Balbriggan later in the year.

The Balbriggan Intergenerational Project (BIPs) are focusing on the lack of shared spaces in Balbriggan for all ages and abilities, both indoors and outdoors. They have developed a questionnaire for completion by their peers. The results will be provided to Our Balbriggan and Fingal Operations Department for consideration within their workplans.

There is interest going forward on how Intergenerational Practice can be used within communities when exploring new projects, works, and regeneration. This project will be presented at an upcoming Age Friendly Seminar on Intergenerational Practice.

**Launch of Donabate Memory Cafe** 



Donabate Memory Café offers a safe place for those with Dementia or Alzheimer's and their families and carers, to learn about dementia with sessions hosted by specialists in areas such as nutrition and finance most importantly it's a place to have fun and socialise, share stories over a cup of tea and cake.

Activities include chair yoga, singalongs with local singers and musicians and brain activities. The café is supported by the FCC Community Development Office., HSE, Alzheimer's Society, Donabate Library and local businesses. Over 60 people attended the launch by Mayor of Fingal Cllr. Adrian Henchy. The café opens the last Wednesday of each month, 11am to 1pm.

# **Protected Cycle Lanes:**

#### **BLRS Area:**

#### **R132 Blakes Cross to Quickpenny Lane**

During April and over the Easter period the contractor was busy carrying out work in front of Corduff National School when the school was on mid-term. A new gold (buff) coloured anti-skid surface was applied to the road in front of the school to highlight the school zone and increase awareness to motorists that they are entering into a reduced speed school zone. Kilhedge Lane that links back into Lusk Village had extensive drainage improvements completed in April to help alleviate some of the flooding issues along sections of the road. The road was resurfaced throughout to provide a high-quality new surface that will provide a smooth surface for all walkers and cyclists.

#### **Seatown Road Swords:**

The Engineering Consultant and Project Team are currently working to finalise the Non-Statutory Public Consultation Report, Options Report, Detailed Drawings and Screenings on the final option. Once the documents have been finalised, it will be published on the Consultation Portal in the coming weeks. The project team are working towards going to the market in the coming months for a Contractor to progress to the Construction stage in 2024, subject to NTA approvals.

# **Donabate Portrane R126 cycle paths:**

The Project Team is currently working with our property section to progress the potential acquisition of lands along a section of the route to facilitate the progression of the proposed walking and cycling infrastructure from the end of the distributor road in Donabate along the R126 through to the coast at Portrane.

A further topographical survey has been completed to assist with the development of a preferred option. Once details of the preferred option have been finalised, it will be presented to the members at local ACM later this year.

# Coney Hill Balbriggan R132 cycle paths:

The Engineering Consultant is currently working with the Project Team to finalise concept designs and options report to assist with stakeholder engagement. Further Topographical Surveys are underway to assist with the decision-making process on the preferred option.

This is a complex section of road as the road widths are narrow and confined. All options are being considered at present so that the preferred option can be established. Further details will be presented to Cllr's later in the year.

#### St Cronan's Brackenstown Road Cycle lanes:

The contractor is back on site to complete the outstanding works at the Murrough Road Rathbeale Road Junction. These works include tie in of the cycle lanes from the Murrough Road into the Rathbeale Road. New drop kerbs and road markings to provide safe transition for cyclists and vulnerable road users from the on-road cycle facilities onto the off-road cycle facilities on the Rathbeale Road. These works will be ongoing over the coming weeks together with other snag items on this project. Traffic management will be deployed where necessary and minimal disruption is expected in the area.

#### Pathfinder Pinnock Hill to Airport cycle paths:

An updated options report has been provided by the Engineering Consultant following an initial review from the Project Team. The updated Options Report will be reviewed and agreed with relevant stakeholders before moving to the next steps. Consultation is ongoing with the relevant stakeholders including the DAA, NTA and Bus Connects project team. Further updates will be provided over the coming months, through this report and at ACM level.

#### **Howth-Malahide Area:**

# **Baldoyle-Howth Protected Cycle Lane Scheme Phase 2**

A review of the existing road network in Baldoyle is on the Active Travel Unit's programme for 2024-2025. This will include Willie Nolan Road, Brookstone Road and Main Street. It will comprise an advancement of a previous study for the improvement of pedestrian and cycle facilities on the existing road network.

Preparation of the brief for consultants will begin in Q2, 2024, in line with the Fingal County Development Plan, the Climate Action Plan and an Active Travel Strategy for Fingal.

Once a further study and preferred option has emerged from the process, it is envisaged that the scheme will progress, subject to funding from the National Transport Authority (NTA).

# Paddy's Hill to Broomfield via Naomh Mearnóg GAA

It is intended to run a tender competition in Q2, 2024 for 'Concept Development and Options Selection'. Preparation of the brief and tender documents have begun.

Enabling works have been completed to provide connectivity from Paddy's Hill Car Park to St. Helen's Junior School and Limetree Avenue. This included tree surgeon works, footpath works, new access points to the school, ramps, table-top crossings, dropped kerbs and ramps on the carriageway on Paddy's Hill.









# Seapark Hill to Old Golf Course Link Park

The design brief and tender documents have been prepared. It is intended to publish this tender as soon as possible to progress this project from the design phases through to completion as soon as possible. The design will incorporate feedback from internal FCC stakeholders and the local Resident's Association. A temporary footpath was constructed in December 2023, to provide safe access to the Old Golf Links site and paths through the park, providing safe connectivity to Seamount Heights.

The Developer on the Seamount Road side has recently reopened the access, which is now through the new development, closing the temporary footpath.


# **Feltrim Road Cycle Infrastructure**

The brief and tender documents have been prepared and it is intended to go to tender for the works in early Q2, 2024. The route of the Feltrim cycle scheme is shown on the map below, commencing at Kettles Lane, along the Feltrim Road to Mountgorry Way and on up to the Swords Road Roundabout.

The Active Travel Unit of Fingal County Council proposes to engage a consultant to provide multi-disciplinary consultancy services for the provision and improvement of infrastructure for pedestrians, people on cycles and other vulnerable road users.

The study area is from the Mountgorry Way/Swords Road roundabout via Mountgorry Way and Feltrim Road, tying into the Feltrim Road/Kettle's Lane junction. An indicative route for illustrative purposes is provided below. This map outlines the route of the proposed improved active travel infrastructure with the addition of a pedestrian crossing facility to be provided at/near the entrance to Kettles Park on Kettles Lane, and treatment of the three roundabouts at Swords Road/Mountgorry Way, Mountgorry Way/Feltrim Road, and Drinan Enterprise Centre/Liam Rogers Centre/MPETSS.

It is anticipated that a concept design will be completed by Q4 2024, with Preliminary Design commencing in Q1, 2025.



# Scoil an Duinninigh to Waterside Footpath and Cycleway

Planning permission has been granted for the school and the Department of Education is to engage with Fingal County Council in relation to pedestrian access as a condition of the granted Planning Permission. In the interim, a footpath, dropped kerbs with tactile paving have been provided on the route to/from the school and the Feltrim Road.

# BMCO Area: Snugborough Road - NAC to Ongar

The options report for the project has been completed after internal reviews by the Project Team and a workshop with the NTA. A Gateway 2 Report has been issued to the NTA and approval to proceed to the preliminary design phase of the project has been received.

The consultant has received the stage 1 road safety audit on the emerging preferred option. The drawings are now being updated taking this audit into account. Stakeholder engagement continues with the Bus Connects project team for a proposed new signalised junction at Waterville. A draft preliminary design report has been issued to the Active Travel Unit with comments sent back. Further updates will be provided over the coming months, through this report and at ACM level.

# **Clonee to Blanchardstown Shopping Centre**

All data collection has been collated and has informed the initial development of the options report. Initial discussions have taken place with local landowners. The design consultant has been issued with an updated review of the draft Options report and drawings following input from the Active Travel team. Once reviewed a workshop will be held with the NTA.

#### **Castleknock to Dunsink Lane**

This project is now focusing on Auburn Avenue linking into the Royal Canal at the 12th Lock along the Old Navan Road. The Options Report and relevant drawings for Auburn Avenue have been reviewed and approved by the NTA in compliance with the Gateway 2 Hold Point requirements.

A stage 1 road safety audit has been carried out and comments taken into consideration with drawings updated accordingly. Photomontages of the emerging preferred option have been prepared in advance of a public consultation with information leaflets being drafted for a letter drop to the wider area. Draft EIA and AA screening reports have also been submitted for review.

### Hartstown/Huntstown/Mountview Road

It is proposed to use a newly formed Single Party Framework to progress design from earlier work carried out by the Cycle Design Office. A tender competition has been published to engage the design consultant for phase 2b in this regard. The tender competition is now closed and is under assessment.

Fingal County Council will progress on finalising the detailed design for roundabout and junction upgrades. This is subject to revision of design standards to ensure compliance with the new National Cycle Manual.

### Castleknock to Blanchardstown via Farmleigh

Stage 2 of the tender competition for a design consultant and assessment has been completed. Contract documents have been signed and sealed and a commencement meeting has taken place. The feasibility study has started, and traffic and drone surveys have taken place which will help inform the study. A tender competition to carry out a topographical survey has been completed with survey works starting May 2024.

### **Towns & Villages**

Works are continuing in the development of an Active Travel Plan for several of our Towns & Villages. Details are outlined below.

#### **New Street**

Fingal County Council has received notification of a Judicial Review proceedings challenging the Part 8 approval for the Public Realm Improvements. Fingal County Council's legal team is currently taking instructions in relation to this.

The Active Travel Unit intends to tender the detailed design phase of this project in Q2, 2024.

#### **Balrothery Active Travel Plan**

The Consultant is in the process of incorporating Fingal County Council's comments on the draft report they produced following a well-attended non-statutory consultation event on 20<sup>th</sup> February 2024.

The Consultant is also in the process of identifying Key Performance Indicators for Active Travel in Balrothery, for agreement with the Active Travel Unit. Different approaches to a solution are being developed to deliver Active Travel in Balrothery. Each of these approaches will be examined against the Key Performance Indicators for various locations across Balrothery to determine a best-fit approach.

The Consultant is in the process of identifying and refining a list of interventions under these different approaches to address the issues raised during the consultation. This list will comprise both smaller interventions, as well as bigger moves. The next steps are to obtain baseline survey information in Q2, 2024.

#### **Skerries Active Travel Plan**

A set of draft Stage 2 Tender documents for the appointment of an Integrated Design Team are now under review by the Project Team and Procurement Section. Once these tender documents are reviewed and approved by senior management, they will be published on Etenders in May for the appointment of a contractor in June.

#### **Skerries Harbour Road:**

The project team and consultants are reviewing the Pre-Planning Report received in April from the Planning Department with the aim of addressing feedback during May. Once documents and drawings are revised by the consultants a decision will be made when to bring this project forward to planning and for further engagement with stakeholders. Further meetings will be arranged to update the elected members on the next steps and timelines involved.

# **Connectivity/Permeability**

We are continuing to receive various requests for Permeability and Connectivity improvements from various stakeholders across the county. These requests are being recorded in detail for evaluation through a multi criteria analysis.

The projects are then reviewed across the departments to identify if an appropriate means of delivery can be established on the ground.

Several projects identified through this process are being developed through the design phases for execution on the ground. Other projects are being progressed in the areas at either design or construction stage. These Connectivity and Permeability improvements are being delivered in cooperation with our Operations Department.

These projects will enhance local communities and provide improved walking and cycling infrastructure within the county.

Greenway connectivity support teams have been convened to review, design, and deliver active travel infrastructure that will enhance accessibility between the proposed strategic greenways and residential, educational, amenity and commercial zones. These support projects have been set up for Fingal Coastal Way, Broadmeadow Way/Sutton to Malahide Greenway and Royal Canal Greenway. This will help to optimise the use of the proposed greenway by both leisure and commuter users.

# **Newtown Bridge, Balheary Road:**

The Engineering Consultant and Project Team are currently working to finalise the Non-Statutory Public Consultation Report, Options Report, Detailed Drawings and Screenings on the final option. Once the documents have been finalised, it will be published on the Consultation Portal in the coming weeks. The project team are working towards going to the market in the coming months for a Contractor to progress to the Construction stage in 2024, subject to NTA approvals.

#### **Rush South Beach:**

The project team and the Engineering consultant have prepared concept design and options report for new universal access path. Discussions with landowners are ongoing, with meetings held recently and further meetings with the landowners in the coming weeks.

We are working collaboratively with the property owners to find an optimal solution that caters for everyone's needs.

#### **Beaverstown Road, Donabate:**

Active Travel has completed the Construction stage for the provision of footpath to link up to existing footpath along Beaverstown Road in Donabate.

Landscaping and planting have been completed and the new fence has been erected.



# Balgriffin Park Shared Pedestrian and Cycle Path:

This connectivity piece provides a shared pedestrian and cycle path from the county boundary with Dublin City on Balgriffin Park, to the junction with the R123. This provides a pedestrian and cycling connection for many dwellings on/near Balgriffin Park to the newly constructed pedestrian and cycling facilities on the R123. Works are complete.

#### **Howth Summit Inn to Bus Stop 567:**

Dropped kerbs with tactile paving have been provided on the route between the Summit Inn and Bus Stop 567. This work has been completed.

# Offington, Howth:

Junction tightening and provision of tactile paving is complete at three junctions in Offington, Howth:

The two junctions of Offington Drive with Offington Avenue and the junction of Offington Lawn with Offington Avenue are complete. This will slow turning movements by motorised vehicles while providing a shorter crossing distance for pedestrians and other vulnerable road users. Grassed areas have also being seeded in the new pavement, which will provide additional greening and drainage.

Secure Bicycle Parking Infrastructure

The contractor is progressing works associated with the provision of Secure Bicycle Parking Infrastructure on Rathingle Road, Swords, Co. Dublin.

The Contractor is also currently progressing works to install a number of bicycle parking facilities across the Dublin 15 and Swords Areas. Further works are planned in Skerries, Rush and Balbriggan in the coming weeks.

Expressions of interest has been sent to schools, sports club and community centres in relation to the supply of bike parking facilities. These expressions of interest will be assessed over the coming weeks so that orders can be placed for delivery to these facilities in the coming months.

# Safe Routes to School Round 1 – Tranche 1

The works contractor for the Safe Routes to School Tranche 1 contract is finalising snags at each of the 5 schools. A brief update is provided below for each school site and associated construction works completed to date since the appointment of the works contractor.

# **Rush and Lusk Educate Together**

Works are now completed on this SRTS Project. The contractor has recently carried out some snagging and maintenance work to the rain gardens and addressed issues that were identified through the independent Road Safety Audit.

# Castaheany ETNS / St.Benedict's NS

Works are now completed at the school site. The contractor has carried out minor snagging and maintenance on rain gardens. The Stage 3 Road Safety Audit has been completed by an independent auditor.





#### **Bayside Junior & Senior School**

Works are now completed at the school site. The contractor has carried out minor snagging and maintenance on rain gardens. The Stage 3 Road Safety Audit has been completed by an independent auditor.

#### **Scoil Choilm CNS**

Installation of flexible bollards on Porterstown Rd outside the school entrance is complete. These initial works took place before the new school year starts to alleviate poor parking near the school gates. The main works are due to start at the end of Q2/start of Q3 2024.

#### Round 2

In mid-December, An Taisce announced Round 2 of the Safer Routes to School programme, with the following Fingal schools selected:

- Scoil Bhríde Cailíní, Church Avenue, Blanchardstown
- St Helen's SNS, Limetree Avenue, Portmarnock
- St. Colmcille's Girls' National School, Chapel Lane, Swords

The Active Travel team are working closely with An Taisce in relation to data collection and engagement with the schools to develop delivery plans to enable the designers and contractors to carry out the works.

An Taisce are due to provide the delivery plans for each of the schools in the new year that will inform the design process. Fingal County Council has procured the services of a consultants' team that will be working on the designs for these schools.

#### **Rush National School:**

Active Travel together with Operations have recently launched two public consultations connected to road safety measures in Rush. A School Street initiative for Rush National School and a junction upgrade adjacent to the school are now open for public feedback.

The public has been invited to review plans for changes at Rush National School on the Fingal consultation portal. A proposal has been brought forward by the council's Active Travel unit to provide a School Street in the area. This initiative is being paired with a proposal from the council's Operations unit who have proposed junction upgrade measures at the nearby 5-arm junction at Millbank Road, Chapel Road and Whitestown Road which forms part of the 2024 Programme of Works. Together these upgrades will reduce traffic speeds in the area and provide children walking or wheeling to school with a much safer environment, at and on the approach to the school gate.

The consultation process is now complete, and the consultation report is being prepared. It is intended to update the local representatives at the next ACM meeting.



#### **Climate Action**



# **Litter Management**

The Litter Wardens continued with their daily patrols and carried out inspections on all known litter black spots in Fingal. They investigated any reports of dumping and littering and took enforcement action as required.



The Litter wardens continued to receive several complaints regarding muck on the roads from construction sites. They carried out inspections and ensured that the roads were being keep clean of muck and that the building sites had a road sweeper in operation.



They also followed up on reports to ensure farmers were ensuring the roads were keep clean of muck.



The Litter warden continued to raise awareness of the issue of dog fouling on beaches, paths, and green areas in Fingal. They engaged with dog owners and dispensed dog poo bags, making people aware of their responsibilities to clean up after their dogs. They also erected anti dog fouling signage in areas where complaints were received. The Litter Warden conducted walking patrols, with business regarding engaging responsibilities to keep outside their premises clean and free of litter. They also checked to see if any issues have arisen for the Operations crews, and they carried out inspections and followed up with fines/warning notice if evidence found.

All the bring banks in the Fingal area were inspected daily to ensure that there was no dumping. Any evidence found was dealt with under the Litter Pollution Acts.

The Litter Warden also investigated reports of abandoned cars, taking photographs and updating the litter app and the CRM system.

There were 9 cases before the district court in April 2024. They were successful prosecuted, and costs awarded.

### **Dog Warden Service**

The Dog Wardens continue to carry out enforcement in relation to breaches of the Control of Dogs Act 1986, Control of Dog Regulations 1998, Parks and Open Spaces byelaws and Beach and Foreshore byelaws. They also educate dog owners on the responsibilities of keeping a dog and remind owners to pick up after their pets when in public places. The Dog Wardens also increase their patrols of the beaches during the summer months to optimise bathing water quality and retain the status of Fingal's Blue Flag beaches.

The Dog Wardens are continuing with door-to-door licence checks. Dog owners should ensure that they hold a valid licence for their dog and if issued with a 10-day notice by the dog wardens, should present their licence to controlofdogs@fingal.ie within the 10 days provided on the notice. Failure to do so may result in a fine being issued for failing to produce a dog licence when requested to do so by a dog warden and keeping a dog without a valid licence.

There were 277 x 10 Day Notices and 35 Fines issued by the dog wardens during April 24.

The Dublin County Dog Shelter holds "Meet and Greet" visits for anyone looking to rehome a dog. Visits can be arranged by calling the shelter and arranging an appointment. These visits can be arranged from Monday - Friday from 11am to 1pm and from 2pm to 3.30pm. The shelter is also open on Saturday from 11am - 1pm. The shelter is closed to the public on Sundays. The dog shelter holds stray dogs picked up by the dog warden and dogs who have been surrendered by their owners either to the dog wardens or directly to the shelter. At the beginning of April there were 23 dogs in the shelter. During April 2024, 10 dogs were brought to the shelter by the Dog Wardens as stray or surrenders and 2 dogs was surrendered by a members of the public.

Of these 23 dogs, 0 has been reclaimed by their owner, 5 dogs have been rehomed to rescue, 4 have been rehomed to members of the public and 0 were PTS. At the end of April there are 26 dogs remaining in the shelter. The shelter has a Facebook page Dublin County Dog Shelter and Instagram Account @dublincountydogshelter which they actively update with strays and dogs wishing to be rehomed.



#### **Horses**

Weekly welfare inspections continue on Dunsink Landfill to monitor the numbers and welfare of the horses onsite. There are 15 hay feeders being filled by the Operations Department on a weekly basis to ensure adequate forage for the horses on the landfill.



#### **Environmental Inspections (RMCEI)**

The numbers of complaints investigated and inspections carried out during the first quarter of 2024 are presented in Appendix 4.

# Water Quality River Bracken

The water quality team has continued with its weekly investigative monitoring of the River Bracken which in conjunction with the Drainage Department has unearthed another significant misconnection in the surface water drainage network serving Balbriggan. The removal of this misconnection will result in further improvements in the quality of water in the River Bracken.

# **National Inspection Plan**

The WQ team commenced inspections of Domestic Wastewater Treatment Systems (DWWTS) in accordance with the 2024 National Inspection Plan. There were a number of on site DWWTS inspected in the Rolestown Area. Inspections to date has identified a high level of compliance with the NIP Programme.

### **Bathing Water:**

Fingal County Council's preparations for the 2024 Bathing Season continues. Fingal County Council has now completed and has submitted bathing water profiles for each of its identified bathing areas to the EPA. The purpose of a bathing water profile is to give detailed information on the physical characteristic of each bathing water while also assessing the risk of pollution to the bathing area.

#### **PFAS Pollution**

Dublin Airport PFAS contamination, Dublin Airport responded to a notice issued under the water pollution act requiring the submission of information on PFAS testing. The information was also published by the Airport on their website. The information is being assessed and, in this regard, we have engaged external advice from a specialist firm dealing with land contamination: Geosyntec ltd.

# Waste Enforcement Cloughwater Plastics Ireland Ltd

In 2023 the Council commenced high court proceedings against Cloughwater Plastics Itd Ireland (CPIL) a waste facility permit holder processing waste plastics.

Liquidation proceedings were taken against the company in 2023. The Council was concerned about the amount of waste on site and joined the proceedings to ensure that the liquidation would deal with the waste on site. The liquidation proceedings were subsequently withdrawn. Subsequent inspections revealed that the waste on site was in excess of that permitted by the waste facility permit, the Council initiated high court proceedings under the waste management act to enforce the terms of the permit. There were a number of hearings and site inspections. The company finally went into liquidation in February 2024. The case is not finished yet, however the issues are largely resolved as the site has been taken over by a new operator following the liquidation who has dealt with the remaining waste.

There is a risk to the council that when a waste site closes down that they leave waste behind. In this case the cost of a cleanup could have amounted to more than 350k euro. The cost of taking a high court action is high in the Council's costs were 200k and the court awarded our costs against the other parties to the case, (the Company now in liquidation, the two directors) however it remains to be seen how much we will be able to collect. This case involved 21 site inspections by FCC staff, 4 affidavits, 7 court appearances. The estimated staff time amounted to 38 days in total.

#### **Court cases - storage of waste**

Two cases related to storage of waste were heard by the District Court in early April.

In the first case relating to a property in Turnapin the Defendant did not appear in Court and was found guilty of breaches of Section 32 and 55 of the Waste Management Act, 1966, as amended, guilty of breaches of Regulations 4(3) of the Prohibition of Waste Disposal by Burning Regulations 2009, and of breaches of waste Bye-Laws.

The defendant was fined €500 on each breach (total fine €2,000) and costs of €1,166.92 were awarded to Fingal County Council.

In the second case relating to a property in Swords, the Defendant did not appear in Court and was found guilty of 12 offences under Section 32 of the Waste Management Act, 1996, as amended (WMA) and of 1 offence under Section 55 of WMA. The defendant was fined €500 on each offence (total fine €6,500) and costs of €2,166 awarded to Fingal County Council. A bench Warrant was also issued for the defendant to appear in court in front of the judge.

#### **Air & Noise Section**

The section has engaged with the IAA over the nuisance complaints arising from the operation of the new drone delivery service in Blanchardstown. The IAA have received complaints directly themselves and have identified potential mitigation measures, i.e varying flight paths and seeking to raise the height of the flight paths.

# Fingal's First Irish Wheelchair Association Club

Fingal IWA Multi-Sport Club, a collaborative initiative between IWA-Sport and Fingal County Council Sport Office, was successfully launched at Balbriggan Community College. Catering to children aged 5-15 with physical disabilities, the club provided a platform for young to teens to explore various para sports every week from 6:30pm to 7:30pm. Activities include wheelchair basketball, para athletics, wheelchair rugby, the programme has over 20 participants benefiting from the inclusive sessions and forming teams in the above sports.





# Men on the Move to Everyone on the Move

Men on the Move was a programme originally funded by the HSE, this programme was established to create a space for men to engage or reengage back into physical activity. Following the introduction of Fingal's Sport Strategy the programme is now open to all genders and has seen participant rates increase by 75% by opening the programmes to all in Mulhuddart and Balbriggan.



#### **Fingal Tennis Nursing Home Programme**

Tennis is a timeless sport that everyone can enjoy. Fingal Sport for Life Programme is dedicated to bringing tennis to the older generation, tennis coaches have been visiting nursing homes across Fingal introducing the sport through fun interactive sessions. Along the way, Fingal Tennis are reconnecting with past players from various clubs and communities. The players are thoroughly enjoying the lively atmosphere and excitement generated during these sessions.





#### Fingal's Late Night League

Fingal's Late Night League in conjunction with FAI and Balbriggan's community gardai began on 12<sup>th</sup> April and has seen an uptake of 50 participants per week. This initiative is seeing a positive relationship with teens and the local Gardai who attend the sessions every Friday evening. Swords Late Night League will start 10<sup>th</sup> May in Rivervalley and Blanchardstown will begin the same Friday in Whitestown.



#### **Fingal Tandem Bike Training**

Fingal Sports Office, Active Travel and Vision Sport Ireland collaborated on Saturday to establish tandem bike pilot training for participants to support a person who is visually impaired. The training took place in Fingal Swords carpark with hope that the participants will support athletes going forward who wish to try to cycle.
