Provision of Traffic Calming Measures, Appropriate Road Signage & Road

Markings in Inbhir Ide, Malahide in Accordance with Drawing No.

Fingal County Council in exercise of the powers conferred on it by section 38 of the Road Traffic Act 1994 (as amended) and Section 95 of the Road Traffic Act (as amended) has prepared a proposal to carry out a Safe Routes to School Scheme at pope John Paul II school and the Inbhir Ide area in Malahide.

Pope John Paul II NS applied, and successfully qualified for Round 1 of the programme being rolled out to encourage children and their guardians to walk or wheel to school. A tailored Safe Routes to School design has been provided for Pope John Paul II National School. The proposed changes will promote walking and cycling and make travelling to and from school safer, easier and more convenient for all.

At Pope John Paul II NS we will provide the following:

- Creation of a car-free School Street each morning and afternoon.
- Tightened junctions at Inbhir Ide with Caves Strand, Sea Road. Tightened junctions slow down approaching traffic and make crossing the road quicker and safer.
- Resurfaced footpath on Caves Strand adjacent to the junction.
- Extended footpath around the green area in Inbhir Ide, with flexible bollards protecting the path.
- Added school zone signs and coloured road surfacing at Inbhir Ide Drive.
- Tightened junction at Inbhir Íde Close with Inbhir Íde Drive, and tightened junction at Sonesta.
- Extended footpath from the corner of Inbhir Ide Close to the school along Inbhir Ide Drive.
- Tightening junction at Ard na Mara with Yellow Walls Road.
- Upgraded zebra crossing at Caves Marsh.
- Signage to formalise the one-way system already in place during school drop off and pick up times.
- A series of other minor changes to signage, junctions, and crossings to support the Safe Routes to School scheme.

The proposal includes the provision of traffic calming measures, appropriate road signage and markings where necessary.

CE Order Reference AT/0030/2024

The design of the proposed Safe Routes to School Scheme has been developed and has been submitted to the Garda Commissioner and was presented to the various stakeholder groups in Malahide and Local Elected Members.

A non-statutory public consultation took place between 17 Aug, 2024 - 30 Aug, 2024.

Fingal County Council intends to introduce these proposals on the 23rd September 2024
