## Section C: Conditions & Declaration

- The applicant must provide a suitable secure location for the salt bin that is not causing an obstruction to others. This location must be a **public road/footpath** only. The Council reserves the right to remove any bin which has been placed in a location causing an obstruction to members of the public.
- The applicant must ensure a designated person will control the bin, contents and spreading operations using the salt.
- Salt bin and first fill of salt are included in the price of the bin. Ongoing salt supplies should be sourced from local suppliers. Fingal County Council **will not** be refilling the salt bins after the first fill has been used. It is the responsibility of the applicant to arrange for the refilling of the bin once supply has been exhausted. Ongoing salt supplies will not be arranged by the Council.
- Equipment such as shovels etc. will not be provided by Fingal County Council
- Fingal County Council has no obligation or responsibility for the maintenance or upkeep of the Salt Bins.
- Replacements for damaged/stolen bins can be applied for using this application form. Fingal County Council will offer a discount on the second bin. The applicant must arrange for the safe and correct disposal of the damaged bin.
- Fingal County Council will not take back salt bins once they have been delivered to a group. Once the bins are purchased, the ownership, upkeep and responsibility rests with the applicant/applicant group or organisation.
- Each organisation will be responsible for the maintenance and safe operation of the salting operation & where applicable, obtain the consent of the residents adjacent to the salt bin location. The salt bins may be locked at the applicant's discretion. It is recommended that the bins are locked when not in use. The applicant must organise a lock & keys and manage the locking of any bin, if desired.
- Fingal County Council reserves the right to remove or relocate a bin.
