Introduction

The archive of the Talbot family is held at the Bodleian Library in Oxford. The papers were originally on deposit at Trinity College, Dublin but were transferred to the Bodleian Library in Oxford in 1977 as a gift from Rose Talbot, sister of the 7th and final Baron, Milo Talbot.

The archive consists of the papers of Richard Wogan Talbot, 2nd Baron Talbot of Malahide, James, 3rd Baron, James, 4th Baron, and Richard Wogan, 5th Baron, with family and estate papers, dating from the 13th-20th centuries. Rentals and accounts of the Malahide estate, 1874-1919

These were kept in annual volumes with the rental year ending on 1 May and the accounting year on 1 August. The accounts were kept by the agent, until 1891 this was Henry A. Dillon and thereafter his son, Charles. Most are signed by Lord Talbot to signify his approval. For a few of the later years a second copy survives.

Until 1882 the series includes accounts for the Cavan and Westmeath estates, subsequently sold.
