Information Sheet for the Request by a Plebiscite to Take in Charge a Housing Estate under Section 180 of the Planning and Development Act 2000.

- 1. This will only be an official request if <u>the majority of the owners</u> of the houses involved confirm that they wish the Council to consider taking their estate in charge.
- 2. Please make sure that you have <u>no private interest</u> (such as a private parking space) in the area proposed for taking in charge.
- 3. Please note that if your estate contains highly ornate landscaping or small areas of open space that serve no public utility, Fingal County Council will not be taking this landscaping in charge in accordance with DMS62 -64 of the Fingal Development Plan 2017-2023.
- 4. Please note that if your estate contains high cost materials such as granite kerbs, setts, block paved footpaths, ornamental street lighting, etc. Fingal County Council will replace damaged kerbs, footpaths, roads and street lighting with standard <a href="lower cost alternatives">lower cost alternatives</a> such as concrete kerbs, concrete/tarmacadam paving and standard lighting poles that are used in typical housing estates offered for taking in charge.
- 5. Fingal County Council will <u>not take in charge</u> ornamental or decorative features in open space of housing estates, such as fountains, sculptures etc., that provide no public utility and are not found in the typical housing estates offered for taking in charge.
- 6. If there are services offered up to Fingal County Council for to be taken in charge (such as public lighting, surface water drains, watermains, foul sewer drains etc.) that are in private property, Fingal County Council and/or Irish water reserve the right to gain access to the property and maintain these services.
