Lodging a complaint

If you would like to make a complaint about illegal dumping or possible pollution within Fingal, it is better, where possible, to make your complaint in writing. That way we have the information we need to process the complaint quickly and easily or refer it to another authority if necessary.

In emergency situations, including in the evening and at weekends, members of the public should use the out-of-hours and emergency contact telephone numbers for Fingal County Council and other enforcement agencies.

This standard complaint form has been written to make it easier for you to make a complaint. While the form is not compulsory it does help you and us by allowing you to provide as much relevant information as possible when making a complaint.

You don't have to provide any personal information about yourself when making a complaint to Fingal County Council, although providing your name and address does help us to keep you updated on the progress of our enforcement and to contact you if we need further information or to clarify any information you have already given to us. You can provide your name and address and ask that we keep it confidential but you must let us know this at the time you make a complaint. We will respect your wishes for confidentiality within the powers provided under the Freedom of Information Act 1997.
