### **Chief Executive's Foreword**

The Dublin Citizens' Assembly, has been convened to consider the type of directly elected mayor and local government structures best suited for Dublin, and to bring forward proposals in that regard. I was delighted to accept the invitation to participate in a panel discussion, along with the other Dublin Chief Executives, last Sunday, 1st of May, and to address the 80 members of the Assembly and present an overview of Fingal as an area and Fingal County Council as the third biggest local authority in Ireland in terms of the population it serves, the staff it employs and the budget it spends. I took the opportunity to highlight the strategic importance of Fingal to the Irish economy with Dublin Airport acting as the principal international gateway for inward investment and Furthermore, we have also been entrusted by government to set up and operate the Aircraft Noise Competent Authority responsible for ensuring that noise generated by aircraft activity at Dublin Airport is assessed in accordance with EU and Irish legislation.

Our priority of making Fingal a good place to do business has seen much success due to our crossdepartmental approach in helping indigenous and foreign direct investment businesses establish themselves within the county. We are Fingalfocused acting quickly and decisively for the good of the communities we serve and having councillors from Fingal making decisions that affect the people of Fingal is something that Fingallians identify with. This is largely due to the excellent working relationship between the executive and the elected members. The current Council, which was elected in May 2019, has made 276 separate decisions over the past three years, some of which were nationally significant and pioneering. Local Government is the form of government closest to the citizen with direct accountability for every one of the 380 different services we provide to the people of Fingal. Every day we have presence on the ground in every corner of the county through the work of our Operations crews, Community Librarians, Social Workers, Sports Officers, Litter

Wardens, Arts Officers, Traffic Wardens, Lifeguards, Park Rangers, Environmental Officers, and many, many more of our 1,500 dedicated staff and I am immensely proud of what is achieved on an ongoing basis through the close partnership of the executive and elected members.

The Fingal response to date to the Ukrainian crisis has been commendable and we are endeavouring to assist to the fullest possible extent to meet the needs of refugees arriving in Fingal. We will continue to keep you updated as the situation evolves. The Liam Rodgers Centre in Drinan, Swords has been stood down as an emergency accommodation centre. The occupants have been transferred to more permanent accommodation. The Ballyogan site, in the Dun Laoghaire Rathdown Area, is now operational and will operate on a regional basis providing temporary emergency accommodation for those fleeing Ukraine on behalf of the six counties which comprise the Eastern Region for Major Emergency Management purposes. An online briefing for elected members on the Fingal response has been arranged for tomorrow, Friday, 6<sup>th</sup> May and will give an overview on the community response forum information surrounding accommodation for refugees aswell as providing information on what various FCC Departments such as Community, Libraries and Events have done and are doing as part of the response.

Since 2010, REDC have been tracking sentiment among Fingal residents through a regular residential satisfaction survey commissioned by Fingal County Council. The purpose of the survey is to understand attitudes and opinions among residents of the work of the Council which, in turn, helps the Council continue to provide the highest level of customer service to its residents.

The survey questions residents about their personal experience of living in Fingal, awareness and satisfaction with Fingal County Council, Housing and Council Services as well as their experience of dealing with the Council and knowledge of its work.

The 2022 survey involved face to face interviews with 1,012 residents aged 18+ across the county with interviews being conducted in each of the seven electoral areas. The results will be presented by REDC to councillors in an online briefing on Tuesday, May 17 at 5pm.

In relation to Emergency Accommodation for Ukrainian citizens fleeing the war in Ukraine the Liam Rodgers Centre in Drinan, Swords has been stood down as an emergency accommodation centre. The occupants have been transferred to more permanent accommodation.

The Ballyogan site, in the Dun Laoghaire Rathdown Area, is now operational and will operate on a regional basis providing temporary emergency accommodation for those fleeing Ukraine on behalf of the six counties which comprise the Eastern Region for Major Emergency Management purposes i.e. the four Dublin Local Authorities plus Kildare and Wicklow.

The Major Emergency Unit will continue working with colleagues in the East Region to monitor the situation and respond appropriately where necessary.


### **Buildings Management**

As part of the ongoing Energy Performance Contract, the contractor has commenced the replacement and upgrade of downlighters in the walkways in County Hall, Swords.

There is 833 light fittings and bulbs to be changed to LED 18W Downlighters. (Including Emergency Lights)

Projected savings on this phase of works 52,559KwH/annum.







### Smart Balbriggan Mini Maker Day



Smart Balbriggan Mini Maker Day took place on Saturday 23rd April to kick off the Balbriggan Loves Learning Festival. Over 550 people attended the event which was organised by the Digital Fingal team working with Our Balbriggan and Fingal Libraries.

Balbriggan Mini Maker Day was open to visitors both young and old for a day of family-friendly workshops and maker showcases. The day had a mix of workshops suitable for all ages, including -

### **New Chief Executive Orders System**

The new CE Orders system went live in Fingal on Friday 22<sup>nd</sup> April. Initially the system has been deployed to the Directorate of Economic, Enterprise, Tourism & Cultural Development, and the Digital Services Department in a pilot phase which will run until 23<sup>rd</sup> May.

CE Orders is a new system specifically designed to streamline and automate the creation, approval and management of Chief Executive Orders across all Directorates and Departments in Fingal. It also automatically generates the CE Orders Register. The system utilises SharePoint Online technology for the document repositories and the associated search functionality.

Once the pilot for CE Orders has concluded, the system will be rolled out to remaining Directorates in four deployment cycles over the next two to three months. It is expected that all Directorates will be fully live by end July 2022.

### **Communications**

### Website

The fingal.ie website attractted 79,800 visitors during April and recorded 229,500 page views. This is a decrease of 27% from April 2021 in both visitor numbers and page views. The average amount of time visitors are spending on the website continues to stay at over two minutes with April's average figure of 2:12 being the fifth successive month that the average viewing time has broken the two minute mark. The most popular pages in April were planning applications, recycling, choice based letting, libraries and jobs.

### **Social Media**

Our Twitter account, @fingalcoco, had 452,900 impressions during April and an average engagement rate of 1.7% from 338 tweets.




The EIRE 6 Wartime Neutrality Sign on East Mountain at Howth Head has been restored by a dedicated band of volunteers and there was a special ceremony today to mark the completion of the works which was attended by @PresidentIRL and @MayorofFingal. It looks stunning from the air.



The best performing tweet was a post about the restoration of the Éire 6 Wartime Neutrality Sign on Howth Head which included aerial video footage of the sign. This tweet earned 20,085 impressions

and the video has had 7,899 views leading to 799 total engagements including 202 likes and 40 retweets.

On Facebook, April's posts reached 161,520 people. The number of followers on Facebook is now 27,444 which is a rise of 173 from March. The number of followers on Instagram rose to 5,099 during April. Women make up the majority of followers on both Facebook and Instagram, accounting for over 70% of the audience on both channels, with the 35-44 age groups being the biggest cohort.



The best performing post on Facebook during April was the announcement that Ireland's first ever portable pool will be located at Donabate Community and Leisure Centre. It had a reach of 39,131 with 5,852 engagements.

The LinkedIn account increased its number of followers by 109 to 5,546 while You Tube now has 710 subscribers and published eight videos during April.

### **Projects and Campaigns**

The Communications Unit continues to assist in creating awareness of the Draft Fingal Development Plan and promoted the drop-in events in Swords, Blanchardstown, Malahide and Balbriggan over the past few weeks. Citizens are being encouraged to make submissions up until the May 12 deadline through a campaign which is using social, print and outdoor media.



The Communication Unit is also working with the Sustainable Travel team in the promotion of the non-statutory public consultation on the Sutton to Malahide Pedestrian and Cycle Scheme and the launch of the Active Travel Strategy.

Alongside this work, we have also worked with colleagues on the East Region Communications Group to develop a communications plan and material for the new joint regional rest centre in Ballyogan, that which was established for Ukrainian nationals arriving in Ireland and for which Dún Laoghaire Rathdown County Council is the lead agency.

### **Press Releases and Media Queries**

The Communications Unit dealt with a large number of media queries during April with topics covered including dog attacks, public lighting, planning, and working from home. There was also engagement to handle the claim that no social homes were built by Fingal County Council last year. The Unit also issued 18 press releases and media invitations during the month, including the launch of the Frank Lawless exhibition.

### **Residential Satisfaction Survey**

Since 2010, RED C have been tracking sentiment among Fingal residents through a regular residential satisfaction survey. The 2022 survey involved face to face interviews with over 1,000 residents across the county and the results will be

presented to councillors in an online briefing later this month.

### **UNESCO DUBLIN BAY BIOSPHERE PARTNERSHIP**



The Dublin Bay Biosphere Draft Conservation Strategy has been finalised. This plan also includes a strategic tourism promotional element. The partnership is collaborating with Irish Rail on a DART / commuter campaign promoting North Bull Island, Howth and Portmarnock. A familiarisation trip with key stakeholders was held on 27<sup>th</sup> April.



Following the launch of the Dublin Coastal Trail, is also working with Skerries Tourism on a familiarisation trip to promote Skerries as a key destination on the trail to Fáilte Ireland Press and Publicity Team, key influencers and front line staff.



A member of the Fingal Tourism team attended the AVEA Visitor Attractions and Experiences 2022 Forum at Croke Park on 27<sup>th</sup> April where Insights and Outlooks for the visitor attractions and the AVEA Members' Business Survey 2021 were discussed.

# EXPLORING AND THINKING EARLY YEARS ARTS PARTNERSHIP



The Exploring and Thinking Early Years Arts Partnership – Fingal, Dublin City, South Dublin, and Dun Laoghaire Rathdown County Councils, invite submissions to research and evaluate the partnership which originated in 2016. The partners wish to explore the impact of the Exploring and Thinking Artist Bursary Awards, which were developed in 2019, on artists' practice, and on provision for children (0-6years) in the settings in which the bursary occurred.

# LIBRARY SERVICES FOR UKRAINIANS ARRIVING IN IRELAND

Public libraries offer a safe, neutral and democratic space to everyone and this includes those coming to Ireland from war-torn Ukraine. Libraries in Fingal offer free wi-fi, access to technology, quiet spaces in which to study and reflect, online resources, and events and activities for all ages. In

recent weeks we have been reaching out to the Ukrainian community to publicise specific services:

- Rush, Balbriggan and Malahide Libraries
  have organised weekly meetups for
  Ukrainians new to Ireland. It's an
  opportunity for them to come together
  and to share experiences and information.
- English classes for Ukrainians, organised by Adult Education Services Balbriggan will take place in Rush Library starting in May.
- Blanchardstown Library held a welcome evening for Ukrainians new to Ireland on Thursday 21st April to introduce them to the facilities on offer.
- Children's book in Ukrainian have been sent out to our library branches. There is a limited range available but we are sourcing more junior material and adults title also.

# NEW FINGAL MAKERSPACE AT BLANCHARDSTOWN LIBRARY

The new Fingal Maker Space at Blanchardstown Library has been officially launched by the Mayor of Fingal Cllr Seána Ó Rodaigh and by the Deputy Mayor Cllr Daniel Whooley. The Maker Space is a multi-use, creative and educational community facility which houses a range of equipment including laptops, a 3-D printer and a vinyl cutter. This accessible, dynamic and inclusive space is at

the heart of the Council's commitments under the Creative Ireland initiative, and it will help to build and to support creativity in communities within the Fingal area.

The Maker Space team works with schools in the Fingal area to provide young people with opportunities to take full advantage of the facilities on offer.

It also works in partnership with the Technological University of Dublin to provide adult education opportunities.



# NEW RESOURCE FOR FINGAL LIBRARIES: C-PENS READER PENS

We have a new service on offer to members of the public called Reader Pens. Reader Pens read words and full lines of text aloud for independent reading. Those with dyslexia, those who have difficulty with reading or pronunciation, those learning languages or those with vision problems will find these pens extremely helpful pieces of technology. This device reads text out with a natural speaking voice. The pens have built-in dictionaries so you can access definitions as you read for better understanding.

At present the pens are in Balbriggan, Blanchardstown, Swords and Malahide Libraries for use in branch. We plan by the summer to have them in all libraries with the option of borrowing them for a limited period.



# FRANK LAWLESS, TD (1870 - 1922): EXHIBITION AND FILM

As part of the Decade of Centenaries Commemorations Fingal County Libraries have produced an exhibition highlighting the life of Frank Lawless, TD (1870 – 1922). 'A Dangerous Man: Frank Lawless and the War of Independence in Fingal' is on display to the public at The Atrium, Swords from 19th April – 13th May 2022. It was launched by the Mayor of Fingal, Cllr Seána Ó Rodaigh in The Atrium, Swords on 25th April. The launch also included the first public showing of a specially commissioned film by Fingal Arts Office 'Peace to the Ashes'. An invited audience, including members of the Lawless family, attended.

Frank Lawless was one of the most dynamic regional leaders of the revolutionary period. Born into a farming family in Swords, county Dublin, in 1870, he followed his grandfather and father into nationalist politics, before becoming central to the republican movement in North County Dublin. Although most of his political life was spent in prison, as a result of his prominence in the 1916 Rising, it was cut short with his untimely death on

16th April 1922 after a road accident. The exhibition gives us an insight into his life and politics along with the legacy he left.



Launch of Fingal Libraries Bealtaine Festival 2022

Fingal Libraries annual Bealtaine Festival was officially launched on Wednesday 20th April by Mayor of Fingal, Cllr. Seána Ó Rodaigh. The Festival itself forms part of Ireland's national celebration of the arts and creativity as we age and it runs throughout the month of May. The Festival returns to Fingal library branches for the first time in 2 years after taking place solely as an online festival during 2020 and 2021.

This year people are invited to take part in a chair yoga 4-week course, a computer course for adults focusing on Google and its many products, an art course with John Carpenter and a series of creative writing workshops. The Festival will also feature a mindfulness talk, biodiversity talks by the Irish Seal Sanctuary, 1st aid demonstrations by St John Ambulance, a presentation by a Mintel analyst on changing exercise and fitness trends plus a talk on preparing yourself in terms of fitness to walk the Camino. Mobile Library visited 10 creches all over the county including Donabate, Naul, Swords and Blanchardstown.



### **My Little Library**

Minister for Children, Equality, Disability, Integration and Youth, Roderic O'Gorman, T.D., recently announced the roll-out of the First 5 My Little Library initiative. Under this initiative more than 60,000 children starting school in September are being invited to collect a free book bag and join their local library. The bags of books, in English and in Irish, are currently available at all libraries in Fingal, with library staff distributing them to 4 and 5 year olds and helping them begin their library membership journey. We hope that once they visit the library to pick up their book bag, our new library members and their families will come back regularly to keep their bags filled up with books and to take part in story times and all the other events we have to offer at the library.

# Our Balbriggan 2019 - 2025 Rejuvenation Plan - A Socio-Economic Strategy



The Our Balbriggan Programme Office continues to support the Leadership Group and its five pillars, who meet regularly, to progress work across a range of economic and social measures including: Growing the Local Economy, Public Realm & Infrastructure, Education, Skills & Employment, Community Integration, Health & Well Being and Community Safety.

The Education, Skills & Employment Pillar Group met on 20<sup>th</sup> April to finalise plans for the Our Balbriggan Loves Learning Festival which is running between 23<sup>rd</sup> and 29<sup>th</sup> April 2022. The Local Economy Pillar is scheduled to meet next on 18<sup>th</sup> May and work continues to progress all actions.

The demolition of the former O'Shea's Night Club building (Harbour) is complete, and contractors will be off site by end of April 2022. Archaeology monitoring of the site has also been completed.

The site and layout is being levelled out to create a 'meanwhile space' to allow for temporary planters and seating, pedestrian route with low level picket fence surround.



Paul Keogh Architects, the appointed Integrated Design Team (IDT) for the re-imagined Quay Street & Harbour Area, continue to progress design work. Stage 2A of the Design Report completed in April, following internal and external stakeholder consultations. Pre-planning has been lodged and the Council anticipates bringing forward Part XI proposals in June 2022.



Paul Keogh Architects, the appointed Integrated Design Team (IDT) for 2-4 Dublin Street are progressing design proposals on renovation of these buildings to facilitate artistic studios and creative maker space, public courtyard and gallery. Public Consultations and Part 8 Planning permission anticipated in Q4 2022.



DBFL Consulting Engineers, Our Balbriggan Active Travel and Transport Consultants, are progressing preliminary work on the town's draft transportation and active travel plan.

DBFL are working closely with Paul Hogarth Company (Masterplanning Consultants) and internal Council departments to ensure coherent, effective, sustainable transformative development. Internal consultations on a draft Public Realm Design Guide to accompany the Public Realm Strategy took place in April.





Tenders for the minor works package at the Harbour are due to for evaluation in May. The works package will focus on developing, upgrading and enhancing the facilities and amenities of the harbour, to make the harbour a more attractive asset for a tourism and leisure and providing growth potential for the indigenous fishing

industry. The Harbour Project will link in with other Public Realm Projects upgrades within the town. Funding of €289,000 for this project was awarded in April by the Department of Agriculture, Food and the Marine.



The Education, Skills and Employment Pillar organised their second annual Our Balbriggan Loves Learning Festival which was a hybrid event this year. The festival took place between April 23rd and April 29<sup>th</sup> and encompassed four elements (a) Learning for Work (b) Learning for Employment (c) Learning in the Community and (d) Digital Learning and kicked off with a Maker Day held in Balbriggan Library Building, the free event was open to visitors both young and old. A Loves Learning Festival section can be accessed www.balbriggan.ie/loveslearning and will provide information on all events.

FINGAL LOCAL COMMUNITY DEVELOPMENT COMMITTEE



The Fingal LCDC continues to oversee and administer the key areas of LEADER and SICAP and the various Local Development and Community Development funding programmes under its remit. The LCDC also manages the Healthy Ireland Initiative, the Community Resilience Fund and the Social Enterprise Grants Scheme.



# FINGAL LOCAL ECONOMIC COMMUNITY PLAN 2022-27

The Guidelines for preparing new LECPs have been published by the Department of Rural and Community Development. The new Fingal LECP will be a 'Whole-of-Council Plan' and will involve extensive consultation and engagement with internal and external stakeholders. Introductory seminars on the statutory role, consultation process and suggested thematic areas to be addressed in the new LECP are currently being held online and recordings of these can be viewed on the Department of Rural & Community Development's website.

The Fingal LCDC was delighted to learn during April that it's application for funding under the DRCD Dormant Accounts Funded National Pilot Scheme for Participation and Engagement by Marginalised and Disadvantaged Communities in the Local Economic and Community Planning (LECP) Process was selected. The project for the LGBT Community in Fingal will develop resources to assist engagement and participation in the new LECP Process. The purpose of the pilot programmes nationally are to identify and share methodologies to support the inclusion of those most marginalised in decision making processes at all levels. This is identified as a strategic action in Sustainable, Inclusive and Empowered Communities, the five year strategy to support the community and voluntary sector in Ireland, and supports Ireland's commitment to Agenda 2030 for Sustainable Development and the principle of "Leave no one behind".

The project will seek to determine the best ways to engage with the LGBT Community in order to support their input into the LECP planning process. Four Local Authority areas were selected to participate in the pilot projects, where Local Community Development Committees (LCDCs), in collaboration with local participation structures, such as the Public Participation Network (PPN), and local and national advocacy groups, will, with appropriate expertise and support, develop and use engagement strategies to assist in working towards meaningful participation in the LECP process. Each selected pilot project will be provided with a support budget to cover support costs locally (up to €40,000) and will be expected to participate in information events as part of the overall project activities. The application in Fingal was a collaboration between the Fingal LCDC, the Council's Community Office, the PPN Office and the LGBT Community.



### **COMMUNITY ACTIVITIES FUND**

The Fingal LCDC has been allocated €301,000 to distribute to qualifying community and voluntary groups. The Community Activities Fund supports groups, particularly in disadvantaged areas with running costs and small capital items and facilities improvements. This funding is about giving a helping hand to communities, local groups and clubs. This new fund is being administered by the Fingal LCDC and closed for applications on February 18<sup>th</sup> 2022.

All completed applications were evaluated by the LCDC Evaluation Committee and 111 groups have been approved for Capital funding of €117,000 A further 101 groups have been approved for Current funding (Non-Pay) of €184,000 for use towards running/operating costs

All successful and unsuccessful applicants are currently being contacted by the LCDC.

### **SICAP**



The 2022 Fingal SICAP Programme has seen a considerable increase in budget to €1.39 million for 2022.

The resources and staff of the Fingal SICAP Programme have been leveraged to assist with the emerging Ukrainian Refugee Crisis. The SICAP Programme will continue to help where required in the response to this crisis and is a central

resource to the work of the Ukrainian Refugee Community Response Forum.

### **LEADER PROGRAMME**



The Dublin Rural LEADER Local Action Group and the Dublin Rural LEADER Programme continues to deliver funding and support to eligible projects in the administrative areas of Fingal, Dun Laoghaire Rathdown and South Dublin.

The updated 2021/22 Transitional Funding Arrangements for the LEADER Programme has the Dublin Rural LEADER LAG approved for €1,882,175 to cover both projects funding and administration funding for the period April 2021 - December 2022. Of this amount, €1,411,631 is available for LEADER Project Applications under the categories of Rural Enterprise, Social Inclusion and Rural Environment. Historically, Fingal Projects comprise 65-70% of the total LEADER Projects approved, roughly corresponding to Fingal's share of the Dublin Rural LEADER Geographical Area.

The LEADER Programme reverted on the 1st April 2021 to EU Transition Rules for the period 2021-22 with a new Dublin Rural LEADER Local Development Strategy to be prepared and put in place for 2023 onwards. Under the Transitional Arrangements the Dublin Rural LEADER LAG and LEADER Programme will continue to be funded by the Department of Rural and Community Development under the same eligibility and LEADER implementation rules as before. LEADER continues to approve and fund new projects as usual.

Under the 2021/22 Transition Programme:

Total number of projects approved to date is 19 with a value of €896,422
The remaining Budget for the Transition Programme is €577,052

### Under the Thematic Areas:

Theme 1: Economic, Enterprise & Job Creation to date has 4 Projects with a value of €154,046

Theme 2: Social Inclusion has 10 Projects with a value of €438,908

Theme 3: Rural Environment has 3 Projects with a value of €158.454

EURI (European Union Recovery Instrument) has 2 Projects (Environmental) with a Value of €145,025



### **ENTERPRISE CENTRES**

Fingal's Enterprise Centres continue to participate in ConnectedHubs.ie .

ConnectedHubs.ie is a one-stop-shop for remote working hubs throughout Ireland.

All three Enterprise Centres have space available start-up businesses and businesses who wish to avail of remote working options and facilities. Bespoke options or generic office fit-outs can be considered.

Occupancy rates at the Council's three enterprise centres at the end of April were Drinan 86%, BASE 94% and Beat 88%. The three Enterprise Centres currently support 65 businesses and over 320 direct jobs.

Both Drinan and BASE submitted applications during April for funding under the recent DRCD Connected Hubs Call for Proposals. The applications centred around building upgrades in the areas of renewable energy, vehicle charging points and I.T. infrastructure upgrades.





### LOCAL ENTERPRISE OFFICE FINGAL



LEO Fingal provides a broad suite of support services to stimulate enterprise and enable small businesses to succeed. Some of the LEO highlights for April 2022 are as follows:

### **New Fingal Business Briefing**



LEO Fingal is pleased to announce the launch of a new series of "in-person" Business Support Briefings, to take place on the First Friday of each month throughout the Summer period. The lunchtime briefing will be run at the Riasc Centre, Kinsealy, from 12.00pm to 1.30pm, and is geared at Fingal based business owner/managers and residents that aim to start a new business. A series of speakers will outline up-to-date information on supports that are available to SMEs in Fingal, including how to access grants/financial incentives, management development training, mentoring, and networking opportunities.

### **Trading Online Voucher Scheme**



An initiative under the Government's National Digital Strategy, the TOV scheme continues to support small businesses by allowing them to enhance their online offering by providing a grant of up to €2,500 for ecommerce and digital marketing activities. The next Trading Online Voucher seminar hosted by Fingal Local Enterprise Office will take place at the Riasc Centre, Drinan, Swords on Friday 13th May 2022. Following very successful webinars over the past two years this is our first in-person event and we look forward to seeing everyone there. 51 applications have been approved in 2022, in the amount of 72,860.

### **Fingal Enterprising Women Network**



The Fingal Enterprising Women Network (FEWN) continues to provide learning and networking opportunities for women in business and enterprise. Preparations have commenced for the summer networking event will take place on June 9<sup>th</sup>. Membership of the network is free of charge and we continue to welcome new members over the course of 2022.

### **Food Starter**



LEO Fingal is leading the latest Dublin regional 'Food Starter" Programme which commenced on the 25<sup>th</sup> of April, with sixteen food businesses participating, of which four are from Fingal. The food starter programme is a short, intensive programme designed to help those with a food idea or those at an early stage of starting up a food business (typically the first 24 months).

### **Evaluation and Approvals Committee**

The April Evaluation and Approvals Committee (EVAC) meeting took place on Wednesday the 27th of April. Five applications were approved for €85,000 worth of funding. Year to date, 14 applications have been approved for €303,625 worth of funding. The next Evaluation and Approvals Committee (EVAC) meeting will take place on Wednesday the 25th of May.

### **Business Advice Clinics and Mentoring**

Business Advice Clinics and mentoring services continue to be offered online. In April 2022, 8 Business Advice Clinic days were held, offering advice and support to 70 clients in Fingal. In addition, clients are continuing to receive one to one business mentoring with our panel of mentors and 138 Fingal clients have received this mentoring to date in 2022.

### **Management Development & Training**

LEO Fingal is continuing to provide a series of management development initiatives and workshops to assist the growth of small businesses throughout 2022. Some of the courses and programmes on offer throughout May include Fingal Business Briefing, Bring your Business Idea to Life, Creating Video Content for social media and Lean for Micro informational. Start Your Own Business In-Person Training recommences in May and will be delivered from the LEO Training room.

### **Microfinance Ireland Loans**

LEO Fingal provides a loan scheme through its partnership with Microfinance Ireland, with "soft" loans of up to €25,000. LEO Fingal is actively promoting the availability of loans from businesses that have difficulty raising finance from their bank. Four applications have been processed, assessed and submitted to MFI in 2022.

### **Student Enterprise Programme**



Fingal's Student Entrepreneurs from Coláiste Pobail Setanta put their innovative product on display in Blanchardstown Centre following their success at the Fingal Student Enterprise Programme County Final. Over 1000 students from 24 schools from across Fingal participated in the annual programme locally. Finalists from Coláiste Pobail Setanta and Loreto Balbriggan will now compete against approximately 80 student enterprises from all over the country for a place in the Top 15 shortlisted teams to make it to a live event on Wednesday 18th May at The Helix in Dublin.

### **Balbriggan/Swords Area**

### **Pollinator Planting - Ardgillan Demesne**

Additional Pollinator Planting areas at Ardgillan Demesne are starting to appear and are well worth a visit. This is an area of approximately 1500m2

planted at the front of the castle in curved arcs to allow views within the planting at different angles.



## Playground Refurbishment - St Catherine's Estate Rush

Initial site works have commenced for the long-awaited playground refurbishment at St Catherine's Estate Rush. This project is being funded by the Fingal County Council 2022-2024 Capital Budget at a cost of €100,000 plus an additional €15,000 from DCEDIY funding from the Department of Children Equality Disability Integration and Youth.





Additional Playground Equipment - The Glebe Park Balrothery

Additional Playground equipment including a Trim Trail and Zip Wire was added to Glebe Park Playground in Balrothery. This additional equipment was partly funded via the DCEDIY funding from the Department of Children Equality Disability Integration and Youth.





### **Constructed Tree Pits - Church Street Skerries**

The contract commenced during March to install four additional constructed tree pits on Church Street Skerries. These new plantings replace trees removed during 2019 & 2020. This recent contract will bring to it a total of seven newly installed constructed tree pits on Church Street Skerries.



### **Ardgillan Demesne - Boundary Wall**

As part of improvement works to the Playground at Ardgillan Demesne the retaining wall has been faced with cut stone to replace the original wooden cladding that was installed in 2006 when the playground was opened.



Newbridge Farm - Additional Public Toilets at Newbridge farm

As part of improvement works to Newbridge Farm and additional toilet building is being added to the central farm area to cater for groups and families picnicking nearby. Visitor Numbers have been steadily increasing in this popular tourist attraction and improvements to the infrastructure reflects this increase in demand.



Santry Demesne - Parkland and Walled Garden

As part of improvement works to Santry Demesne some recently planted pollinator areas within the walled garden are starting to really show their colours. Additional path improvement works within the walled garden and the main parkland will commence shortly. The fantastic Santry Demesne Community Garden committee also recently held gardening classes that were hugely popular and well attended.





The Public Lighting Section will continue with the LED Programme in 2022 with 92.8% of all lights switched to LEDS.




## **Road Opening Licences:**


The Licensing unit continues to process and manage the licensing system for the County,

applications are allocated by area for examination and conditioning which includes reviews of the existing carriageway, footpaths, cycleways, and grass verges. Applicants submit temporary traffic management plans for review to ensure all works are carried out safely within the public domain. Road Opening Licences are a cross functional process for the department and are essential for the asset management of Fingal County Council Road network.

#### 99 licences were granted as of 22/04/2022.







**T1 Application:** The T1 is not a licence. It is notification of intent to perform works of high impact due to extent or complexity.

**T2 Applications:** An application to carry out works of moderate impact due to the location, extent, amount, or duration of the work.

**T3 Applications**: An application to carry out works of low impact due to the location, extent, amount, or duration of the work. A T3 licence requires a short application period and does not require a works programme notification.

**T4 Applications:** A notification of emergency works (as defined under legislation). Notification must occur at the time or as soon as possible after commencement and works must be carried out during a limited time period.

#### **Ongoing Projects**

There are currently a number of significant road opening licence projects ongoing including under the supervision of the Operations Engineering Team.

#### **Water and Wastewater Connections**

There are 67 applications with Fingal as of 20th April 2022, this consists of 42 drainage connection applications as per the Irish Water System Maximo.

The back log of 105 applications in January 2022 has now been reduced to 67 live applications at the end of April.

# Storm Water (surface water) Network - Operations

Operation and maintenance of the stormwater network is ongoing, in line with Covid-19 restrictions.

#### **Works summary:**

- Phase 1 works to install a section of new Stormwater (surface water) Network in Ballyboughal is completed. These works were carried out in conjunction with FCC's Housing Department. Phase 2 works which require the laying of a 450mm section across private land are still on hold pending the agreement of wayleaves.
- The Stormwater manhole cover and frame replacement programme for replacing assets at the end of life is ongoing – Covers and frames were replaced in the following locations: Portmarnock & Lusk.
- Funding is being procured for a property flood alleviation project in The Bawn & Old Bawn in Malahide. Currently a tender is being drafted for a detailed design. It is hoped that construction works on this new network will take place in late 2022. Contributions towards the works have been received from a local development company and have been assigned to the relevant project code.
- CCTV surveys were carried out in the Carrick Hill estate in Portmarnock, Bath Road Malahide, Rusheeny Park Clonsilla and Hamilton Place in Balbriggan. A number of issues with root ingress, concrete rubble, displaced and partially collapsed sections were uncovered. These reports are now being analysed to identify the most cost-effective means of repairing these issues.

- A contractor is being procured to jet and drag the last section of a slow-moving pipeline in Inbhir Ide in Malahide. This jetting and dragging will remove any remaining debris and complete this section of works to help alleviate any future flooding.
- Survey works are ongoing along Burrow Beach in Sutton to access the condition of the existing line and the possibility to lowering the height of some manhole cover and frames.
- Recently completed works include the installation of 30m of Stormwater diversion in the Admiral Park estate in Baldoyle. This will resolve a long-standing issue with flooding in the roadway and the green areas of the estate.
- Works to jet, drag and CCTV survey the Stormwater network in Chalfont, Malahide to assist road operations with the alleviation of ongoing road flooding are now complete. A partial collapse was identified and works to repair this collapse are being costed for tender.
- CCTV surveys were carried out in Heather Walk and Carrickhill Rise in Portmarnock to identify the cause of slow flows. Large root ingress and partial collapses were identified. A contractor is being procured to provide a quote for the repairs including robotic cutting and Part Liner installation. In some locations an open dig will need to be performed to remove the damaged sections and replace the failed pipes.
- The Stormwater preventative maintenance cycle is ongoing for 2022. It has been set up to record and map the condition of the Stormwater network in a number of estates in the Fingal area. A contractor was procured with a jet vac recycler truck and CCTV camera van. Hire started in early February initially on a 4 week hire. A number of estates were identified, and work began in Portmarnock Hill/Rise in Portmarnock. The objective of this work is to undertake maintenance in jetting the network, and to identify any deficiencies within the network, to provide a CCTV survey and log and report the condition of the lines and the associated manholes.

- Circa 5000m of lines and 101 manholes were surveyed in February. Following on from surveys carried out in these estates a number of structural defects were identified within the network and manhole system. A report is being compiled to recommend what remedial works are required. From this report a number of job lots were created to identify how best to proceed and complete the necessary repairs. FCC Water Services staff are currently working on 25 manholes requiring immediate works that were identified. Work has also started to remove roots, repair manhole benching and replace damaged cover and frames.
- The next section of our Stormwater network preventative maintenance cycle commenced on the 4th of April starting with the Cardy Rock and Hamilton Place estates in Balbriggan. To date 4000m of lines have been surveyed and recorded and 65 manhole reports have been created.



## **Planning Applications**

There have been 348 planning applications received to the end of March 2022, 28 of these applications were invalid leaving a total of 320 valid applications. The volume of applications received by Local Electoral Area (LEA) is detailed in the table below.

Between January and end March 2022, 3 Strategic Housing Development (SHD) applications were made to An Bord Pleanála totalling 761 units. 1 decision was made by the board up to end of March 2022. This application was Refused in March. There is a total of 7 SHD's (3,195 units) currently in the formal application process.



#### **Planning Decisions**

A total of 290 planning decisions have been made to the end of March 2022. There have been 242 decisions to grant permission (83%) and 48 refusals of permission (17%). There have been 21 grants of permissions in respect of single house construction, 144 grants of permission for domestic extensions, 60 commercial/retail grants of permission and 7 grants of permission in

respect of housing developments of which 5 relate to development of 2 - 20, 1 relates to 20 – 50 and 1 relates to 50 -100.


#### **Building Control Admin**

In March 2022, there were 116 Building Control submissions made. This was made up of 55 Commencement Notices, 26 Compliance of Completion Certificates, 22 Fire Safety related Certificates and 13 Disability Access related Certificates.

Commencement Notices and Compliance on Completion Certificates can only be submitted through the Projects module on BCMS.

Fire Safety, Disability Access, Regularisation and Dispensation/Relaxation Certificate applications can be submitted online via the Applications module on BCMS and we are also still accepting hard copy applications directly into the office. Most applications are now being submitted via the online system.

In March 2022 the Building Control Admin team processed 97 decisions relating to Fire Safety and Disability Access Certificates.

**Draft Fingal Development Plan 2023 - 2029** 



The Draft Fingal Development Plan was published on 24<sup>th</sup> February. The public consultation will run until the 12<sup>th</sup> of May and during that time the document is available for download from the <a href="https://www.fingal.ie/development-plan">https://www.fingal.ie/development-plan</a> website and can be inspected at Fingal County Council's offices in Swords and Blanchardstown or any branch of Fingal Libraries.

The Council is seeking to encourage public debate among citizens, businesses, community groups and other interested parties on the Draft Development Plan and online submissions can made by citizens and organisations between now and May 12th on Fingal County Council's Consultation Portal, <a href="https://www.consult.fingal.ie">www.consult.fingal.ie</a>

A webinar was held online on 22<sup>nd</sup> March, followed by four drop-in events at different locations across the County. These events were attended by staff from the Planning and Strategic Infrastructure Department who were available to address queries.

The Development Plan process has been running for almost a year and the final plan is scheduled to be adopted by Councillors in February 2023. Last year Council officials set out the strategic direction for the Plan with the publication of an Issues Paper which attracted 551 no. submissions. This then formed the framework into which objectives and policies for the Chief Executive's Draft Plan were created.

#### **Sustainable Swords**

Work continues on the Sustainable Swords project. The ambition of Sustainable Swords is to create a multi-faceted approach to the planning, design and management of the town, in order to achieve better quality places as the physical setting for life in Swords. Sustainable Swords plans to consolidate and strengthen the historic town centre of Swords. The project will also set specific objectives for the town centre with the goal of increasing the resilience of the local economy and fostering an enhanced, accessible, inclusive, child friendly and healthy urban environment.

A second stage of consultation took place in October 2021. This follows the 'Your Swords, Your Say' survey which was carried out in May and the briefing session with Elected Members in July.

The publication of the draft Strategy and the third round of consultation is expected to take place in Q2 of this year.



**Vacant Site Register** 

There are currently 10 sites on the Vacant Sites Register (VSR). These include 3 no. residential sites and 7 no. regeneration sites.

The Women of Fingal Tapestry created by artist Agnieszka 'Uisce' Jakubczyk which captures aspects of Fingal's women throughout the ages - from finds uncovered on the Drumanagh excavations to revolutionary women - was launched in Rush Library by Mayor of Fingal Cllr Seána Ó Rodaigh.

Funded by Creative Ireland the tapestry forms part of the Women of Fingal theme for the Heritage Plan implementation, which focuses on putting women's experience back into heritage. The Tapestry is currently available to view in the Chapel of Swords Castle.

# Porterstown Park All-Weather Running Track and Sport Pitch Facility

On 4<sup>th</sup> April, work commenced on the site of the new All-Weather Running Track and Sports Pitch facility at Porterstown Park. The launch of the works was attended by Deputy Mayor Daniel Whooley and Dublin West TD and Minister for Sport Jack Chambers alongside local Councillors and community groups who will benefit from the new sporting facilities. Significant earthworks are ongoing, following a topsoil strip, earth grading to the exact levels required using laser guided technology is taking place. (*Pictured is the west curve of the running track taking shape*). The next steps over the coming weeks include drainage



installation and the importation of stone to form the base layer of the synthetic surfaces of the running track and pitch. To date significant stakeholder engagement has kept park users, local sports groups and clubs well informed and the Council's Parks and Green Infrastructure Division will continue to liaise as required going forward. It is anticipated that the facility will be complete by Q1 of next year and will become a valuable state of the art sporting amenity for the people of Dublin 15 and the wider area.



# Bremore Castle Boundary Works, Bells Lane, Balbriggan

The significant upgrade works to the boundary of Bremore Castle have been recently completed. The feature boundary works encompassed Bells Lane, the surrounds of Bells Cottage and at the entrance to Bremore Castle car park. The works, managed by the Parks and Green Infrastructure Division, have achieved an aesthetic in keeping with the status of Bremore Castle as a Jewel in the crown of Fingal County and have set the standard for the boundary treatments of the ongoing development of Bremore Regional Park. The upgrade consists of the installation of granite-capped, limestone stub walls and piers, with solid bar railings and gates; the undergrounding of the existing telecoms line running to the Castle from the R132; and providing for the future installation of both fibre-optic telecoms and public lighting through the installation of requisite ducting.



## **Flood Risk Assessments/ Drainage Strategies**

FCC staff continue liaising with the appointed consultants developing the Strategic Flood Risk Assessment for the upcoming County

Development Plan. The SFRA DRAFT flood mapping and DRAFT report has been completed. This mapping and report will be updated over the coming months subject to new information (Tolka flood study) and submissions received from Councillors/public.



A new document "Nature-based Solutions to the Management of Rainwater and Surface Water Runoff in Urban Areas -Water Sensitive Urban Design - Best Practice Interim Guidance Document" has been issued by the Department of Housing, Local Government and Heritage. It is intended as a high-level best practice interim guidance document for all those whose work impacts on the urban environment, for urban planners and all built environment professionals involved in the planning process such as engineers, architects and landscape architects and shows how to move towards a more systematic and sustainable approach to urban planning and design that seeks to mimic the natural water balance of rural areas through "water sensitive urban design".



 Sustainable Drainage System (SuDS) – The Fingal SuDS guidance document (Green/Blue Infrastructure for Development) has been reviewed to include changes in technical standards. This document along with the Draft SFRA documents have been incorporated into the new development plan.

## **Taking in Charge**

- "The Hawthorns" in Castleknock and Cnoc Dubh in Ballyboughal were Taken in Charge in the April Council Meeting.
- Phase 1 Taking in Charge works on the following estates - Chieftain's Way, Martello, New Haven Bay are currently underway and nearing completion.
- Phase 2 Taking in Charge works Drynam, are still under construction. There is also works almost complete in Thornleigh Swords by a completion contractor on behalf of the bondsman.
- There was one tenderer for the appointment of consulting engineers for managing the Taking in Charge works in Ongar which closed on 8<sup>th</sup> March 2022. The successful tenderer has been appointed and a kick off meeting is due to start with the tenderer in the first week of May.
- Dargans Way has been priced by Direct Labour and construction works will start shortly.
- There are currently 57 developers set up on our "External Taking in Charge SharePoint Site" to upload Taking in Charge documentation. The Architect's Department have also uploaded Taking in Charge information for Racecourse Estate in Lusk and Ladyswell Crescent in Mulhuddart to the "Taking in Charge Internal Sharepoint" site.

#### **Dangerous Structures**

 We currently have 55 active dangerous structures. There was 1 new notification in March and none so far in April.

## **Harry Reynolds Road**

The Harry Reynolds Road is now at approval stage with the NTA and subject to this approval will be going forward for tender in June.


Procurement of the main contractor to carry out this project will take place with tender assessment and appointment in Q3 and Q4 respectively, with a view to works commencing on site in early 2023.

### **Snugborough Interchange Upgrade Project**



Bridge Central Piers, Columns and the central pier head beam were completed in April and following four nights of road closures on the N3, bridge beams were positioned in place to form the main bridge structure over the N3 motorway, a most significant phase of this project. Works have commenced on the underpass under the Snugborough Road, with excavations taking place in April in advance of the precast units being installed in May. Construction of walls and columns continued through April to support the bridge crossing of the River Tolka. The website www.snugboroughinterchange.ie containing information on the project is now live and will continue to be updated with information relating to the project over its life term.





## **Hole in the Wall Road Junction Upgrade**

The Hole in the Wall Road Junction Upgrade project, which was officially opened last December, has been nominated for an Irish Construction Excellence (ICE) Award.

The ICE Awards recognise performance excellence for the contracting sector in Ireland. The judging panel consists of 18 respected industry experts from various construction disciplines.

The judging process includes an Interview Stage with Q&A to quiz nominees on their projects in line with best international professional competition

practice. The winners will be announced in May 2022.



## **Donabate Pedestrian Bridge**

The Donabate Pedestrian Bridge project will see construction of a new footbridge over the Dublin-Belfast Railway Line, thereby facilitating a safe cycling and pedestrian route that will connect development lands on either side of the railway with Donabate Village and Newbridge Demesne. The project has progressed through the initial planning and design stages and discussions with Irish Rail regarding technical approval for placing the bridge into service above the railway are at an advanced stage. Upon conclusion of these discussions, tender documents to appoint a contractor to construct the bridge will be finalised and issued to shortlisted construction companies.

## **Church Fields Link Road**

Fox Building and Civil Engineering have established the site offices and compound for the project, fencing has been installed to the perimeter of the lands and earthworks for the link road phase of the project is well underway.



## **Sutton to Malahide Pedestrian & Cycle Route**

The Project Team are currently undertaking a 6 week non statutory public consultation on the scheme preliminary design. The consultation period commenced on the 24th March and concludes on the 9th May. The consultation is being run to help the project team complete and develop the preliminary design in advance of a submission to An Bord Pleanála undertaken 2023. Consultation and documentation published includes:



**Local Authority Home Loan** 


There were a total of 1,473 home loan applications received by Fingal County Council (FCC) since the introduction of the Rebuilding Ireland Home Loan (RIHL) now known as the Local Authority Home Loan (LAHL). Any applicant normally resident anywhere in the state can apply for a mortgage under the scheme.

Of the 1,473 applications received, 911(62%) were received from addresses within Fingal and 562 (38%) were received from outside of Fingal.


The first chart below shows the breakdown of these applications within Fingal Local Electoral Areas, showing Swords to be the highest source of applications to date.

## **Energy Efficiency/Retrofitting Programme**

In 2021 the allocated target of retrofitting 65 properties to a B2 standard was achieved. The 2022 target allocation for Fingal County Council to retrofit to a B2/Cost Optimal standard has been determined by the DHLGH at 81 units and the submission is awaiting approval. It is envisaged that works should commence by the end of May and tenants will be notified in advance outlining the level of works required.

The new online portal to facilitate the Choice Based Letting (CBL) scheme has proven efficient with staff and applicants. CBL is an approach used for the allocation of designated Social Housing Units. It allows housing applicants to express an interest in being considered for the allocation of designated Social Housing Units.

Applicants with active applications can access Choice Based Letting by logging onto https://cbl.fingal.ie using their unique username and password. To access their unique username and password applicants must contact choicebasedlettings@fingal.ie with their housing reference number and phone number. The housing team has issued over 1,200 secure passwords and usernames to date. Applicants are actively encouraged to obtain their passwords and usernames to express interest in any properties advertised.

Approved Social Housing applicants log in each week to check the dwellings that are available using their username and password.

Applicants are continued to be encouraged to obtain their username & password. To date 1654 passwords have been sent since the CBL portal opened (08/12/2021) of which 217 have been issued during the month of April.



#### **Homeless Services**

The Council's Homeless Team continue to engage with those experiencing homelessness to offer advice and support. Homeless Assessments continued to be carried out.

In April 2022 there were 44 new homeless presentations, comprising 15 families and 29 singles/couples.




#### **Homeless Exits**

During April 2022, 13 households, exited homeless circumstances into various forms of social housing

support - including into private rented tenancies under Homeless HAP.

Homeless HAP accounts for 12 of these tenancies.



## **Rough Sleeper Count - Spring 2022.**

The rough sleeper count takes place bi-annually (Spring & Autumn/Winter) to measure the level of street homelessness in the Dublin Region. Since 2020 the count has taken place over a full week, during which the Dublin Simon Outreach Team engage a full regional assessment of the people met sleeping rough, or at risk of sleeping rough.

The rough sleeper count for Spring 2022 was conducted between 28<sup>th</sup> March and 3<sup>rd</sup> April.

During the count week, there were 2 individuals found rough sleeping in the administrative area of Fingal County Council.

At present the Homeless Section are aware of 4 rough sleepers in the county of Fingal at the moment. 2 are in the Malahide area, 1 in the Howth area and 1 in Dublin 15. Of these 4 individuals,

none currently have a Social Housing Application with Fingal County Council.

As with all reports of rough sleeping in the Fingal area Homeless Services are closely linked in with our own Housing Inspectors, the Outreach Team, the Dublin Region Homeless Executive and other support services to provide assistance and advice to these individuals.

#### **Draft Homeless Action Plan 2022- 2024**

The DRHE is currently preparing the Draft Homeless Action Plan Framework for Dublin 2022-2024.

This Plan is the first plan to be put into operation since Ireland signed the Lisbon Declaration on combatting homelessness in June 2021, which aims to end homelessness by 2030.

It will follow on from the previous Homeless Action Plan for 2019- 2021 and continues with the three key themes of **Prevention**, **Protection and Progression**.

The Plan is being developed as a result of a detailed consultative process including submissions from various Stakeholders, interested organisations, Service Providers, Members of SPCs of the four Local Authorities, the Dublin Joint Homelessness Consultative Forum and the Statutory Management Group.

#### **Those Fleeing the Conflict in Ukraine**

The Government is committed to delivering a humanitarian response to welcome people fleeing

the conflict in Ukraine and seeking protection in Ireland.

Please note that if a situation arises where an immediate humanitarian response is required, Local Authorities are asked to use discretion and provide Emergency Accommodation (EA) and in this instance FCC will refer the case to IPAS.

# Traveller Accommodation Plan Traveller Accommodation

A programme of works in relation to the refurbishment and upgrading of existing accommodation on specific sites is currently in development with the County Architect for further progression in 2022. Refurbishment work is planned for a number of sites in accordance with the Traveller Accommodation Programme 2019-2024. A review of the TAP is ongoing.

Daily site visits by Housing Inspectors continue on all Fingal County Council Traveller specific sites while checking on vulnerable residents and advising on the continued supports available. Senior Officials are engaged on an ongoing basis with residents and liaise with various external agencies and traveller advocacy groups as required.

Housing and Community Department staff are currently working collaboratively with colleagues from the Libraries Department on a Traveller creative engagement project which we hope to initiate next month at one of our Group Housing Schemes with a view to extending the project to other sites later in the Summer and continue into next year.

#### **Housing Welfare Service**

The Social Workers attached to the Housing Department are available to support vulnerable tenancies and to work with housing applicants who have medical/welfare needs.

The Estate Management Section continues to work with the most vulnerable and complex of our Tenants in collaboration with our Social Workers, Tenancy Sustainment Officers and external statutory agencies to protect and assist the most vulnerable of our tenancies.

## **Boiler Servicing Programme**

The Council provides an annual boiler servicing facility, including all maintenance and upgrade works, for a nominal fee of €3 per week to participating tenants. The Council releases batches of work to dedicated Contractors throughout the course of the year. Contractors are progressing the 2022 works programme with 5 batches totaling 1,217 properties been issued so far incorporating following areas: Whitestown Sheepmoor Estate, Corduff Estate, Greenridge, Abbeylea, Ballygarra, Clonmethan Green, Earnan's Wood, Drynam Avenue, Lambeecher, Cardy Rock, Longstone Park, Glasmore Park, Seaview Park, Strandmill Road.

#### **Anti-Social Behaviour/Inspectorate Unit**

The ongoing management and sustainment of social Tenancies and good estate management falls within the remit of the ASB/Inspectorate Unit. Alleged breaches of Tenancy Agreements are investigated and pursued in accordance with housing legislation and policy.

There are occasions when the vulnerabilities, complexities and heath related issues associated with a tenancy require tenancy sustainment and welfare intervention and supports. Ongoing case management and review with a variety of external agencies, including Approved Housing Bodies, An Garda Síochána, TUSLA and the HSE may be

required to ensure all agencies work collaboratively with a view to achieving best outcomes for our Communities. This work is ongoing in relation to a number of Tenancies in the county.





#### RACECOURSE COMMON, LUSK UPDATE

The Community Department have been working with Racecourse Green and Park since October 2021 to assist with the development of a youth sports programme which led up to the successful family day in November. The Community Department continue to build capacity of this group and the third meeting of Racecourse Common Residents Association took place on 28th April in the Cottage Community Centre. A very successful clean-up day took place on Saturday 23rd April and great support was received from

young and old who came out to participate in the event. A big thank you is also extended the Lusk Tidy Towns, Lusk Community Council and Cllr. Rob O'Donoghue who also supported the efforts on the day. We are looking forward to tackling the landscaped areas on the next clean.





## **Planet Youth Research Project**

The Mayor in the company of An Taoiseach Micheál Martin, recently launched the research findings of the Planet Youth project. This project is led by the North Dublin Regional Drugs Taskforce and is an Icelandic research model which has been very successful in Galway, Mayo and Roscommon. This data captured in December 2021 from thousands of 3<sup>rd</sup>, 4<sup>th</sup> & 5<sup>th</sup> year students will be crucial to the future service planning. The data also presents interesting data on what life as a teenager is currently like, with questions from e-cigarettes & drink consumption to whether there is enough to do or if they wish to migrate to another county.

This data was captured during the pandemic and it will be interesting to compare the results when the research is carried out again in two years' time. The North County Community Development Unit will continue to support the Samh groups with the next steps using this information for change.







## **Thrive Balbriggan**

On the 7<sup>th</sup> of April 2022 the Community Office in association with Thrive Balbriggan and Mental Health Ireland supported the local community in Balbriggan to come together for 'Hello, how are you' day.

Thrive Balbriggan is a mental health movement which involves communities, services and agencies working together collaboratively and in a coproductive way to generate ideas. It aims to build understanding and awareness of mental health

and well-being in order to create a mental health friendly community for all.

The event began with the group handing out conversation cards in Balbriggan. Flemington Community Centre hosted an information forum with tea and conversations asking each other in a meaningful way 'Hello, how are Conversation Cards and support services were handed out through the day and were translated into several languages including Ukrainian which can be accessed through the Flemington and Castleland community centre website. Empower led a 'Hello, how are you' walk and talk with community and there was a gathering in the square where the Mayor of Fingal spoke words of inspiration. There was presence in Balbriggan of the Thrive Group promoting the campaign throughout the day including a showcase from Men's Shed and Ardgillan College Choir performing for the community in the Square. The day ended with the Balbriggan Gospel Choir preforming in the Millfield Shopping Centre



## **Ukrainian Solidarity Group**

On the 24<sup>th</sup> of April (Ukrainian Easter) the Ukrainian Solidarity Group met in Flemington Community Centre. People were encouraged to come along and bring Easter Baskets. With support of the Community and Sports Hub in Balbriggan, the Ukrainian Solidarity group have been meeting to plan activities, develop contacts, discuss group options for activities to support integration of Ukrainians into the Community.



# Fingal Community Partner WRAP Programme

The Community Development Office are delighted to announce that the Fingal Community Partner WRAP programme will commence in Fortlawn on the 7th and 14th of May. This programme will train over 10 community partners to become facilitators of WRAP (Wellness Action Recovery Plan) and will result in the roll out of multiple wellbeing programmes around Dublin 15 over the coming months.

## **Accredited Cambridge English Classes**

The Community Office in partnership with Mountview Community Centre are organising Cambridge Accredited English Classes in May. A placement test for the Classes will take place on Thursday the 28th of April. Full classes start on the 16th of May in Mountview Community Centre. These classes will target members of the community that need to progress from local Failte Isteach/Conversational English classes. This an

excellent opportunity for people to improve the English language proficiency and receive an internationally recognised certificate.

## **Mountview Community and Sports Hub**

The Mountview Community and Sports Hub is expanding its supports and services to the local community. D15 Community Drugs team will offer a drop-in information and advice service from the 25<sup>th</sup> of May. The DDLETB will provide a free Career Guidance and employment support service on the first Wednesday of every month starting on the 04<sup>th</sup> of May. The hub is also continuing to host Cultúr Migrant Centre that has a drop-in and free advice and supports around English language and upskilling courses for migrants. The Tyrrelstown Community and Sports Hub hosted a Financial Wellbeing Talk on the 26<sup>th</sup> April with Aileen Morrissey, a financial wellbeing coach from Bank of Ireland.



In addition, Blanchardstown Adult Education Service will hold clinics on the last Wednesday of the month for the next 3 months. These clinics will provide a space to discuss career, employment and education options with a Guidance Counsellor The community and sport hub are also open to any new or emerging groups and the Community officer is available to meet groups looking to establish themselves and find out information on supports and services offered by the Community Development Office.

Saolta delivered a Global Citizen Education Workshop focusing on the essential function and importance of embedding and implementing these principals as well as the United Nations Sustainable Development Goals within the County Development Plans. The workshop was designed to enlighten participants about the purpose, function, and broader societal meaning of GCE and the SDGs. It also highlighted why they are a crucial roadmap to follow to ensure that our environment, our society, and our economy are future proofed for the generations to come through a clear understanding and activation of meaningful and sustainable practices and policies. This workshop took place online on Wednesday 13th April from 7-9pm.

#### **UKRAINIAN REST CENTRE**

The Fingal Liam Rodgers Centre was identified as a suitable rest centre for Ukrainian Refugees. The Facility has now been assigned as a designated rest centre. The day-to-day management of the rest centre is overseen by the Civil Defence and supported by the staff team at Liam Rodgers who are working daily to ensure that adequate supports are put in place. Other community centres across Fingal are also developing ways to provide Ukrainian people with additional activities such as English language classes, yoga etc. The

local community at Drynan has rallied around and are bringing in additional supplies to those remaining at the rest centre. The numbers vary from day to day and the centre has the capacity to facilitate 70 people. The Community Development Office has set up a response working group who are looking at developing additional ways to support Ukrainian people in Fingal.

# NEW COMMUNITY FACILITIES INVESTMENT FUND

Minister Humphreys has announced details of a New €15M Community Centre Fund. This new funding scheme is open to all community led facilities who are either owned or managed under a management licence by local community groups and organisations. The Community Development Office will work very closely with facilities from across the county to support them with their applications. This fund will be invaluable in supporting community centres to carry out essential emergency repairs and support centres to become more accessible.

#### FINGAL OPC ANNUAL CONFERENCE

On the 24<sup>th</sup> May 2022 Fingal's Older Peoples Council (OPC) will host an Older Persons Conference with 100 participants in the Marine Hotel, Sutton. Attendees to the conference are guaranteed to go away with lots of tips and information about aging well as specialist speakers will present on entitlements, decisions making supports and information on how to remain living at home as you age. A technical expert will also attend on the day to demonstrate practical tips on the use of technology.

#### **Intergenerational Practice Masterclass**





Integration Practice "aims to bring people together in purposeful, mutually beneficial activities which promote greater understanding and respect between generations and contributes to building more cohesive communities" (Beth Johnson Foundation, 2011).

Fingal County Council hosted a masterclass on Intergenerational Practice on Thursday 7<sup>th</sup> April 2022 in the Hilton Airport Hotel, Dublin. The event was a collaboration between the Community Development Office and Fingal's Community Facilities Network.

Although Fingal's Community Facilities Network holds regular masterclasses for members, due to interest in the topic among organisations who collaborate on initiatives with Fingal County Council, invitations were extended to these organisations. Over 60 participants working in services as diverse as youth work, family support services, addiction services, community centres, day centres, sports facilities, childcare services, active age groups and Fingal County Council sports, community and integration offices were in attendance.

The masterclass was opened by Robert Burns, Director of Services, Housing and Community, Dr. Carmel Gallagher and Dr. Anne Fitzpatrick presented on the principles and benefits of intergenerational practice. Case studies on intergenerational practice in the early years sector were presented by Ms. Rachael Duff and Ms. Breege McGinty. Ms. Vicki Titterington, Director, Linking Generations Northern Ireland provided

practical advice on developing intergenerational projects.

Roundtable discussions allowed participants the opportunity to discuss projects, identify potential partners and provide feedback. Following feedback and a question-and-answer session which addressed opportunities and challenges, the proceedings closed. While an evaluation has yet to be completed, the feedback has been overwhelmingly positive.

# Cricket4All: Intergenerational Multiability Cricket Project



Following a successful application for funding from the Department Children, Equality, Disability, Integration and Youth an intergenerational multiability cricket project commenced in March with the appointment by Cricket Leinster of a part-time project coordinator. The project is taking place in Balbriggan and Skerries and taster sessions have taken place to encourage participation among older people and young people with disabilities.

A taster session took place in Flemington Community Centre with participants from Prosper Fingal, St. Michael's House, and the Irish Wheelchair Association with positive feedback from staff and carers. Three coaches from Balbriggan Cricket Club assisted coaching at a taster session for 32 participants from Remember Us. The taster session included a mix of fielding games, batting drills and table cricket and highlighted an unforeseen issue with the balls being used which has now been resolved. Full coaching sessions for these groups will commence in Flemington Community Centre in May. A taster session in St. Michael's House Primary School in Skerries has resulted in an eight-week coaching course taking place each Friday in the school commencing Friday 29th April 2022.

A table cricket leaders' course held in Flemington Community Centre helped establish a base of local people to assist in the project. As the cricket season begins, the recruitment of older people in both Balbriggan and The Hills Cricket Clubs has begun with older club members indicating their interest in being involved in the project.

#### **Women For A Better World Workshops**

The Fingal Integration Team have collaborated with AkiDwA to present four workshops titled "Women For A Better World" which shares the UN's 17 Sustainable Development Goals and promotes discussion among women from near and far on the following topics Advancing Gender Equality Globally, Equality and Human Rights in Ireland, Connecting Sustainable Goals to our everyday lives

and experiences and Re-imaging our future -developing a manifesto for change. The four workshops will take place on 26<sup>th</sup> April 3<sup>rd</sup>, May 10<sup>th</sup> and 17 May in Blakestown Resource Centre.

#### **Active Travel**

#### **Strategic Planning**

Fingal County Council has prepared a draft Active Travel Strategy. This was presented to the SPC in April and councillors were briefed on the draft strategy thereafter. The non-statutory public consultation commenced following those briefings and will run until the 23rd of May 2022. The public can find the draft strategy through the online consultation portal at <a href="https://consult.fingal.ie">https://consult.fingal.ie</a> and can make a submission or register to attend one of the 2 webinars. Interviews with strategic external stakeholders are ongoing.

#### **Cycle Protected Lanes**

# Baldoyle-Howth Protected Cycle Lane Scheme Phase 1

Upgrade works are continuing at Baldoyle Road/Dublin Road junction. Civil works have been completed on all arms along with ducting work for the new traffic signal equipment. Resurfacing works are ongoing this week at the junction. Works will continue regarding traffic signal upgrades. Works ongoing on snags for Grange Road and

Warrenhouse Road. Snags completed on Howth Road.







## **Towns & Village**

Works are ongoing in the development of a brief for a number of our Towns & Villages. A brief is being developed by our Active Travel Team for Balrothery Village to look at the scope of works required to be delivered under our Active Travel pillars.

Work is also ongoing to develop a Brief for Skerries Active Travel Plan in order to Procure and Engage with a multi-disciplinary Engineering Consultant to carry out this study. We have engaged with the ESRI in order to get their input regarding Behavioural Change, Commercial and Socioeconomic factors. They are currently reviewing the draft brief to provide feedback and comment in advance of going out to the procurement of a consultant.

#### **Connectivity/Permeability**

We are continuing to receive various requests for Permeability and Connectivity improvements from various stakeholders across the county. These requests are being recorded in detail for evaluation and if appropriate identification of a means of delivery on the ground.

Where other project being progressed in the area at either design or construction stage; we endeavour to include these Connectivity and Permeability improvements within those projects.

Some of the requests that have been received and evaluated are included in a brief that has been prepared and is gone out to the market to engage a consultant to develop these projects through Options report and concept design initially. This will allow the projects to be developed to detailed design for implementation. Once these are further developed, we will make available to the members.

Greenway connectivity support teams have been convened to review, design, and deliver active travel infrastructure that will enhance accessibility between the proposed strategic greenways and residential, educational, amenity and commercial zones. These support projects have been set up for Fingal Coastal Way, Broadmeadow Way/Sutton to Malahide Greenway and Royal Canal Greenway. This will help to optimise the use of the proposed greenway by both leisure and commuter users.

The Road Safety Officer and Team will review the Governments recently published Road Safety Strategy and commence to prepare a local Road Safety Plan for Fingal to try and reduce the number of fatalities on our roads and work towards the Governments targets to reduce fatalities and serious injuries by a minimum of 50% by 2030 and works towards 'Vision Zero' for 2050.



#### Bike Week 2022

Fingal Bike Week 2022 will take place this year from Saturday 14<sup>th</sup> May to Sunday 22<sup>nd</sup> May and is coordinated by Fingal County Council's Active Travel Section who have organised a range of virtual, staff and public events which will take place at various locations across Fingal and has something for all ages.

Virtual events include Self-led family cycles using maps prepared by the Team of suitable family cycle locations, "Pedal for your Medal", Bling your Bike Competition and #CycleThere photo competition. Other events include an all-inclusive cycle event with Prosper Fingal in Malahide Demesne, BMX bike tracks for local schools, transition year cycle in Balbriggan, Spin and Swim event in Velvet Strand, Adult Cycle Training, Cycling without Age launch and much more. Staff events include guided and self-guided lunchtime cycles from Blanchardstown and Swords offices and we are encouraging staff to participate and catch up with their colleagues while also enjoying the outdoors and getting some exercise. Bike week

will culminate with a flagship, family fun cycling event to be held in Malahide Demesne on Sunday 22<sup>nd</sup> May.

#### **Cycle Study Tour Copenhagen**

In April, a number of staff from the Active Travel Team together with Senior Management, Cllrs, and members of **Planning** the & Strategic Infrastructure Department and Operations Department embarked on an educational and eyeopening cycle study tour in Copenhagen to research some of the Cycling & Walking Infrastructure and Public Realm enhancements that have been introduced there over the years.

The Study Tour included informative and thought-provoking presentations by Gehl Architects, a leading architectural company in sustainable infrastructure, Cycling without Age founder Ole Krassow, City of Copenhagen officials, Smart Mobility at Ramboll, Danish Cycling Embassy and much more. We cycled approximately 50km over the two days in some really harsh, cold, wet and snowy weather – "when in Rome, do as the Romans"!

While the Infrastructure, active lifestyle culture and behaviour towards walking and cycling is well ahead of where we are currently at in Ireland, everybody took something from the trip and identified with some small and large element of change that will help build the blocks of what can be achieved here in Fingal on our Active Travel Journey. The trip was well received by everybody and has opened our minds and understanding of what can be achieved if we all work together.





#### **Climate Action**

Fingal's Climate Action Section have partnered with Skerries Tidy Towns and The Conscious Cup Campaign <a href="https://www.consciouscup.ie">www.consciouscup.ie</a> on a Skerries based pilot campaign which runs between 21<sup>st</sup> and 28<sup>th</sup> April and aims to promote reusables and encourage a move away from single use disposable cups.

In Ireland, 22,000 single use cups are wasted every hour, the combination of plastic and paper in their design making them virtually non-recyclable. In an effort to reduce this waste, 14 cafés and businesses in Skerries have signed up to the Reusable Cup Campaign. They are actively displaying campaign posters at their premises and

are promoting the fact that they accept reusable cups on their social media. Some businesses have branded and unbranded reusable cups to sell instore and are displaying Conscious Cup Campaign posters provided by the Council. The Council supported the event with prizes and promotional material and the participating cafés came together to produce a promotional video to raise awareness on social media.



In April a visit to the glass recycling in Naas Co Kildare was conducted by staff from the ECCAT Department.

Fingal County Council manage the Regional Glass Collection and Recycling Contract on behalf of the 4 Dublin Local Authorities.

A detailed tour of the factory was undertaken showing the full process of how the glass in broken down into small pieces that are required to make into new glass bottles. All products are recycled as far as possible i.e., sand from the process is sent on to factories for recycling, as are metal and plastic which are bailed on site, the whole process striving towards zero waste. The contractor gave a background to the company and what they do and how they process the glass, which is then transported to Fermanagh to be turned into glass bottle once again. This was an example of the circular economy being brought from start to finish on the island of Ireland

Income from dog licences have increased by €3,400 from March.

The Department will continue to advertise the requirement for dog owners to hold a licence for their dogs on social media platforms.



#### **Dog Warden Service**

The dog wardens continue to patrol the County and issue 10 Day Notices to dog owners who do

not have dog licences. This is followed up with a fine if the licence has not been purchased and produced within 10 days of the notice being issued. House calls to check for dog licences in April took place in Castleknock, Dublin 15. An additional two dog wardens will take up duty in May for the Summer. Door to door licence checks will increase during these months and additional patrols will be carried out on beaches and in parks by the new wardens.

In April,  $26 \times 10$  day notices and 26 fines were issued.

#### **The Dog Shelter Service**

The dog shelter holds "Meet & Greet" visits for those looking to rehome a dog. Visits can be arranged, by appointment only, from Monday – Friday, 10am until 4pm and on Saturday from 11am and 1pm



The dog shelter holds stray dogs picked up by the dog warden and dogs who have been surrendered by their owners. At the beginning of the month there were 8 dogs in the shelter. During April, 9 dogs were found straying and 1 dog was surrendered.

Of these 18 dogs, 9 have been rehomed through rescue centres or to members of the public and 9 dogs have been reclaimed by their owners. 4 dogs remain in the shelter at the end of April.

#### **Dog Fouling**

There was one fine issued in April relating to dog fouling. The issue of dog fouling continues to be an issue in Fingal. Comms have scheduled anti dog fouling posts on social media platforms to highlight the issue and remind dog owners to be responsible and clean up after their dogs.



#### **Abandoned Cars**

The Abandoned Cars Pilot scheme is continuing. Final notices were issued in April for 4 cars which resulted in 2 being removed by the owners and 2 being removed by the Council.

#### **Water Quality Protection**

#### **Bathing Water**

The EPA have published the bathing water classifications for the 2022 Season on their website www.beaches.ie. The classification is based on water quality data for the previous four years (2018-2021). The full EPA report is due to be published in early May.

Within Fingal one beach has improved in rating and one has declined. A temporary "All season - advice not to swim" notice will be in place again at Front Beach Balbriggan for the 2022 bathing season. A Management Plan for the beach at Front Strand, Balbriggan has been approved by the EPA and will be available on the Fingal website. #### **Winter Swimming Survey**

The survey was designed to find out more information about where, when and why people are swimming during winter to help inform potential options for helping to protect winter swimmers' health. ## <u>Nature-Based Solutions to Rainwater</u> <u>Management</u>

The Department of Housing, Local Government and Heritage have published a best practice interim guidance document 'Nature-based Solutions to the Management of Rainwater and Surface Water Runoff in Urban Areas;

The guidance outlines how to move towards a more systematic and sustainable approach to urban planning through water sensitive urban design.

#### **Nitrates Action Programme**

Irelands Fifth Nitrates Action programme (NAP) 2022-2025 has been published with the objective of protecting water quality from agricultural pollution and to promote good farming practices. An overview of new measures since the fourth action programme can be found here https://www.gov.ie/en/publication/f1d01-fifthnitrates-action-programme-2022-2025/. Ireland's new Nitrates Directive includes a longer closed period for spreading both chemical and organic fertiliser, a 10% reduction in the chemical fertiliser limit applied nationally, and a stronger focus on compliance and enforcement. The new EU Fertiliser Products Regulation will also come into effect on 16 July 2022, laying down rules on the making available on the market of EU fertilising products.

# PhD proposal presented to Climate Action, Biodiversity and Environment Strategic Policy Committee

An investigation of monitoring strategies for assessment of water quality pressures at Balbriggan was undertaken with Professor Fiona Regan, DCU Water Institute which resulted in the drafting of a PhD proposal for a Smart bathing water monitoring programme using novel technologies available. This work was a follow up from a motion for 'daily testing' at Balbriggan bathing water raised by Cllr. Ann Graves at a 2021 County Council meeting to engage MESTECH/DCU and their 'rapid testing' device entitled 'Colisense'. The proposal was presented to the SPC on 29<sup>th</sup> March, 2022 and the Committee requested that the proposal be sent to the Environmental Protection Agency (EPA) to seek a formal support of the project.

#### **Waste Enforcement & Regulation**

#### **Self Compliers under Packaging Regulations**

Under the European Union (Packaging) Regulations 2014, Major Producers of packaging (i.e. companies having an annual turnover in excess of €1 million and placing more than 10 tonnes of packaging annually on the market) have to either join a compliance scheme (Repak) or register with the Local Authorities. In 2022, 15 companies have applied to register with Fingal County Council and so far 12 have been registered, with the remaining 3 having their registration pending (due to some elements of their application outstanding).





Self-complying companies have to accept packaging back from the public and their customers, the same type of packaging as the packaging they are placing on the market. The types of packaging accepted and location where packaging can be returned is advertised on our website and is detailed below:

#### **Waste Complaints**

**Anti-Dumping Initiative 2022** 

The Department of the Environment, Climate and Communications has made funding available, through the Waste Enforcement Regional Lead Authorities (WERLA's), to support the 2022 Anti-Dumping Initiative (ADI). Since the launch of this initiative in 2017, over 1,300 projects have been successfully delivered across all 31 local authority areas. This ADI initiative has served to ensure that illegal dumping remains high on the agenda for communities across the country and that the

appropriate supports and interventions are available to combat the problem.

The Waste Enforcement Section have submitted 5 applications for funding under the AD1 2022 totalling €150,000. The projects focus on a variety of matters including Illegal Dumping and Fly-Tipping, the Waste Presentation Bye-Laws, Clean Up Operations, CCTV monitoring, Drone Training, an initiative to increase collaboration with Community Gardai at a number of key blackspot

dumping areas. If grant funding is secured the projects will commence in June 2022.
