ROADS ACT 1993 TO 2023 - SECTION 75 PROPOSED TEMPORARY ROAD CLOSURE.

An application has been made by Fingal County Council's Operations Department for the temporary road closure of Redfern Avenue, Portmarnock, Co. Dublin.

The purpose of this closure is to facilitate road resurfacing works along the public road as part of the 2025 Programme of Works.

The period of the proposed temporary closure will be from 9:00am to 5:30pm each day beginning Monday 18th of August to Friday 29th of August 2025.

The closure will be from the junction with Blackwood Lane/Carrickhill Upper Hill/ Redfern Avenue to the junction of Redfern Avenue/Briar Walk. Traffic management will be in place along with traffic marshals along the proposed diversion route. The proposed diversion route is as follows:

Eastbound Traffic: Vehicles travelling along Blackwood Lane approaching the Redfern Avenue/Blackwood Lane/Carrickhill Upper Road junction will have to turn left onto Onward Walk and continue onto Limetree Avenue. Traffic then must turn right onto Briar Walk and continue onto the Wendell Avenue junction before turning left onto Wendell Avenue to continue on their journey.

Westbound Traffic: Vehicles traveling on Wendell Avenue will have to turn right onto Briar Walk and then turn left onto Limetree Avenue and continue along onto Onward Walk, Traffic then must turn right at the Onward Walk/Blackwood Lane/ Carrickhill Road Upper junction to continue their journey.

Fingal County Council's Road section is liaising with Dublin Bus on the closure and diversion impact.

Local access will be provided for residents and pedestrians along the length of the closure.
