PROPOSED AMENDMENT TO THE ROAD TRAFFIC (SPECIAL SPEED LIMITS)

(COUNTY OF FINGAL) BYE-LAWS 2020 – L-1171, MOYLARAGH ROAD FROM

JUNCTION AT THE PARK/CASTLEMILL LINK ROAD AND THE JUNCTION AT

HARRY REYNOLDS ROAD

Fingal County Council hereby gives notice of proposed amendment to Road Traffic (Special Speed Limits) (County of Fingal) Bye-Laws 2020 Moylaragh Road (L-1171) between junction of Moylaragh Park/Castlemill Link Road and the roundabout junction Moylaragh Road/Moylaragh Park.

In accordance with Section 9 of the Road Traffic Act 2004, and in the interest of road safety, the Proposed Amendments to the 'Road Traffic (Special Speed Limits) County of Fingal Bye-Laws 2020' have been prepared as follows:

It is proposed to decrease the Speed Limit on the road as described below (from coordinates (ITM) - Point A 718758 E, 763928 N to coordinates (ITM) - Point B 719215 E, 763998 N – which equates to a length of 462 metres) speed limit of 50km/h amended to 30km/h –Refer to Drawing Number SSL_BRLS_001 Moylaragh Rd Balbriggan.

This proposal to decrease the Speed Limit on this section of road is based on the following criteria:

• A speed limit appeal submission was submitted to Fingal County Council to examine the existing speed limit on Moylaragh Road, Balbriggan.

- Current speed limit is 50 km/h.
- Road was examined against Setting and Managing Speed Limits in Ireland Guidelines (2015).
- Result of examination outlined that a reduction in speed limit was merited as set out against the criteria in the guidelines.
