PROPOSED TEMPORARY ROAD CLOSURE OF CASTLEKNOCK ROAD, COLLEGE ROAD, WHITES ROAD TO FACILITATE THE ROUTE OF DUBLIN HALF-MARATHON RACE.

An application has been received by Marathon Event Management Dac Race Series Ltd for permission to temporarily close the following roads **Castleknock Road, College Road, Whites Road**. The closure is necessary to facilitate the route of the Dublin Half-Marathon Road Race to be held on **Sunday 21st of September 2025 from 8am to 1pm**.

The dates/times for road closure is:

Road/Street Name: Castleknock Road from Phoenix Park to junction with College Road. Hours Closed: From 8:30 am to 9:45 am

Road/Street Name: College Road to Junction with Whites Road.

Hours Closed: From 8:30 am to 9:45 am

Road/Street Name: Whites Road from Tower Road to Phoenix Park.

Hours Closed: From 8:30 am to 9:45 am

Alternative routes available for vehicular traffic are as follows:

Diversions:

- For traffic travelling from Dublin City direction, at Ashtown Roundabout continue on N3 and use Auburn Avenue for local access up to the junction with Castleknock Road (closed).
- For access to Castleknock Village continue on N3 to Blanchardstown (The Bell) and travel eastbound along R806 back on Castleknock Road up as far as junction with College Road.
- For traffic travelling from Castleknock direction to Dublin City, travel towards Blanchardstown direction, access N3 at The Bell junction and take N3 in citybound direction.
- Emergency access will be maintained.

Local access will be maintained at all times. Emergency services access will also be made available in the event of an emergency.
