



## **ROADS ACT 1993 TO 2023– SECTION 75**

### **PROPOSED TEMPORARY CLOSURE OF CORRS LANE RUSH CO. DUBLIN**

An application has been received from GMC Utilities Ltd on behalf of Uisce Eireann for permission to temporarily close Corrs Lane Rush Co. Dublin for the purpose of installing a wastewater connection. It is proposed that the road will be **closed on the 30th January 2026** for one day from **08:00 to 20:00**.

#### **Alternative routes available for vehicular traffic are as follows:**

Corrs Lane / Golf Road will be closed from the junction with Sandy Road to the junction with Sundrive Road. Local access will be allowed from both sides.

During the hours of 08:30–09:30 and 14:30–15:30, Channel Road will be closed due to the School Streets programme. The following diversion routes apply during these times:

#### **Traffic travelling west on Sandy Road**

- No left turn onto Corrs Lane / Golf Road.
- No straight access (Channel Road closed).
- Diversion: turn right onto Chapel Green then left onto Whitestown Road turn left onto Healy's Lane then straight onto Daly's Lane then left onto Sundrive Road.

#### **Traffic travelling west on Sundrive Road**

- No right turn onto Corrs Lane / Golf Road.
- Diversion: continue straight turn right onto Daly's Lane then straight onto Healy's Lane turn right onto Whitestown Road then right onto Chapel Green then left onto Sandy Road.

#### **Traffic travelling east on Sundrive Road**

- No left turn onto Corrs Lane / Golf Road.
- Diversion: turn around on Sundrive Road turn right onto Daly's Lane then straight onto Healy's Lane then right onto Whitestown Road turn right onto Chapel Green then turn left onto Sandy Road.

#### **Traffic travelling north on Golf Road**

- No through access onto Corrs Lane / Golf Road.
- Diversion: left onto Sundrive Road turn right onto Daly's Lane then straight onto Healy's Lane turn right onto Whitestown Road then right onto Chapel Green turn left onto Sandy Road.

**Emergency services access will also be made available in the event of an emergency.**
