PEACEPLUS

PEACEPLUS is a funding programme designed to support peace and prosperity across Northern Ireland and the border counties of Ireland.

Aims & Objectives

PEACEPLUS is a cross-border EU funding programme that supports peacebuilding, social cohesion, and economic development in Northern Ireland and the border counties of Ireland (Cavan, Donegal, Leitrim, Louth, Monaghan, and Sligo).

The programme's goal is to build a more prosperous and stable society by:

- strengthening relationships between communities
- tackling long-standing social and economic challenges
- encouraging cross-border collaboration and mutual understanding
- supporting regional stability and sustainable growth

What does it support?

PEACEPLUS funds peace and reconciliation initiatives, as well as cross-border projects that improve economic, social, and environmental wellbeing. All projects must have a cross-community and cross-border collaboration element, and they must be able to demonstrate peace impacts.

Funding is focused on six themes:

1. Building Peaceful and Thriving Communities
2. Delivering Economic Regeneration and Transformation
3. Empowering and Investing in Our Young People
4. Healthy and Inclusive Communities
5. Supporting a Sustainable and Better Connected Future
6. Building and Embedding Partnership and Collaboration

Within each theme there are several investment areas – these have a more specific focus and target specific organisations such as local authorities or community groups.

Who can apply?

The Programme area includes Northern Ireland and the border counties of Ireland, namely Counties Cavan, Donegal, Leitrim, Louth, Monaghan and Sligo.

However, cross border collaboration is not strictly limited to the administrative borders of the Programme but has a flexible geography depending on the topic

concerned. This is called a functional area and allows for organisations and institutions not based in the core Programme area to get involved in projects by linking with partners within the core Programme area.

Budget

A total of €1.1 billion from 2021-2027.

Coimisiún na Meán - Sound & Vision 4

Sound & Vision 4 is a funding scheme for broadcasters and independent producers that funds the production of high-quality programmes about Irish culture, heritage, and experience and programmes to improve adult literacy.

Recent Funding Outcomes

- Rath Dara Community College Music Project – In this three-part series for community radio station, Phoenix FM, listeners follow Transition Year students in a Dublin DEIS school on a music composition journey. With support from professionals, they brainstorm themes and genres, compose, perform, record, mix their music piece and promote their music online.
- Additional €2 million funding secured by the Minister for Tourism, Culture, Arts, Gaeltacht, Sport and Media to support content focusing on the voices of immigrant and new Irish Communities.

Scheme Objectives

The objectives of the Scheme are also derived from the legislation, Section 155, and are as follows:

- Quality: develop high quality programmes based on Irish culture, heritage and experience;
- Irish Language: develop these programmes in the Irish language;
- Additionality: increase the availability of programmes referred to in paragraphs (a) and (b) to audiences in the State;
- Diversity: represent the diversity of Irish culture and heritage;
- Heritage: record oral Irish heritage and aspects of Irish heritage which are disappearing, under threat, or have not been previously recorded; and
- Local & Community Broadcasting: develop local and community broadcasting.

Programme Themes

Programme Themes Sound & Vision 4 offers funding support for the production of new quality television and radio programmes on the following four themes.

These reflect the provisions of the Act and the BAI accepts applications for programmes on either an individual theme or encompassing a number of themes.

(a) Irish culture, heritage and experience

The legislation offers the following examples of programme topics related to these themes and these are outlined below for reference.

- History (including history relating to particular areas, groups or aspects of experience, activity or influence);
- Historical buildings;
- The natural environment;
- Folk, rural and vernacular heritage;
- Traditional and contemporary arts;
- The Irish language; and,
- The Irish experience in European and international contexts.

These are not the only categories of programmes under this theme that can be supported by the Fund. The Authority takes a broad view of Irish culture, heritage and experience and includes all of its contemporary expressions. The statute offers examples of programme themes but applicants to the Fund need not limit their programme proposals to these areas. The ideal outcome for the Fund is one that has a balance between reflections of Ireland's past and its vibrant present.

(b) Adult Literacy or Media Literacy

Programme topics should be focused towards methods of improving adult literacy or media literacy. Adult Literacy is defined as involving speaking, listening, reading, writing, numeracy and using everyday technology to communicate and handle information. Media Literacy is defined in the Act as bringing about a better public understanding of the nature and characteristics of broadcast and related electronic media, the processes by which it is selected and produced, the available access systems and their regulation.

(c) Global issues Programmes which raise public awareness and understanding of global issues impacting on the State and countries other than the State.

(d) Irish Language Programmes under (a), (b) and (c) above in the Irish Language.

Dublin Airport Community Fund

For decades, Dublin Airport has supported community activities across education, literacy, sports and the arts, and through the Community Fund we are continuing this work while extending support to even more local initiatives with over €3.3million to local community initiatives since its launch.

In 2025, Dublin Airport's Community Fund awarded €500,000 to 117 schools, clubs and groups in the local neighbouring communities, many of which Dublin Airport has been the main sponsor for several years.

The Dublin Airport Community Fund annually makes a call for applications and once open, applications are accepted for up to six weeks. Applications made outside of this period will **not** be accepted.

All applications must be submitted via the Community Fund's online portal and forms cannot be accepted as hard copy or by email.

Applications are reviewed and assessed by an independently chaired Grant Making Panel, after which the groups will be contacted to proceed to the payment stage.

The OWW Seed Fund is an exciting opportunity for youth organisations to explore an aspect of the Sustainable Development Goals (SDGs), and to connect your work locally with issues, and events globally. In other words, to connect young people's personal experiences with their community and the wider world.

Project implementation should take place between June 30th – 28th August 2026

Successful applicants will receive a grant of up to €400 and free training with the Youth 2030 expert team to support you in delivering a young person-centred project on issues relating to our global world. This funding is to support projects in the non-formal youth work education sector. Bring your ideas to life!!

Who can apply?

Any group that works within the non-formal youth sector.

Why should I apply?

- Receive a grant of up to €400 to support you deliver a young person-centred project on our global world.
- Participate in a free training (online and/or in-person) with the Youth2030 expert team supporting you to explore critical youth work in your youth organisation. This training will support you to develop your own project idea. As well as build curiosity and confidence to talk about key issues like, the environment, the economy, technology, politics and culture with a group of young people.
- Receive resources to support your work free of charge.
- Benefit from connections, ideas and support from the Youth 2030 team, to support you in getting the most out of your seed grant and bring your ideas to life!

Funding Criteria

- One World Week (OWW) training is required as part of this funding (training is free).
- One World Week (OWW) will take place online and in person in 2026 a blended approach. As part of this grant, you will be expected to attend at least one event for OWW 2026.
- Please use recycled material wherever possible for arts-based activities.

- NYCI will not fund the purchase of any merchandise materials such as T-shirts, baseball caps, etc.
- Applications accepted from the island of Ireland only.

What else do I need to know before I apply?

- Your project can be stand-alone or part of a bigger project.

- Projects should explore themes that have a social justice focus and that has both a local and a global dimension.

The Gum Litter Taskforce (GLT) is a joint initiative between industry and government working to increase awareness of the chewing gum litter issue and to encourage positive behavioural change around gum disposal. Through the national “Bin your gum when you’re done” campaign, the GLT highlights the importance of responsible disposal and supports stronger enforcement of the €150 fine.

Thanks to the continued efforts of communities nationwide, gum litter now accounts for just 7.3% of all litter nationally-the lowest figure to date-with 92% of people reporting that they dispose of their gum correctly.

The GLT would like to reward TidyTowns groups that are delivering environmental awareness initiatives aimed at eliminating chewing gum litter in their area. All-Ireland Pollinator Plan – Local Authority Pollinator Award

Prize Fund €10,000

Sponsored by Heritage Offices & Biodiversity Offices of Local Authorities across Ireland, in partnership with the National Biodiversity Data Centre

Local Authority Pollinator Award aims to encourage TidyTowns groups to implement pollinator-friendly actions in their towns and villages as part of the TidyTowns competition. Wild Irish bees, crucial to the pollination of our plants, trees and vegetables, are in decline – this is because we’ve drastically reduced the areas where they can nest and the amount of food our countryside provides for them. The aim of the award is to reverse this trend by encouraging TidyTowns groups to take simple pollinator-friendly measures in their local area. The Local Authority Pollinator Award supports the All-Ireland Pollinator Plan and is sponsored by the Heritage Offices & Biodiversity Offices of Local Authorities across Ireland.

A prize of €1,000 will be awarded in each of the four regions at Village/Small Town category and at Large Town/Large Urban Centre category. Out of these eight finalists, one overall national winner will receive an additional €1,000. There is also a “Best Newcomer Award” with a prize of €1,000.

Traveller and Roma Local Employment Initiative

The Department of Children, Disability, and Equality (DCDE and/or ‘the Department’) is inviting applications from eligible organisations for funding under the new Traveller and Roma Local Employment Initiative (TRLEI) Pilot Scheme and for the appointment of a national TRLEI Coordinator.

Funding under the TRLEI Pilot Scheme will be allocated for the purpose of providing employment and training support services through TRLEI local offices. The Pilot Scheme is open only to local offices that have not previously received funding under the SIT. Existing local offices receiving funding under the TRLEI will continue to use the existing application process for 2026.

Applicants are permitted to apply for both the role of TRLEI Coordinator as well as funding to provide the services of a TRLEI local office under the TRLEI Pilot Scheme. In the event of a successful application to both the TRLEI Coordinator and the TRLEI local office, the applicant will be duly notified and asked for their preference to be given.

The TRLEI is administered by the Traveller and Roma Policy Unit in DCDE.

Purpose of the Traveller and Roma Local Employment Initiative

The TRLEI, formerly known as the Special Initiative for Travellers (SIT), is an employment support programme targeted at Traveller and Roma communities in Ireland. Previously, the programme only targeted Travellers: however, under the [National Traveller and Roma Inclusion Strategy II 2024 – 2028](#) (‘NTRIS II’), Roma are now included as a target group in each TRLEI location.

The Department provides funding to select organisations around the country to host TRLEI local offices and so provide supports and services to Travellers and Roma in securing and retaining employment, gaining new skills and expertise, and engaging in further education and training.

The objective of the TRLEI Programme is to address the imbalance in Traveller and Roma unemployment by providing effective, locally based training, employment, advocacy and referral pathway supports to individuals from both communities, including by coordinating efforts with other local training and employment services, and by building interlinkages with local Traveller and Roma communities and their representative organisations and with local employers.

The TRLEI Programme contributes to the realisation of the strategic outcome under the employment and enterprise theme of NTRIS II:

“Travellers and Roma have equal access to quality and sustainable employment. Entrepreneurship and self-employment opportunities for Travellers and Roma are

supported. There is a positive and inclusive workplace culture where diversity is valued, and every individual is treated with respect and dignity.”

TRLEI Pilot Scheme

Under the TRLEI Pilot Scheme, the Department intends to fund a further eight local offices across the country to provide employment, enterprise, and training supports and services to Travellers and Roma. The type of services each local office will provide will be determined on a case-by-case basis; however, it is intended that a job coach, support worker, or equivalent will be employed to provide one-to-one employment supports to clients, undertake outreach, advocacy, and referral services, and identify further learning needs and training opportunities.

The choice of locations for the new TRLEI local offices will be informed by the size of the Traveller and Roma populations in the different local areas for which applications are received.

National TRLEI Coordinator

To support the Department in the coordination, governance, and oversight of both the existing TRLEI local offices as well as the local offices selected under the TRLEI Pilot Scheme, the Department will provide funding to an eligible, suitable organisation to act as National TRLEI Coordinator.

The TRLEI Coordinator will operate as the primary point of contact for all TRLEI local offices and will liaise regularly with the Department, as well as relevant stakeholders, to facilitate the improvement of the services provided and the standardisation of the processes used to carry out these services. The TRLEI Coordinator will ensure that issues are identified and responded to efficiently. It will also coordinate the national TRLEI contribution and response to new initiatives that support employment, training, and enterprise development for Travellers and Roma.

Funding Available

Funding period

The funding period for both the TRLEI Pilot Scheme and the TRLEI Coordinator will commence on 1 September 2026 and will conclude on 31 December, for a total operating period of four months.

Applicants should note that the Department proposes that, subject to appropriate funding commitments being secured for 2027 in the Estimates process during the second half of 2026, the scheme will be extended, without the requirement for a new expression of interest process, for a further calendar year covering the period 1 January 2027 to 31 December 2027, with funding provided pro-rata to the 2026 grant amount. This is applicable to both funding streams.

TRLEI Pilot Scheme

The Department expects that any funding allocated to successful applicants under the TRLEI Pilot Scheme will be within the following thresholds for the period outlined above.

- Minimum grant allocation: €20,000.00 per applicant for the period of four months.
- Maximum grant allocation: €30,000.00 per applicant for the period of four months.

TRLEI Coordinator

The Department expects that any funding allocated to the successful applicant for the purposes of providing the services of the TRLEI Coordinator will be within the following thresholds for the period outlined above:

- Minimum grant allocation: €25,000.00 for the period of four months.
- Maximum grant allocation: €35,000.00 for the period of four months.

Movember - Community Men's Health Research Program

Movember is launching the Community Men's Health Research Program, a new multi-million global research funding opportunity across Canada, *Ireland*, the United Kingdom and the United States (California only).

This opportunity is built around a research partnership model—embedding Community Fellows (early-career researchers <5 years post-PhD) directly within community organizations already making a difference.

The focus is simple: generate high-quality, real-world evidence on what works.

Together, we will build a stronger understanding of how to improve the emotional and relational health of boys and young men aged 12–35—in the places they already are.

Grounded in community-based participatory research, the program centers equity, shared power, and lived experience.

It focuses on three core areas of men's health:

- Coping and consumption
- Social connection
- Early fatherhood.

Funding available per annum is USD \$75,000 (plus up to \$26,250 toward related mandatory institutional obligations) and a research support allocation of \$8,000. Community organizations receive USD \$40,000 per year for up to three years. Research must be carried out under the direction of a suitably qualified and experienced supervisor or established research mentorship.

To apply, Community Fellows will need to be partnered with a community organization making a difference with boys and young men aged 12–35.

Competitive applications will demonstrate partnerships with organizations that:

- Are trusted, embedded, and part of the communities they serve
- Are reaching boys and young men who are underserved or face real barriers to engagement
- Deliver support in everyday, non-stigmatizing settings such as youth spaces, education, peer groups, arts-based programs, or psychosocial interventions
- Center lived experience and co-design in how they work
- Value partnership, learning, and working alongside a community

- Can support regular, in-person collaboration throughout the 3-year fellowship.

What is the Community Men’s Health Research Program

Across our focus countries, community organizations are already transforming the lives of boys and young men.

But too often, that work is:

- under-recognized
- under-evidenced
- and invisible to funders and systems

This program changes that!

We are investing in research that sits within communities—not outside them—to generate rigorous, practice-based evidence of what improves boys’ and young men’s emotional and relational health in real world settings.

The goal is not to create new interventions. It’s to understand, strengthen, and evidence what’s already working. That’s exactly why we’re lifting the profile of this vital community work and investing in research that showcases its impact.

What types of community organizations should researchers look to pair with for this funding opportunity?

Movember is seeking to support Community Fellows who have partnered with organizations working directly with boys and younger men aged 12–35—either through an existing relationship or newly established one.

Strong partnerships will involve organizations that:

- are already delivering programs that support boys’ and younger men’s emotional and relational health, including established service providers or research ready grassroots groups delivering funded programs with strong community trust, lived experience led design, and reach into underserved populations
- are delivering research-ready intervention or program(s) in at least one of the core themes below

Community organizations receive an annual contribution to support their capacity to host the Community Fellow, participate in shared learning and evaluation, and engage in a wider community of practice with Movember and other funded partners. The focus is on working alongside existing programs to better understand, strengthen and evidence what is already working.

The three core themes are:

1. Coping and consumption: How younger men cope with stress, trauma and adversity, including the role of alcohol, other drugs, gambling, gaming, pornography and other consumption behaviors, and how these shape help-seeking, relationships and health system use.
2. Social connection: Loneliness, isolation, peer relationships and belonging, including how community settings create trust, identity and pathways into support for men who are otherwise disengaged from services.
3. Early fatherhood and health: The transition to fatherhood as a critical window for men's emotional and relational health, including how services and community support can better reach, support and retain new and expectant fathers.

What is the funding opportunity for researchers?

One Community Fellow will be embedded within each community organization, receiving funding over three years (administered through their host university), mentorship from global experts, and access to world-class learning and development.

Embedded within their partner organization, Community Fellows will design and deliver research to generate high quality, ethical and impactful evidence on how boys' and younger men's emotional and relational health is improved in real world settings

Who can apply for the Request for Application (RFA)?

Curious, open, and ready... to learn, adapt, and evidence what works?

We encourage Community Fellows (early career researchers <5 years post PhD) in Canada, Ireland, the United Kingdom, and the United States (California only) to register their interest in this funding opportunity. There are 16 positions available across four markets (6 in United Kingdom, 6 in Canada, 2 in Ireland, and 2 in California). The full Request for Applications will be published on May 7, 2026.

To apply, you will need to be partnered with a community organization delivering a research ready program or intervention with the following characteristics:

- Has strong local trust and established relationships with boys and/or younger men aged 12–35
- Demonstrates a proven ability to reach boys and/or younger men who are underserved or face real barriers to engagement
- Delivers programs in non-stigmatizing, everyday community settings (e.g., youth spaces, educational settings, peer groups, physical activities, arts-based programs, or psychosocial interventions)
- Uses delivery models grounded in lived experience and co-design

- Aligns with one or more of the following themes related to emotional and/or relational health: coping and consumption, social connection, or early fatherhood
- Has limited formal evaluation or organizational maturity, but shows a strong willingness to learn, adapt, and build evidence
- Is committed to generating stronger evidence on what improves younger men’s emotional and relational health
- Is open to partnership, evaluation, and potential scaling support
- Is located within a reasonable travel distance to enable consistent in-person engagement during the fellowship

Education

Delivery of this project can include the development of new programmes of traditional music education.

Research

It is envisaged that implementation of this project should result in tangible outcome, which may take the form of book/CD publication, lecture recital, journal article, website etc.

Eligibility

To be eligible for Strategic Funding, your organisation must:

- Be formally constituted as either a Company Limited by Guarantee (CLG) or a Designated Activity Company (DAC) or a statutory body.
- Apply in its own name and not in the name of another company or individual
- Have previously successfully applied for Arts Council funding either in the name of your organisation or in the name of a key person involved in the organisation.

Note: Organisations that are not formally constituted as either a CLG or DAC may apply on the understanding that they will commit to formally incorporating as a CLG or DAC if their application is successful.

Royal Irish Academy - Disinformation Research Grant

The RIA is pleased to announce that the RIA Disinformation Research Grant, supported by the Department of Culture, Communications and Sport is now open for applications for the first time.

This new scheme will support nuanced, collaborative research on different aspects of disinformation, involving research across multiple disciplines and networks.

Who can apply

- The grant is open to academic researchers working in higher education institutions (HEI) or research institutes (RI) in Ireland. In each application the lead applicant must be employed by a HEI or RI in Ireland (not including Northern Ireland). See list [here](#).
- Lead applicants must be on open-ended, continuing or fixed term contracts which extend beyond the end of August 2027, which is the end-date of the envisaged grant period. The grant cannot be used to extend an applicant's contract.
- Each application must also include a named partner in an organisation to be:
 - a) a researcher in another discipline/field in a HEI or RI (from the same institution or another eligible HEI or RI)

or

 - b) a staff member of a civil society organisation as defined [here](#).

Criteria

- Proposals are invited for a clearly defined piece of research or research activity with an output. It is expected that the output will be made freely available to the public via an Open Access publication; applicants may provide a note as to why this is not applicable in the context of their research.
- The only expenses payable are the costs directly related to the research being carried out, up to a maximum of €30,000 per project approved. All costs must be supported by evidence of payment (receipts, invoices etc.) upon completion of the project.
- Applications are invited for amounts from €20,000 to €30,000.
- All projects must be completed, and all associated reports and invoices/financial details submitted by the end of August 2027.

Eligible Costs

- Research time: appropriate and recognised salary costs at a daily or hourly rate, excluding on-costs
- Administrative assistance: on a daily or hourly basis, at appropriate and recognised salary costs at an hourly rate
- Research consumables: examples include licenses for archival material or for software that are required for research to be carried out; printed brochures for dissemination events; tea, coffee, lunch for meetings etc.; postage, stationery and photocopying
- Library fees, illustration permissions, copyright fees, photographic services
- Assistance with publication costs (in the form of guarantee against loss or for illustrative material)
- Translation services and transcription of interviews
- Research-related travel: reasonable expenses, using standard class fares (excluding first and business class travel), accommodation, subsistence, visa
- Costs associated with disseminating results arising from the project – through publication or presentation at specialist conferences. Dissemination costs are normally up to a maximum of 10% of the requested budget.

Power to Participate: Strengthening Stakeholder Engagement Fund 2026

Power to Participate: Strengthening Stakeholder Engagement Fund has been established by the Department of Children, Disability and Equality for Disabled Persons' Organisations and Civil Society organisations advocating for disabled people.

The Fund will make €750,000 available to these organisations to strengthen their capacity to engage strategically with the State specifically in relation to the delivery of the National Human Rights Strategy for Disabled People 2025-2030.

The [National Human Rights Strategy for Disabled People 2025-2030](#) launched in September 2025, sets out a whole-of-Government approach to disability. The Strategy is based on five thematic pillars:

1. Inclusive Learning and Education
2. Employment
3. Independent Living and Active Participation in Society
4. Wellbeing and Health
5. Transport and Mobility.

The Strategy supports Ireland to progressively realise the rights of disabled people under the United Nations Convention on the Rights of Persons with Disabilities (UNCRPD).

A key commitment of the Strategy is to establish and embed a robust framework across Government for supporting meaningful and participatory stakeholder engagement with disabled people. Throughout the lifetime of the Strategy there will be a dual focus on building the capacity of both civil and public servants and disability stakeholders.

Under Article 4 (3) of the UNCRPD, the State is required to engage on an ongoing basis with disability stakeholders, including Disabled Persons' Organisations (DPOs) and other representative organisations, in the development and implementation of policy and legislation. Article 33 (3) further requires governments to ensure the full involvement and participation of civil society, in particular persons with disabilities and their representative organisations, in its monitoring process.

Rethink Ireland - Skills for Tomorrow Fund

The Skills for Tomorrow Fund is a €1.5 million, 2.5 year fund supported by Deloitte Ireland and the Department of Rural and Community Development and the Gaeltacht (DRCDG) via the Dormant Accounts fund.

The Skills for Tomorrow Fund aims to support innovative, evidence-based projects that build the capacity of individuals and communities experiencing marginalisation to thrive in the future world of work.

It will fund initiatives that provide practical, accessible and relevant pathways to employment while addressing the root causes of disadvantage and promoting inclusive economic participation.

There are two strands to the fund: one strand supporting youth-focused projects and another strand supporting adult-focused projects.

We see opportunities for social innovations to achieve greater impact by using artificial intelligence to generate operational efficiencies and to embrace data-driven decision making. This fund will also support awardees to explore and optimise their use of artificial intelligence to extend and maximise their impact.

The fund offers a package of cash grants and non-financial supports over 2.5 years for up to five projects, to help them expand and increase their social impact.

This includes:

- A cash grant between €150,000 to €187,500 for each awarded project
- A non-financial supports package per project including:
- A place on Rethink Ireland's Accelerator Programme
- Bespoke business and capacity-building supports designed in consultation with the successful projects on topics such as strategic planning, maximising your impact, communications, storytelling and fundraising.
- Access to Rethink Ireland's networks.

* The Rethink Ireland Board will decide how much money to award, which may be less than the amount requested. The final amount of the award will depend on how many organisations are selected.

Údarás na Gaeltachta - Pilot Support Scheme – Gaeltacht Tourism

Údarás na Gaeltachta has designed a new grant scheme (pilot) to support the tourism sector in the Gaeltacht. Funding of €350,000 has been approved for the pilot phase. Grants of up to €50,000 are available, with rates of 50% or 75%, depending on the business category.

The aim of the scheme is to support tourism development in the Gaeltacht through targeted investment in high standard tourism products based on the language and unique culture of the Gaeltacht. The aims are to:

1. Showcase the Irish language — its everyday use and progression — as a central pillar of the tourism projects.
2. Create year round employment opportunities, reducing dependency on seasonal work.
3. Develop shoulder season products & services to extend the tourism season.
4. Enable partnerships and synergies by connecting with existing tourism offerings.
5. Encourage innovation in products, services and/or marketing.
6. Foster co-operation between private enterprise and community groups.

Eligibility Criteria

Category A – Private Enterprise (Grant Rate 50%):

- Micro, small & medium enterprises (SMEs) located in Gaeltacht areas or in Language Planning Areas
- Businesses with less than 250 employees and an annual turnover of less than €50m.
- Businesses registered with the Revenue Commissioners.
- Business operating for 6 months minimum.

Category B – Community Organisations (Grant Rate 75%):

- Community groups, co-operatives and non-profit organisations located in Gaeltacht areas or Language Planning Areas.
- Organisations registered as a Company Limited by Guarantee (CLG) or as a co-operative.
- Organisations with a governance structure.

- Commercially focused social enterprise in the Gaeltacht.

The Environment

An Ghaeltacht Ghlas, sustainable development of the green economy in the Gaeltacht regions, is one of the primary objectives set out in Údarás na Gaeltachta's Strategic Plan. There is an increasing and significant focus on environmental matters, encompassing climate change and long-term sustainability. Projects that align with these objectives will be welcomed.

Irish Language & the Linguistic Landscape

Údarás na Gaeltachta believes that the Irish language is the unique selling point of the Gaeltacht. Even if the visitor does not speak or understand Irish, they should have a chance to hear and get a feel for the language. To the millions of Irish that learned Gaeilge but never got the opportunity to use it outside of school, tourism in the Gaeltacht gives an excellent opportunity for businesses to offer it. There are many other Gaeltacht traditions that can be shared with the visitor, giving them an unforgettable cultural experience. Whatever business or project you have, explain how you intend to implement the language into your project.

Projects should contribute to the linguistic landscape of the Gaeltacht through the visible and audible use of the language.

Successful applicants under this scheme must outline how Gaeilge is incorporated into their project. On completion of the project, an assessment will be made of the Irish language actions as outlined the application. Failure to fulfil planned actions may have an impact on payment.

Successful applicants will be able to seek advice and help from the language Planning Executive in the Údarás regarding how incorporate Irish into their project. Workshops and info sessions will be available in relation to the use of Irish for marketing and sales.

The application must display:

1. How will the project incorporate and promote the use of Irish
2. Clear objectives relating to team training in Irish and the use of Irish

3. Measures to offer Irish language services to visitors
4. Signage and materials to be in Irish only or bilingual (Irish first)
5. Irish to be visibly on display on any public material and on any community or marketing material.

They support the creation, presentation and mediation of the arts across a range of artforms and arts practices. They support professional, collaborative, voluntary and amateur arts practice.

Recipients of Arts Centres Partnership Funding play a critical part in delivering the policy priorities of [Making Great Art Work](#), the Arts Council's ten-year strategy.

What are the aims and objectives of Arts Centres Partnership Funding?

In offering Arts Centres Partnership Funding, the Arts Council wishes to ensure:

- The year-round production and dissemination of arts activities, events and services of the highest quality throughout the country
- That audiences are engaged by the provision of a diverse range of high-quality arts experiences.
- That artists are supported in their professional practice
- That audiences, artists and participants reflect the diversity of contemporary Ireland
- Increased depth of engagement by and with the public
- High standards in governance and management.

In accordance with its [Policy and Strategy for Arts Centres](#), the Arts Council wishes to encourage arts centres to engage with and further develop supports for artists locally throughout the country. Examples of this might be by:

- Apply in its own name, and not in the name of another company or individual.

What types of activities will be supported through Arts Centres Partnership Funding?

Arts Centres Partnership Funding is intended to support activities that your organisation undertakes to realise your mission and related operating costs.

Note: Include any activities that were previously supported through separate funding schemes. For example:

- Residencies
- Artist-development initiatives
- Resource sharing
- Young ensembles
- Touring and dissemination of work in 2026.

Arts Centres Partnership Funding may not be used for the purchase of capital items.

The Community Centres Investment Fund is the largest ever capital investment in Community Centres. It provides funding for investments in Community Centres in order that these vital services remain useable, accessible, and safe and continue to meet the needs of the community into the future.

This capital fund of €25 million is providing funding for the improvement and refurbishment of existing community centres in both urban and rural areas.

Funding is being made available under 2 Categories, with grants of between €10,000 and €100,000 available:

Building Blocks Extension Grant Scheme

Minister for Children, Disability and Equality Norma Foley has announced the opening of a €10 million capital funding scheme to deliver a significant number of additional early learning and childcare places.

The Building Blocks Extension Scheme Phase 2 will provide grants for community and private early learning and childcare services who are Core Funding partner services to increase their capacity by means of extensions to their existing premises.

Community providers can apply for a capital grant of between €100,000 and €530,000 to extend their existing premises. Private providers can apply for a capital grant of between €50,000 and €265,000 to extend their existing premises.

All projects will be required to deliver net increases in full-time places for one to three-year-olds. Projects will also be required to incorporate Universal Design Guidelines.

The scheme is open to Core Funding Partner Services that:

- will offer additional full-time places for the 1–3-year-old (pre-ECCE) age-cohort;
- part-time services, sessional services and school age childcare services that are willing to extend their operations to provide full time places for the 1-3-year-old (pre-ECCE) age-cohort;
- will commit to opening for a minimum of 46 weeks per year, five days per week and 8 hours per day.

There are two strands to the Scheme, as follows:

Community strand:

- Community providers can apply for a capital grant of between €100,000 (minimum) and €530,000 (maximum) to extend their existing premises.
- Match funding is not a requirement.
- Project values between €100,000 and €680,000 will be eligible.
- Any additional project costs between €530,000 and €680,000 must be funded by the provider.

Private strand:

- Private providers can apply for a capital grant of between €50,000 (minimum) and €265,000 (maximum) to extend their existing premises.

- Match funding will be required.
- Project values between €100,000 and €680,000 will be eligible.
- Any additional project costs between €530,000 and €680,000 must be funded by the provider.

Eligible projects are limited to physical extensions to existing premises. This may include the physical extension of an existing premises or the installation of a modular building.

All proposed projects must adhere to the Early Years Services Regulations 2016 and must incorporate Universal Design Guidelines for Early Learning and Care Settings (UDG).

The closing date for applications is 31 July 2026. This will ensure that all applicants have sufficient time to engage with their design teams and their solicitors prior to the closing date. The outcome of the appraisal process will be communicated to services in September 2026.

Successful applicants can commence their projects after 1 January 2027 and all projects must be completed by 31 December 2027.
