This leaflet is a guide to Fingal County Council's rent assessment and collection.

Rent is based on the income source of each member of the household **over 18*** years of age. This is known and referred to as assessable income.

How is Rent Calculated at our properties?

We calculate rent for each household member over 18 on 14.5% of their assessable income.

Assessable income is Net income. That is Gross income minus TAX, PRSI and USC. This is then divided by the number of weeks worked in current job and/or the number of weeks receiving social welfare payments.

The highest earner is the **principal earner** their rent is calculated at 14.5% of their income/ earnings (this is not necessarily the tenant). There is no rent cap on the rent amount charged.

Subsidiary earners are all other persons over 18, who have an income in the household or who are entitled to an income. Their rent is also calculated at 14.5% but capped at a €60 charge per week.

A charge for your gas boiler maintenance and management fee will be applied weekly.

Reductions may apply if members of the household take part in the following schemes/courses:

Community Employment scheme: If a tenant/occupant is on a Community Employment scheme, we will reduce their income to their social welfare payment for a maximum of 3 years, after which time their employment income will be applied in full.

Full time education courses: Students in full time education, who are not the tenant(s) (No age restriction) can earn up to €17,000 per annum (Employment detail summary for proof) before they become liable to pay rent in their own right. A letter from the relevant college confirming their attendance at full time education is required annually. Student income exceeding €17,000 is assessable for rent.

The parent of the student will have the qualified child charge incorporated into their rent charge.

Apprenticeship: If undertaking an apprenticeship, Fingal will assess you on your social welfare "age equivalent rate" payment unless the income from the apprenticeship exceeds €17,000. Like that of a student, income exceeding €17,000 is assessable for rent.

To ensure a fair differential rent charge per tenancy, Fingal County Council calculates and applies a minimum rent charge to all households based on all members living there.

This calculation is comprised of what you would be entitled to receive from the Department of Social Protection, irrespective of whether the person is claiming the payment or not.

How often will my income be assessed for rent ?

Your household income will be assessed at least once every two years based on the information we request from you. It is important that you send all evidence of employment income when required as this will affect the amount you will be charged for your rent and no changes will be made to this in the two years following your assessment .

We will accept a permanent change of income (permanent meaning it will apply to you for more than 6 months).

What do I need to do as a tenant?

- Pay rent on time and in full, as per your tenancy agreement.
- Return Rent Assessment Form and required documents in full when requested
- Reply to any correspondence/contact from our office.

Contact the rent assessment team when there is **permanent** change to your household circumstances (of more than 6 months). Examples include but are not restricted to:

- A new job or loss of job.
- Change in your Social protection payment or end of payment.
- If someone moves into your property following permission received from the Council.
- If someone moves out of your property (inform Rents with documented proof).
- Births, Marriages, or Deaths.

When is rent due?

Rent is due to be paid weekly. If you wish to pay monthly rent must be paid in advance. Call 01 8905000 for assistance from a member in the rent account management team.

Rent is applied the Saturday after the date you sign your tenancy agreement and every Saturday thereafter.

How can rent be paid?

- It is policy that where appropriate, the tenant(s) must sign a Direct Debit / Standing Order / Household Budget deduction form in respect of the payment of rent.
- Payment through the Council's **Cash Payments** Office at Blanchardstown or Swords.
- By **Telephone** on **01 8905000** using your Visa, Mastercard or Revolut between 9.30 a.m. to 3.30 p.m. (Please quote your Tenancy Account Number beginning with the letter D, R, M, L etc).
- A **Standing Order** deduction through your Bank. Forms available by emailing rents.collection@fingal.ie (Please quote your Tenancy Account Number beginning with the letter D, R, M, L etc).
- Direct payment at the **Post Office** using your Council rent payment card.
- **Household Budget Deduction:** Rent can be deducted weekly at source from certain Social Welfare payments. Forms are available from An Post or rents.collection@fingal.ie.
- **Postpoint:** Rent can be paid through local shops, petrol stations etc where you see the Postpoint sign. A list of outlets are available from postpoint.ie by clicking on find your nearest store.
- **Online:** You can now pay your rent online which you can access through the following link <https://www.mycoco.ie/quickpay/fingal-rentpayment> - just have your account number and email address ready. You can register for our [housing online portal](#) to access your rent account balance and use of other services such as our text message service. To opt in to receive text messages, click the "update contact details" tile, check your registered mobile phone number is correct and select "Yes" to accept SMS.

Failure to pay your rent is a breach of your tenancy agreement and may result in court action and eviction.

What can I do if I can't pay my rent?

If you are having difficulty in paying your rent due to exceptional circumstances, please contact a member in the rent account management team.

Tá treoir le fáil sa bhileog seo maidir le modh measúnaithe agus bailithe cíosa Chomhairle Contae Fhine Gall.

Tá cíós bunaithe ar fhoinse ioncaim gach ball teaghlaigh atá níos sine **ná 18*** mbliana d'aois. Ioncam inmheasúnaithe a thugtar air seo.

Conas a Ríomhtar Cíós ár réadmhaoine?

Ríomhtar cíós le haghaidh gach ball teaghlaigh atá os cionn 18 mbliana d'aois ag ráta 14.5% dá n-ioncam inmheasúnaithe.

Is ionann **ioncam inmheasúnaithe** agus Glanioncam. Is ionann é sin agus Ollioncam lúide CÁIN, ÁSPC agus USC. Ansin roinntear é sin ar an líon seachtainí oibrithe sa phost reatha agus/nó an líon seachtainí a raibh íocaíochtaí leasa shóisialaigh á bhfáil.

Glactar leis gurb é/í an duine leis an ardioncam sa teaghlach an **príomhshaothraí ioncaim** agus ríomhtar cíós an duine sin ag ráta 14.5% dá (h)ioncam/tuilleamh (ní gá gurb é an tionónta a bheadh i gceist). Níl aon chaidhp chíosa luaite leis an méid cíosa a ghearrtar.

Glactar le gach duine eile atá os cionn 18 mbliana d'aois a bhfuil ioncam acu sa teaghlach nó atá i dteideal ioncam a bheith aige/aici mar **fhoshaothraithe**. Ríomhtar cíós na ndaoine sin ag ráta 14.5% ach tá caidhp €60 luaite leis an muirear seachtainiúil.

Cuirfear muirear le haghaidh cothabháil do choire gáis agus táille bainistíochta i bhfeidhm gach seachtain.

D'fhéadfadh go mbeadh lagduithe i bhfeidhm má ghlacann baill den teaghlach páirt sna scéimeanna/cúrsaí seo a leanas:

Scéim Fostaíochta Pobail: Tá tionónta/áititheoir ag glacadh páirte i Scéim Fostaíochta Pobail, laghdóimid a n-ioncam chuig a n-íocaíocht leasa shóisialaigh le haghaidh 3 bliana ar a mhéad, agus ina dhiaidh cuirfear a n-ioncam fostaíochta i bhfeidhm go hiomlán.

Cúrsaí oideachais lánaimseartha: Is féidir le mic léinn atá i mbun cúrsa oideachais lánaimseartha, nach tionóntaí iad (Níl aon teorainn aoise) suas le €17,000 a thuilleamh gach bliain (Achoimre ar mhionsonraí fostaíochta mar chruthúnas) sula mbíonn siad dlite cíos dá gcuid féin a íoc. Ní mór litir ón gcoláiste ábhartha ina ndeimhnítear go bhfuil siad ag freastal ar chúrsa oideachais lánaimseartha a chur ar fáil gach bliain. Tá ioncam mic léinn sa bhreis ar €17,000 inmheasúnaithe chun críche cíosa.

Beidh muirear an linbh cháilithe san áireamh i muirear cíosa thuismitheoir an mhic léinn.

Printíseacht: Má tá printíseacht á déanamh ag duine, bunóidh Comhairle Contae Fhine Gall measúnú an duine sin ar íocaíocht "ráta aoischoibhéiseach" leasa shóisialaigh mura sáraíonn an t-ioncam ón bprintíseacht €17,000. Cosúil le cás an mhic léinn, tá ioncam sa bhreis ar €17,000 inmheasúnaithe chun críche cíosa.

D'fhonn a chinntiú go bhfuil muirear cíosa difreálaí cothrom luaite le gach tionóntacht, ríomhann Comhairle Contae Fhine Gall agus cuireann sí íosmhuirear cíosa i bhfeidhm le haghaidh gach teaghlach bunaithe ar gach ball foirne atá ina gcónaí ann.

Is éard atá sa ríomh seo an méid a mbeifeá i dteideal a fháil ón Roinn Coimirce Sóisialaí, beag beann ar cibé acu atá nó nach bhfuil an íocaíocht á héileamh ag an duine.

Cé chomh minic a dhéanfar m'ioncam a mheas chun críocha cíosa?

Déanfar d'ioncam teaghlaigh a mheas uair amháin gach dhá bhliain bunaithe ar an bhfaisnéis a iarraidimid uait. Ní mór an fhianaise ar fad maidir leis an ioncam fostaíochta seo a chur ar fáil nuair is gá de bhrí go mbeidh tionchar aici ar an méid cíosa a ghearrfar ort agus ní chuirfear aon athruithe i bhfeidhm air seo sa dá bhliain i ndiaidh do mheasúnaithe.

Glacfaimid le hathrú buan ar ioncam (ciallaíonn buan go mbeidh sé i bhfeidhm le haghaidh níos mó ná 6 mhí) ach ní chuirfear aon athruithe eile i bhfeidhm ar do chuntas i rith na tréimhse dhá bhliain.

Céard ba cheart domsa, mar thionónta, a dhéanamh?

- Íoc cíosa in am agus go hiomlán, de réir do chomhaontaithe tionóntachta.
- Cuir an Fhoirm Mheasúnaithe Cíosa agus na doiciméid riachtanacha ar fáil nuair a lorgáítear a leithéid
- Freagair aon chomhfhreagras/teagmháil ón oifig seo.

Déan teagmháil leis an bhfoireann mheasúnaithe cíosa má bhíonn athrú **buan** ar d'imthosca teaghlaigh i gceist (níos mó ná 3 mhí). Áirítear i measc na samplaí ach níl siad teoranta do:

- Post nua nó cailteanas poist.
- Athrú ar d'íocaíocht Coimirce Sóisialaí nó deireadh le híocaíocht.
- Má bhogann duine éigin isteach i do réadmhaoin i ndiaidh cead a fháil ón gComhairle.

Cuirtear cíós i bhfeidhm ar an Satharn i ndiaidh an dáta a shíníonn tú do chomhaontú tionóntachta agus gach Satharn ina dhiaidh sin.

Conas is féidir cíós a íoc?

- Is é an beartas nach mór don tionónta nó do na tionóntaí foirm Dochair Dhírighe/foirm Buanordaithe/foirm asbhainte Buiséid Teaghlaigh a shíniú i leith cíós a íoc, i gcás gur cuí.
